Mini Track: Inter-organisational learning

This mini-track focuses on knowledge sharing strategies aiming to reduce misinterpretations amongst actors.

Building trust between the actors, understanding the (inter)organizational needs, facilitating tools that ease and/or support collaborative work routine, changing organizational culture and dysfunctional climate are the highlighting issues of this mini-track. Special attention will be drawn on knowledge sharing behaviours of actors which have cultural and behavioural differences (i.e. work methodologies, disciplinary languages, communication channels and their uses and organizational structures within various contractual settings). Other popular areas are 1) planning (drivers, constraints, and challenges of knowledge sharing), 2) focusing on implicit knowledge and 3) performance evaluation of these strategies such as success, effectiveness, efficiency.

Research issues as follows are of special interest:

- Planning and performance assessment of knowledge sharing strategies
- Tools (enablers), obstacles and drivers of knowledge sharing strategies
- Intellectual assets of organizations in project environment
- Knowledge transfer among disciplines, knowledge integration among organizations
- Stimulating knowledge sharing behaviour
- Sharing tacit knowledge in/across organizations
- Learning knowledge sharing from other industries
- Other topics

Abstract details: The Abstract should be a minimum of 300 and no more than 500 words including up to five keywords and keyphrases to be received by **22 April 2010**. Please read the abstract guidelines section of the website before submitting.

Submission: Online at <http://academic-conferences.org/icickm/icickm2010/icickm10-abstract-submission.htm> Please ensure that you complete all relevant sections of the form, including the conference track the abstract is intended for, the proposed title for the paper, the full names (first name and surname, not initials) and email addresses of all authors and a postal address and telephone number for at least one contact author. Please indicate clearly if the contact author is not the lead author.

Full paper: Only required when the abstract has been selected and not to be more than 5,000 words including abstract, keywords and references (the Harvard referencing rules need to be followed). Submission date will be no later than **10 June 2010**. Papers should be submitted as .doc or .rtf file attachments by email to the Conference Manager, Elaine Hayne, at Elaine.hayne@academic-conferences.org

The selection panel of the conference committee will consider all abstracts received by the submission deadline to ensure that the proposed paper is relevant to the Conference. The authors of abstracts that describe a relevant paper will receive a notification of abstract selection. All full papers will be double-blind reviewed by members of the conference committee to ensure an adequate standard, that the proposed subject of their abstract has been followed, that the paper is of a suitable length, the standard of English is adequate and the paper is appropriately referenced. For authors whose first language is not English we request that you have your work proofread preferably by a native English speaker prior to submission (or at least a fluent English speaker) – papers may be rejected due to a poor standard of English. Papers that are accepted will be published in the conference proceedings providing at least one author registers and presents the work at the Conference (see the registration section of the conference website for more information about registration).

Due to the large number of papers expected for this conference, the committee only allows an author to present one paper. Therefore if multiple papers are accepted for presentation different co-authors need to present each paper. Please direct enquiries to Elaine.hayne@academic-conferences.org
