The Prevention and Chronic Care Management (PCCM) Advisory Council Initial Report is available here.

The Council has finalized their first issue brief "Chronic Disease Management" which aims to increase education about chronic disease prevention and management and include lowa-specific information and data. During the creation of this issue brief, the Council decided to add a seventh recommendation to the initial six laid out in their first report. The seventh recommendation is:

"Create a societal commitment to health through implementing policies to remove barriers that prevent lowans from leading healthy lives. Empower and expect lowans to take personal responsibility for being as healthy as genetically possible and improving their own health, as well as the health of those around them."

Another issue brief on "Disease Registries" is currently being developed collaboratively by the PCCM Advisory Council, the Medical Home System Advisory Council, and the eHealth Advisory Council.

At the last meeting, it was decided that the Council will break into two subgroups- one representing Chronic Disease Management and the other representing Prevention. The subgroups will meet in the mornings of the Council meetings, and then we will come back as a full Council in the afternoon. It was also decided that there will be a Chair and Co-Chair of the Council, each representing a different subgroup.

Results for Chair and Co-Chair have been calculated and determined. We are excited to announce:

- Chair (representing the Chronic Disease Management subgroup)- Dr. Don Skinner, McFarland Clinic
- Co-Chair (representing the Prevention subgroup)- Terri Henkels, Iowa State Association of Counties

The Subgroups will meet the mornings of the Council meetings, and then come back as a full group in the afternoons. This structure will allow focused work but will also continue to keep the issues of PCCM working together to promote a healthier population.

Medical Home System Advisory Council

The Medical Home System Advisory Council Progress Report #1 is available here. The Council's Progress Report #2 is currently being developed and will describe the activities of the Council over the past year, as well as other Medical Home advances in the state, and next steps for the Council.

Iowa submitted an application for the Children's Health Insurance Program Reauthorization Act (CHIPRA) Quality Demonstration Grant funded by the Centers for Medicare and Medicaid Services. Iowa's application is titled Navigating the Neighborhood: Improving Child Health Quality in Iowa and is organized around a medical neighborhood model of care. Unfortunately, Iowa did not receive funding for the CHIPRA Quality Demonstration Grant. However, the partnerships that were formed when writing the grant and the medical home implementation plan that was created for children in Medicaid are very valuable and will be utilized in the future.

April 8th, 2010 is the scheduled date for Iowa's National Academy for State Health Policy (NASHP) technical assistance site visit. Iowa was chosen as one of eight states for the NASHP Consortium to Advance Medical Homes for Medicaid and Children's Health Insurance Program (CHIP) Participants. The site visit will provide an opportunity for the MHSAC and partner organizations to receive technical assistance and learn from experts regarding the spread of the medical home concept.

Prior to their last meeting, the Council members completed an electronic survey regarding developing issue briefs. The results of the survey show that there is a strong interest in developing these. The purpose of the issue briefs is to educate legislators, members of other HCR councils, interested parties, and other stakeholders. They will summarize the topic and provide lowa specific information and data. Their first issue brief will be **"Patient Centered-What Does it Look Like"** and will summarize what patient-centered care encompasses and will lay out improvement strategies at an organization and system level to help leverage widespread implementation of patient-centered care.

Electronic Health Information Advisory Council

On March 15th, IDPH received notification from the Office of National Coordinator for Health Information Technology (ONC) that Iowa has been awarded \$8,375,000 over the next four years to plan and implement Iowa's statewide Health Information Exchange (HIE). This funding, made possible through the American Recovery and Reinvestment Act (ARRA) of 2009, is instrumental in moving Iowa e-Health forward to develop the statewide HIE.

The lowa e-Health Executive Committee and Advisory Council continue to draw on several volunteer workgroups and subcommittees that provide expertise regarding the components of health information technology (health IT). The workgroup and subcommittee members have offered enormous support and volunteer hours which are instrumental in developing lowa's strategic and operational plan. The lowa e-Health workgroups and subcommittees include:

- <u>Assessment Subcommittee</u>- Guiding various health care provider assessments, including provider practices, home health, long-term care, laboratories, and pharmacies, to name a few.
- <u>Communication and Outreach Subcommittee</u>- Developing communication materials that will be used to educate and inform Iowa health care providers and consumers about the uses and benefits of health IT.
- <u>Continuity of Care Document and Interoperable Electronic Health Records (EHRs)</u>- Describing the types of data transactions that will take place through the Health Information Exchange (HIE).
- <u>Governance and Finance</u>- Discussing preferences and recommendations for a long-term governance structure, including finance options and strategies.
- <u>HIE Infrastructure and Networks</u>- Discussing and outlining the core components needed for the HIE technical infrastructure (e.g., Master Person Index, Record Locator Service, Data Storage, and Participation Expectations).
- <u>Provider Adoption of EHRs</u>- Reviewing the HIE data transactions to ensure they will effectively improve patient care within and across provider settings.
- <u>Safeguard Privacy and Security</u>- Identifying potential privacy and security policies that will need to be in place to securely exchange patient information through the Iowa HIE.
- <u>Workforce and Education</u>- Outlining the core competencies of the health IT workforce and preparing for health IT curriculums at Iowa community colleges.
