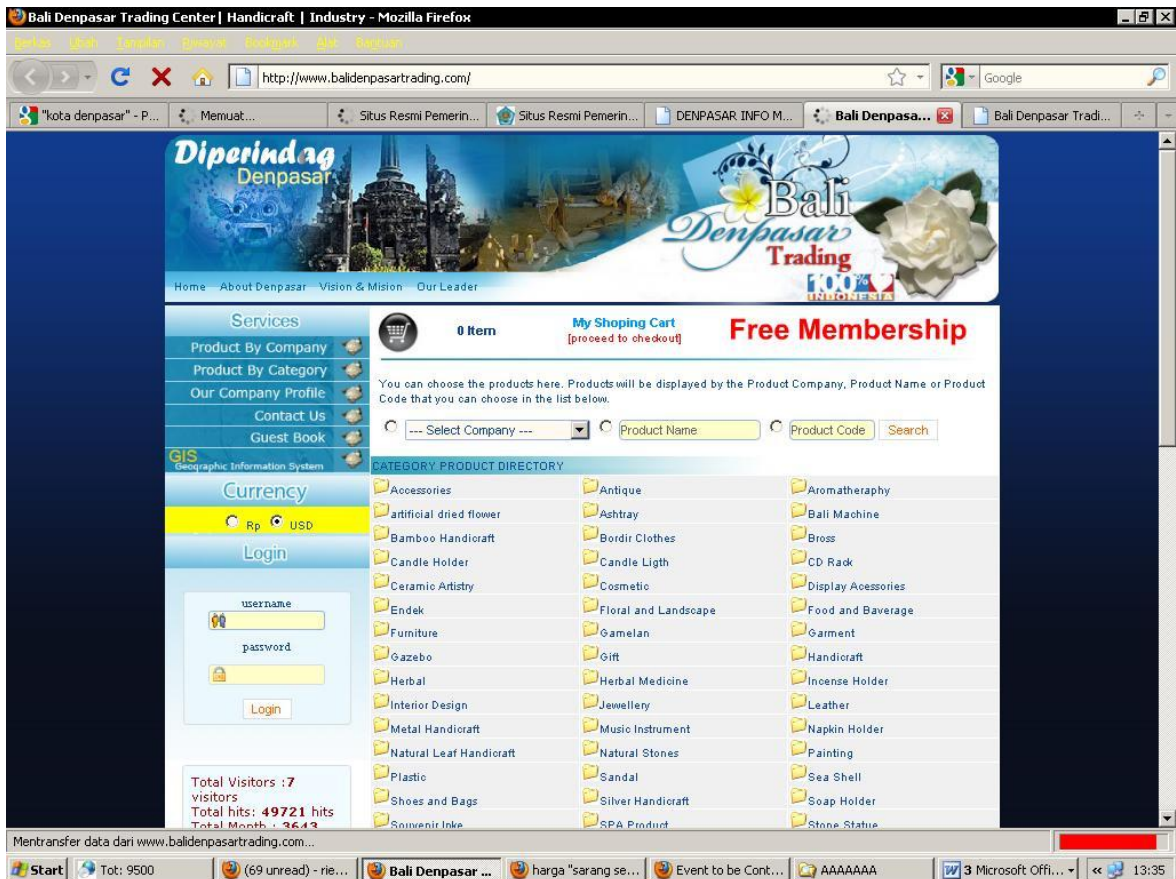


Figure 1: Category Product Directory

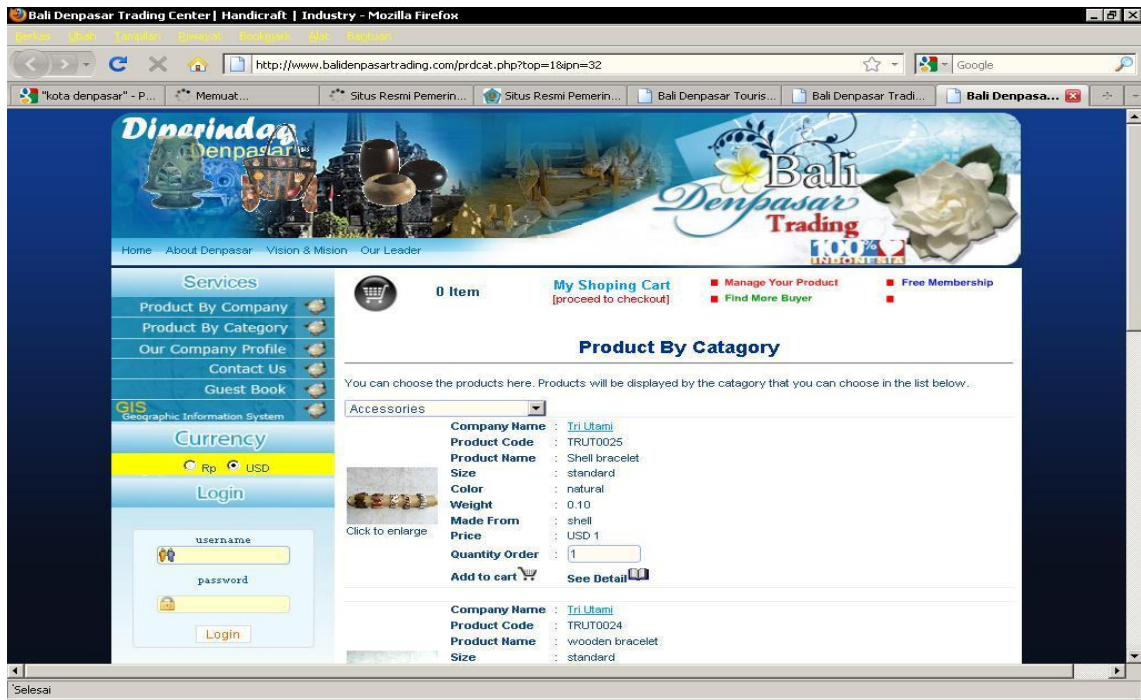


Figure 2: Search function- by product or service category
