Background



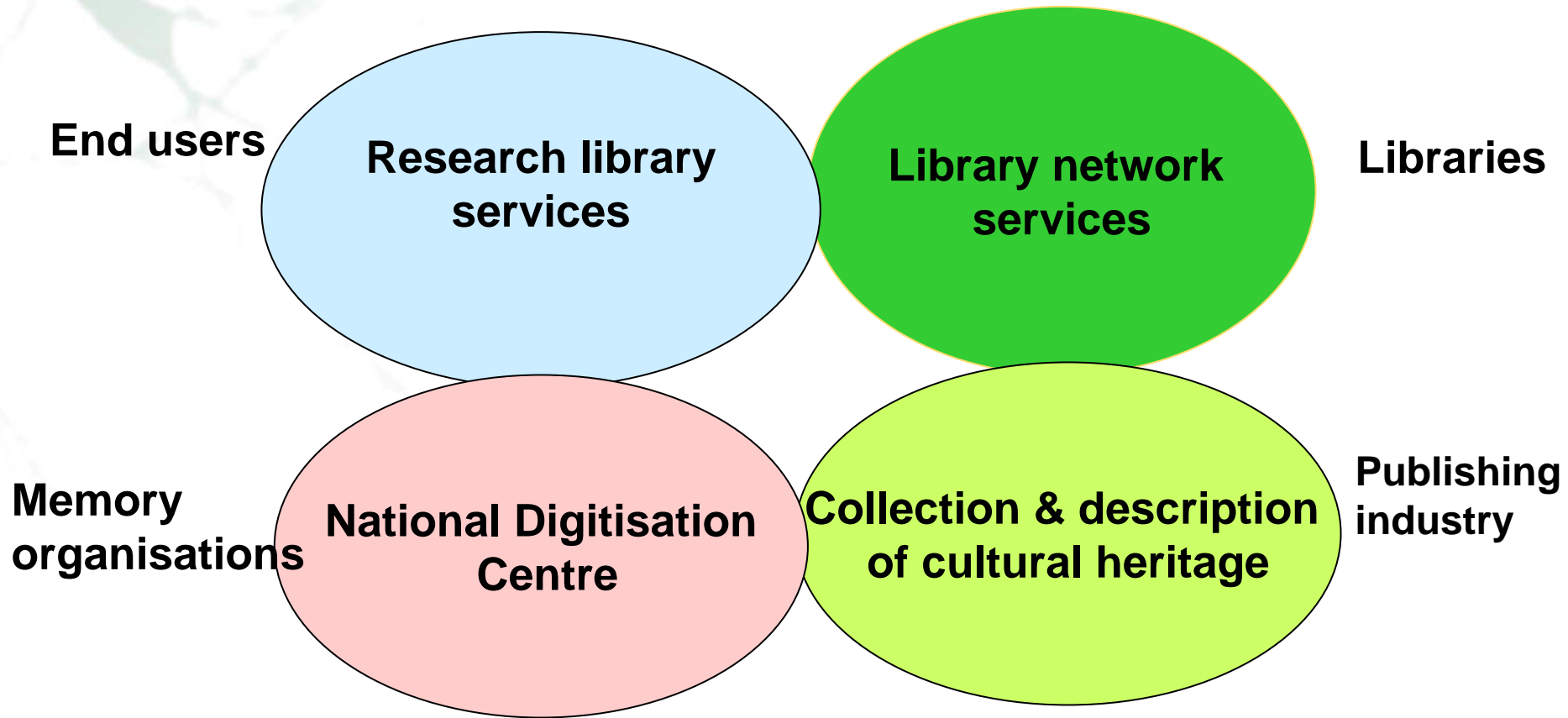
- National Library is a service centre for the library network since 1.8.2006
- The library network in Finland is well organised
- Universities, polytechnics and public libraries are under the Ministry of Education
- There are major structural changes taking place in the network of universities and polytechnics, research institutes as well as public libraries

National Library of Finland



- Change of the name of the organisation 1.8.2006
- Legal changes
 - University law and act
- New steering mechanism
 - Ministry of Education
 - National Library & libraries network
- New budgetary system
- Enlarged clientele
 - Universities
 - Polytechnics
 - Special libraries
 - Public libraries
- Central funding for universities, polytechnics and public libraries
- Defined services for the libraries

National library organisation 2007



The Library Network



- The network consists of 4 library sectors
 - Universities, polytechnics, special libraries and public libraries
- Each sector has organised its own activities
 - Council + working committee structure
 - Each sector has a chair person and a secretary
- 3 library consortia in the country
 - FinELib – national licensing and national portal
 - Linnea – library system
 - AMKIT – polytechnic libraries consortia

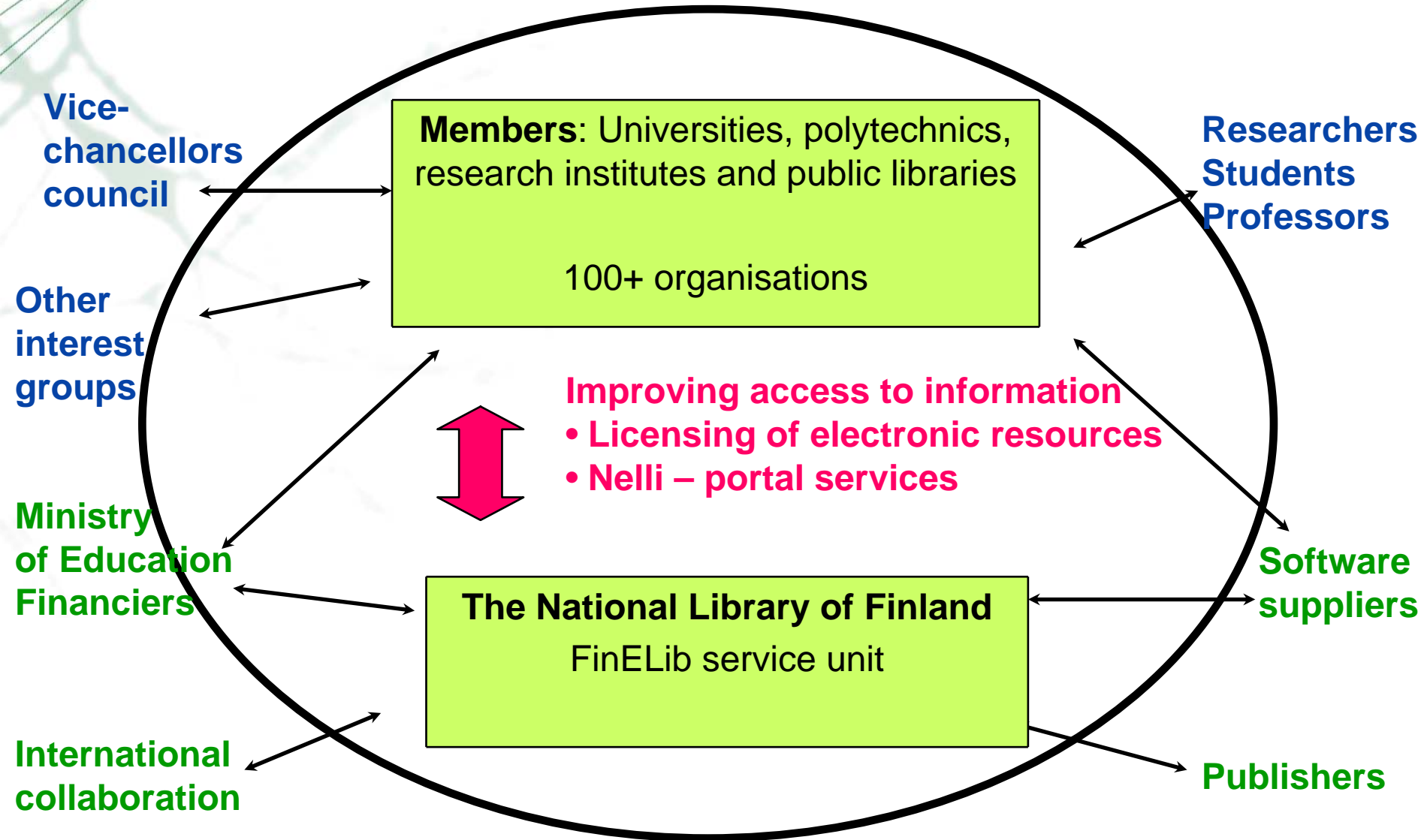
Structural changes



- University consortia are being created
- Mergers of polytechnics are taking place
- Municipalities are merging affecting the operations of public libraries

- Structural change will have an **impact on the funding** of universities and polytechnics
- National and international **infrastructure policies** will become forces of change in the development of scientific libraries

The frame of the work - FinELib-Consortium

Core e-resources for research and well-being – the process

- Working group of library directors formed
 - 2 representatives/library sector
 - Universities, polytechnics, special libraries, public libraries
 - FinELib staff; chair + 2 specialists
 - Model example of cooperation
- Available data analysed
 - Usage + user feedback
 - Total cost
 - Size of consortium
 - Feedback from e-resources working groups

Core e-resources for research and well-being – the process

- Defining the vision
 - **E-resources to support the competitiveness of Finnish research**
 - **E-resources to support wellbeing, studying, economic life**
 - **Tool to reallocate central funding to support strategically access to information**
- Defining the price tag
- Presenting the idea for stakeholders
- Preparing marketing/ lobbying materials

E-resources to support the competitiveness of Finnish research

- E-books
- Reference management tools
- 10 resources

CRITERIA

- Much used
- High quality
- Multidisciplinary
- Resources to support research in strategic research areas

Why should the government invest in scientific e-resources?



- To develop the national innovation system
- To develop the infrastructure for research
 - Content being one important part of it
- To guarantee access to information in the structurally changing environment (merges, new partnerships etc.)
- To support internationalisation of research

E-resources to support wellbeing, studying, economic life



CONTENT

- Reference databases
- Reference works
- Dictionaries
- 7+ resources

CRITERIA

- National resources in Finnish and Swedish
- Resources describing the Finnish society
- Resources covering health issues, law, statistics

Why should the government invest in e-resources for citizens?

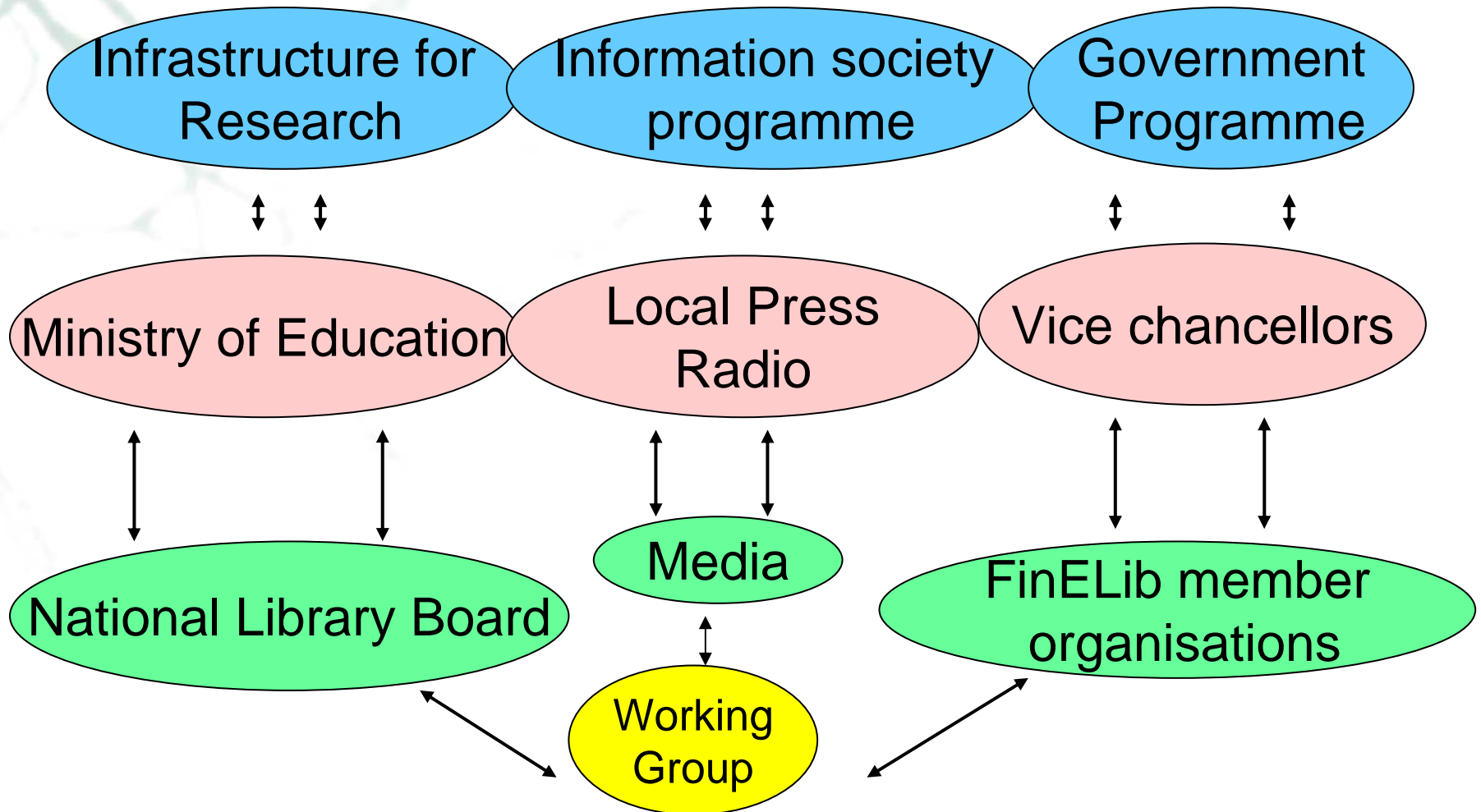


- To guarantee equal access to information all over Finland
- To safeguard citizens' access to reliable information resources
- To support studying and learning

Proposed: EUR 5-10 million

- 5 million
 - 50%-50% central / own funding for resources to support research
 - Current resources; current consortium
 - 100% funding for resources to support well-being
- 10 million
 - Same share between central/ own funding
 - National licenses
 - More resources for a larger user group
 - New content
 - New technologies to make access easier

EUR 5-10 million to support access to information!



Status summer 2007

- The idea has been introduced into
 - Government programme
 - Infrastructure for research programme
 - Information society programme
- Stakeholders have been very interested in the concept
- We are waiting for the reactions – and the funding!
