Dear Nancy:

As you know, the Committee is considering legislation to extend and amend the Arts and Humanities legislation. It would be helpful to us if you could supply some basic background material so that we may better understand the operation of the Endowment during the past three years.

Therefore, would you please provide the Committee with the following information:

1. A listing of each Arts Council member, his or her affiliation and background. Please note the number of Council meetings held each year and list the attendance records for each member.
2. Describe the structure of the Arts Endowment and provide a specific listing of all panels which you have created in each Art field. Also, please include the following data for each panel: (a) the composition of the membership; (b) background information regarding each panelist; (c) description of role and responsibility of panelist; (d) specific areas of responsibility for each panel; (e) level of funding for each panel during the past three fiscal years; (f) number of full time and/or part time staff assigned to each panel; (g) detail the amount of reimbursement paid for services of each panel member.
3. A listing of all grants and contracts recommended by each of these panels to the Council indicating which were approved and which were disapproved.

List all grants or contracts (by year) for the last three fiscal years by each Art area and include (a) a description (b) the total amount (c) the agency, organization or individual who received it, and (d) the name of the Director. This list should also include the results obtained from each grant or contract.
5. Please list No. 4 by panel area and make a second cross-referenced list breaking down the data by state.
6. Provide a list of personnel employed by the Arts Endowment, including salary, title and area of responsibility for each. Also, please submit the names, affiliations, length of service and amount paid for consultants.
7. Please provide the names and amounts of grants or contracts to non-American agencies, organizations or individuals.
8. Please provide the names and amounts of any grants or contracts given under the Director's authority without Council approval.
9. Please provide a listing, if any, of grants or contracts made that did not require the 50-50 match. Indicate to whom, the amount, and the reason for each exemption.
10. Please send copies of any audits made by the Endowment during the last three years.
