REPORT FOR SENATOR CLAIBORNE PELL Prepared by W. T. Chase

1. Size of the Laboratory

The Technical Laboratory contains approximately 500 square feet; the Picture Mounting Studio contains approximately 1,000 square feet. Space is temporarily borrowed at times in other areas—for instance, we often work on large objects in stone sculpture storage.

3. Staff

The Technical Laboratory employs two full-time technicians, a full-time secretary, and three part-time employees. The Picture Mounting Studio employs four full-time specialists.

4. Chief area of interest

The Technical Laboratory has as its chief area of interest the examination and conservation of Oriental Antiquities. In recent years emphasis has

been given to works of art in metal. It also has charge of all of the conservation and restoration for the Gallery except for that of the oriental paintings, which is the chief area of responsibility of the Picture Mounting Studio. The two sections cooperate closely. The Picture Mounting Studio is unique and the most complete organization of this type in the Western World.

5. Cooperation with other government agencies

The Technical Laboratory and the Oriental Picture Mounting Studio often provide assistance to other bureaus of the Smithsonian and other government agencies, as well as institutions at home and abroad, which seek our services. In addition, the Technical Laboratory often makes use of the facilities and equipment of other government agencies. In the past year we have used the services of other branches of the Smithsonian, especially the Conservation-Analytical Laboratory and the Department of Mineral Sciences, the National Bureau of Standards, the Naval Ordnance Laboratory, as well as the Geological Survey.

6. Cooperation with industry

The Technical Laboratory has had little opportunity to cooperate with industry. We have, on occasion, advised companies on specific problems relating to the use of their products and equipment in our field.

7. Funding

Although it is the responsibility of the Smithsonian Institution, in accordance with the Deed of Gift, to maintain the conservation program of the Freer Gallery of Art, this has not been done; the entire program is currently maintained from the original endowment.
