## CALL FOR SPECIAL ISSUE PROPOSALS

### Seeking Proposals for a Special Issue to be Published in Fall 2018 and 2019

The special issue should focus on a targeted area of interest relevant to problem-based learning, project-based learning, case-based learning, anchored instruction, or inquiry broadly. ## Responsibilities

The responsibilities of the guest editor(s) are as follows:

- Develop and distribute a call for proposals
- Solicit proposals from potential authors (Suggested deadline: by June 15, 2017)
- Select and invite full manuscripts based on proposals (Suggested author notification date: by July 1, 2017;

suggested manuscript submission date: by September 30, 2017)

- Suggest and recruit reviewers for full manuscripts
- Provide critical feedback on manuscripts
- Make manuscript decisions following the review processes
- Write a guest-editor introduction for the special issue

## Proposal

To propose a special issue, please submit the following by the due date to editors Michael M. Grant ([michaelmgrant@sc.edu](mailto:michaelmgrant@sc.edu)) and Krista Glazewski ([glaze@indiana.edu](mailto:glaze@indiana.edu)):

- Write a cover letter that includes a description of the proposed special issue topic and its direct relevance to the *IJPBL* audience (no more than 500 words).
- Provide a rationale for your expertise in editing the special issue with any publications or presentations that may support this.
- Suggest a number of authors who may contribute to the issue. (At this point, it is not necessary to have all of these authors committed to submitting a manuscript proposal for the issue, but it does help to know if they have been contacted.)
- Submit a current vita for each editor on the proposal.

## Deadline

The deadline for special issue proposals is April 30, 2017.
