#### CHAPTER 1

#### INTRODUCTION

#### Background

The investigator is a developer of training programs for USG Corporation, a major manufacturer of construction materials and allied products. The proposed research problems have arisen from certain difficulties in the administration of USG Corporation's sales training courses.

The Corporation now has in use over 30 such courses covering all major product lines. These courses are intended for new Sales Representatives as well as experienced Sales Representatives taking on new product lines. The programs are generally print-oriented, with reinforcement via videotape and audiotape. Instruction is individualized and administered with a minimum of supervision.

Sales Representatives take the courses through a nationwide learning center network. The learning centers are located at major sales offices and manufacturing facilities. Each learning center contains videotape and

audiotape playback equipment as well as all necessary course materials.

Though the courses themselves are both comprehensive and well-designed, course utilization has been disappointing. The problem stems from the fact that economics do not permit the use of full-time training supervision in the field. This means that course-completion and testscore records are inadequate. As a result, many trainees now give the programs only perfunctory attention.

It appears that one way to increase trainee commitment to the course material might be to computerize the training. Through computer interaction, the trainee could receive individual attention and supervision. The computer could also make it possible to maintain a centralized electronic record of each trainee's progress and achievement. Both of these features would certainly encourage course participants to take their work more seriously.

Because of economic constraints, the Company would probably adopt a computer-managed instruction (CMI) format rather than a computer-assisted instruction (CAI) format. In other words, existing audio-visual and text teaching materials would remain unchanged while administrative instructions, course tracking information and review examinations would be given via computer. At the same time, the computer would automatically maintain a record of the trainee's progress and achievement.

In the current course format, administrative instructions and review examinations are provided via a printed study guide. To implement the plan just described, then, the printed guide would be replaced with a computerized version. This computerized guide should be relatively inexpensive to develop and administer.

#### The Problems

Before implementing full-scale conversion to computerized study guides, USG Corporation would like to have the answers to two key questions -- which are the problems to be addressed in this study:

- (1) Would trainees be resistant to the introduction of a computerized study guide as described?
- (2) Would switching to a computerized study guide as described adversely affect trainee performance in the sales training programs?

The following chapter reviews current literature relevant to the proposed research problems.

#### **CHAPTER 2**

## **REVIEW OF THE LITERATURE**

## Introduction

Many studies have been designed to assess attitudinal effects on students learning via CMI. Those appropriate to the current investigation have focused on:

- determining the effect of exposure to
   CMI on learner attitudes towards working with computers.
- (2) determining how such attitude changes might, in turn, affect attitude towards the content being studied.

CMI testing strategies studied in recent

literature focus on the type of feedback presented after the student answers a test item. The completeness of the information given, the timing of it, the degree of personalization and "friendliness" and the response expected of the student have all been shown to affect subsequent student retention of test content.

#### Literature Concerned With Assessing Attitudinal Effects

As part of an investigation on instructional strategies for CMI, Lawler and others (1972) administered an instrument designed to provide data on attitude towards content being studied (college level health education). They found no significant difference among treatment groups -- which included a control group taking the course conventionally and three groups exposed to various CMI strategies.

Cartwright and Derevensky (1975) reported an attitudinal study based in part on the work of Bundy (1968), Mathis and others (1970), and Goodman (1968). Bundy had shown that student attitudes towards specific methods of learning are highly correlated with achievement; Goodman had suggested that attitudes towards CAI might be modified by exposure to particular programs and systems; Mathis and others had concluded that exposure to CAI produced positive attitudes towards CAI as a learning method.

Cartwright and Derevensky worked with six sections of an introductory educational psychology course. In three of the sections, all quizzes and exams were given by computer; in the other three, quizzes and exams were conducted in the traditional manner. Students taking the computer quizzes and exams were given immediate feedback on the correctness of each response.

A teaching methods questionnaire administered at the end of the year showed that:

- (1) The computer sections scored significantly higher than the non-computer sections on scales measuring both attitudes towards computer-assisted instruction and attitudes towards course lectures. The latter result was a surprise to the investigators, and has been interpreted (Barnett, 1974) as a result of students perceiving the instructors who initiated the computer quizzes as better lecturers. The result might also stem from enhanced feelings of achievement expressed by those in the computer sections.
- (2) an analysis of general comments solicited from the students showed that those in computer sections perceived the computer quizzes as being more of a learning than an evaluation experience.

Wooley (1978) investigated attitudes towards CAI as a part of a study aimed at developing three different types of CAI strategy for use in a college-level astronomy course. In his article, Wooley reviewed the reports of Gilman (1969) and Lawler (1972 - as quoted earlier in this

review) -- both of which suggest that variations in CAI strategies do not result in significant attitude variations. Wooley also reported on the work of Judd (1973), who surveyed attitudes of students who had taken a computer-assisted survey course in special education. A neutral score on Judd's instrument was 189, and results ranged from a slightly negative feeling (181) to a vey positive one (294). The mean was 241. Wooley also reported on the work of Culp and Lagowski (1971), who obtained very favorable attitudinal responses from students in a computer-assisted organic chemistry course.

Wooley's results supported those of Gilman and Lawler in that student attitudes towards CAI seemed independent of the CAI strategy used. He also found that females scored significantly lower than males in both course achievement and CAI attitude measures. Judging by the responses on the CAI instrument, the negative attitude towards CAI expressed by females is related to what they perceive as the mechanical and impersonal nature of computerized testing.

In a very elegant and thorough study (Steffenson and others, 1982), the attitudes of 64 students enrolled in an introductory biology course utilizing CMI were surveyed. In part, these investigations were concerned with verifying the work of Hausmer and Henderson (1972), who felt that students using CMI tended to view their

instructors as coaches rather than adversaries. The two also found that student anxiety levels in regard to CMI testing were much lower than towards conventional testing. Among the other authors supporting this point of view and quoted by Steffenson <u>et al</u> are Cartwright and Derevensky (1975 -- reviewed earlier in this section) and Torop (1975).

An attitudinal pre-test administered to 64 students consisted of ten questions not requiring <u>a priori</u> knowledge of the CMI experience. The post-test, administered at the end of the course, contained the same ten questions plus thirty additional ones. Twenty of these attempted to measure students' feeling about the CMI experience. The other ten items attempted to ascertain students' attitude towards the computer instructional facilities and operations at the university (South Dakota State) where the study was carried out.

From the overall results of the pre-test and post-test attitudes of students towards CMI, it was apparent that the subjects had demonstrated a significant positive growth in their attitudes towards the CMI method. An analysis of responses to specific test items showed that the subjects did not feel that CMI made learning too mechanical or impersonal. On the other hand they did feel, very strongly, that CMI provided both a testing and a learning experience.

# Literature Concerned With CMI Testing Strategies

Lawler and others (1972 -- see previous section of this review) studied three types of strategies for CMI testing. They found that one strategy was significantly best as indicated by comparing achievements in a final exam on course content. This strategy (called by the authors "Remedial Prescription -- forced Mastery") involved:

- (1) giving students who failed a particular quiz a remedial prescription keyed to the failed objectives.
- (2) requiring such students to reschedule terminal time to retake that particular quiz.
- (3) not allowing these students to take other quizzes (related to other course modules) before passing the failed quiz.

As has already been outlined in the previous section of this review, Cartwright and Derevensky (1975) noted very positive student reaction to a CMI testing method giving immediate item-by-item feedback on the correctness of each test response. In addition to this information, students could request a feedback paragraph telling what the correct response was and why it was correct, as well as the reasons alternative selections were not correct. The paragraph also gave information on source material to be reviewed for information relating to

the test items. This test strategy was based on B.F. Skinner's (1968) argument that the student should have immediate knowledge of test results.

An interesting sidelight on CAI strategy was explored by Lippold (1977). He investigated the effects of "personalization, encouragement and humor" of CAI responses on student attitude and subsequent performance. Lippold developed two CAI programs for his study. The first, or control, program was an interactive drill-and-practice unit in general psychology. The second program was identical to the first except that it was personalized by making frequent referral to the subject's name during the course of the instruction. The second program also contained many comments designed to be encouraging and humorous.

A sample of 61 male and female undergraduate students was randomly assigned to the two program groups. The results of a pre- and post-test showed no significant difference in relative attitude change between the groups. The control group, however, did significantly better on a test of program content -- indicating that the inclusion of personalization, encouragement and humor had a negative effect on the experimental group's recall learning.

In the 1978 article mentioned in the previous section of this review, Wooley based his study of CAI

strategies on the work of Brown (1967) and Gilman (1969).

Brown listed the following options for test item feedback:

- (1) no feedback
- (2) "wrong" if response is incorrect
- (3) "correct" if response is correct
- (4) statement containing the correct response
- (5) statement of why the response is correct
- (6) statement of why the response is incorrect
- (7) repeat question if response is incorrect
- (8) repeat all questions missed until all questions are answered correctly.

Gilman considered a set of options similar to Brown's as follows:

- (A) no feedback (like Brown's #1)
- (B) knowledge of results (like Brown's #2 and #3)
- (C) knowledge of correct response (like Brown's #4)
- (D) response contingent (like Brown's #5 and #6)
- (E) combination of knowledge of results, knowledge of correct response and response contingent feedback (not one of Brown's options).

Gilman tested the effects of his feedback options

on the rate of learning retention, and students' attitude towards instruction, on a CAI program for teaching science concepts. He found that feedback types (C), (D) and (E) -- which guided the learners to the correct response -were conclusively better than types (A) and (B), which forced the learner to "discover" the correct response.

In Wooley's study, which included two treatment groups and a control group, the treatment subjects were given feedback equivalent to Gilman's type (B) and type (E). No significant difference was found in the performance of the subjects of these two groups, and thus Gilman's findings were not supported.

Many programs for computer-assisted instruction are based on the premise that immediate feedback of the correct response is necessary for learning to occur. However, many authors during the period 1966-1972 showed that delays of 24 or 48 hours in presenting feedback resulted in enhanced retention of the material one to seven days later. In every case, the conditions under which the effect was found were as follows:

- (A) The learning tested was academic material.
- (B) The initial test and informative feedbackwere presented in a multiple choice format.
- (C) There was only one presentation of informative feedback.

(D) The retention test consisted of the same

items as the initial test.

In a study confirming these findings, Sturges (1978) worked with four groups of undergraduate child psychology students. These groups were given, respectively, no feedback (control group), 2-second feedback delay, 20-minute delay, and 24-hour delay. Sturges noted that the 20-minute delay group exhibited about the same enhanced retentivity as the 24-hour delay group. In a similar study (Rankin and Trepper, 1978) the following treatment groups were compared:

- immediate feedback presented after each response.
- (2) feedback presented 15 seconds after each response
- (3) feedback presented only after all test items were completed

Groups (2) and (3) showed significantly greater retentivity than group 1; there was no significant difference in retentivity exhibited by groups (2) and (3).

# <u>Conclusions</u>

A review of this literature led the investigator to believe that learner attitude towards a training program being studied would become more positive, or at least remain unchanged, after exposure to CMI (see,

especially, Lawler and others, 1972; Wooley, 1978). It further appeared that positive attitude change could be maximized if the learner perceived the computer test as a helpful coaching procedure rather than a cold-blooded evaluation. (Cartwright and Derevensky, 1975; Steffenson and others, 1982). However, computer responses that are over-friendly or humorous (Lippold, 1977) might adversely affect recall learning.

The literature also suggests that student performance is not degraded by CMI, and can be improved by proper design of computer responses (feedback) presented during interactive testing. Studies analyzing effects of completeness of feedback have been contradictory (Wooley, 1978). However, Lawler and others (1972) have shown that achievement in CMI programs is improved if the student is given diagnostic information and required to master every quiz before proceeding with other course units. Sturges (1978) and Rankin and Trepper (1978) report that retention of course material can be significantly enhanced by delaying computer feedback.

The following chapter will show how the present study was designed to test some of these ideas and answer the questions posed at the end of Chapter 1.

#### CHAPTER 3

#### RESEARCH DESIGN

# **Research Questions**

Based on the problems posed at the end of Chapter 1, and the results reported by previous investigators, it was decided to address the following research questions:

- 1 (a) Do learners in self-study sales training programs better retain course material when working with printed study guides containing pencil-and-paper self-testing exercises, or when working with computerized study guides incorporating simple CMI procedures?
  - (b) What is the effect, on attitude towards CMI, of working with computerized study guides incorporating simple CMI procedures?
- 2. How would the results obtained from investigation (1) be changed if the simple CMI procedures were enhanced using some of the techniques described in academic literature?

#### Definition of Terms

In this study, the term CMI (computer-managed instruction) refers to instructional programs containing self-testing exercises of one of the two following types: <u>nominal</u> computer testing or <u>enhanced</u> Computer testing. Both of these types of testing are fully described in the "Instrumentation" section of this chapter. <u>Retention of</u> <u>course material</u> is measured by the results of a paper-and-pencil examination taken one week after completion of the experimental instruction. <u>Attitude</u> <u>towards CMI</u> is defined as relative performance on a specified attitude test. (See "Instrumentation" section.)

#### **Hypotheses**

The following null hypotheses were formulated for use in studying the research questions previously described:

- The experience of taking nominal computer tests has no significant effect on the learner's attitude towards CMI.
- The experience of taking enhanced computer tests has no significant effect on the learner's attitude towards CMI.
- 3. There is no significant difference in retention of course material between learners who have taken pen-and-pencil tests and

learners who have taken nominal computer tests.

- 4. There is no significant difference in retention of course material between learners who have taken pencil-and-paper tests and learners who have taken enhanced computer tests.
- 5. There is no significant difference in retention of course material between learners who have taken nominal computer tests and learners who have taken enhanced computer tests.

#### Subjects

It was decided to confine the study to subjects typical of entry-level participants in industrial sales training programs. But it was not possible to obtain the required forty-five subjects from the population of newly-hired Sales Representatives at USG Corporation. There were simply not enough such individuals in any one place at any one time. Instead, volunteer subjects were obtained from the first- and second-year classes at the J.L. Kellogg Graduate School of Management of Northwestern University (Evanston, IL). It is not unusual for entry-level Sales Representatives in large industrial organizations to have an advanced business background, and it was judged that the Kellogg students would not be too different in attitudes, interests and maturity from such new hires.

# Experimental Procedure

The 45 experimental subjects were randomly assigned to three groups of 15 each -- <u>Group 1</u>, <u>Group 2</u>, and <u>Group 3</u>. Each member of each group studied the same excerpt from a USG Corporation course used in the training of Inside Sales Representatives. As is standard for USG training programs, the excerpt contained print, video and audio segments. The excerpt required a study time of between two and three hours, and included two self-testing exercises.

The self-testing exercises used by each group varied. All contained the same set of multiple choice questions. However, the <u>Group 1</u> set were in standard pencil-and-paper form; the <u>Group 2</u> set were in <u>nominal</u> computer form; the <u>Group 3</u> set were in <u>enhanced</u> computer form. (See "Instrumentation" section for descriptions of nominal and enhanced computer tests.) The three self-test variations are the independent variables of this investigation.

Just prior to beginning study of the training program, members of Group 2 and Group 3 were asked to take a pretest measuring attitude towards CMI. Just after completing the training program, members of Group 2 and Group 3 took a posttest form of the same instrument. At the conclusion of the test sessions, each participant

was informally interviewed by the investigator and encouraged to freely express his/her reactions to the study and test materials.

One week after finishing the training program, each subject was mailed an identical "retention test" for completion at home and instructed to mail it back within 24 hours. This paper-and-pencil test contained the same set of multiple-choice questions used in the original self-test exercises. The retention test scores and attitude change scores are the dependent variables of the study.

#### Instrumentation

The <u>paper-and-paper</u> self-test exercises used by Group 1 during the treatment sessions (and by all groups as a retention test) were slightly modified versions of the standard USG Corporation instruments. The modification consisted of making all questions conform to a multiple-choice format -- thus making them easily convertible to the computerized versions required for Group 2 and Group 3. As is typical for USG Corporation self-test exercises, the correct answers to all questions were printed in the back of the test booklet.

The <u>nominal</u> computer self-test exercises used by Group 2 were designed to give the learner immediate feedback on each test response. Just as with the pencil-and-paper exercises, however, the feedback concerned only the correctness of the responses. The correct answer was supplied when the learner gave an incorrect response, but no further information was provided. The "correct" and "incorrect" feedback messages were brief and never varied; only one form of each was used. The learner was allowed to proceed to the next test item whether or not he/she had answered correctly.

The <u>enhanced</u> computer self-test exercises used by Group 3 were designed to incorporate some of the features reported in the literature as enhancing student performance. Feedback messages were deliberately delayed for several seconds after each response. The messages were given in informal, conversational style and occasionally referred to the learner by name.

In the enhanced exercises, if repeated wrong answers to a test item were given, the learner was prompted twice to rethink the response and try again. Information on where to look in the course for the correct answer was given at the second prompt. Only after the third unsuccessful attempt at answering the question was the correct answer supplied and the learner allowed to move to the next test item. The feedback messages in response to right or wrong answers were varied in style.

The multiple-choice question set used for these exercises, as well as the computer feedback messages for both nominal and enhanced test styles, are given in the Appendix at the end of this study.

All computer self-test exercises were prepared by the investigator on a Commodore 64 computer using the authoring language "Pilot." The computer is an inexpensive home model and the language is one designed for the preparation of interactive learning materials by computer lay people. These choices were made, in part, to determine whether computer tests for USG Corporation training programs could be developed using inexpensive equipment and by non-professional personnel.

The same computer was used to administer the self-test exercises. However, to avoid the necessity for orienting the subjects to the computer keyboard, and to avoid experimental errors caused by differences in keyboard skills, a simplified response system was used. During the test sessions, the keyboard was kept covered, and the student entered test responses via a small, separate keypad.

The keypad contained a small number of alphabetically labeled keys, an "ENTER" key, and a key labeled "?." The subject simply pressed the key corresponding to the letter of the selected answer, then pressed the "ENTER" key. The subject had the option of changing his/her answer by pressing the "?" key prior to pressing "ENTER." This cleared the original selection so

that a new one could be made.

The instrument measuring student attitude towards computer-managed testing (both pretest and posttest forms) was derived from similar tests used by Steffenson and others (1982), Hagerty (1970) and Brown (1967). In most test items, the subject was asked to indicate -- on a 5-point scale -- the degree of his agreement, or disagreement, with a particular attitudinal statement. Informal questions were added at the end of each test to get a general idea of the subject's previous experience with computers (pretest) and to solicit reactions to procedures used in this study (posttest). The posttest contained the same ten formal questions used in the pretest, and also contained thirty additional ones designed to elicit responses concerning the specific study environment and method of testing. Both pretest and posttest forms will be found in the Appendix at the end of this study.

## Statistical Analysis

To test hypotheses 1 and 2, which are concerned with the effect of the test-taking experience on the learner's attitude towards CMI, the investigator studied pretest-posttest changes in the subjects' responses to the first ten questions in the attitude assessment instrument. Separate t-tests (of hypothesis about two

dependent means) were run to determine statistical significance of the change scores on each test question for each of the two groups tested (Group 2 and Group 3). The results for Group 2 (<u>nominal</u> computer testees) were used to assess hypothesis 1; the results for Group 3 (<u>enhanced</u> computer testees) were used to assess hypothesis 2.

Scores on the remaining 30 formal questions in the attitude instrument (which appeared on the posttest only) were simply averaged on a question-by-question basis for each of the two groups tested (Group 2 and Group 3). These averages were then used (in conjunction with the informal questions asked on the pretest and posttest) to make qualitative judgements concerning the attitudes of each group towards the learning and testing experiences.

Separate t-tests (of hypothesis about two independent means) were used to determine statistical significance of difference between retention test scores of Group 1 and Group 2 (to assess hypothesis 3); between the retention test scores of Group 1 and Group 3 (to assess hypothesis 4); and between the retention test scores of Group 2 and Group 3 (to assess hypothesis 5).

The following chapter will present the results obtained from analysis of the data obtained in this study.

#### CHAPTER 4

#### RESULTS

## Pretest-Posttest Attitude Change

Following are the ten questions that appeared both on the pretest and the posttest versions of the attitude evaluation instrument:

- In a situation where I am trying to learn, it is important to me to know where I stand in relation to others.
- I feel perfectly comfortable about answering test questions by pressing buttons on a computer.
- 3. Being tested and evaluated by computer makes me feel that no one really cares whether I learn.
- 4. I am concerned that I might not understand the material presented by computer.
- 5. I am concerned that computer-managed testing might make learning too mechanical.
- The mechanics of working with the computer might be more difficult than learning the material presented.

- I like to know immediately whether or not my answers to test questions are correct.
- I feel that I can work satisfactorily at my own pace with computer-managed testing.
- 9. Computer-managed testing will make me feel isolated and alone during part of the course.
- 10. Computer-managed testing will use a student's time more effectively.

As is apparent, these questions were designed to determine if the subject felt that being tested by computer might be too impersonal (questions 1,3,5,9), was concerned about the mechanics of interacting with a computer (questions 2, 4, 6), and agreed that the computer might be helpful in the testing process (7,8,10).

For each question, the subject was asked to indicate degree of agreement/disagreement by circling one of the responses on the following Likert-type scale:

1 2 3 4 5 The numbers below the responses did not appear on the question sheet, but were assigned as indicated in order to carry out the statistical analyses summarized on the following pages.

tcrit=2.145 for 5% significance level tcrit=2.977 for 1% significance level A study of the pretest score means suggests a similar attitudinal profile for both experimental groups. In both cases, there is definite agreement with the statements of questions 2, 8, and 10 and definite disagreement with the statements of questions 3, 4, 6, and 9. This suggests that both groups were at home with computers and had positive feelings about their usefulness as an aid to learning. In the case of the remaining three questions, response for both groups was in the uncertain range.

The t test results for pretest-posttest attitude score differences showed statistically significant change in only one case. This was question seven as answered by Group 3 -- where the t value indicates an increase in agreement with the statement that is significant at the 5% level (and is very close to being significant at the 1% level). The t test for the same question as answered by Group 2 also showed an increase in agreement. Though not quite statistically significant, the increase represented the greatest attitude change in the question set.

Based on the results of the t-tests, Hypothesis 1, "The experience of taking nominal computer tests has no significant effect on the learner's attitude towards CMI," must be accepted for all ten of the questions studied. Hypothesis 2, "The experience of taking enhanced computer

tests has no significant effect on the learner's attitude towards CMI," must be accepted for all questions but 7. For question 7, the hypothesis is rejected because of an attitude change (increase in agreement) significant at the 5% level. While not being able to reject Hypothesis 1 for question 7, it's certainly worth noting that the increase in agreement was almost significant at the 5% level.

#### Responses To Remaining Posttest Questions

The remaining 30 post-test items are direct questions concerning the subjects' reactions to participation in the study. Thus, there are no matching pretest questions and no change scores. As in the case of the test items already discussed, each question consists of a statement to which the subject is asked to respond on a 5-point, Likert-type scale. Three different variations of this response scale are used.

The following three tables summarize the subjects' responses to the questions. For ease in analyzing the results, each table contains the statements associated with a particular response scale. The statements are abbreviated here for presentation in tabular form. For the complete statements, see the posttest instrument itself, which is reprinted in its entirety in the Appendix at the end of this study.

Once again, the attitudes expressed by Group 2 closely paralleled those expressed by Group 3, with the response means being quite similar for each question.

As a whole, the students did not feel that learning was too impersonal or mechanical (questions 12, 13, 24, 33, 36) and had no trouble interacting with the computer (questions 16, 17, 18, 19, 26, 27, 28, 29, 32)



or working with the hardware (questions 22, 23, 30, 38, 39, 40). Responses to frankly positive statements about computer testing were more guarded, but still generally in agreement (questions 11, 20, 21, 25, 31, 34, 35, 37). Where disagreement was indicated, it was not very strong (questions 14 and 15).

Both Group 1 and Group 2, then, were at home with the computer and did not see it as a threat or as an impediment to learning. While not willing to wholeheartedly endorse the computer as a learning aid, most could perceive beneficial effects.

### Retention Of Course Material

The following two tables summarize the results of the retention test for all three experimental groups. While it is obvious by inspection that there are no significant differences between the mean scores reported in Table 6, differences between the means were also studied by means of t-tests. The results of these tests are reported in Table 7.

The results of table 7 verify that there is no significant difference between the means of Groups 1 and 2, Groups 1 and 3, or Groups 2 and 3. This requires acceptance of the last three hypotheses to be tested. (Hypothesis 3, "There is no significant difference in retention of course material between learners who have taken pen-and-pencil tests and learners who have taken nominal computer tests."; Hypothesis 4, "There is no significant difference in retention of course material between learners who have taken pen-and-pencil computer tests and learners who have taken enhanced computer tests."; Hypothesis 5, "There is no significant difference in retention of course material between learners who have taken nominal computer tests and learners who have taken computer tests.")

# Response To Informal Questions

A group of informal questions concerning previous experience with computers was included at the end of the attitude evaluation Pretest. The results of these showed that 14 of the 15 participants in Group 2 (nominal computer testees) and 13 of the 15 participants in Group 3 (enhanced computer testees) had some prior experience with computers -- usually through use of word processing and financial analysis programs in connection with school assignments. Seven of the participants in Group 2 actually had prior experience in taking computerized tests, as did three of the participants in Group 3.

A blank area at the end of the posttest was provided for the participant to write down any comments

he/she might like to express concerning the procedures used in the study. Prior to leaving the test room, each participant was also informally interviewed and invited to discuss his/her reactions. At these sessions, participants were encouraged to make spontaneous comments about points they felt were important, but no leading questions were asked. Following are the participant comments that seem especially significant to this study:

Reported by five people in Group 2 and four people

<u>in Group 3:</u> "I found it frustrating to have the computer tell me I was wrong, but not <u>why</u> I was wrong. Would have liked to discuss my answer."

Reported by two people in Group 2 and two people in Group 3: "I liked the computer's immediate feedback regarding correctness of answers."

Reported by two people from Group 2: "Would be nice if the computer could call me by name and give me "pats on the back" for correct responses."

Reported by four people from Group 3: "Liked the personal touch of having the computer call me by name and respond enthusiastically to the correct answer."

The next chapter will analyze the implications of the experimental results and recommend guidelines for the use of computer-managed instruction.

## CHAPTER 5

# CONCLUSIONS AND RECOMMENDATIONS

This study was designed to provide answers to two basic research questions:

- 1. Do learners in self-study sales training programs better retain course material when working with printed study guides containing pencil-and-paper self-testing exercises, or when working with computerized study guides incorporating simple CMI procedures?
- 2. What is the effect, on attitude towards CMI, of working with computerized study guides incorporating simple CMI procedures?

# Conclusions Concerning Attitude Evaluation Tests

Analysis of the attitude evaluation pretests for the two experimental groups exposed to computer-managed instruction (CMI) suggested that both groups were at home with computers and had positive feelings about their usefulness as an aid to learning. Comparison of the pretest and posttest responses to ten key questions showed

an important attitude change in just one case. This was a strong positive reaction to the immediate feedback offered by the computer. (The attitude change of the "nominal" group was not quite strong enough to be statistically significant, but the reaction of the "enhanced" group was.) The remaining posttest items (which asked direct questions concerning the subjects' reactions to the experimental treatment) turned up few negative reactions from either group.

# Conclusions Concerning Retention Tests

The results of the retention tests (follow-up tests on course content administered about a week after the experimental treatment) were almost identical for all three experimental groups. There were no significant differences between any two of the "pencil and paper." "nominal computer." and "enhanced computer" groups. Hence, under the conditions of this study, the type of study guide used made no difference in retention of course material

It is interesting to note that the "enhanced" computer test instrument (see Chapter 3) was no more effective in promoting learner retention of course material than the "nominal" computer test instrument. However, responses to the questionnaires and interviews indicated that the participants had positive reactions to

many of the "enhanced" features.

More than one participant favorably mentioned the personal touch of being called by name, the variety of informal responses and the enthusiastic and encouraging tone. In fact two participants from the "nominal" group (with no knowledge of the contents of the "enhanced" test) commented independently that they missed having just such features in their test.

On the other hand, the artificial delay introduced into the answer evaluation process (found by some researchers to promote retention of course material) was specifically mentioned by one student as being annoying. This investigator recommends, then, that all of the features of the "enhanced" test, except for the artificial delay, should be considered for inclusion in the design of any computerized review exercises of this type.

It is also worth noting that several participants wished they had been able to discuss their incorrect answer choices with the computer instead of having them unilaterally branded as "wrong." One way to avoid causing such participant frustration -- and at the same time make the tests better learning tools -- would be to have the computer explain why incorrect choices are wrong. This will be even more effective if the multiple choice distractors are carefully selected to represent common misconceptions about the answer.

#### Recommendations

The results of this study show that computerized study guides incorporating simple CMI procedures can be substituted for printed study guides containing pencil-and-paper self-testing exercises with no adverse effects on learner attitude or learner performance. This investigator believes that a second study should now be designed and implemented to build on these results.

In this new study, the "computerized" study guide format would be introduced into a real course being taught over a period of several days in an actual Company setting. Self-test exercises would incorporate all the features of the "enhanced" test used in this study, except for the artificial delay. If possible, the learner would also receive feedback on why each incorrect answer choice was considered wrong. The study would be designed to determine if participant commitment (and therefore performance) is indeed increased through the factors outlined in Chapter 1 (individual attention received through computer interaction and knowledge that learning progress is being evaluated and recorded).

The opening screen for the "enhanced" self-testing exercises was identical, except that it was prefaced with a greeting using the subject's first name ("Hello <u>name</u>,"). Subject names were entered into the "enhanced" computer program, on an individual basis, prior to the subjects' arrival in the testing room. This made it possible to personalize occasional computer responses throughout the "enhanced" exercises as will be discussed later.

#### Response To Answers -- Nominal

In the "nominal" self-testing exercises, the computer responded immediately to every answer entered by the

subject. The complete question and set of possible answers remained on the screen during all responses. If the answer entered was correct, the response was always as follows:

## Your answer was (<u>letter entered</u>). That's Correct. Press ENTER to continue.

If the answer was incorrect, the response was always as follows:

# Your answer was (<u>letter entered</u>) The correct answer is (<u>correct letter</u>) Press ENTER to continue.

Pressing ENTER following either computer response caused the next question to appear on the screen.

#### Response To Answers -- Enhanced

In the "enhanced" self-testing exercises, the computer delayed for six seconds before responding to an answer entered by the subject. The complete question and set of possible answers remained on the screen during all delays and responses. During each delay, the following message appeared on the screen:

## ANSWER BEING EVALUATED

If the answer was correct, one of the following two

responses appeared on the screen:

That's right! (<u>letter entered</u>) is the best answer. Please press ENTER to continue.

or

Nice going, (<u>subject name</u>), (<u>letter entered</u>) is correct. Please press ENTER to continue.

Pressing ENTER following either computer response caused the next question to appear on the screen.

If the answer was incorrect, one of the following two responses appeared on the screen:
