CALL FOR PAPERS FOR THE 1987 NACS PROCEEDINGS

Papers presented at the 1987 NACS conference in Salt Lake City, Utah are being solicited for consideration for publication in the NACS proceedings. Papers which are submitted must meet the guidelines listed below:

- The manuscript should not exceed 25 double-spaced typewritten pages.
- The manuscript must be in final draft form. The Editorial Committee will not consider incomplete manuscripts.
- The manuscript style should adhere to the guidelines found in Kate Turabian's, <u>A Manual for Writers</u> or Jacques Barzun and Henry Graff's, <u>The Modern</u> <u>Researcher</u>.
- 4. Only presentations which were listed in the 1987 NACS program are eligible for consideration.
- 5. Manuscripts that have been submitted for publication elsewhere will not be considered.
- 6. The DEADLINE for submitting your manuscript is <u>November</u> <u>30, 1987.</u> THERE WILL BE NO EXCEPTIONS.
- 7. Manuscripts should include a title page with the following information:
 - a) Title
 - Name, address, institutional affiliation, and phone number of author.
- 8. Biographical information on the author should be attached to the manuscript.

STUDENT PAPER COMPETITION

The National Association for Chicano Studies announces its annual student paper competition. A one hundred and fifty dollar prize plus consideration for publication in the annual conference proceedings is awarded to the best graduate and undergraduate paper.

Requirements

- Students must be NACS members. To join the association write to Elisa Linda Facio, Chicano Studies Department, University of California at Santa Barbara, Santa Barbara, California 93106.
- All papers must be on a Chicano Studies topic, fully referenced, typed, and double-spaced. A limit of 10-12 pages is strongly recommended.
- 3. Three copies of each paper are required.
- 4. Each paper should have a title page with full name, address, institutional affiliation, and telephone number. Each paper should be clearly marked GRADUATE or UNDERGRADUATE. Lack of clear identification of competition category will disqualify the paper from the competition.
- 5. The title should appear on the title page and again on the first page of the paper. The author's name should not be repeated on the first page.
- Papers should be postmarked no later than <u>February 1, 1988</u>. Late papers will be returned to sender.
- 7. Students are encouraged to present their papers at the annual conference.

NOMINATIONS FOR NACS SCHOLAR

Nominations are being accepted for the NACS Scholar. The NACS Scholar should be an individual who has made a significant contribution to Chicano Studies. According to the NACS bylaws, the specific criteria to be used in recognizing a scholar are as follows:

- a scholar's personal history of involvement in the development of Chicano Studies literature or as a discipline; and
- his/her significant contributions to scholarly research and writing on the Mexican population in the United States.

Nominations should include an explanation of the appropriateness of such recognition. Nominations should be sent to the NACS general coordinator no later than <u>October</u>, <u>1988</u>. (Address below).

EDITORIAL COMMITTEE NOMINATIONS

Nominations are being solicited to fill two positions on the NACS Editorial Committee. The Editorial Committee is responsible for soliciting, reviewing, and selecting papers presented at the national conference for inclusion in the NACS proceedings. Specific obligations are as follows:

- Members are elected by the general NACS membership and serve two year terms.
- A Member must be prepared to pay for half of the transportation cost to attend one meeting of the committee.
- Members will be required to read, critique and edit manuscripts, write introductory essays, proofread galleys, and work closely with the authors.
- A member must have access to secretarial assistance and be able to make long distance calls and pay for mail outs.
- 5. The review process requires at least 60 hours of work and lasts from the conclusion of the annual conference until the completed manuscripts are sent to the press.
- Interested persons are asked to submit a brief biographical sketch of his/her gualifications.

Northern California Foco: The Northern California Regional Foco will be holding a conference hosted by UC-Berkeley on November 7, 1987. The theme for this year's regional meeting is "Chicanos and the Politics of Community." Panels covering a variety of relevant topics will be discussed. Presentations have been scheduled around issues concerning the Politics of Culture, Health Concerns, Educational Issues, Politics in the Bay Area, Literature and Chicano-Mexicano relations. In particular, a plenary session focusing on the 1988 undergraduate requirements for California state universities will be highlighted. El Teatro from Sacramento State University will conclude the program with a presentation in the evening.

In an earlier newsletter (Summer '87) an article, generated from the No. Ca. Regional Foco, concerned the 25th anniversary of the United Farm Workers Union (UFW). For those of you who did not receive the previous newsletter, I would like to take the liberty to briefly inform you of the article's content. As mentioned in the previous article, the California Supreme Court has charged the UFW with a \$1.7 million law suit. The union will have to post \$3.3 million in bond to pursue appeals. The union has launched a grape boycott and is determined to mobilize its broad support.

Again, on behalf of the Northern California Foco, I would like to appeal to the entire membership to support the UFW as they face this very serious ruling from the California Supreme Court.
