Sorry I was unable to get in touch with you before you left for your trip. Welcome back! I hope you had a great and relaxing time.



Carole Garrison had sent me files on the following women: P.J. Baunach, Carolyn Block, Angela Browne, Meda Chesney-Lind, Clarice Feinman, Drew Humphries, Merry Morash, Nicole Hahn Rafter, Margaret Zahn, and Marjorie Zatz. As I mentioned on the phone, I was appointed (?) head of the Fellows Nominations "Committee" at ASC in November at San Francisco, but I was never informed of whether there were other committee members and, if so, who they were. My spring semester was a semester from hell and I had no time to do anything but work, sleep and breathe. Now that I am in "recovery," I have gone through the files using the criteria that were forwarded to me.

Those criteria are: evaluating vitae on the basis of 1) service, teaching and/or mentoring activities; 2) research directed toward women's issues and crime. Summarizing the scanty information that was forwarded to me, the women criminologists who received awards in the past were: June Morrison in 1977, and Joan McCord and Sue Titus Reid in 1982. In 1985-86, nominees by W&C were Rita James Simon, Joan Petersilia and Louise Shelley. In 1986-87, Rita Simon and Rosemary Sarri were nominated. In 1990, Meda Chesney-Lind and Nicole Hahn Rafter were recommended by W&C. The nominees by the Women and Crime Division in 1991 were Meda Chesney-Lind and Merry Morash. Merry withdrew as she served on the Fellows Committee for ASC. There is no mention of whether any of the nominees after 1982 were actually given any awards. This information is obviously incomplete and it seems to me that past records should be dredged up and an accurate and full summary of nominations for awards as well as receipt of awards should be established for the W&C Division. This information needs to be completed and kept up to date in a regular manner. I could also use an updated W&C membership roster.

In a memo sent to all Committee Chairs and members of the Executive Committee by Carole Garrison on March 23, 1992, before she left for Cambodia (!), she mentioned on page two under the topic

of "Awards" that "Nominations went in for ASC awards: Fellows, Meda Chesney-Lind; Sunterland (sic), Jacqueline Cohen, Joan Persilia and Ann Dryden White; Sellin-Gluek (sic), Carol Smart." I don't know if this means that the work for 1992 Fellows Committee has been done, since I did not get to it before she left. This may need checking into.

If there is still a need for nominations, given the files that I was sent, I would suggest the following nominations based on the above criteria: P.J. Baunach, Meda Chesney-Lind, and Clarice Feinman. I base these recommendations on the outstanding, unusual, unique, and long-term contributions in the Criminal Justice field by these women. They are unique both as Criminologists and as women. They do not necessarily meet standard "male" academic criteria, especially P.J. Nevertheless, I do not think we should be bound by those narrow and unwritten gender-related biases.

P.J. Baunach was employed from 1974-75 with the Minnesota Governor's Commission on Crime Prevention and Control, then from 1976-82 at the National Institute of Justice and 1982-87 at the Bureau of Justice Statistics, Washington, D.C. She had many publications from those positions, often emphasizing women in criminal justice, particularly women in corrections. She had earned here Ph.D. in Psychology and Sociology from the University of Minnesota in 1974, but went back to school, while working full-time, and earned a law degree from George Washington University in 1986. From 1987-90 she worked with a law firm in Washington, D.C. and from July 1990-present she has been with the U.S. Department of Justice. She has received numerous awards, both academic and professional and has a long list of publications that have made important contributions in Criminal Justice. [Personally and professionally, I like to see non-traditional people be recognized and especially not to have to force-squeeze women into a mold developed for and by men to glorify themselves.--not to be quoted outside W&C] P.J. meets all the criteria and more, and she reaches areas of CJ that most academic people have not reached. Her contributions are unique and to be valued and should be recognized. Most of her publications were through government documents, but they were solid and new contributions none the less and deserve recognition.

Meda Chesney-Lind received her Ph.D. in Sociology in 1977 from the University of Hawaii. She worked as a Sociology instructor at Honolulu Community College 1973-1985, obviously while she was working on her doctorate and beyond. She has been at the University of Hawaii-Manoa 1979-present, in various positions, indicating a woman's struggle to be accepted into the "mainstream" of academia. She has been a recipient of eight research awards, co-authored Girls, Delinquency and Juvenile Justice in 1992, has published a long list of journal articles in various refereed journals as well as chapters of books. She has also authored many

book reviews, technical reports and local monographs. She has served on the editorial board of three journals and as a referee and consultant. She is the recipient of several awards as well.

Clarice Feinman has also been in the trenches a long time. She received her Ph.D. from New York University in 1976 in History. She has been teaching at Trenton State College, NJ 1976-present. She has been a Research Consultant with the Australian Institute of Criminology, 1984; a Visiting Lecturer at the Institute of Criminology, Cambridge University, England, 1982; a consultant with the New Jersey Department of Corrections Training Academy, 1978-81; visiting professor at New York University 1977 and 1980. She was Director of Women's Development Unit Project, New York City Correctional Institution For Women, Rikers Island, 1975-76; Assistant Director, Women's Development Unit Project, New York City Correctional Institution for Women, 1975; Adjunct lecturer Baruch College, NY, 1971 and 1976, etc. She has published several works on Women in the Criminal Justice System and the Criminalization of a Woman's Body, as well as numerous articles on women in prisons, minority women in the criminal justice system, societal violence and women as it's victims, sex-role stereotypes, impacts of criminal codes on women, etc. Her works were pace setters that called "hidden" issues of women to the forefront and made them mainstream topics. She has made fundamental contributions to the field, especially from women's point of view. She is editor of Women & Criminal Justice.


If the ASC doesn't honor these women, then the Women & Crime Division should give them big awards and start making a fuss about some of our longest standing members who have made some of the biggest contributions in the field. We should sing their praises to the skies and let other people inside and outside the CJ field know about them. Their recognition and presence can serve as mentors for up-coming women in the CJ field and give hope for the not-so-young women who are still struggling. Personally, I think we should start with some of the women who make the earliest contributions and paved the way for others. They faced the worst opposition and non-recognition among their peers. It is still so intense today, it is hard to imagine how it was 25 years ago! [I myself began my career in CJ as a practitioner in 1970 and it wasn't nearly as bad as the non-recognition in academia that I started facing in 1981, so my hat really goes off to these women who have made their mark in academia, which is some ways is so much more sexist and gender-snobbish (though pretending not to be) than the practitioners in the field.] We can compete with the men's standards, yes, but we can go beyond that and recognize a more complete human being! **There is also nothing wrong in recognizing the struggle that women have had to go through in the CJ field just to get accepted, to work to even have an opportunity, and to have their work recognized as legitimate.**

I will bundle the materials that Carole Garrison sent to me and ship them to you when I go in to my university later in the week. But in the meantime, I'll get this letter off to you so that you will have something to begin acting on. This has been an interesting exercise for me to go over the few files that I had. There are some other very outstanding women in the list, but it seems to me that we should honor the "old war horses" (do we want to use that term?) first and let the young rising stars "season" awhile. Their time will certainly come, especially if W&C gets itself more organized and pro-active in this area. We should really push the recognition of all outstanding women in CJ, and not just those who meet the traditional (male-made) academic-role stereotypes. We should create our own standards and work to get them accepted, thus broadening the field and making it less exclusive and more inclusive of all kinds of important contributions. I happen to be a firm believer in combining and recognizing contributions of a practical nature in the CJ field as well as academic, and don't believe that so much should be made about the separation of the two. Criminal Justice is a practical field after all, and if one hasn't had any practical experience, then it is all theory and they really don't know what they are talking about in the real world. When people combine both, they have the best possible combination.




Dear Lynne,

RE: Proposed Award to be presented by Division of Women and Crime

I. Proposed Text:

The Division on Women and Crime will present awards annually to a member or members of its Division who have made outstanding contributions to the fields of Criminal Justice and Criminology, especially in areas that concern Women. The focuses will include research and practice by Women, for Women, for the greater elucidation of women's issues, problems and contributions in the Criminal Justice fields including: feminist theory, the role of women in society, sex-role stereotyping and its effects on the intellectual, emotional and moral development of women; the status and treatment of women offenders; and women professionals, practitioners and academics who labor in the various fields of criminal justice. Special attention will be paid to honor women who have made unique contributions to the enhancement and furtherance of knowledge and/or programs for and about Women in Criminal Justice. Efforts will be made to bring women forward for public acknowledgement whose contributions may have been ignored by the traditional (male?) standards that have not included issues for and about women.

II. Proposed Process of Nominating and Selecting Candidates for the Award for Outstanding Contributions, by the Division on Women and Crime:

A. A DWC Award Selection Committee of five women will be appointed by the current Chair of the DWC (or elected at the annual meeting?), based on nominations and volunteers who have expressed interest in serving on the committee. The Chair will attempt to appoint people who represent a cross-section of DWC membership, including age, experience, type of fields or expertise, academic/practitioner, race, ethnicity and geography.

B. Nominations for the Award will be called for at the DWC Annual Meeting. Nominations will further be solicited in the following DWC newsletter, which should be mailed no later than the following mid-January. A deadline for nominations should be set for the end of February each year. All nominations should either be accompanied by vitae of the nominees, or the nominees contacted and asked to send them to the Chair of the Award Committee by late March.

What selected with committee meet

C. The Committee will meet at least once during the Annual ASC Meeting to formulate a mode of communication and assigned tasks. Communications may be by phone, mail, fax or e-mail. The committee will set a time-line to distribute vitae of women who have been nominated. Vitae will be copied by

the Committee Chair and sent to the other members of the committee by mid-April.

D. The Committee will decide whether to give the award to one or more of the nominees each year, depending on the quality of the nominations and the histories of the women who have been nominated. Attention will be paid to whether the nominees have received other awards by the ASC previously, but that will not prohibit women from being honored by more than one source. The Committee will decide upon who will receive the DWC Award via mail/phone/FAX/E-mail during the month of May.

E. After the Annual DWC Meeting at the Annual ASC, the Committee will decide on what criteria by which they will be basing their selections. The chair may ask for input from attenders at the Annual DWC Meeting. The committee will apply those criteria to the vitae received and other members' knowledge and recommendations about the nominees work, lives and contributions. Selections will be made and forwarded to the Chair of the DWC by June of each year.


F. The Chair and the Executive Committee of the DWC will decide in what form the DWC Award for Outstanding Research/Service will be made, that is, plaque, certificate, financial award. The women who receive the award should be written up in the following DWC Newsletter with an explanation of why they were selected to receive the DWC Award.

Thanks for faxing me the text on the award. It's really starting to shape up.

I have spoken with Sarah Hall and have asked her to send me the text on the awards given by the ASC now. I thought we should try to be as consistent as possible with those awards.

A couple of points and questions:

(1) Should we give the award a name, such as the Ruth Cavan award? That has a nice ring to it, and Imogene Moyer is in the process of working on her biography.

(2) I think it should only be one award per year.

(3) I think we may wish to make it possible to give the award for one of two types of accomplishments, at the discretion of the awards committee. The award could be given either to: (1) a person who has made significant contributions to the development of knowledge about women in the criminal justice system as offenders, victims, or professionals (I'm not sure we want to be all that more specific with respect to subfields within this general area. I would probably vote to delete your description of topics-- e.g. feminist theory, the role of women in society, etc.) or (2) a person who has enhanced women's status within criminology and criminal justice through their contributions to professional organizations and/or the justice system.

(4) The process seems fine. I like the idea of having five division members (I wouldn't say women although they are likely to be) as the awards committee. I like the way you specified diversity of membership.

Rather than have awards solicited in the newsletter (in case there isn't one), let's say nominations will be solicited through a flyer distributed at the annual ASC meeting and again in a mailing to the membership made no later than mid-January (we can probably include the flyer in the registration packet, like the other awards). I would suggest that self-nominations be allowed, as well as nominations from others.

(5) I didn't really understand section E. of your report. Shouldn't the criteria be the same every year?

(6) I think we should decide in our proposal the form the award would take. I personally think that money is not necessary. I rather like the idea of a plaque or nicely calligraphied certificate or something.

When I receive the information from Sarah I will pass it on to you. I have also asked Nancy Wonders to be co-chair of the Awards committee for next year and have sent her a copy of the draft you sent me. Would you like to continue your involvement as co-chair? Please let me know. In any event, I hope you and Nancy can work together in getting this proposal shaped up for presentation later this month.

Thanks again for your work.


