**No. 2846.**—“THE TRADING WITH THE ENEMY ENACTMENT, 1914,  
AMENDMENT ENACTMENT, 1916.”

IN exercise of the powers conferred upon him by section 17 (ii) of “The Trading with the Enemy Enactment, 1914, Amendment Enactment, 1916,” the Chief Secretary to Government amends the Statutory List of persons with whom trading is prohibited, which was published in the First Schedule of Notification No. 2247 of the 11th July, 1916, and varied and added to by Notifications Nos. 2401, 2416, 2659 and 2675 of the 22nd and 31st July, 18th and 29th August, 1916, respectively, by the further variation and addition of the names set forth in the Schedule hereto.

**No. 2847.**—“THE QUARANTINE AND PREVENTION OF DISEASE ENACTMENT, 1903.”—ORDER UNDER RULE 90 (i) OF THE RULES UNDER.—Whereas information has been received that rabies exists among dogs in the State of Johore, it is hereby ordered by the Resident of Negri Sembilan that the importation of dogs into Negri Sembilan, by land or sea, from the State of Johore, except with the permission in writing of the Veterinary Surgeon or the Health Officer, Negri Sembilan, is prohibited until further notice.
