# Advanced tools and concepts for quantum cognition: A tutorial ${ }^{\text {/ }}$

#### Abstract

This tutorial is intended to provide an introduction to some advanced tools and concepts needed to construct more realistic quantum models of decision. The aim is to cover, in a format suitable for researchers with some limited exposure to quantum models of cognition, the ideas of density matrices, POVM type measurements and open system dynamics. The central theme we explore is how we might introduce noise into our quantum models, and the effect this has on model behaviour. These important ideas are likely to be very useful for constructing more realistic cognitive models, but they are generally not covered by introductory accounts of quantum theory. We hope that this tutorial will help to introduce these tools to other researchers interested in constructing quantum models of cognition.

## 1. Preamble

Recent years have seen a surge of interest in so-called quan- ${ }_{3}$ tum models of cognition and decision making (Busemeyer and ${ }_{34}$ Bruza, 2014; Aerts, 2009; Mogiliansky et.al., 2009; Yukalov ${ }_{35}$ and Sornette, 2011; Khrennikov, 2010; Pothos and Busemeyer, ${ }_{36}$ 2013; Wang et al., 2013). These models are based on the math- ${ }^{37}$ ematics of quantum probability theory (QT), but abstracted ${ }^{37}$ from the usual physical content. These models have arisen in ${ }_{39}$ part as a response to the empirical challenges faced by 'ratio- ${ }^{39}$ nal' decision-making models, such as those based on Bayesian probability theory (such examples are mostly associated with ${ }^{4}$ the famous Tversky-Khanaman research tradition. See e.g. ${ }^{42}$ Tversky and Kahneman (1974); Chater et al. (2006).) These quantum models posit that, at least in some circumstances, hu- ${ }_{45}$ man behaviour does not align well with classical probability ${ }^{45}$ theory or expected utility maximisation. However unlike, for ${ }^{46}$ example, the fast and frugal heuristics programme (see, e.g. ${ }_{48}^{47}$ Gigerenzer et al., 2011), quantum cognition aims not to do away ${ }_{49}$ with the idea of a formal structure underlying decision-making, but simply to replace the structure of classical probability the- ${ }_{51}$ ory with an alternative theory of probabilities. This new probability theory has features, such as context effects, interference ${ }^{52}$ effects and constructive judgments, which align well with psy- ${ }^{53}$ chological intuition about human decision-making. Initial re- ${ }^{54}$ search involving quantum models tended to focus mainly on ${ }^{55}$ explaining results previously seen as paradoxical from the point ${ }^{56}$ of view of classical probability theory, and there have been a ${ }^{57}$ number of successes in this area (Pothos and Busemeyer, 2013; ${ }^{58}$ Wang et al., 2013; Trueblood and Busemeyer, 2011; White et ${ }^{59}$ al., 2014; Pothos and Busemeyer, 2009; Aerts et al., 2013; ${ }^{60}$

[^0]Bruza et al., 2015; Blutner at al., 2013; Pothos et al., 2013, 2015). More recently, the focus has switched to some extent to testing new predictions arising from quantum models, and designing better tests of quantum vs classical decision theories (Atmanspacher and Filk, 2010; Yearsley and Pothos, 2014, in press; Wang et al., 2014).

Although good progress has been made in understanding how to build simple cognitive models using QT there has been less work done on developing more sophisticated or realistic models. Toy QT models can provide a good qualitative understanding of some cognitive processes, but if the ultimate goal is to pit QT models against the current best models of cognition and decision making then the sophistication of QT models will need to grow to match such models. This necessitates a move beyond toy models to something more realistic. In addition, many of the current toy QT models have obvious conceptual problems beyond their over-simplicity; one simple example is that typical models for the evolution of cognitive variables are unitary, which means they have no fixed points. Under such a model no amount of evidence presentation can ever lead to a fixed belief state.

The solution to these problems is to move to a slightly more sophisticated framework for QT modelling that can better represent realistic decision making. However there is a challenge here; although this more sophisticated framework is not technically or conceptually more demanding than that employed by toy QT models, it is considerably harder to access. Although there are a wealth of introductory accounts of quantum physics that can be easily accessed by cognitive scientists (eg (Isham, 1995; Peres, 1998; Pelnio)) (and even a number specifically written for them, (Busemeyer and Bruza, 2014; Yearsley and Busemeyer, 2015)) it is much harder to find introductory accounts of some of the tools needed to build more realistic QT models.

The purpose of this tutorial is to try and give a brief intro-121 duction to some of these tools. The material presented consists ${ }_{122}$ mainly of advanced concepts and ideas from the physics lit-123 erature, some of which have made it into more sophisticated ${ }_{124}$ quantum cognitive models, but some of which are yet to find ${ }_{125}$ a concrete application. The idea is to present these ideas in $\mathrm{a}_{126}$ way which makes them accessible to cognitive scientists inter-127 ested in QT models. A key aim of this tutorial is also to make ${ }_{128}$ clear when and why these more sophisticated ideas need to be applied, so that researchers have a better understanding of the limits of the current toy QT models.

Since the potential scope of this tutorial is vast, the presenta- ${ }_{130}$ tion style will be somewhat non-standard. Specifically we are ${ }_{131}$ aiming for a broad and shallow overview of several different ${ }_{132}$ topics, or a sort of 'London Bus Tour' of modern quantum me- ${ }_{133}$ chanics. We will be satisfied if we can point out some of the ${ }_{134}$ major landmarks, and suggest how readers may wish to explore ${ }_{135}$ the issues in more depth for themselves, as and when they feel ${ }_{136}$ it necessary.

Some more general comments:

1. These notes are not meant as an introduction to the whole ${ }^{139}$ of the Quantum Cognition program. In particular we as- ${ }^{140}$ sume prior familiarity with the basics of QT. For those ${ }^{141}$ with no previous exposure to QT, we recommend the book ${ }^{142}$ by Busemeyer and Bruza (2014) or the recent tutorial ${ }^{143}$ Yearsley and Busemeyer (2015) as a good place to start. ${ }^{144}$ For more detail about the maths, Isham (1995) is a good reference, alternatively there are many sets of excellent ${ }_{145}$ lecture notes available online Pelnio.
2. The mathematics underlying some of the ideas presented ${ }^{146}$ here is extremely interesting. However since this is in-147 tended as an introductory account we will mostly avoid ${ }_{148}$ lengthy proofs or derivations, including them only when ${ }_{149}$ we feel they aid understanding.
3. A comment on notation; we will be making use of bra-ket ${ }^{151}$ notation throughout. Thus state vectors will be written as 152 $|\psi\rangle$. Also we won't usually write hats on operators or use ${ }^{153}$ bold/underline to denote vectors - whether something is an 154 operator, a vector or a number should be obvious from the ${ }^{155}$ context. Finally we will adopt the physicists' convention 156 of setting $\hbar$ equal to 1 .
4. A note on references; we have tried to include only the ${ }^{158}$ most useful references we could find. For the most part this means books or review papers where possible, but we've also included genuine research papers where they are useful/comprehensible. There is pretty much no limit to the number of references one could include, see e.g. Cabello (2000). Two sources are worthy of particular mention; 1) arXiv.org. Cognitive scientists may not be familiar with this, but it's a pre-print archive used by the physics/maths community as a place to upload papers prior to publication. Most are subsequently updated upon publication to reflect the published versions. The upshot of this is that probably the majority of published physics papers, dating back to the late 90 's, are available free from this one site. Where we can find it therefore, we have
included the arXiv reference alongside the journal info, to make papers easier to track down. 2) The single text used most in putting these notes together is The Theory of Open Quantum Systems by H.-P.Breuer and F.Petruccione (2006). This is much more a physics text than a psychology one, but it's nevertheless worth a special mention, since we've consulted it so frequently while preparing this tutorial.

## 2. Introduction: Noise!

The most commonly encountered toy models of QT are idealisations in a number of ways. The key one for the purpose of this tutorial is that they assume experimenters have perfect knowledge/control over the cognitive state of participants, the form and effect of measurements, and finally the details of any 'evolution' of the state.

In the real word (or even the real lab), things are rarely this simple. We want to show you some tools that can let you generalise the models you've come across so far to apply in more realistic situations. It turns out that doing this will also teach us some profound things about the meaning of the quantum approach to cognition, and how it differs from classical approaches. The theme of this tutorial is therefore 'Noise', specifically 'Noise in the cognitive state', 'Noise in the measurements' and finally 'Noise in the evolution.'

## 3. Noise in the cognitive state: Density matrices

### 3.1. Introduction

Let us begin with a simple motivating example. Suppose we wish to perform an experiment in the lab and the expected results depend on whether participants are left or right-handed. Our PhD student collects an equal number of left and right handed participants and lets them into the lab one at a time. Unfortunately the PhD student doesn't tell us which participants are which, so all we know is that there's a 50/50 chance of getting a left/right-handed participant each time. Suppose the cognitive state of the left handed participants is given by $|L\rangle$ and that of the right handed ones by $|R\rangle$ (and that these two states are orthogonal), what is the correct cognitive state to describe our unknown participants?

You might guess the answer is,

$$
\begin{equation*}
\psi=\frac{1}{\sqrt{2}}(|L\rangle+|R\rangle) \tag{1}
\end{equation*}
$$

but this turns out not to be correct. You might have guessed this because if I ask "What's the probability that a participant given by this state will say they are left/right-handed if we ask them?" then the answer is;

$$
\begin{align*}
p(l e f t)=\langle\psi| P_{L}|\psi\rangle & =\frac{1}{2}\left[\langle L| P_{L}|L\rangle+\langle L| P_{L}|R\rangle\right. \\
& \left.+\langle R| P_{L}|L\rangle+\langle R| P_{L}|R\rangle\right]  \tag{2}\\
& =\frac{1}{2}
\end{align*}
$$

and the same for right. (Here $P_{L}=|L\rangle\langle L|$ etc.)
However this isn't the correct state because what we've made here is a 'quantum' mixture (or superposition) of left and right, whereas what we were really looking for was a classical mixture. $|\psi\rangle$ tells us the participant is in some sense neither left nor right handed ${ }^{1}$, at least until we ask, whereas of course what's really happening is that each participant is definitely either left or right handed when they enter the lab, we just don't know ${ }_{185}^{184}$ which.

In other words, what we want to do is to add in classical un- ${ }^{18}$ certainty to our description of a quantum system. This section ${ }^{187}$ describes how to do this.

### 3.2. The Density Matrix $\rho$

Let's see if we can get a clue about the right answer by look- ${ }_{-192}^{191}$ ing at the statistics for the outcomes of our experiment on these participants. Suppose our experiment is represented by an op-193 erator $O$, and for left and right handed participants the expected result is $l$ and $r$ respectively. Since we have an equal number of ${ }^{194}$ left and right handed participants half the time we will get the result $l$ and half the time we will get the result $r$. The average ${ }^{195}$ outcome across many experiments will therefore be,

$$
\begin{align*}
\langle O\rangle & =\frac{1}{2}\langle L| O|L\rangle+\frac{1}{2}\langle R| O|R\rangle,  \tag{3}\\
& =\frac{l+r}{2} .
\end{align*}
$$

We can write this result in a simpler way by introducing the density matrix $\rho$,

$$
\begin{equation*}
\rho=\frac{1}{2}(|L\rangle\langle L|+|R\rangle\langle R|) \tag{4}
\end{equation*}
$$

Then the expected outcome of our experiment can be written as,

$$
\begin{equation*}
\langle O\rangle_{\rho}=\operatorname{Tr}(O \rho) \tag{5}
\end{equation*}
$$

where Tr denotes the trace of an operator. The trace of an operator is defined by,

$$
\begin{equation*}
\operatorname{Tr}(A)=\sum_{i}\left\langle\phi_{i}\right| A\left|\phi_{i}\right\rangle \tag{6}
\end{equation*}
$$

where the $\left\{\phi_{i}\right\}$ form an orthonormal basis of the Hilbert space. It is easy to show that if the trace of an operator exists, it is independent of the choice of basis $\left\{\phi_{i}\right\}^{2}$. (In terms of matrices, the trace of a matrix is just the sum of the diagonal terms.)

[^1]More generally, if we have a classical mixture of possible states $\left|\psi_{\alpha}\right\rangle$ which occur with probabilities $\omega_{\alpha}$ this ensemble can be represented by a density matrix,

$$
\begin{equation*}
\rho=\sum_{\alpha} \omega_{\alpha}\left|\psi_{\alpha}\right\rangle\left\langle\psi_{\alpha}\right| \tag{7}
\end{equation*}
$$

It turns out that every expression you might have previously encountered in quantum theory has an equivalent in terms of the density matrix. In fact density matrices represent the most general way of writing the equations of quantum theory, and they will prove extremely valuable for the rest of this tutorial. It is therefore worth noting a few properties of the density matrix, and the density matrix analogues of some of the familiar expressions in quantum theory.

Properties of the density matrix:

- It is a Hermitian ${ }^{3}$ operator, $\rho^{\dagger}=\rho$.
- It is normalised in the sense that $\operatorname{Tr}(\rho)=1$.
- It is a positive operator, meaning,

$$
\langle\psi| \rho|\psi\rangle \geq 0, \quad \forall|\psi\rangle \in H
$$

These three properties essentially ensure that the eigenvalues of $\rho$ are positive, real numbers which sum to 1 , and thus have the interpretation of probabilities.

As we mentioned above, all of the expressions you have encountered so far in quantum theory can be rewritten in terms of the density matrix. For example, from the expression for the time evolution of a vector, $|\psi(t)\rangle=U(t)\left|\psi_{0}\right\rangle$, where ${ }^{4}$ $U(t)=e^{-i H t}$ it follows that,

$$
\begin{equation*}
\rho(t)=U(t) \rho U^{\dagger}(t) \tag{8}
\end{equation*}
$$

From this, it is easy to see that the analogue of the Schrödinger equation for a density matrix is ${ }^{5}$,

$$
\begin{equation*}
\frac{\partial}{\partial t} \rho=-i[H, \rho] \tag{9}
\end{equation*}
$$

This is often known as a master equation. Finally if we perform a measurement on the state represented by the density matrix $\rho$ the probability that we will get the answer represented by the projection operator $P_{a}$ is given by,

$$
\begin{equation*}
p(a)=\operatorname{Tr}\left(P_{a} \rho\right) \tag{10}
\end{equation*}
$$

and if we do, the state collapses to the new state,

$$
\begin{equation*}
\rho^{\prime}=\frac{P_{a} \rho P_{a}}{\operatorname{Tr}\left(P_{a} \rho\right)} . \tag{11}
\end{equation*}
$$

In the special case of $\rho=|\psi\rangle\langle\psi|$ this is easily seen to be equivalent to the usual expression involving state vectors.

[^2]We mentioned above that our original guess at the state for ${ }_{251}$ an equal mixture of left and right-handed participants, $\frac{1}{\sqrt{2}}(|L\rangle+252$ $|R\rangle$ ), wasn't correct. Since this state can also be written as a ${ }^{253}$ density matrix, we can compare our guess, $\rho_{g}$, with the correct254 answer, $\rho_{c}$. Working in the $\{|L\rangle,|R\rangle\}$ basis, we have; ${ }^{255}$

$$
\begin{align*}
\rho_{g} & =\frac{1}{2}(|L\rangle+|R\rangle)(\langle L|+\langle R|)=\left(\begin{array}{ll}
1 / 2 & 1 / 2 \\
1 / 2 & 1 / 2
\end{array}\right) \\
\rho_{c} & =\frac{1}{2}(|L\rangle\langle L|+|R\rangle\langle R|)=\left(\begin{array}{cc}
1 / 2 & 0 \\
0 & 1 / 2
\end{array}\right) \tag{13}
\end{align*}
$$

Comparing the two expressions, we can see that they differ only ${ }_{261}$ in their 'off-diagonal' elements. Thus the difference between the classical mixture of left and right handed, and the quantum superposition of left and right handed is in some way encoded ${ }^{262}$ in these off-diagonal terms in the density matrix. It is tempting therefore to think that the difference between classical and quantum descriptions of a system can be expressed in this way, and that quantum superpositions can be turned into classical mixtures by somehow removing these terms. We will discuss this further in a later section, but for now note that the situation is a bit more complicated than it seems. For a start, the properties of the density matrix guarantee that it is diagonalisable, i.e. all density matrices are diagonal in some basis. The issue about whether a given density matrix represents a classical or a quantum mixture is therefore more about the basis in which it is diagonal Halliwell (2005); Zurek (1991).

### 3.3. Using Density Matrices

It might be useful at this point to give a short outline of two ways in which density matrices might be used to construct quantum models of decision. Our motivating example was useful for setting the scene and explaining what density matrices are, but it is obviously unrealistic. What is true however, is that the usefulness of density matrices is primarily in the area of modeling individual differences. We mean this less in the sense of explaining the behaviour of particular participants, and more in the sense of predicting the spread of results, rather than just average behaviour. Most quantum models in the literature are rather simple constructions that are concerned with predicting $\mathrm{a}^{263}$ particular average behaviour (for example the conjunction fal-264 lacy.) An important future direction for research will be under-265 standing the spread of participant behaviours, rather than just ${ }^{266}$ the average behaviour. Density matrices allow us to do this $\mathrm{in}^{267}$ two ways;

- If we happen to know that some individual characteristic ${ }_{270}$ is important, and we know the distribution of this characteristic in our testing population, then we can make direct predictions about the average behaviour and the spread of behaviours by encoding these differences as an initial density matrix, in a very similar way to our toy example of left and right handed participants.
- Suppose instead we only think there might be some individual characteristic that is important, but we have no idea about its distribution in our testing population. Well then we can encode the differences in an initial density matrix
again, but now leave the distribution of the characteristics as a free parameter, and try to fit this distribution from the data. In other words, if we think different groups of participants might show different behaviours, we can use a density matrix to perform a sort of mixed models analysis, and determine what distribution of individual differences best fits the data.

To the best of our knowledge, neither of these approaches have been explored so far, but they obviously represent important next steps for the QT approach, if our ambition is to produce ever more accurate models.

### 3.4. The Entropy of a Quantum State

We introduced the density matrix as a way to capture a classical uncertainty about the quantum state. It is therefore natural to ask about the entropy associated with a given density matrix. The entropy of a classical state is a frequently used quantity, and is obviously central to approaches like MaxEnt. Having a quantum analogue is therefore very useful. However before we do this we will first look at a simpler measure of uncertainty, called the 'purity' of a quantum state. This is defined by,

$$
\begin{equation*}
\gamma=\operatorname{Tr}\left(\rho^{2}\right) \tag{14}
\end{equation*}
$$

If we write our density matrix in diagonal form, i.e. as,

$$
\begin{equation*}
\rho=\sum_{i} p_{i}\left|\phi_{i}\right\rangle\left\langle\phi_{i}\right| \tag{15}
\end{equation*}
$$

where the $\left\{\phi_{i}\right\}$ form a complete orthonormal basis, then,

$$
\begin{equation*}
\gamma=\operatorname{Tr}\left(\rho^{2}\right)=\sum_{i}\left(p_{i}\right)^{2} \tag{16}
\end{equation*}
$$

Either by diagnalising or by directly squaring the matrix, we can see that,

$$
\begin{equation*}
\gamma_{g}=1, \quad \gamma_{c}=\frac{1}{2} \tag{17}
\end{equation*}
$$

where, recall, $\rho_{g}$ was our guess for the mixture of left and right states, and $\rho_{c}$ is the correct expression. Density matrices which can be written in the form $\rho=|\psi\rangle\langle\psi|$ always have $\gamma=1$ and are known as pure states, states which cannot be written in this form have $\gamma<1$ and are called mixed. Clearly $\rho_{g}$ is a pure state, whereas $\rho_{c}$ is mixed. The purity of a density matrix turns out to be a useful approximate measure of the entropy of the state, but to see this we first need to define the entropy proper.

For a classical probability distribution over a finite set of variables, $\left\{p_{i}\right\}$, the classical Shannon entropy is given by ${ }^{6}$,

$$
\begin{equation*}
S=-\sum_{i} p_{i} \ln \left(p_{i}\right) \tag{18}
\end{equation*}
$$

Now Eq.(15) suggests that we could define the quantum analogue of the Shannon entropy in the same way as Eq.(18), but

[^3]where the $p_{i}$ are now the 'probabilities' associated with the various basis states $\left|\phi_{i}\right\rangle$. In the basis where $\rho$ is diagonal, this would be equivalent to ${ }^{7}$,
\[

$$
\begin{equation*}
S=-\operatorname{Tr}(\rho \ln (\rho)) \tag{19}
\end{equation*}
$$

\]

but recall the trace operation is basis independent, thus Eq.(19) is valid generally. It is straightforward to compute the entropies ${ }_{270}$ of our two quantum states,

$$
\begin{equation*}
S_{g}=0, \quad S_{c}=\ln (2) \tag{20}
\end{equation*}
$$

Eq.(??) is know as the von Neumann entropy ((Neilsen and ${ }^{278}$ Chuang, 2000)). It is easily seen that in general pure states like ${ }^{279}$ $\rho_{g}$ have zero entropy.

We can now explain briefly one reason why the purity is such ${ }^{281}$ a useful measure. Suppose our density matrix is close to being ${ }^{282}$ pure i.e. $\rho^{2} \approx \rho$. We can Taylor expand the logarithm as, ${ }^{283}$

$$
\begin{equation*}
-\ln (\rho)=(1-\rho)+(1-\rho)^{2} / 2+(1-\rho)^{3} / 3+\ldots \tag{21}
\end{equation*}
$$

It follows that

$$
\begin{align*}
S & =\operatorname{Tr}\left(\rho-\rho^{2}\right)+\text { higher order terms }  \tag{22}\\
& =1-\gamma+\text { higher order terms } \tag{23}
\end{align*}
$$

The quantity $1-\gamma$ is often called the linear entropy, as it's ${ }^{290}$ the term that comes from the linear expansion of $\ln (\rho)$. The ${ }^{291}$ linear entropy is a lower approximation to the von Neumann ${ }^{292}$ entropy, but is much easier to calculate, since it doesn't involve ${ }^{293}$ diagonalising $\rho$. In Fig. 1 we plot both the von Neumann entropy ${ }^{294}$ and the linear entropy as a function of $p$, for the state,

$$
\begin{equation*}
\rho=p|L\rangle\langle L|+(1-p)|R\rangle\langle R| \tag{24}
\end{equation*}
$$



Figure 1: The von Neumann and linear entropies for the state Eq.(24).
For a classical probability distribution, the maximum entropy308 state is the one with equal probability for any outcome. The 309 quantum analogue of this is a density matrix which is diagonal,310 and where all the diagonal elements are equal. This state is311 given (for a Hilbert space of dimension $d$ ) by,

$$
\rho_{\max \text { entropy }}=\frac{1}{d}\left(\begin{array}{cccc}
1 & 0 & \cdots & 0 \\
0 & 1 & \cdots & 0 \\
\vdots & \vdots & \ddots & \vdots \\
0 & 0 & \cdots & 1
\end{array}\right)=\frac{1}{d} \mathbb{1}_{d}
$$

[^4]where $\mathbb{1}_{d}$ is the identity matrix in $d$ dimensions (we will usually drop the subscript $d$ since the number of dimensions should be obvious.) It's easy to see that,
\[

$$
\begin{equation*}
S\left(\rho_{\text {max entropy }}\right)=\ln (d) \tag{26}
\end{equation*}
$$

\]

which agrees with the classical result for a maximally uncertain state.

### 3.5. Discussion

The introduction of states with classical as well as quantum uncertainty represents a very significant development in the quantum formalism. We can now go ahead and represent a much more general variety of knowledge states, which probably better reflect the kind of participants we might encounter in a realistic experiment.

However the introduction of these states also gives us a chance to discuss what we think is one of the most powerful a priori reasons for considering quantum models of cognition and decision. At the heart of this argument is the difference between classical and quantum uncertainties. Suppose we have a classical system such as a fair coin, where our best description consists of a probability distribution for the two possible outcomes, head or tails. The probabilistic description reflects the fact that we are uncertain about the outcome of a given coin toss. Classical probability distributions have an associated Shannon entropy, and so classically the uncertainty about the outcome of the coin toss (probabilistic description) is related to a lack of knowledge (entropy) about the state of the system. In other words, classically we have,

> Uncertainty about outcomes
$\Leftrightarrow$

## Lack of knowledge about state

Suppose we want to build a classical cognitive model of a participant's preferences; specifically, let's imagine we want a model of what type biscuit the author will choose to eat from the box he has in front of him, as a reward for finishing this subsection. To simplify matters, suppose there are only two types, milk or dark chocolate. The author professes to be indifferent between them currently, and experience (and the number of each kind left in the box) tells us he is equally likely to choose either variety. A classical description of the author's cognitive state, which aimed to match his behaviour, would have to be a probability distribution which gave equal weight to milk and dark chocolate biscuits.

There's something odd about this though. To be clear, such a description would give the correct statistics for choices. However recall our discussion above; this classical probability distribution would have an associated entropy, and should be interpretable in terms of a lack of knowledge about the state. But wait, what information exactly is it that we lack? In the example of a coin toss above, if we toss a coin and ask you to guess heads or tails, there is of course a 'correct' answer, a probabilistic description reflects your lack of knowledge about the true state of the coin. Going back to our cognitive model, the
only knowledge you could be lacking here is the author's true $3_{62}$ preference for his next biscuit type. In other words, every time $3_{63}$ you use a classical probability distribution to describe a system,364 you assume that there is a true state of the system, that you are ${ }_{365}$ ignorant of. This might be ok for coins, but it is far from ob-366 vious that this makes sense for decision makers. For example,367 according to a classical theory, the author really do have a defi-368 nite preference for my next biscuit, he's just not telling himself fre $_{3}$ what it is...

We don't want to build a quantum model of biscuits pref-371 erence here, but suppose we represent the author's preference $3_{372}$ as the superposition state $\frac{1}{\sqrt{2}}(\mid$ milk $\left.\rangle+|d a r k\rangle\right)$. This state has ${ }_{373}$ the same expected outcomes as the classical probability distri-374 bution, but critically it has zero entropy. That is, for a quantum superposition, although the best description of the expected measurement outcomes is probabilistic, there is no extra information that it is possible to gain that would improve your ability to predict a choice. In quantum theory,

Uncertainty about outcomes

## $\nRightarrow$

## Lack of knowledge about state.

For the author's money, this is one of the most powerful arguments for using quantum probability theory to model cognition.

Now, time for that biscuit.

### 3.6. Summary

To recap; we introduced the concept of a density matrix, which can be used to represent a state with both classical and ${ }_{375}$ quantum uncertainty. In particular, if we have two different ${ }_{376}$ groups of participants, represented by the pure states $\left|P_{1}\right\rangle$ and $_{377}$ $\left|P_{2}\right\rangle$, then we can form a mixed state by taking,

$$
\begin{equation*}
\rho=\lambda\left|P_{1}\right\rangle\left\langle P_{1}\right|+(1-\lambda)\left|P_{2}\right\rangle\left\langle P_{2}\right|, \quad 0 \leq \lambda \leq 1 . \tag{27}
\end{equation*}
$$

Here $\lambda$ gives the relative frequencies of the two types of partici-380 pants in our ensemble. If the two types occur equally frequently, then $\lambda=\frac{1}{2}$.

All of the quantum theory you have encountered before can be rewritten in terms of density matrices, and we gave a few examples of common relations.

We discussed the purity and entropy of a density matrix. Pure states always have zero entropy, but density matrices let us think about techniques such as entropy maximisation in quantum models.


Finally we noted that quantum models break the connection382 between uncertainty and entropy, and this might represent as83 powerful argument for their use in cognition.

## 4. Noise in the measurements: POVMs

### 4.1. Introduction

Designing good experiments is hard. Errors can creep into experiments because of participant quality, but they can also occur because of experimental design. One type of error occurs in studies where the questions have some sort of time pressure
associated with them. Participants are forced to rush somewhat through the questions, and as such they sometimes click the wrong box or make other simple errors. Another type of error might occur when studies are very long, and participants loose focus and start giving inconsistent answers.

Suppose we wish to model an experiment where we have participants express a preference for one of two alternatives, $A$ or $B$, and that these are exhaustive and exclusive alternatives. In an ideal measurement these would be represented by projection operators $P_{A}=|A\rangle\langle A|, P_{B}=|B\rangle\langle B|$. Suppose instead our measurement isn't ideal but, intentionally or otherwise, is subject to some noise. This means some participants who really prefer $A$ will select option $B$, and vice versa.

Let's see how we might model this. What we want is an operator $E_{A}$, whose expectation value in the state $|A\rangle$ is close to one, but which also has a non-zero expectation value in the state $|B\rangle$, and likewise for $E_{B}$. That is,

$$
\begin{array}{llrl}
\langle A| E_{A}|A\rangle=1-\epsilon, & & \langle B| E_{A}|B\rangle=\epsilon, \\
\langle A| E_{B}|A\rangle=\epsilon, & & \langle B| E_{B}|B\rangle=1-\epsilon . \tag{28}
\end{array}
$$

Where $0 \leq \epsilon \leq 1$ is some small error probability. Let us also assume,

$$
\begin{equation*}
\langle A| E_{A}|B\rangle=0, \text { etc. } \tag{29}
\end{equation*}
$$

In the basis $\{|A\rangle,|B\rangle\}$ these operators can therefore be written as,

$$
E_{A}=\left(\begin{array}{cc}
1-\epsilon & 0  \tag{30}\\
0 & \epsilon
\end{array}\right), \quad E_{B}=\left(\begin{array}{cc}
\epsilon & 0 \\
0 & 1-\epsilon
\end{array}\right) .
$$

Can we use these operators to describe a measurement process? It is easily seen that they are not projection operators, unless $\epsilon=0$ or 1 , nevertheless they satisfy the following properties,

- They are positive operators, which means they have positive eigenvalues.
- They are complete, in the sense that $E_{A}+E_{B}=1$.

These properties mean that for any density matrix $\rho$,

$$
\begin{equation*}
0 \leq \operatorname{Tr}\left(E_{A} \rho\right) \leq 1 \tag{31}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{i=A, B} \operatorname{Tr}\left(E_{i} \rho\right)=1 \tag{32}
\end{equation*}
$$

The quantities $\operatorname{Tr}\left(E_{i} \rho\right)$ can thus be interpreted as probabilities, and so $E_{A}$ and $E_{B}$ are good candidates to describe a measurement process.

But what measurement process do they describe? Well there are many ways to think about this, but probably the easiest is to note that we can write,

$$
\begin{equation*}
E_{A}=(1-\epsilon) P_{A}+\epsilon P_{B}, \quad E_{B}=\epsilon P_{A}+(1-\epsilon) P_{B} . \tag{33}
\end{equation*}
$$

In other words, we can write these operators like,

$$
\begin{equation*}
E_{A}=\sum_{i} p_{A}(i) P_{i} \tag{34}
\end{equation*}
$$

The probability that a measurement described by $E_{i}$ gives a positive answer is then given by,

$$
\begin{equation*}
p(i)=\operatorname{Tr}\left(E_{i} \rho\right) . \tag{35}
\end{equation*}
$$

A given POVM can have many different possible realisations. A realisation $\phi_{i}$ is essentially the operation applied to the state $\rho \rightarrow \phi_{i}(\rho)$, so that,

$$
\begin{equation*}
\operatorname{Tr}\left(\phi_{i}(\rho)\right)=\operatorname{Tr}\left(E_{i} \rho\right) \tag{36}
\end{equation*}
$$

The simplest realisation of a POVM $\left\{E_{i}\right\}$ probably consists of just taking the operator square roots of the $E_{i}$, i.e. writing

$$
\begin{equation*}
E_{i}=M_{i}^{\dagger} M_{i} \tag{37}
\end{equation*}
$$

we have

$$
\begin{equation*}
\phi_{i}(\rho)=M_{i} \rho M_{i}^{\dagger} . \tag{38}
\end{equation*}
$$

The $M_{i}$ are often called 'measurement operators'. It's easy to see from this why a given realisation of a POVM isn't unique. Suppose we use different measurement operators given by $M_{i}^{\prime}=$ $U M_{i}$ where $U$ is an unitary operator. Then,

$$
\begin{equation*}
M_{i}^{\prime \dagger} M_{i}^{\prime}=M_{i}^{\dagger} U^{\dagger} U M_{i}=M_{i}^{\dagger} M_{i}=E_{i} \tag{39}
\end{equation*}
$$

so these new measurement operators form a realisation of the same POVM, but,

$$
\begin{equation*}
\phi_{i}^{\prime}(\rho)=U M_{i} \rho M_{i}^{\dagger} U^{\dagger}=U \phi_{i}(\rho) U^{\dagger} \tag{40}
\end{equation*}
$$

so the final state after the measurement is different in the two realisations.

In the rest of these notes we will mostly ignore the issue of multiple realisations, by sticking to the choice $M_{i}=\sqrt{E_{i}}$. In practice the appropriate realisation can be determined from the details of the measurement process.

The analogue of the collapse postulate in terms of POVMs is simply that if a measurement of the POVM $\left\{E_{i}\right\}$ yields the outcome $i$, then the state collapses to,

$$
\begin{equation*}
\rho^{\prime}=\frac{\phi_{i}(\rho)}{\operatorname{Tr}\left(\phi_{i}(\rho)\right)}=\frac{M_{i} \rho M_{i}^{\dagger} .}{\operatorname{Tr}\left(E_{i} \rho\right)}, \tag{41}
\end{equation*}
$$

where the second equality holds for our simple choice of realisation Eq.(37)

To return to our example above, for the $\operatorname{POVM} E_{A}$, in the basis $\{|A\rangle,|B\rangle\}$ the associated measurement operator will be,

$$
M_{A}=\left(\begin{array}{cc}
\sqrt{1-\epsilon} & 0  \tag{42}\\
0 & \sqrt{\epsilon}
\end{array}\right), \quad M_{B}=\left(\begin{array}{cc}
\sqrt{\epsilon} & 0 \\
0 & \sqrt{1-\epsilon}
\end{array}\right),
$$

which is nice and simple.
One feature of POVMs that is worth noting is that they represent measurements that are not perfectly repeatable, in the sense that if we measure a variable and find the value $x$ then immediately measuring the same variable again will not yield the result $x$ with certainty. This is essentially because for the elements of a POVM $E_{A}^{2} \neq E_{A}$. Suppose we start with an initial state $\rho=\operatorname{diag}(1-p, p)$. If we measure the POVM above and get the outcome $A$ then our state collapses to,

$$
\rho^{\prime}=\frac{1}{(1-\epsilon)(1-p)+\epsilon p}\left(\begin{array}{cc}
(1-\epsilon)(1-p) & 0  \tag{43}\\
0 & \epsilon p
\end{array}\right) .
$$

if we now perform another measurement of the POVM then the probability we will get the outcome $A$ again is,

$$
\begin{equation*}
\operatorname{Tr}\left(E_{A} \rho^{\prime}\right)=\frac{(1-\epsilon)^{2}(1-p)+\epsilon^{2} p}{(1-\epsilon)(1-p)+\epsilon p} \leq 1 \tag{44}
\end{equation*}
$$

for small $\epsilon$ and $p<1$ this goes as,

$$
\begin{equation*}
\operatorname{Tr}\left(E_{A} \rho^{\prime}\right)=1-\frac{\epsilon}{1-p}+O\left(\epsilon^{2}\right) \tag{45}
\end{equation*}
$$

so that this POVM measurement is not perfectly repeatable.

### 4.3. Non-Orthogonal Measurements and 'Maybe'

One interesting property of POVMs, as opposed to a description of a measurement process based on projection operators, is that the elements of a POVM need not be orthogonal. This means that we can have more measurement outcomes than there are dimensions in our Hilbert space. One application of this is where we have a two dimensional set of choices, say $A$ or $B$, but more than two possible responses, say "prefer $A$ ", "prefer $B$ " and "don't know". There are doubtless better ways of modelling this situation, but let's follow this through and see what happens. The states associated with each outcome are given by,

$$
\begin{align*}
\text { Prefer } A= & |A\rangle \\
\text { Prefer } B= & |B\rangle \\
\text { Don't know }= & \frac{1}{\sqrt{2}}(|A\rangle+|B\rangle)  \tag{46}\\
& \text { or } \frac{1}{\sqrt{2}}(|A\rangle-|B\rangle)
\end{align*}
$$

They have associated projection operators $P_{A}, P_{B}, P_{+}$and $P_{-}$in what we hope is an obvious notation. Now these set of projection operators can't form a description of a measurement, because they are not normalised, i.e.

$$
\begin{equation*}
\sum_{i=A, B,+,-} P_{i}=2 \tag{47}
\end{equation*}
$$

but we can easily turn them into a POVM by normalising. The ${ }^{488}$ POVM is therefore given by the set,

$$
\begin{equation*}
E_{A}=\frac{P_{A}}{2}, E_{B}=\frac{P_{B}}{2}, E_{+}=\frac{P_{+}}{2}, E_{-}=\frac{P_{-}}{2} . \tag{48}
\end{equation*}
$$

Suppose our state is $|+\rangle=\frac{1}{\sqrt{2}}(|A\rangle+|B\rangle)$. Then we can show,

$$
\begin{equation*}
p(A)=\frac{1}{4}, \quad p(B)=\frac{1}{4}, \quad p(\text { don't know })=\frac{1}{2} . \tag{49}
\end{equation*}
$$

It turns out this example is not very realistic (e.g. $p$ (don't know) $=\frac{1}{2}$ always!) but we hope it shows POVMs have potential for modeling this kind of measurement. We will see a better example in the next section.

### 4.4. POVMs for Likert scales

Many experimental conditions in psychology involve requesting responses on a Likert scale. Belief and preference strengths are often elicited in this way, but they can be used to measure almost any cognitive variable.

Likert scales pose an interesting problem for quantum models, because it is somewhat unclear how to approach modeling ${ }_{452}$ the corresponding variables. Suppose one is interested in a vari-453 able $x$ which we are going to take to be a belief that some event 454 will happen, say that it will rain tomorrow. One might imagine ${ }_{455}$ measuring participant's beliefs about this event in a number of ${ }_{456}$ different ways,

1. Do you think it will rain tomorrow? (Yes, No)
2. On a $1-9$ scale, where 1 is certainty of rain, and 9 is certainty of no rain, how likely do you think it is that it will ${ }_{46}$ rain tomorrow?
3. What percentage chance do you think there is of rain to- ${ }^{462}$ morrow?
4. ...

It is reasonably clear that these are all measuring the same un-466 derlying cognitive variable, belief in rain tomorrow. However if ${ }^{467}$ one assumes that the different response options are orthogonal then they appear to require vastly different dimensional Hilbert spaces, from 2 to 100 (or even an infinite dimensional space if one allows a continuous response option like a slider.) Our challenge is to come up with a unified way of modeling these different response types as arising from a single quantum variable. There are many way to do this. We will describe one of the simplest ${ }^{8}$.

[^5]Suppose we allow the different responses on the Likert scale to be non-orthogonal. Suppose we use an $N$ point scale, we can take the responses $|x=0\rangle=|0\rangle$ and $|x=N\rangle=|1\rangle$ and the intermediate responses to be,

$$
\begin{equation*}
|x=n\rangle=\cos \left(\frac{n \pi}{2 N}\right)|0\rangle+\sin \left(\frac{n \pi}{2 N}\right)|1\rangle \tag{50}
\end{equation*}
$$

These states give rise to a set of projection operators $\left\{P_{n}\right\}$ that can be turned into a POVM by normalising. The probabilities that a measurement of this variable will yield one of the responses 1-9 for the states $|0\rangle$ and $\frac{1}{\sqrt{2}}(|0\rangle+|1\rangle)$ are shown in Fig 2 , for the choice of a 9 point response scale. Note that there is


Figure 2: Probabilities for each of the 1-9 options on a Likert scale assuming the POVM based on Eq.(50).
obviously some spread in the choices, however if the true state is $|0\rangle$, say, then the probability of choosing either 1,2 or 3 on the scale is almost $63 \%$.

There are other, perhaps better ways of modeling Likert scale type judgments in quantum theory, in particular this approach rapidly looses its value as the number of responses becomes larger. Nevertheless we hope this semi-realistic example is useful in setting out where POVMs can be used in practice.

### 4.5. Order effects in noisy measurements

An important question is whether noise in the measurement process spoils the quantum features of that measurement. One example of such a quantum feature is order effects in survey designs (Wang et al., 2014), so we will briefly look at whether noise in the measurements spoils order effects. This is covered in more detail in Yearsley and Busemeyer (2015).

A striking simple example of an order effect is to consider an initial state $|A\rangle$ and two possible projective measurements, $P_{B}$

[^6]onto the state $|B\rangle$ and $P_{+}$onto the state, $\frac{1}{\sqrt{2}}(|A\rangle+|B\rangle)$. It is easy471 to see that (working for the rest of this subsection in the basis472 $\{|A\rangle,|B\rangle\})$,
\[

$$
\begin{aligned}
p(+ \text { and then } B) & =\operatorname{Tr}\left(P_{B} P_{+} \rho P_{+}\right) \\
& =\operatorname{Tr}\left(\left(\begin{array}{ll}
0 & 0 \\
0 & 1
\end{array}\right)\left(\begin{array}{cc}
\frac{1}{2} & \frac{1}{2} \\
\frac{1}{2} & \frac{1}{2}
\end{array}\right)\left(\begin{array}{ll}
1 & 0 \\
0 & 0
\end{array}\right)\left(\begin{array}{ll}
\frac{1}{2} & \frac{1}{2} \\
\frac{1}{2} & \frac{1}{2}
\end{array}\right)\right) \\

\end{aligned}

\]

Whereas,

$$
\begin{align*}
p(B \text { and then }+) & =\operatorname{Tr}\left(P_{+} P_{B} \rho P_{B}\right) \\
& =\operatorname{Tr}\left(\left(\begin{array}{cc}
\frac{1}{2} & \frac{1}{2} \\
\frac{1}{2} & \frac{1}{2}
\end{array}\right)\left(\begin{array}{ll}
0 & 0 \\
0 & 1
\end{array}\right)\left(\begin{array}{ll}
1 & 0 \\
0 & 0
\end{array}\right)\left(\begin{array}{ll}
0 & 0 \\
0 & 1
\end{array}\right)\right)  \tag{52}\\
& =\operatorname{Tr}\left(\left(\begin{array}{cc}
0 & 0 \\
0 & 0
\end{array}\right)\right)=0 .
\end{align*}
$$

This striking result arises from the fact that $\left[P_{B}, P_{+}\right] \neq 0$. So what happens if we replace this set of ideal measurements with a POVM?

We let's replace the projection operators with the following ${ }^{9}$,

$$
\begin{align*}
& P_{B} \rightarrow E_{B}=\left(\begin{array}{cc}
\epsilon & 0 \\
0 & 1-\epsilon
\end{array}\right) \\
& P_{+} \rightarrow E_{+}=\left(\begin{array}{cc}
\frac{1}{2} & \frac{1-2 \epsilon}{2} \\
\frac{1-2 \epsilon}{2} & \frac{1}{2}
\end{array}\right) \tag{53}
\end{align*}
$$

These have associated measurement operators,

$$
\begin{array}{r}
M_{B}=\left(\begin{array}{cc}
\sqrt{\epsilon} & 0 \\
0 & \sqrt{1-\epsilon}
\end{array}\right) \\
M_{+}=\left(\begin{array}{cc}
\frac{\sqrt{1-\epsilon}+\sqrt{\epsilon}}{2} & \frac{\sqrt{1-\epsilon}-\sqrt{e}}{2} \\
\frac{\sqrt{1-\epsilon}-\sqrt{e}}{2} & \frac{\sqrt{1-\epsilon}+\sqrt{\epsilon}}{2}
\end{array}\right) \tag{54}
\end{array}
$$

Now we can see that,

$$
\begin{align*}
p_{\epsilon}(+ \text { and then } B) & =\operatorname{Tr}\left(E_{B} M_{+} \rho M_{+}\right) \\
& =\frac{1}{4}(1-2(1-2 \epsilon) \sqrt{\epsilon} \sqrt{1-\epsilon}) \tag{55}
\end{align*}
$$

and

$$
\begin{align*}
p_{\epsilon}(+ \text { and then } B) & =\operatorname{Tr}\left(E_{+} M_{B} \rho M_{B}\right) \\
& =\frac{\epsilon}{2} \tag{56}
\end{align*}
$$

We plot these results against the value of $\epsilon$ in Fig.3. The results are interesting. The key is that the difference in the values of the probabilities, ie

$$
\begin{equation*}
\delta=p_{\epsilon}(+ \text { and then } B)-p_{\epsilon}(+ \text { and then } B) \tag{57}
\end{equation*}
$$

[^7](plotted as the dotted line) decreases sharply with increasing $\epsilon$, i.e. with increasing noise. Note however that the value of $\epsilon$ is interpretable in terms of the 'error' probability of the measurement. Realistic experiments would probably have values of $\epsilon$ in the range $1-5 \%$ (as found in Yearsley and Pothos (in press)), and so order effects are still likely to be visible in such experiments, although they might appear smaller than you might have expected.


Figure 3: $p_{\epsilon}(B$ and then +$), p_{\epsilon}(+$ and then $B)$, and their difference, plotted against $\epsilon$.

We don't have space here to pursue this further, but it is clear that small amounts of noise will still allow order effects to be observed, even though very large amounts of noise rapidly kill off such effects. This has important implications for studies looking for these effects in the wild (Wang et al., 2014).

### 4.6. Summary

We have shown that the description of measurements in quantum theory can be generalised to non-orthogonal sets of measurements. These POVM type measurements can be used to describe noisy realistic measurements, where even participants with a definite knowledge state may not make completely predictable decisions. They can also be used to model situations where there are simply more possible choices than orthogonal states in the space.

We mentioned that one useful way to think about POVMs was as averages over a set of projective measurements, e.g.

$$
\begin{equation*}
E_{A}=\sum_{i} p_{A}(i) P_{i} \tag{58}
\end{equation*}
$$

where the $\left\{P_{i}\right\}$ are a complete and orthogonal set of projection operators and the $p_{A}(i)$ are positive numbers such that,

$$
\begin{equation*}
\sum_{A} p_{A}(i)=1 \tag{59}
\end{equation*}
$$

which ensures the POVMs are normalised.
POVMs are likely to be a very important tool as we strive to make the predictions of the quantum models more accurate. They are also particularly relevant if an experimental set up involves asking participants the same questions repeatedly, see? for an example.

## 5. Noise in the Evolution: CP Maps

### 5.1. Introduction

The final type of noise we will consider is noise in the evo- ${ }^{552}$ lution of the state. In a typical experiment we manipulate the ${ }^{553}$ cognitive state of a participant by presenting some kind of stim- ${ }^{554}$ uli. Although we might have good control over the stimuli we ${ }^{555}$ present, we have much less certainty about how particular par- ${ }^{556}$ ticipants respond to these stimuli. In addition, we usually as- ${ }^{557}$ sume that different preferences and beliefs are more or less in- ${ }^{558}$ dependent of one another, so that, e.g., a model of chocolate ${ }^{559}$ biscuit preference can consider this belief state as an isolated ${ }^{560}$ system, independent of, e.g. preference for tea or coffee.

In reality, things are not this simple. We therefore need more ${ }^{562}$ realistic models of evolution that can help us answer two ques- ${ }^{563}$ tions;

1. What effect does the interaction between different beliefs/preferences have on the evolution of a cognitive state?
2. How do we model evolution when we are unsure about the effect of a stimuli on a particular participant?

It will turn out that these two questions have essentially the same answer. In addition an important motivation for considering noisy evolutions turns out to be the following question,
3. How do we model evolutions that are irreversible, or that cause a general initial state to tend towards some final fixed state which is independent of the initial one?

This question arrises because the usual unitary evolution we consider is reversible, ie for any unitary evolution $U(t)=e^{-i H t}$ there is another unitary evolution given by $U^{\dagger}(t)$ such that $U(t) U^{\dagger}(t)=U^{\dagger}(t) U(t)=1$. There are of course many situations in cognition where we might wish to model evolutions that are (effectively) irreversible, eg decays. This is particularly apparent when we cause a cognitive state to evolve by presenting some stimuli, e.g. some extra information, whose effects ${ }^{564}$ we can't undo.

Again, somewhat remarkably, we will find that the answer ${ }^{566}$ to question 3 is the same as the answers to questions 1 and $^{567}$ 2. We will also find that this way of incorporating noise into ${ }^{568}$ cognitive models has some very profound consequences for the ${ }^{569}$ 'quantum-ness' of the systems under study.

### 5.2. CP Maps

Generally speaking, in quantum theory noisy evolutions are $5_{54}$ motivated by considering a system of interest $S$ which interacts with some other less well controlled system which we ${ }_{575}$ call an environment $\mathcal{E}$. We will follow the same reasoning, ${ }_{576}$ although it's reasonable to have concerns about how well the physics/cognition analogy works here. In the end though the key point of this subsection is that there is a standard form for these noisy evolutions which guarantees that they make mathematical sense. In practice we just pluck noisy evolutions out of thin air to do a particular job, our only concern being that they
match this standard form. However it's useful to have some idea about where they come from ${ }^{10}$.

The idea is that we want to study the system $S$ which interacts with an environment $\mathcal{E}$ about which we have little or no interest in or information on. What one does then is to specify the dynamics of the joint system+environment, including information about the evolution and initial states to arrive at a description of the density matrix of the whole, $\rho_{S+\varepsilon}$. This density matrix contains information about the environment, which we don't want, so to get at a description of just the system we perform an operation called a partial trace, where we sum over the environmental degrees of freedom, essentially throwing away the information we don't want, to leave us with an effective description of the dynamics of the system only in terms of a reduced density matrix $\rho_{S}$.

We are interested in the effect this has on the master equation for the system alone, i.e. the evolution equation for the reduced density matrix $\rho_{S}$. For the complete density matrix $\rho_{S+\varepsilon}$ we have,

$$
\begin{equation*}
\frac{\partial}{\partial t} \rho_{S+\varepsilon}=-i\left[H_{S+\varepsilon}, \rho_{S+\varepsilon}\right] \tag{60}
\end{equation*}
$$

where $H_{S+\varepsilon}$ is the joint Hamiltonian of the system plus environment. When we perform the partial trace to remove the environmental degrees of freedom this becomes,

$$
\begin{equation*}
\frac{\partial}{\partial t} \rho_{S}=-i\left[H_{S}, \rho_{S}\right]+\mathcal{L} \rho_{S} \tag{61}
\end{equation*}
$$

where $\mathcal{L}$ is a super-operator which encodes the extra dynamics that come from the system-environment interaction. The most general form this equation can take is the so-called 'Lindblad' form (Lindblad, 1976),

$$
\begin{align*}
\frac{\partial}{\partial t} \rho_{S}= & -i\left[H_{S}, \rho_{S}\right] \\
& +\sum_{k}\left(L_{k} \rho_{S} L_{k}^{\dagger}-\frac{1}{2} L_{k}^{\dagger} L_{k} \rho_{S}-\frac{1}{2} \rho_{S} L_{k}^{\dagger} L_{k}\right) \tag{62}
\end{align*}
$$

where $\left\{L_{k}\right\}$ are a set of operators called the 'Lindblad' operators, which model the effect of the environment.

The key feature of evolution according to the Lindblad equation is that it preserves the properties of the density matrix which are important if it is to describe a real cognitive system. The most important (in the sense of difficult to achieve) property is positivity, which recall means that all the eigenvalues of $\rho$ are non-negative. For this reason master equations of the form Eq.(62) are known as 'Completely Positive' or CP-maps ${ }^{11}$. In the next sections we will consider a number particularly useful CP-maps, designed to model specific types of evolution.

### 5.2.1. Some Extra Detail

We add a few extra points here for interested readers.

[^8]In the derivation of Eq.(61) we assume that we can separate out the system and environmental degrees of freedom in the system. So we can write the total Hilbert space $\mathcal{H}=\mathcal{H}_{S} \otimes \mathcal{H}_{\mathcal{E}}$. We can therefore choose a basis for the Hilbert space which consists of tensor products of basis vectors from the system and environment, i.e. $\left|\phi_{i j}\right\rangle=\left|S_{i}\right\rangle \otimes\left|\mathcal{E}_{j}\right\rangle$, where $\left\{\left|S_{i}\right\rangle\right\}$ form a basis for $\mathcal{H}_{S}$, and likewise for the environmental degrees of freedom. The partial trace over the environmental degrees of freedom is therefore defined as,

$$
\begin{equation*}
\operatorname{Tr}_{\mathcal{E}}(A)=\sum_{j}\left\langle\mathcal{E}_{j}\right| A\left|\mathcal{E}_{j}\right\rangle \tag{63}
\end{equation*}
$$ and the reduced density matrix for the system alone is given by ${ }_{6}{ }_{614}^{613}$

$$
\begin{equation*}
\rho_{S}=\operatorname{Tr}_{\mathcal{E}}\left(\rho_{S+\varepsilon}\right) \tag{64}
\end{equation*}
$$

A couple of further points to note. First, most derivations of ${ }^{617}$ Eq.(61) for real systems assume that the initial density matrix ${ }^{618}$ can be factorised as

$$
\begin{equation*}
\rho_{S+\mathcal{E}}(t=0)=\rho_{S}(t=0) \otimes \rho_{\mathcal{E}}(t=0) \tag{65}
\end{equation*}
$$

In other words the assumption is that the system and environ- ${ }_{-623}$ ment were independent to begin with, at time $t=0$. This can ${ }_{624}$ have some funny effects on the dynamics. For example, one of ${ }_{625}$ the features of noisy evolutions is that they tend to kill of en-626 tanglement between different parts of the system. However if ${ }_{627}$ you take two systems and allow them to interact, they will tend to become entangled with each other. These models of noisy evolutions can therefore have some funny behaviour at short times, that results from assumptions made about the initial state to simplify the analysis.

Another point to note is that in order to make the transition from Eq.(60) to Eq.(61) tractable one often has to make simplifying assumptions about the dynamics. Typical assumptions are that the interaction between the system and environment is weak, and also that it is Markovian. Thus many explicit models of noisy evolutions are Markovian. If you have good reason to believe the system you are trying to model does not have this property, you should be extra careful in your choice of CP map.

Finally, if you are interested in seeing how a derivation of ${ }_{628}$ the master equation for a real system/environment interaction ${ }_{629}$ proceeds, I strongly recommend the paper by Halliwell (2007), ${ }_{630}$ for a simple introduction. This gives a simplified derivation of ${ }_{631}$ the master equation for quantum Brownian motion, that is, the ${ }_{632}$ dynamics of a system coupled to a thermal environment. The $6_{63}$ full blown analysis can be found in the classic paper by Caldeira ${ }_{634}$ and Leggett (1983), and also in Breuer and Petruccione (2006); ${ }_{635}$ Hu et al. (1992). A nice introductory tutorial can be found $\mathrm{in}_{636}$ Kryszewski and Czechowska-Kryszk (2008).

### 5.3. A CP-Map for Irreversible Evolutions

In this section we want to introduce a tractable example of $\mathrm{a}_{640}$ master equation we could use to describe a real cognitive sys-641 tem. The example we will discuss is a simple two-level system642 $\{|1\rangle,|2\rangle\}$, that might be used to model a binary variable. For the ${ }_{643}$ rest of this section we'll work in this basis.

Now a good model for the noisy evolution of such a system is given by the so-called Quantum Optical Master Equation (QOME), which describes the evolution of a two level system interacting with a thermal (i.e. random) system of other systems. The dynamics of this system are described by a master equation of the form Eq.(62) with,

$$
L_{1}=a\left(\begin{array}{ll}
0 & 1  \tag{66}\\
0 & 0
\end{array}\right), \quad L_{2}=b\left(\begin{array}{ll}
0 & 0 \\
1 & 0
\end{array}\right)
$$

and with the specific choice $a=\sqrt{\omega N}, \quad b=\sqrt{\omega(N+1)}$ where $\omega$ and $N$ are constants.

However the full dynamics of the QOME is complex (For a full solution see Yu (1998); Breuer and Petruccione (2006).). So instead of considering the full dynamics of a system interacting with an environment, what we will do here is to use a special case of this master equation to solve an important problem in quantum models of cognition - how do we model an irreversible evolution?

To keep things simple, we will specialise to the following situation: We have an initial state $\left|\psi_{0}\right\rangle=\frac{1}{\sqrt{2}}(|1\rangle+|2\rangle)$, and we want to imagine evolving the state in an irreversible way, maybe by giving the participants new information that cannot be taken back, so that the state tends towards $|1\rangle$. Unitary evolution won't work here, first since it's reversible, and second since evolving for long enough could cause the state to 'overshoot' and move back towards $|2\rangle$.

It turns out that one solution to this problem is given by a special case of the QOME, with $a=\sqrt{\gamma}$ some constant and $b=0$, that is,

$$
\begin{equation*}
\frac{\partial}{\partial t} \rho=\gamma\left(L \rho L^{\dagger}-\frac{1}{2} L^{\dagger} L \rho-\frac{1}{2} \rho L^{\dagger} L\right) \tag{67}
\end{equation*}
$$

with $L=\left(\begin{array}{ll}0 & 1 \\ 0 & 0\end{array}\right)$, and we've assumed there is no unitary part to the evolution. The solution, for the initial condition given above, is,

$$
\rho(t)=\left(\begin{array}{cc}
1-\frac{1}{2} e^{-\gamma t} & \frac{1}{2} e^{-\frac{\gamma t}{2}}  \tag{68}\\
\frac{1}{2} e^{-\frac{\gamma t}{2}} & \frac{1}{2} e^{-\gamma t}
\end{array}\right)
$$

As we can easily see, the solution tends to $|1\rangle$ at large times, and it doesn't overshoot. $|1\rangle$ is therefore a fixed point of the evolution. This solution therefore describes a state evolving towards $|1\rangle$, and getting there asymptotically. Solutions for decays towards other states can be obtained by applying unitary transformations to the Lindblad operators.

One interesting feature of this evolution is that it does not preserve the purity of the state, and by extension also the entropy. Typically the entropy initially increases, before decreasing again as the state tends to the known final state. The reason for this is subtle but is essentially due to the fact that this system is not closed but is modeled as interacting with a much larger system. The total entropy of system plus environment will always increase, as it should. We plot the behavior of the entropy and purity in Fig.4.

In summary then, this particular example of a master equation can be very fruitfully used to model irreversible evolutions,

which are common place in the lab, but impossible to model via unitary transformations. There are many other possible master equations for modeling this sort of evolution, but they all have in common that they represent noisy, non-unitary evolution.

### 5.4. A CP-Map for Uncertain Stimuli: The Montevideo Master Equation

In this section we want to consider a second type of noisy evolution, which is not so readily interpretable in terms of a system/environment interaction. However we shall see that it too can be modeled in terms of a master equation of Lindblad form.

Suppose we wish to model the evolution of a system caused by the presentation of certain stimuli. Suppose we can present our stimuli in a continuous manner, so it could be that the change in the cognitive state depends on the length of time for which the stimuli are presented. Alternatively it could be that the stimuli are discrete, but individually weak, so that pre- ${ }_{68}$ sentation of multiple stimuli can be closely approximated by a continuous in time master equation like Eq.(61). Either way, suppose the stimuli are fixed, but their effect on the participants is unknown. We might be able to assume that the effect of the stimuli is on average to produce a shift in a certain direction, but the size of that shift is unknown. This is equivalent to saying that we have a definite evolution but we are unsure, for each participant, how long that participant's state is evolved for.

Specifically, we will assume that the effect of evolution of a state for a time $t$ is not to produce the change $\rho(0) \rightarrow$ $e^{-i H t} \rho(0) e^{i H t}$ but rather,

$$
\begin{equation*}
\rho(t)=\int d s p_{t}(s) e^{-i H(t+s)} \rho(0) e^{i H(t+s)} \tag{69}
\end{equation*}
$$

where $p_{t}(s)$ is a probability distribution centered around 0 , reflecting the distribution of 'evolution times' for our participants, and we have assumed the underlying evolution about which we are uncertain is unitary. If $p_{t}(s)=\delta(s)$ we recover standard unitary evolution. We have allowed this probability distribution to depend on $t$ also to reflect the fact that the uncertainty in the evolution time, i.e. the width of $p_{t}(s)$, might depend on the time evolved for, so that longer average evolution times are associated with larger uncertainties.

We want to be able to represent this evolution in the form of a semi-group ${ }^{12}$, in other words, if $\rho(t)=\mathcal{L}_{t}(\rho(0))$, then we want,

$$
\begin{equation*}
\mathcal{L}_{t}\left(\mathcal{L}_{s}(\rho(0))\right)=\mathcal{L}_{t}(\rho(s))=\rho(t+s)=\mathcal{L}_{t+s}(\rho(0)) . \tag{70}
\end{equation*}
$$

In other words, $\mathcal{L}_{t} \cdot \mathcal{L}_{s}=\mathcal{L}_{t+s}$. Writing this in terms of Eq.(69) we see that we can express this evolution in one of two ways,

$$
\begin{equation*}
\rho\left(t_{1}+t_{2}\right)=\int d s p_{t_{1}+t_{2}}(s) e^{-i H\left(t_{1}+t_{2}+s\right)} \rho(0) e^{i H\left(t_{1}+t_{2}+s\right)} \tag{71}
\end{equation*}
$$

or

$$
\begin{align*}
\rho\left(t_{1}+t_{2}\right)= & \int d s_{2} p_{t_{2}}(s) e^{-i H\left(t_{2}+s_{2}\right)} \rho\left(t_{1}\right) e^{i H\left(t_{2}+s_{2}\right)} \\
= & \int d s_{1} d s_{2} p_{t_{2}}\left(s_{2}\right) p_{t_{1}}\left(s_{1}\right) \\
& \times e^{-i H\left(t_{1}+t_{2}+s_{1}+s_{2}\right)} \rho(0) e^{i H\left(t_{1}+t_{2}+s_{1}+s_{2}\right)}  \tag{72}\\
= & \int d s d z p_{t_{2}}(s-z) p_{t_{1}}(z) \\
& \times e^{-i H\left(t_{1}+t_{2}+s\right)} \rho(0) e^{i H\left(t_{1}+t_{2}+s\right)}
\end{align*}
$$

Eq.(71) and Eq.(72) are equivalent if,

$$
\begin{equation*}
p_{t_{1}+t_{2}}(s)=\int d z p_{t_{1}}(z) p_{t_{2}}(s-z) \tag{73}
\end{equation*}
$$

which constrains the possible form for $p_{t}(s)$. One natural choice is the following,

$$
\begin{equation*}
p_{t}(s)=\sqrt{\frac{1}{\pi \sigma t}} e^{-\frac{s^{2}}{\sigma t}} \tag{74}
\end{equation*}
$$

where $\sigma>0$ is some constant. This is easily seen to be normalised and to obey Eq.(73). Note also that,

$$
\begin{equation*}
\lim _{t \rightarrow 0} p_{t}(s)=\delta(s) \tag{75}
\end{equation*}
$$

in the sense of distributions. $(\delta(s)$ here is the Dirac delta function ${ }^{13}$.)

We want to show that this evolution can be written in the form of a master equation. We start with Eq.(69), differentiate both sides with respect to $t$, and use the very useful property, for small $t^{14}$,

$$
\begin{equation*}
p_{t}(s)=\sqrt{\frac{1}{\pi \sigma t}} e^{-\frac{s^{2}}{\sigma t}}=\delta(s)+\frac{\sigma t}{4} \delta^{\prime \prime}(s)+\ldots \tag{76}
\end{equation*}
$$

to obtain,

$$
\begin{align*}
\frac{\partial \rho}{\partial t} & =-i[H, \rho]-\frac{\sigma}{4}[H,[H, \rho]] \\
& =-i[H, \rho]+\frac{\sigma}{2}\left(H \rho H-\frac{1}{2} H^{2} \rho-\frac{1}{2} \rho H^{2}\right) \tag{77}
\end{align*}
$$

[^9]So the master equation for this evolution is indeed of Lindblad705 form, with $L=L^{\dagger}=\sqrt{\frac{\sigma}{2}} H$.

As an aside, we've called Eq.(77) the 'Montevideo' master ${ }_{707}$ equation, because it crops up as part of a particular approach $\mathrm{to}_{708}$ the foundations of quantum mechanics called the 'Montevideo ${ }_{709}$ Interpretation' MVI (2001). The derivation of this equation $\mathrm{in}_{710}$ that context is rather different, but the net result is much the ${ }_{711}$ same.

712
Let's see what the solution of this master equation looks like, ,713 for a particular choice of Hamiltonian $H$. Let's choose $H={ }_{714}$ $\gamma\left(\begin{array}{cc}1 & 0 \\ 0 & -1\end{array}\right)$. This can be thought as generating rotations about ${ }_{716}^{715}$ the z -axis. We wont derive the solution to the master equation $\mathrm{rl}_{717}$ here, although it's pretty easy and we encourage you to try this ${ }_{718}$ as an exercise. ${ }^{15}$. The solution is,

$$
\rho(t)=\left(\begin{array}{cc}
\rho_{11}(0) & e^{-2 i \gamma t-\sigma \gamma^{2} t} \rho_{12}(0)  \tag{78}\\
e^{2 i \gamma t-\sigma \gamma^{2} t} \rho_{21}(0) & \rho_{22}(0)
\end{array}\right)
$$

where $\rho_{11}(0)$ etc are the initial values of those components of $\rho$.
This solution tells us a lot of interesting information. Firstly,721 the evolution does nothing to the diagonal components of ther22 density matrix. Secondly the evolution has the effect both of $7_{23}$ causing an oscillation in the off diagonal components of $\rho$, and 724 of causing them to decay in magnitude. A nice illustration of $7_{725}$ this is to choose the state we introduced way back in Section726 2 , which, recall, was a superposition of left and right handed.727 Making the identification $|L\rangle \rightarrow|A\rangle,|R\rangle \rightarrow|B\rangle$ we have,

$$
\rho_{g}=\left(\begin{array}{ll}
\frac{1}{2} & \frac{1}{2}  \tag{79}\\
\frac{1}{2} & \frac{1}{2}
\end{array}\right)
$$

If we evolve this state according to Eq.(77) we get, for $t \rightarrow \infty$, ${ }_{733}$

$$
\lim _{t \rightarrow \infty} \rho_{g}(t)=\left(\begin{array}{cc}
\frac{1}{2} & 0 \\
0 & \frac{1}{2}
\end{array}\right)=\rho_{c}
$$

where, recall, $\rho_{c}$ was the correct answer for a mixture of left ${ }^{737}$ and right handed participants. In other words, this sort of noisy ${ }^{738}$ evolution turns quantum superposition states into classically in- ${ }^{739}$ terpretable mixtures!

In summary then, this Montevideo master equation describes ${ }^{741}$ a very useful sort of evolution, which corresponds to evolv- ${ }^{742}$ ing with a stimuli whose exact effect on participants we do not ${ }^{743}$ know. Amongst other things, this has the effect of killing off the ${ }^{744}$ off-diagonal terms in the density matrix, and thus making our ${ }^{745}$ superposition states look more like classical mixtures.

### 5.5. Discussion

 evolution appears to turn quantum superpositions into classi cal mixtures, turns out to be pretty general. This effect goes by the name of 'decoherence', and is an important part of the story[^10]of why we don't see quantum effects like interference in our everyday lives (Zurek, 1991).

In the world of cognitive modeling, this effect is also likely to be significant. Quantum effects are generally not robust when states are allowed to interact with an environment, or when the evolution is otherwise not well controlled. This has two implications; first, it suggests that care might be needed to ensure cognitive states remain quantum during experimental manipulations. Failure to do so could mean no quantum effects are visible. Second, it suggests an explanation for why some cognitive variables do not show quantum effects, perhaps certain preferences/beliefs are just to hard to isolate, and the inevitable interaction between them and other thoughts quickly kills off any quantum behaviour before it can be observed. This is a worthy subject for future research.

### 5.6. A CP-Map for continuous variables

Most of the variables we study in cognitive science are discrete, either by definition, as for a 'yes', 'no' question, or because having a finite number of response options for a variable such as preference strength is more practical than treating that variable as continuous. However there are some occasions where it might be more appropriate to work with truly continuous cognitive variables. First, it may be the case that we really have a variable that we think of as being continuous, for example preference strength. We could in principle allow a response via a slider or something else with a continuous set of response options, but even if we only allow participants a finite set of response options it may be more appropriate to treat the underlying variable as continuous. After all, it seems reasonable that changing the number of options on a Likert scale should not change the underlying variable being measured. Second, it is hard to construct simple quantum models of discrete variables when the variables can take a large number of values, simply because the Hamiltonian involves many parameters. An alternative is to start with a continuous variable and discretize, this can quickly lead to a sensible Hamiltonian for the discrete variable. A good recent example of this can be found in Kvam et al. (2015).

To cover these cases we need to develop a CP Map for continuous evolutions that is both simple enough to be useful and is reasonably general. Thankfully this problem has already been considered in physics. The general setting is a quantum version of Brownian motion, in a high temperature limit. For full details of this see Caldeira and Leggett (1983); Hu et al. (1992). The key is that under certain conditions this full evolution reduces to,

$$
\begin{equation*}
\frac{\partial}{\partial t} \rho=-i[H, \rho]-D[x,[x, \rho]] \tag{81}
\end{equation*}
$$

where $H$ is the Hamiltonian for the closed system, and $D$ is a positive constant that controls the strength of the systemenvironment coupling. In the $(x, y)$ basis, and assuming a

Hamiltonian of the form $H=\frac{p^{2}}{2 m}+V(x)$, this reads,

$$
\begin{align*}
\frac{\partial}{\partial t} \rho(x, y)= & \frac{i}{2 m}\left(\frac{\partial^{2} \rho(x, y)}{\partial x^{2}}-\frac{\partial^{2} \rho(x, y)}{\partial y^{2}}\right)  \tag{82}\\
& +i(V(x)-V(y)) \rho(x, y)-D(x-y)^{2} \rho(x, y)
\end{align*}
$$

A good account of a simplified derivation of this equation, ${ }^{803}$ suitable for a general audience, can be found in Halliwell $1_{804}$ (2007). This master equation can be discretized, either to gen-805 erate a candidate evolution for a discrete variable, or simply to $\mathrm{o}_{806}$ allow for numerical solution. It may then be solved using stan-807 dard techniques. Analytic solutions also exist for Eq.(82) $\mathrm{in}_{808}$ some situations.

Eq.(82) may be written in Lindblad form with operators ${ }_{810}$ $L \sim x$. Evolution according to this master equation therefore ${ }_{811}$ tends to make the density matrix diagonal in the $x$ basis. $\mathrm{In}_{812}$ other words, if the variable $x$ represents, say, a particular level $l_{813}$ of confidence as in Kvam et al. (2015), then the effect of this ${ }_{814}$ evolution will be to collapse superpositions states involving dif-815 ferent levels of confidence.

### 5.7. Summary

In this section have have explored the idea of noisy evolu- ${ }^{819}$ tions in quantum cognition. The idea behind such evolutions is ${ }^{820}$ that interactions between the system under study and other cog- ${ }^{821}$ nitive variables can influence the evolution of the system $\mathrm{we}^{822}$ are interested in in a profound way. We saw that the most gen- ${ }^{823}$ eral type of evolutions in quantum cognition are those that can be written in the form of a master equation of Lindblad form. ${ }^{824}$ We saw that these evolutions, also called CP-maps, may also be ${ }^{825}$ used to describe irreversible changes to the state, and the effect ${ }_{826}$ of presenting stimuli of unknown strength.

We also saw that we can use CP-maps to model irreversible ${ }_{828}$ evolutions, such as we might realistically come across in the ${ }_{829}$ lab. It is an open question whether the sort of models we have ${ }_{830}$ presented match data from real experiments, but the ideas seem $\mathrm{m}_{83}$ promising.

832
Finally we noted that generally noisy evolutions have the ef-833 fect of diminishing the 'quantum-ness' of a system. This might ${ }_{834}$ have implications for attempts to observe quantum effects $\mathrm{in}_{835}$ more complex cognitive variables. It might also explain why ${ }_{836}$ some such variables do not appear to show any quantum effects.

## 6. Conclusion

That concludes our whistle stop tour of some topics in mod-840 ern quantum theory! Let's see if we can recap and draw out any ${ }_{841}$ major themes.

In the real world, or even the real lab, all cognitive processes ${ }_{843}$ involve some level of noise. We've discussed ways in which ${ }_{844}$ we can incorporate noise into quantum systems via the state,845 the measurements and the evolution. Along the way we also846 learned some practical lessons, such as how to compute the en-847 tropy of a state, how to model non-orthogonal measurements, 848 and how to model evolution where we are unsure about the ${ }_{84}$ strength of a stimuli.

Overall we hope that the reader has learnt about some interesting tools and ideas that can be applied to modeling realistic cognitive systems using QT. We look forward to seeing these appear in future research.

### 6.1. Theme 1: QT can be adapted to cover realistic experiments

Realistic experiments involve inhomogeneous groups of participants, experimental error and noise and interactions between the variables we would like to study, and those we are less interested in. QT can be adapted to incorporate all of these things. The way is open therefore to a whole new level of modeling which aims to reproduce not just the average result, but also the statistical distribution of results for a given trial.

Having the tools to model realistic experiments also let's us think about taking QT out of the lab and into the real world. In particular having an idea about how the qualitative behaviour of a quantum system differs when there is noise present should help us decide where QT might be applicable in the wild. The tools we've covered here can also be used to address other problems in quantum cognitive modeling, such as how to model non-orthogonal measurements.

Overall then, this tutorial will hopefully have some practical value for readers who wish to go on to use QT to model decision making. It should also prove useful to those simply reading research papers in quantum cognition in helping to decide whether modeling assumptions are reasonable or not.

### 6.2. Theme 2: QT features are robust in the presence of small amounts of noise, but not against large amounts

We haven't often mentioned this explicitly, but it is clear that most quantum features are robust against reasonable levels of noise. This is good to know, as it gives us hope that quantum ideas might be applicable in all sorts of real world situations. However it's also very interesting to see how quantum features can break down when there is too much noise, and the description reverts to looking much like a classical one. This has important implications, both on a practical level, for the types of variables we can hope to see QT effects with, and on a more fundamental level, for our understanding of why some variables appear quantum, and some do not.

### 6.3. Theme 3: Adding noise to QT teaches us interesting things

One thing we hope we hope to have communicated in this tutorial is that exploring the effects of adding noise to a quantum system does more than simply teach us how to model careless participants. In some ways the real structure of QT is only revealed when we introduce density matrices, POVMs and CPmaps. One particularly important thing we learn is about the connection between classical and QT systems. Studying ideal QT systems might lead you to believe that they are diametrically opposed to classical ones, and the only overlap is for idea cases such as sets of commuting operators. However once we learn about adding noise to a QT system, we can appreciate that classical systems are in some general sense a special case of QT ones, and that it is even possible in some sense to dynamically
transition between QT and classical dynamics. Of course, we $9_{10}$ have only scratched the surface of this subject, and we'd caution ${ }^{911}$ against overgeneralising from the simple cases presented here, ${ }_{913}^{912}$ but nevertheless we hope that through this tutorial you can be-914 gin to glimpse the possibility of a unified approach to decision915 making, that incorporates both the quantum and the classical. ${ }^{916}$ Now that would make an exciting research project...

[^1]:    ${ }^{1}$ Some people often claim that a state such as $|\psi\rangle$ represents a situation where the participant is both left and right handed at the same time. Similarly, in physics people often say things like "The particle can be in two places at once!" However this isn't really correct. If a system has a property $A$ that means that the state must be an eigenstate of the projection operator $P_{A}$ onto the subspace associated with that property. Thus if our state represented a partici-200 pant who was left handed, we would have $P_{L}|\psi\rangle=|\psi\rangle$. Since this isn't true for ${ }_{201}$ $P_{L}$ or $P_{R}$ the correct conclusion is that $|\psi\rangle$ represents the state of a participant who is neither left nor right handed, rather than one who is somehow both at the same time.
    ${ }^{2}$ The trace operation has a bunch of fun and useful properties that you can read about in any good text on quantum theory. The key ones for us are firstly that it is cyclic, i.e. $\operatorname{Tr}(A B C)=\operatorname{Tr}(B C A)=\operatorname{Tr}(C A B)$ and secondly that for any operator $A, \operatorname{Tr}(A|\psi\rangle\langle\psi|)=\langle\psi| A|\psi\rangle$.

[^8]:    ${ }^{10}$ It's worth noting that this will be pretty wooly. The full mathematical treatment is complex and irrelevant for usage we want to make of the formalism.
    ${ }^{11}$ Actually Eq.(62) has an additional property not needed to preserve the properties of the density matrix, which is that it is continuous in time. Evolutions of the form Eq.(62) are therefore only a subset of possible CP-maps.

[^9]:    ${ }^{12}$ All physical evolutions have to be expressible in terms of semi-groups, which means that the product of two evolutions is also an evolution. If an evolution also has an inverse, then it is representable as a group, not just a semi-group. Unitary evolutions have this form.
    ${ }^{13}$ Defined by $\int_{-\infty}^{\infty} d x \delta\left(x-x_{0}\right) \phi(x)=\phi\left(x_{0}\right)$ for any smooth function $\phi$.
