Scholarships to MSTC

In most state colleges, like MSTC, there is a recurring danger that the practical aspects of the work being done may over-emphasize the "institutional" side of the college at the expense of the human side.

No one connected with MSTC is likely to forget that it is an institution established and maintained by the State of Minnesota to insure a supply of competently trained teachers for the public schools of the state. But preventing such a college from becoming only an efficient, soul-less mill for turning out trained teachers should be the continuing concern of its students, faculty, alumni, and friends. Because a de-personalized institution is not likely to graduate wellrounded teachers, this may also be the concern of the state; but the job of humanizing such a college can only be done by human beings, not by a state, or a legislature, or a board, or an administrative policy.

Several years ago the students of MSTC took an important step in this direction when they initiated the present freshman scholarship program. This was their answer to the teacher shortage problem. It was also a genuine testimonial to their faith in the college and a real contribution to the human side of this teacher training institution.

The idea of giving scholarships to deserving and outstanding high school graduates is a comparatively new one at MSTC. The plan first began in 1952, when the money raised by the Alpha Epsilon Song Fest was designated for such a purpose. In the spring of 1952 the nearly \$500 raised by the annual

variety show was used to give scholarships to five entering freshmen.

Although the plan was hampered because proper machinery had not been set up to secure applications from and information about the best available applicants, the program was considered so successful that the proceeds from the Song Fest have since been ear-marked each year for the same purpose. Since then the faculty has raised another \$500 each year, and a like amount has been contributed annually by the MSTC Bookstore.

In 1953-54 the freshman scholarship system was launched on a much larger scale. Money was made available for seventeen scholarships, including one (the Cupler Memorial) on a permanent basis.

Last year the Cupler Memorial Scholarship was given to Rae Iverson of Alexandria, Minnesota, daughter of Ralph Iverson, well-known MSTC alumnus. Rae, in addition to being one of the best freshmen scholastically (2.4 average), was an active leader. She had one of the main roles in the freshman play.

Most of the other scholarship students had excellent scholastic and activity records. One of them was Barbara Caughey of Perham, Minn., who was the top ranking freshman of the year and winner of the Tainter Memorial Award.

Among the other top freshmen who came to MSTC on scholarships were Mary Coyne, Graceville, Minn.; Kay Thompson, Morris, Minn.; Jeanne Johnson, Parkers Prairie, Minn.; Lois Johnson,

son and Ralph Burke, both of Crookston, Minn. All of these students had straight B averages or better in their first year at MSTC, besides doing well in extracurricular activities.

Through the effort of students and faculty, with some outside help, money was raised for twenty freshman scholarships for the coming school year. Because more publicity was given to them and a greater effort made to secure as many good applicants as possible, the scholastic and achievement level of the applicants for scholarships this year was much higher than ever before.

Although this meant that many deserving high school graduates had to be turned down, it also meant that the scholarships were given to an exceptionally select group, including a number of valedictorians and other top students, both in scholarship and school activities, from the high schools of this area.

The Janet Cupler Memorial Scholarship has been awarded to Delsie Darlene Charais of Fisher, Minnesota. The Dr. Ella Hawkinson Memorial Scholarship, to be awarded annually to a Campus High School senior who plans to attend MSTC, has been given to Joanne Baugh of Moorhead.

One additional scholarship, provided by the Owl fraternity, has not yet been awarded. The fraternity has voted to award a scholarship to one incoming freshman with athletic as well as scholastic ability.

The scholarships cover tuition and fees for one year and are open to both men and women. The awards are based on scholarship promise, leadership, financial need, and moral character.

This year the method for awarding scholarships has been revised. Each student applying for a scholarship is carefully considered by the scholarship committee. In applying for a scholarship, the student must be placed in nomination by either his high school principal or superintendent. The nominee must submit a letter on his educational plans and vocational ambition.

Along with the letter of application from the nominee and references from school and community leaders, the scholarship application consists of a nomination blank and a standard Minnesota College Association blank.

Janet Cupler Memorial Scholarship

The first permanent freshman scholarship to MSTC was presented to the college by Mr. and Mrs. A. W. Cupler of Fargo, as a memorial to their daughter,

Janet Cupler.

Miss Cupler was born in Fargo on June 14, 1913. After attending Fargo High School and graduating from Starrett School for Girls in Chicago, she took her bachelor's degree from the University of Chicago. She received the masters degree in journalism from the University of Minnesota in 1947.

After graduating from the University of Chicago, Miss Cupler was employed by the Cuneo Press, Chicago and later worked in the advertising and editiorial departments of the Western Newspaper Union in Chicago. One of her duties was conducting a women's column for the papers affiliated with the organization.

During and after World War II she was in the national headquarters of the American Red Cross in Washington, D. C., doing publicity work on war fund

campaigns.

After World War II Miss Cupler did graduate work at Minnesota and free lance writing in New York and Washington. She died of a heart attack in Washington on July 2, 1953.

Arthur W. Cupler, senior partner in the law firm of Cupler, Tenneson, Serkland, and Leahy, has been practicing law in Fargo since 1906. He is a charter member and past president of the Fargo Lions Club, past potentate of El Zagel Temple of the Shrine, a former Fargo alderman, and has been president of the North Dakota State Bar Association. At present he is president of the Board of Trustees of the North Dakota Conference of the Methodist Church.

Mrs. Arthur Cupler (Clara Undseth) received her bachelor's degree from M. TC in 1931 and her masters from Teachers College, Columbia University, in 1936. She was a supervisor in the college laboratory school from 1931 to 1944. Mrs. Cupler is a member of Gamma Nu sorority, Lambda Phi Sigma, Kappa Delta Pi, Delta Kappa Gamma. In 1954, she received the Gullick Award, national recognition of her leadership training work for the Campfire Girls. She has

been active in this organization during the past thirty years.

The Janet Cupler Memorial Scholarship was presented to MSTC on August 20, 1953. A perpetual endowment fund was set up by the investment in \$3000 par value Northern Pacific Railway Company prior lien 4% bonds. Pursuant to a written trust agreement between Mr. and Mrs. Cupler and the Governor, Auditor, and Treasurer on behalf of the State of Minnesota, the income from the trust fund is to be paid annually to MS TC to provide this scholarship each year,

A copy of the trust agreement is on file in the business office of MSTC as well as in the office of the state Auditor, and can be followed by persons desiring to create scholarships, awards, or gifts for any college purpose. This document, which conforms to the provisions of the Minnesota statutes providing for the investment and administration of such perpetual trust funds, establishes a legal pattern that can be followed by other donors without expense to themselves or to MSTC.

Dr. Ella Hawkinson Dies

Dr. Ella A. Hawkinson, member of the MSTC faculty from 1920 to 1947, died in St. Paul on January 27, 1954, following a three months illness.

Miss Hawkinson left MSTC in 1947 to teach history and political science at Hope College, Holland, Michigan. She was awarded a Fulbright lectureship in Norway for the school year 1952-53. She worked at the Trondhjem Institute of Technology and the University of Oslo.

On her return she went to Oregon to conduct a summer workshop in international education at the Southern College of Education, Ashland, Oregon. While serving as a consultant in secondary education for the state of Oregon, she was forced to resign her position last October because of illness.

Miss Hawkinson spent a few hours visiting friends on the campus last September before going out to Oregon to take up her new position.

The first woman on the MSTC faculty to get her Ph.D. (from Minnesota, in 1941), Dr. Hawkinson is credited with virtually founding the Campus High School, a gradual process effected during the 1920's. She was also the co-founder of Lambda Phi Sigma, local education fraternity, the first honorary fraternity on the campus.

As a memorial to her, an Ella Hawkinson Memorial scholarship has been set up. The nucleus of the scholarship fund is the sum of nearly \$400.00 left in the treasury of Lambda Phi Sigma, which has now been superceded by Kappa Delta Pi, national honorary education fraternity, and money for these scholarships pledged by Campus High School faculty, students, and alumni. If the scholarship is to be a permanent one, however, additional memorial contributions will be needed from Dr. Hawkinson's former students and friends.

alogue also lists a page of other fees and special fees, ranging from \$1.00 to \$20. Over a period of four years these increase the cost of education by a sizeable sum.

Students confronted with the problem of choosing a college must select either a public institution supported by state funds or a private college supported by tuition, endowments, and voluntary donations. The cost is invariably lower in the public college. The difference in cost between these two types of institutions, amounting approximately from \$300 to \$500, can be considered equivalent to a scholarship of this amount. This scholarship is available to every graduate of an accredited high school whose residence is in Minnesota. For out-of-state residents, the additional annual cost is only \$15.

Even though the cost of education for students in the Moorhead State Teachers College is nominal in comparision with the actual cost and in comparision with the cost in private denominational colleges, nevertheless it is sufficient to prevent many capable young men and women from entering college. Their limited financial resources deter some capable high school graduates from taking the initial step to enroll in college. Experience proves, however, that many students who receive financial aid for their first year of college work find the financial means to continue their education throughout the other years.

The generous contribution Mr. and Mrs. Cupler made to establish a scholar-ship in memory of their daughter is described elsewhere in The Bulletin. The Alpha Epsilon Fraternity, the Owl Fraternity, the MSTC Student Exchange Bookstore, the Faculty of the College, and the friends of Dr. Ella A. Hawkinson have established approximately seventeen scholarships to be awarded to freshmen

annually. Many additional scholarships should be provided in the future for worthy and deserving students by the alumni and friends of the College.

Fifteen MSTC alumni are currently on the college faculty. Eight of them are supervisors in the College Laboratory School, and seven teach in the College. Four of them have their doctors degrees and seven others their masters. The alumni faculty members are:

News of the College

MSTC Acquires More Land

Fourteen and a half acres of land lying just east of the campus became MS TC property last February. The tract lies between 6th and 9th Avenues South and extends a block and a half east from 14th Street.

During the 1953 session of the Minnesota legislature \$40,000 was appropriated for the purchase of this land. The final purchase was the result of yearlong negotiations between the State and the owners.

Final plans have not yet been made for the use of the land. The tract was seeded this summer and many people connected with the college feel that the main athletic field should be located on this plot.

College Building Needs

With the additional land allowing room for expansion, one of the first requests MSTC will make of the State Legislature is an appropriation to provide permanent stands for athletic contests.

Two other long-standing projects that will come up at the 1955 legislative session are the addition of a second story to the college library and the expansion of Weld Hall. The Weld Hall project involves re-wiring, enlargement of the stage, and additional space for the industrial arts, science, and instrumental music departments.

Fifth Year of Work Leads to Masters Degree

By authority of the State Legislature a fifth year program, leading to a Master of Science in Education degree, was established in the five state teachers colleges in the summer of 1953. The program is designed to improve the quality of class room teaching, and the degree is offered in both the elementary and secondary teaching fields.

At Moorhead State Teachers College, thirty-nine students have enrolled for graduate work to date. These students come principally from an area of one hundred miles surrounding the college. Practically all are experienced teachers in the field.

Most of the graduate work is offered during the summer sessions for the benefit of those who find it difficult to commute during the regular school year.

The program is under the direct supervision of the Council on Graduate Professional Education. Students are required to work in three areas: in the field of specialization, in professional education, and in a third field other than the first two. The last requirement provides the means of encouraging the student to broaden his educational background.

College Night Program

During the school year 1951-1952 MSTC began an experiment in adult education that is well-known to most alumni living in the Fargo-Moorhead area, the "College Night" program.

The program was so successful that it has been continued, with two ten-week sessions offered each year. Enrollment has run from a low of 119 to a high of 186.

The courses that have drawn the most people are Oil Painting, Travelers Spanish, Hobbies and Crafts, and Human Growth and Development. Enough people have enrolled for the Great Books classes to keep them on the schedule each term.

The future of the "College Night" program is uncertain. It has admittedly been a valuable public relations venture. However, the faculty members who teach the courses have given much of their free time to put over the program and they are willing to continue only if the people of the community show real interest in having "College Night" continued.

Nemzek Heads Alumni Association

Alex J. Nemzek, Jr., '30, was named president of the MSTC Alumni Association in an election conducted by mail this summer. Elected to a one-year term, Sliv succeeds John Ingersoll, '32, who was named to a term on the Alumni Board. Also named to the board this summer were H. K. Eklund '26 and Keith Woods '50.

Holdover members of the board are Vincent Murphy '40, Mrs. Ernie Anderson (Bernice Cronquist '24, '53), Neil Wohlwend and Marco Gotta '38, and Tom Manley '50.

Jennie Owens, now retired, is secretary of the board. Dr. Clarence Glasrud '33 is faculty alumni representative.

World War II Veterans Annual

The 1946 Dragon, MSTC annual was a special veteran's edition, dedicated to the 500 men and women who served during the war. There are service pictures of some 200 of them. There are still about 50 of these annuals left on hand. If you do not have a copy and want one, it will be mailed to you for the asking. If you wish to pay for it, do it this way: send any contribution you can afford to help set up a Veteran's Scholarship honoring the 25 MSTC men who were killed in the war.

The State of the College

MSTC is currently improving and expanding in at least three important ways: in the qualifications of its faculty, in enrollment, and in the physical campus.

With freshman applications running more than fifty over any previous year, this fall should see an entering class of 300 and a total on-campus enrollment of 700 students. The 20 scholarships awarded give special assurance that the freshman class will include many outstanding first year students.

This student body will be taught by the best qualified faculty in the history of the college. More than one-third of its members have earned doctorates and at least three others have educational training that equals the doctorate.

The twenty-two faculty members who have their doctorates earned them in the following institutions: Harvard, 2; Chicago, 3; Columbia, 2; Michigan, 1; Wisconsin, 2; Illinois, 1; Minnesota, 1; Iowa, 4; Syracuse, 1; Pennsylvania State, 1; Oregon, 1; Colorado State College of Education, 1; North Dakota, 2.

Nine faculty members have been added to the staff for the coming year to replace members who retired or resigned, and to fill in for three members of the regular faculty who have sabbatical leaves: Mason Boudrye, Roy Domek, and John Jenkins.

Mrs. Monica McCarty DuCharme (MSTC '35) will be sixth grade instructor and supervisor in the Campus School. She replaces Grace Gregerson, who has been transferred to the Division of Professional Education in the college.

Richard B. Jensen has his B. S. from the University of Illinois and has done his graduate work at the Colorado State College of Education in Greeley. He will teach social studies and assist in athletics in the college high school, replacing Floyd Temple. Mrs. Orda Olson Pederson (MSTC '52) will be second grade instructor and supervisor in the Campus School, replacing Mary B. Williamson, retired.

Dr. Allen D. Page will replace Dr. James Perlman in the field of natural science and physics. He took his B.A. from Ripon, his M.A. from Ohio State, and his Ph.D. from Wisconsin.

Dr. Paul Tasch, who taught at NDAC last year, will fill in for Mason Boudrye in the field of biology and natural science. He has his B.S. from CCNY, an M.S. from Penn State, and a Ph.D. from Iowa.

Laurence R. (Larry) MacLeod will fill in next year for Roy Domek as head basketball coach and physical education teacher. He took his B.S. from Mayville STC and his M.A. from Colorado State College of Education.

Miss Elinor V. Mohn will replace Mrs. Virginia Wilder as Dean of Women and director of the women's dormitories. A graduate of Gonvick, Minn. HS, she has both her B.S. and M.A. from Minnesota and has done additional graduate work at the University of Washington.

Dr. Lloyd I. Watkins will teach communications and speech, replacing Ethel Tainter, retired. He has his B.S. from Southeast Missouri State College and both his M.A. and Ph.D. from the University of Wisconsin.

Dr. Joseph H. Satin has been added to the faculty to teach humanities and communications. He has his B.S. from Temple University and his M.A. and Ph.D. from Columbia.

Four New Doctorates at MSTC

Werner E. Brand, principal of the campus high school at MSTC, received the degree of doctor of education at the summer commencement at Colorado State College of Education at Greeley, on August 19. The degree was in secondary education. Brand took his masters degree in mathematics at the University of North Dakota. Before coming to MSTC in 1948, he taught at Hawley and Halstad.

Allen G. Erickson received his doctor of education degree from the University of Oregon on June 13, 1954. His work was done in remedial reading and corrective speech. Erickson, who graduated from MSTC in 1934, began teaching

speech at the college in 1946. He spent the past year with his family at Eugene, Oregon, on a sabbatical.

Nels N. Johnson of the MSTC art department, who joined the faculty in 1939, received his doctor of education degree from Pennsylvania State University on August 7, 1954. His field of specialization was art education. Before coming to MSTC, Johnson taught at Northern State Teachers College, Aberdeen, South Dakota, from 1931 to 1939. He received both his B.A. and M.A. degrees from the University of Iowa.

Marlowe E. Wegner, who graduated from MSTC in 1941, will receive his doctor of education degree from the University of North Dakota in January 1955. His major field was psychology and his minor industrial arts. Wegner's thesis was accepted and his orals passed on August 5. He completed his work at U.N.D. on August 20, 1954. He has taught in the MSTC industrial arts department since 1947, except for a sabbatical leave this past year.
