


Figure 1 Summons to Sheriff's Court in London, TNA, C104/197




Figure 2 William Caxton's advertisement for Sarum Pie, John Rylands Library, Incunable Collection, 23122




Figure 3 Distribution of articles for different jurisdictions 1547-1700.




Figure 4 The spread of printed visitation articles for dioceses 1547-1647.




Figure 5 Articles produced for archdeaconries 1547-1647 in 25 year intervals.




Figure 6 Articles printed in Cambridge for dioceses and archdeaconries 1547-1647.




Figure 7 Articles printed in Oxford for dioceses and archdeaconries 1547-1647.




Figure 8 Inside page of articles printed by Da. Maxwell, (London: 1662), YML, XXXVII.F.6.




Figure 9 Title page of articles by John White (York: 1692), YML, XXXVII.F.6.




Figure 10 Printed administration bonds in different court records held at York registry.




Figure 11 Administration bond for William Newton of Great Driffield,
Precentorship Peculiar, 1681 with close up of scribal correction.




Figure 12 Front and back of administration Bond for Henry Carvile, 27th
October 1677, BI, Chancery Court Wills.




Figure 13 Front and back of manuscript administration bond for Robert Hitch, 20 February 1676/7, BI, Chancery Wills, 1675-1677.




Figure 14 Marriage Bond 1660, BI, MB 1618-1660.




Figure 15 York Excommunication Certificate, BI, Y. V/Exc. Excommunication, 1682-1718.




Figure 16 Will of John Gibson, March 1696/7, BI, Exchequer Wills, Ainsty-Holderness.




Figure 17 East Riding Excommunication Certificate, BI, ER. V/Exc., 1669-1684.




Figure 18 Manuscript Citation, BI, CP. series E-J, Citations, Monitions and Inhibitions 1664-5.




Figure 19 Printed Citation, BI, Court Papers 1666 (&1664), Citations, Monitions and Inhibitions.




Figure 20 Table of Fees for Litchfield Church Court, BI, Diocesan Accounts, DR/ACC 2/22/1.




Figure 21 Penance Certificate of John Cravon, 1700, BI, D/C. V/ Pen. Dean and Chapter Penances 1666-1718.





Figure 22 Printed sheet of Receipts BI, REV.P., Procuration Receipts and Papers 1614-1953.




Figure 24 1598 summons, BL, MS 42596, Brockman Papers Vol XI, fol.68.




Figure 25 Brief issued by James I, LMA, P96/SAV/1898-1951.




Figure 26 Privy Seal Loan 1628, Huntington Library, STT, Account Box 55 (38). My thanks to Claire Canavan for providing me with this image




Figure 27 Printed receipt issued by Bishop Bonner, TNA, E135/8/43.




Figure 28 Landlord receipts from fee-farms, NRO, FH/D/B/A/2065 a-c.




Figure 29 A printed letter from William Cavendish, Duke of Newcastle, requiring contributions for the army in Yorkshire. 1642. Bod. Lib., G.S Pamph. 1675(l)




Figure 30 Printed circular letter for civil war collection, LMA, P92/SAV 1898-1951.




Figure 31 Diagram of print flow in hearth tax administration




Figure 32 Surrey Exemption certificate, TNA, E179/346, Reigate Hundred, f.185.




Figure 33 Exemption Certificate, TNA, E179/80/362, Desborough Hundred, f. 345.




Figure 34 Sheet of blank notices for hearth tax assessments, TNA, E179/80/362, Buckingham Hundred, f.144.




Figure 36 Receipt for 'relief of Ireland' 1649, TNA, E192/13/5.

Figure 37 John Wentworth's hearth tax receipt 1684, Brotherton Library, MS/DEP/Wentworth Hall/15.




Figure 38 New River Company Receipt, TNA, E192/13/5.




Figure 39 New River Company Lease, NRO, FH/D/D/A/3348.




Figure 40 Robert Nailer's receipt book, TNA, C110/2.




Figure 41 Sacrament certificate, LMA, WR/R/S/001.




Figure 42 Distribution of printed quarter session orders.




Figure 43 Counterpart to a Wine License from Raleigh, TNA, E 192/17/729.




Figure 44 Anne Chamberlain's Alehouse Recognizance, 1600, TNA, E180/105/3.




Figure 45 Bundle of Lenten bonds TNA, E180/190.




Figure 46 Proportion of printed documents in E180.




Figure 47 Dates of printed documents in E180.




Figure 48 Distribution of printed alehouse licences.




Figure 50 Entries for commissioning print in company records at decadal intervals.




Figure 51 Percentage of accounts with entries for commissioning print in the 1620s, 1640s, 1660s and 1680s.




Figure 53 Sheet of blank tickets in Merchant Taylors scrapbook GL, MS 34104, f. 49.




Figure 54 Printed summons to a member of the Artillery Company for the funeral of John Underwood, April 29th 1641. Bod. Lib., Rawlinson, D, Vol.317, f.90b.




Figure 55 Westminster Feast Ticket, BA, Elmhirst Papers, Pye Family, EM1287.

Due to the nature of my source material and because this is an ongoing project of cataloguing previously uncatalogued print I have organised the Printed Primary Sources part of my bibliography into three separate sections to give an accurate and clear record of the print found. The main aim in doing this was to provide an ongoing database of print and make it as useful as possible for any further research.

In Section 1, I have provided a list of all printed receivers receipts from SP 28/296. In Section 2, I have provided a database of all printed receipts I have found so far dating from c.1640-c.1710. In Section 3, I have catalogued all material cited from the ESTC and organised this into sub-sections by type of print. I have done this because the titles given for this material on the ESTC often do not give enough information about what the item of print is and it is therefore clearer to group them by type. I have cited the earliest edition of each text and the first ESTC reference in each case.
