

**DIRECT AND INVERSE THEOREMS FOR MULTIVARIATE  
BERNSTEIN-SCHURER-STANCU OPERATORS**

*Abstract.* In this paper, we introduce the multivariate Bernstein-Schurer-Stancu operators. Then, we state the Volkov-type theorem and investigate the order of convergence by means of modulus of continuity and by Lipschitz class functionals. Moreover, the inverse theorems are studied for the multivariate Stancu variant of Bernstein operators.

## 1. INTRODUCTION

The celebrated Bernstein polynomials [16]

$$B_n(f; x) = \sum_{k=0}^n f\left(\frac{k}{n}\right) \binom{n}{k} x^k (1-x)^{n-k}, \quad x \in [0, 1]$$

have been the most attractive approximating operators which were studied by various mathematicians and have many applications in mathematics, physics, engineering, economy, etc (see [3], [4], [7], [8], [9], [10], [11], [12], [14], [15], [17], [18], [19], [20], [21], [23]).

In the year 1962, Schurer [22] defined the Schurer operators as:

$$B_{n,p}(f; x) = \sum_{k=0}^{n+p} f\left(\frac{k}{n}\right) \binom{n+p}{k} x^k (1-x)^{n+p-k}, \quad x \in [0, 1]. \quad (1.1)$$

We should notice that if  $p = 0$  in (1.1), we have  $B_{n,0}(f; x) = B_n(f; x)$ .

On the other hand, Barbosu [1] estimated the Schurer-Stancu operators as:

$$\left(\tilde{S}_{n,p}^{(\alpha,\beta)} f\right)(x) = \sum_{k=0}^{n+p} f\left(\frac{k+\alpha}{n+\beta}\right) \binom{n+p}{k} x^k (1-x)^{n+p-k}, \quad x \in [0, 1] \quad (1.2)$$

where  $\alpha$  and  $\beta$  are real parameters such that  $0 \leq \alpha \leq \beta$  and  $p$  is a fixed non-negative integer.

Letting  $\alpha = \beta = 0$  in (1.2), we have

$$\left(\tilde{S}_{n,p}^{(0,0)} f\right)(x) = B_{n,p}(f;x).$$

Afterwards, Barbosu introduced the bivariate operators of Schurer-Stancu type in [2] as:

$$\begin{aligned} \left(\tilde{S}_{m,p,n,q}^{(\alpha_1,\alpha_2,\beta_1,\beta_2)} f\right)(x,y) &= \sum_{k=0}^{n+p} \sum_{j=0}^{m+q} f\left(\frac{k+\alpha_1}{n+\beta_1}, \frac{j+\alpha_2}{m+\beta_2}\right) \binom{n+p}{k} \binom{m+q}{j} \\ &\quad \times x^k (1-x)^{n+p-k} y^j (1-y)^{m+q-j}, \end{aligned} \quad (1.3)$$

where  $m, n \in \mathbb{N}$ ,  $p, q \in \mathbb{N}_0$  and  $\alpha_1, \beta_1, \alpha_2, \beta_2$  are real numbers which satisfy the conditions  $0 \leq \alpha_1 \leq \beta_1$  and  $0 \leq \alpha_2 \leq \beta_2$  and  $(x, y) \in [0, 1] \times [0, 1]$ . Then he obtained the Volkov-theorem (bivariate Bohman-Korovkin theorem) and studied the order of convergence of these operators by means of the first modulus of continuity for two variables functions. It should be noted that, taking  $p = q = 0$  in (1.3), we get the operators investigated in [5].

In 2008, Büyükyazıcı and İbikli introduced the multivariate generalized Bernstein polynomials [6] as:

$$B_n(f; x_1, \dots, x_m) := \sum_{k_1, \dots, k_m=0}^n f\left(\frac{k_1}{b_n}, \dots, \frac{k_m}{b_n}\right) \prod_{j=1}^m \left[ \binom{n}{k_j} x_j^{k_j} (1-x_j)^{n-k_j} \right] \quad (1.4)$$

where  $(b_n)$  is a sequence of positive numbers such that  $\lim_{n \rightarrow \infty} b_n = \infty$  and  $\lim_{n \rightarrow \infty} \frac{b_n}{n} = 1$ . Then, they studied direct and inverse theorems for the multivariate generalized Bernstein operators.

We organize the paper in the following way:

In section two, the multivariate Bernstein-Schurer-Stancu operators are introduced and the moments of the operators are calculated. In section three, the Volkov-type theorems are obtained. In section four, we give quantitative results for the error in terms of the modulus of continuity and the Lipschitz class functionals. In section five, we study inverse theorems of the multivariate Bernstein-Schurer-Stancu operators.

## 2. CONSTRUCTION OF THE OPERATORS

We introduce the multivariate Bernstein-Schurer-Stancu operators by

$$B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; x_1, \dots, x_m) \quad (2.1)$$

$$:= \sum_{k_1, \dots, k_m=0}^{n+p} f\left(\frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n}\right) \prod_{j=1}^m \left[ \binom{n+p}{k_j} x_j^{k_j} (1-x_j)^{n+p-k_j} \right]$$

where  $\alpha = (\alpha_1, \dots, \alpha_m)$  be  $m$ -tuples real parameters satisfying the conditions  $\alpha_i \geq 0$  ( $i = 1, \dots, m$ ),  $f$  be a continuous function on  $D^p := \otimes_{j=1}^m [0, p+1]$ , for fixed  $p \in \mathbb{N}_0$  and  $(b_n)$  is a sequence of positive real numbers satisfying

(1°) For each  $n \in \mathbb{N}$ ,  $n + \max\{\alpha_1, \dots, \alpha_m\} \leq b_n$ ,

(2°)  $\lim_{n \rightarrow \infty} \frac{b_n}{n} = 1$ .

It is clear that  $B_{n,p}^{(\alpha_1, \dots, \alpha_m)} : C_{\mathbb{R}^m}(D^p) \rightarrow C_{\mathbb{R}^m}(D^0)$ . Note that, if we choose  $p = 0$  and  $\alpha = (\alpha_1, \dots, \alpha_m) = (0, \dots, 0)$  in (2.1), we get the operators in (1.4).

In giving the approximation properties of the operators

$B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; x_1, \dots, x_m)$ , we need the following lemma:

**Lemma 1.** Let  $B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; x_1, \dots, x_m)$  be given in (2.1). The first few moments of the operators are

i)  $B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(1; x_1, \dots, x_m) = 1$ ,

ii)  $B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(t_j; x_1, \dots, x_m) = \frac{n+p}{b_n} x_j + \frac{\alpha_j}{b_n}$ , ( $j = 1, 2, \dots, m$ ),

iii)  $B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(|\mathbf{t}|^2; x_1, \dots, x_m)$   
 $= \frac{(n+p)^2}{b_n^2} |\mathbf{x}|^2 - \frac{n+p}{b_n^2} |\mathbf{x}|^2 + \frac{|\alpha|^2}{b_n^2} + \frac{n+p}{b_n^2} \sum_{j=1}^m (2\alpha_j + 1) x_j$

iv)  $B_{n,p}^{(\alpha_1, \dots, \alpha_m)}((\mathbf{t}-\mathbf{x})^2; x_1, \dots, x_m) = \left( \left( \frac{n+p}{b_n} - 1 \right)^2 - \frac{n+p}{b_n^2} \right) |\mathbf{x}|^2$

+  $\sum_{j=1}^m \left[ \frac{n+p}{b_n^2} (2\alpha_j + 1) - 2\frac{\alpha_j}{b_n} \right] x_j + \frac{|\alpha|^2}{b_n^2}$  ( $j = 1, 2, \dots, m$ ),

where  $|\mathbf{x}| = \sum_{i=1}^m x_i$ ,  $|\mathbf{t}| = \sum_{i=1}^m t_i$ ,  $|\alpha| = \sum_{i=1}^m \alpha_i$ .

*Proof.* i) It is clear that  $B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(1; x_1, \dots, x_m) = 1$ .

ii) For the proof of (ii), we have

$$\begin{aligned} & B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(t_j; x_1, \dots, x_m) \\ &= \sum_{k_1, \dots, k_m=0}^{n+p} \left( \frac{k_j + \alpha_j}{b_n} \right) \prod_{i=1}^m \left[ \binom{n+p}{k_i} x_i^{k_i} (1-x_i)^{n+p-k_i} \right] \\ &= \frac{n+p}{b_n} \sum_{k_1, \dots, k_m=0}^{n+p} \frac{k_j}{n+p} \prod_{i=1}^m \left[ \binom{n+p}{k_i} x_i^{k_i} (1-x_i)^{n+p-k_i} \right] + \frac{\alpha_j}{b_n}. \end{aligned}$$

Then after some straightforward calculations, we obtain the result directly.

iii) Using the operator  $B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; x_1, \dots, x_m)$ , we have

$$\begin{aligned} & B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(|t|^2; x_1, \dots, x_m) \\ &= \sum_{k_1, \dots, k_m=0}^{n+p} \sum_{j=1}^m \left( \frac{k_j + \alpha_j}{b_n} \right)^2 \prod_{i=1}^m \left[ \binom{n+p}{k_i} x_i^{k_i} (1-x_i)^{n+p-k_i} \right] \\ &= \sum_{k_1, \dots, k_m=0}^{n+p} \sum_{j=1}^m \left( \frac{k_j^2 + 2k_j\alpha_j + \alpha_j^2}{b_n^2} \right) \prod_{i=1}^m \left[ \binom{n+p}{k_i} x_i^{k_i} (1-x_i)^{n+p-k_i} \right] \\ &= \frac{(n+p)^2}{b_n^2} \sum_{j=1}^m \sum_{k_1, \dots, k_m=0}^{n+p} \left( \frac{k_j^2}{(n+p)^2} \right) \prod_{i=1}^m \left[ \binom{n+p}{k_i} x_i^{k_i} (1-x_i)^{n+p-k_i} \right] \\ &+ \frac{2(n+p)}{b_n^2} \sum_{j=1}^m \alpha_j \sum_{k_1, \dots, k_m=0}^{n+p} \left( \frac{k_j}{n+p} \right) \prod_{i=1}^m \left[ \binom{n+p}{k_i} x_i^{k_i} (1-x_i)^{n+p-k_i} \right] + \frac{|\alpha|^2}{b_n^2}. \end{aligned}$$

Since  $|\mathbf{x}| = \sum_{i=1}^m x_i$  and  $|\alpha| = \sum_{i=1}^m \alpha_i$  then we have

$$\begin{aligned} & B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(|t|^2; x_1, \dots, x_m) \\ &= \frac{(n+p)^2}{b_n^2} |\mathbf{x}|^2 - \frac{n+p}{b_n^2} |\mathbf{x}|^2 + \frac{|\alpha|^2}{b_n^2} + \frac{n+p}{b_n^2} \sum_{j=1}^m (2\alpha_j + 1) x_j. \end{aligned}$$

Then, the proof is completed.

iv) Using (i), (ii) and (iii) we have

$$\begin{aligned} & B_{n,p}^{(\alpha_1, \dots, \alpha_m)}((t-x)^2; x_1, \dots, x_m) = B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(|t|^2; x_1, \dots, x_m) \\ & - 2B_{n,p}^{(\alpha_1, \dots, \alpha_m)}\left(\sum_{j=1}^m x_j t_j; x_1, \dots, x_m\right) + B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(|\mathbf{x}|^2; x_1, \dots, x_m) \end{aligned}$$

Hence, we get the desired result.  $\square$

### 3. VOLKOV-TYPE APPROXIMATION

In this section, the Volkov-type approximation theorem is proved for the operators  $B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; x_1, \dots, x_m)$ . Let  $C_{\mathbb{R}^m}(D^0)$  be a linear normed space endowed with the following norm

$$\|g\|_{C_{\mathbb{R}^m}(D^0)} = \max_{(x_1, x_2, \dots, x_m) \in D^0} |g(x_1, x_2, \dots, x_m)|.$$

We will use the following Volkov-type approximation theorem to give our main results of this section.

**Theorem 1** ([13]). *Let  $T_n : C_{\mathbb{R}^m}(D^0) \rightarrow C_{\mathbb{R}^m}(D^0)$  be a sequence of linear positive operators. If the following  $(m + 2)$  conditions are satisfied*

$$\lim_{n \rightarrow \infty} \|T_n(1; x) - 1\|_{C_{\mathbb{R}^m}(D^0)} = 0, \tag{3.1}$$

$$\lim_{n \rightarrow \infty} \|T_n(t_j; x) - x_j\|_{C_{\mathbb{R}^m}(D^0)} = 0, \quad (j = 1, 2, \dots, m) \tag{3.2}$$

$$\lim_{n \rightarrow \infty} \|T_n(|\mathbf{t}|^2; x) - |\mathbf{x}|^2\|_{C_{\mathbb{R}^m}(D^0)} = 0, \tag{3.3}$$

where  $\mathbf{t} = (t_1, \dots, t_m)$ ,  $\mathbf{x} = (x_1, \dots, x_m)$ , then for any function  $f \in C_{\mathbb{R}^m}(D^0)$ , we have

$$\|T_n(f; \cdot) - f(\cdot)\|_{C_{\mathbb{R}^m}(D^0)} = 0, \quad n \rightarrow \infty.$$

Note that, similar theorem can be stated for the operator  $T_n : C_{\mathbb{R}^m}(D^p) \rightarrow C_{\mathbb{R}^m}(D^0)$ .

**Theorem 2.** *Let the sequence of real numbers  $(b_n)$  satisfies  $(1^\circ)$  and  $(2^\circ)$ . For all  $f \in C_{\mathbb{R}^m}(D^p)$ ,  $B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; x_1, \dots, x_m)$  is uniformly convergent to  $f$  as  $n \rightarrow \infty$ .*

*Proof.* Using Lemma 1 and taking into account  $(1^\circ)$  and  $(2^\circ)$ , we have

$$\begin{aligned} & \|B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(1; x) - 1\|_{C_{\mathbb{R}^m}(D^0)} = 0, \\ & \lim_{n \rightarrow \infty} \|B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(t_j; x) - x_j\|_{C_{\mathbb{R}^m}(D^0)} = 0, \quad (j = 1, 2, \dots, m) \\ & \lim_{n \rightarrow \infty} \|B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(|\mathbf{t}|^2; x) - |\mathbf{x}|^2\|_{C_{\mathbb{R}^m}(D^0)} = 0. \end{aligned}$$

Thus, the conditions (3.1), (3.2) and (3.3) are satisfied and the proof follows from Theorem 1. □

*Remark 1.* If we choose  $m = 2$  in (2.1), the multivariate Bernstein-Schurer-Stancu operators for  $f(x_1, x_2)$  have the following form:

$$\begin{aligned} B_{n,p}^{(\alpha_1, \alpha_2)}(f; x_1, x_2) & := \sum_{k_1=0}^{n+p} \sum_{k_2=0}^{n+p} f\left(\frac{k_1 + \alpha_1}{b_n}, \frac{k_2 + \alpha_2}{b_n}\right) \binom{n+p}{k_1} \binom{n+p}{k_2} \\ & \times x_1^{k_1} (1-x_1)^{n+p-k_1} x_2^{k_2} (1-x_2)^{n+p-k_2}. \end{aligned} \tag{3.4}$$

Furthermore, we set the following,

$$\begin{aligned} f(x_1, x_2) & = \cos(x_1 x_2), \\ b_n & = 1/(\log(n+p+1) - \log(n+p)) \\ n & = 5, 10, 30, 60, 80, 100, \end{aligned}$$

$$p = 1, 2, 3, 4, 5, 6,$$

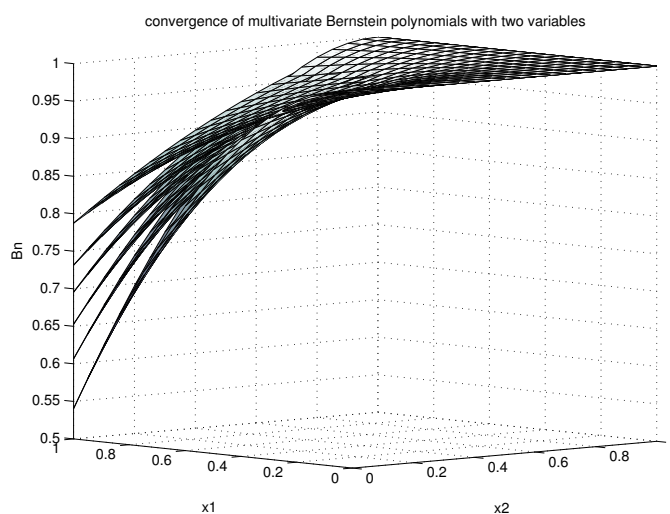


FIGURE 1. The convergence of multivariable Bernstein-Schurer-Stancu operators with two variables

$$\alpha_1 = \alpha_2 = \frac{1}{100}, \frac{1}{90}, \frac{1}{80}, \frac{1}{70}, \frac{1}{60}, \frac{1}{50},$$

in (3.4). According to the above parameters, the convergence of  $B_{n,p}^{(\alpha_1, \alpha_2)}(f; x_1, x_2)$  to  $f$  is shown in Figure 1.

*Remark 2.* If we choose  $m = 3$  in (2.1), the multivariate Bernstein-Schurer-Stancu operators for  $f(x_1, x_2, x_3)$  have the following form:

$$B_{n,p}^{(\alpha_1, \alpha_2, \alpha_3)}(f; x_1, x_2, x_3)$$

$$:= \sum_{k_1=0}^{n+p} \sum_{k_2=0}^{n+p} \sum_{k_3=0}^{n+p} f\left(\frac{k_1 + \alpha_1}{b_n}, \frac{k_2 + \alpha_2}{b_n}, \frac{k_3 + \alpha_3}{b_n}\right) \binom{n+p}{k_1} \binom{n+p}{k_2} \binom{n+p}{k_3}$$

$$\times x_1^{k_1} (1-x_1)^{n+p-k_1} x_2^{k_2} (1-x_2)^{n+p-k_2} x_3^{k_3} (1-x_3)^{n+p-k_3}. \quad (3.5)$$

Moreover, let us choose

$$f(x_1, x_2, x_3) = \left(x_1 - \frac{1}{3}\right)^2 + \left(x_2 - \frac{1}{3}\right)^2 + \left(x_3 - \frac{1}{3}\right)^2 - \frac{1}{9},$$

$$b_n = 1/(\log(n+p+1) - \log(n+p)),$$

$$n = 5, 30, 60, 80,$$

$$p = 1,$$

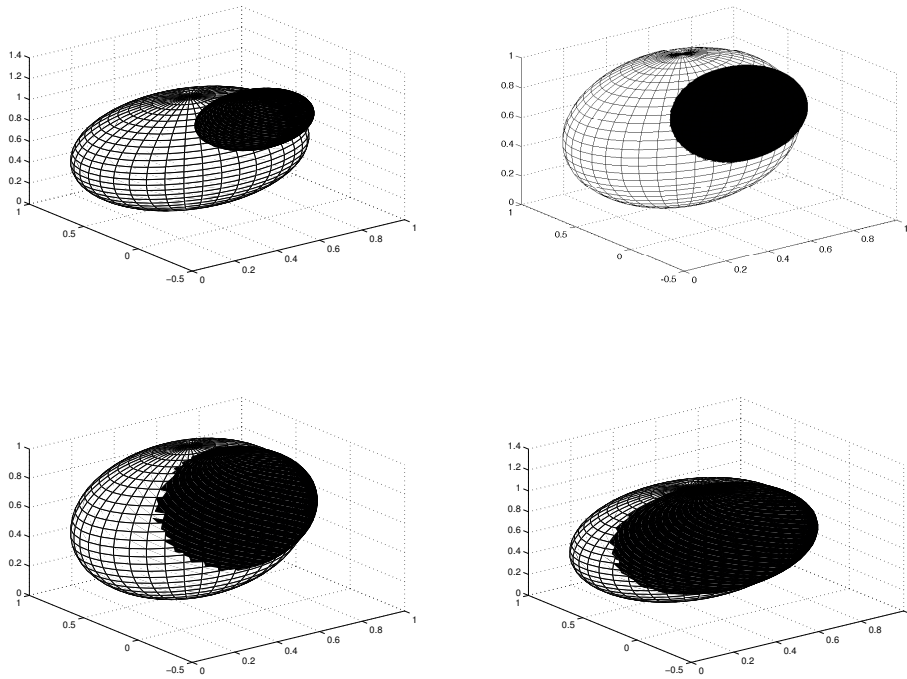


FIGURE 2. The convergence of multivariable Bernstein-Schurer-Stancu operators with three variables

$$\alpha_1 = \alpha_2 = \frac{1}{100}, \frac{1}{90}, \frac{1}{80}, \frac{1}{70}$$

in (3.5). According to the above parameters, the convergence of  $B_{n,p}^{(\alpha_1, \alpha_2, \alpha_3)}(f; x_1, x_2, x_3)$  to  $f$  is illustrated in Figure 2.

#### 4. RATE OF CONVERGENCE

In this section, we study the order of convergence of multivariate Bernstein-Schurer-Stancu operators by means of modulus of continuity and Lipschitz class functionals.

Firstly, let us recall the definitions of modulus of continuity and partial modulus of continuity, respectively.

The full modulus of continuity of the function  $f \in C_{\mathbb{R}^m}(D^p)$  is defined by

$$\omega(f; \delta) := \max_{\substack{\sqrt{\sum_{j=1}^m (x_j - y_j)^2} \leq \delta \\ (x_1, \dots, x_m), (y_1, \dots, y_m) \in D^p}} |f(x_1, \dots, x_m) - f(y_1, \dots, y_m)|$$

where  $f \in C_{\mathbb{R}^m}(D^p)$  and  $\delta > 0$ . For each fixed  $i = 1, \dots, m$ , the partial modulus of continuity of  $f$  with respect to  $x_i$  is defined by

$$\omega^{(i)}(f; \delta) := \max_{0 \leq x_1, \dots, x_m \leq 1} \max_{\substack{|x_i - y_i| \leq \delta \\ x_i, y_i \in [0, 1+p]}} |f(x_1, \dots, x_{i-1}, x_i, x_{i+1}, \dots, x_m) - f(x_1, \dots, x_{i-1}, y_i, x_{i+1}, \dots, x_m)|.$$

Furthermore, it is well known that

$$\lim_{\delta \rightarrow 0} \omega(f; \delta) = 0$$

and for any  $\lambda > 0$ ,

$$\omega(f; \lambda \delta) \leq (\lambda + 1) \omega(f; \delta). \quad (4.1)$$

Note that the same properties are satisfied by partial modulus of continuities. Our quantitative results in terms of full and partial modulus of continuities are presented in the following theorem.

**Theorem 3.** *Let  $f \in C_{\mathbb{R}^m}(D^p)$ , then for all  $\mathbf{x} = (x_1, \dots, x_m) \in D^0$ , the following inequalities*

$$\begin{aligned} i) & \left| B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) - f(\mathbf{x}) \right| \leq 2\omega\left(f; \sqrt{\delta_n(\mathbf{x})}\right), \\ ii) & \left| B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) - f(\mathbf{x}) \right| \leq 2 \sum_{i=1}^m \omega^{(i)}\left(f; \sqrt{\delta_n^{(i)}(x_i)}\right) \end{aligned} \quad (4.2)$$

holds, where

$$\begin{aligned} & \delta_n(\mathbf{x}) \\ &= \left( \left( \frac{n+p}{b_n} - 1 \right)^2 - \frac{n+p}{b_n^2} \right) |\mathbf{x}|^2 + \sum_{j=1}^m \left[ \frac{n+p}{b_n^2} (2\alpha_j + 1) - 2 \frac{\alpha_j}{b_n} \right] x_j + \frac{|\boldsymbol{\alpha}|^2}{b_n^2} \end{aligned}$$

and

$$\delta_n^{(i)}(x_i) = \left( \left( \frac{n+p}{b_n} - 1 \right)^2 - \frac{n+p}{b_n^2} \right) x_i^2 + \left[ \frac{n+p}{b_n^2} (2\alpha_i + 1) - 2 \frac{\alpha_i}{b_n} \right] x_i + \frac{\alpha_i^2}{b_n^2}.$$

*Proof.* i) From (2.1) we get

$$B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) - f(\mathbf{x})$$



$$= \sum_{k_1, \dots, k_m=0}^{n+p} \left( f \left( \frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n} \right) - f(\mathbf{x}) \right) \prod_{j=1}^m \left[ \binom{n+p}{k_j} x_j^{k_j} (1-x_j)^{n+p-k_j} \right],$$

then

$$\begin{aligned} & \left| B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) - f(\mathbf{x}) \right| \\ & \leq \sum_{k_1, \dots, k_m=0}^{n+p} \left| f \left( \frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n} \right) - f(\mathbf{x}) \right| \\ & \quad \prod_{j=1}^m \left[ \binom{n+p}{k_j} x_j^{k_j} (1-x_j)^{n+p-k_j} \right] \\ & \leq \sum_{k_1, \dots, k_m=0}^{n+p} \omega \left( f; \sqrt{\sum_{i=1}^m \left( \frac{k_i + \alpha_i}{b_n} - x_i \right)^2} \right) \prod_{j=1}^m \left[ \binom{n+p}{k_j} x_j^{k_j} (1-x_j)^{n+p-k_j} \right]. \end{aligned}$$

Then by using (4.1), and then applying Cauchy-Schwarz inequality, we get

$$\begin{aligned} & \left| B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) - f(\mathbf{x}) \right| \leq \omega(f; \delta_n(x)) \\ & \times \left\{ 1 + \frac{1}{\delta_n(x)(\mathbf{x})} \left( \sum_{k_1, \dots, k_m=0}^{n+p} \sum_{i=1}^m \left( \frac{k_i + \alpha_i}{b_n} - x_i \right)^2 \right. \right. \\ & \left. \left. \prod_{j=1}^m \left[ \binom{n+p}{k_j} x_j^{k_j} (1-x_j)^{n+p-k_j} \right] \right)^{1/2} \right\} \\ & = \omega(f; \delta_n(x)) + \frac{\omega(f; \delta_n(x))}{\delta_n(\mathbf{x})} \left( B_{n,p}^{(\alpha_1, \dots, \alpha_m)} \left( (t-\mathbf{x})^2; \mathbf{x} \right) \right)^{1/2}. \end{aligned}$$

By choosing

$$\delta_n(\mathbf{x}) := \sqrt{B_{n,p}^{(\alpha_1, \dots, \alpha_m)} \left( (t-\mathbf{x})^2; \mathbf{x} \right)},$$

then we can write the following inequality

$$\left| B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) - f(\mathbf{x}) \right| \leq 2\omega \left( f; \sqrt{\delta_n(\mathbf{x})} \right).$$

*ii*) In a similar manner, we can obtain the inequality (4.2). □

Now, we want to give the quantitative result in terms of the Lipschitz class functionals. It is known that  $f \in D^p$  belongs to  $Lip_M(\gamma)$  if

$$|f(\mathbf{x}) - f(\mathbf{y})| \leq M \left( \sum_{i=1}^m (x_i - y_i)^2 \right)^{\gamma/2}$$

and  $f \in Lip_M(\gamma_1, \dots, \gamma_m)$ , if

$$|f(\mathbf{x}) - f(x_1, \dots, x_{i-1}, y_i, x_{i+1}, \dots, x_m)| \leq \sum_{i=1}^m M_i |x_i - y_i|^{\gamma_i}, \quad i = 1, 2, \dots, m$$

where  $0 < \gamma \leq 1$  and  $0 < \gamma_i \leq 1$  ( $i = 1, 2, \dots, m$ ),  $\mathbf{x} = (x_1, \dots, x_m)$ ,  $\mathbf{y} = (y_1, \dots, y_m)$ .

**Theorem 4.** For all  $f \in Lip_M(\gamma)$ , we have

$$\begin{aligned} \left| B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) - f(\mathbf{x}) \right| &\leq M \left( \left( \left( \frac{n+p}{b_n} - 1 \right)^2 - \frac{n+p}{b_n^2} \right) |\mathbf{x}|^2 \right. \\ &\quad \left. + \sum_{j=1}^m \left[ \frac{n+p}{b_n^2} (2\alpha_j + 1) - 2 \frac{\alpha_j}{b_n} \right] x_j + \frac{|\boldsymbol{\alpha}|^2}{b_n^2} \right)^{\gamma/2}. \end{aligned}$$

**Theorem 5.** For all  $f \in Lip_M(\gamma_1, \dots, \gamma_m)$ , we have

$$\begin{aligned} \left| B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) - f(\mathbf{x}) \right| &\leq \sum_{i=1}^m M_i \left( \left( \left( \frac{n+p}{b_n} - 1 \right)^2 - \frac{n+p}{b_n^2} \right) x_i^2 \right. \\ &\quad \left. + \left[ \frac{n+p}{b_n^2} (2\alpha_i + 1) - 2 \frac{\alpha_i}{b_n} \right] x_i + \frac{\alpha_i^2}{b_n^2} \right)^{\gamma_i/2}. \end{aligned}$$

*Remark 3.* In Table 1, the error of approximation of the function  $f(x_1, x_2) = \cos(x_1 x_2)$  by the  $B_{n,p}^{(\alpha_1, \alpha_2)}(f; x_1, x_2)$  is given, where we choose

$$\alpha_1 = \alpha_2 = \frac{1}{100}, \frac{1}{90}, \frac{1}{80}, \frac{1}{70}, \frac{1}{60}$$

and  $b_n = 1/(\log(n+p+1) - \log(n+p))$ .

5. INVERSE THEOREMS

In this section, we obtain the inverse theorems of multivariate Bernstein-Schurer-Stancu operators.

**Theorem 6.** *If  $f \in C_{\mathbb{R}^m}(D^p)$  such that*

$$\left| B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) - f(\mathbf{x}) \right| \leq M \left( \frac{1}{n+p} \right)^\gamma, \quad (0 < \gamma \leq 1)$$

for some positive constant  $M$ , then  $f \in Lip_M(\gamma)$ .

*Proof.* For fixed  $i = 1, 2, \dots, m$ , taking partial derivative of (2.1) with respect to  $x_i$  we get

$$\begin{aligned} & \frac{\partial B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; x_1, \dots, x_i, \dots, x_m)}{\partial x_i} \\ &= \frac{\partial}{\partial x_i} \left[ \sum_{k_1, \dots, k_m=0}^{n+p} f \left( \frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_i + \alpha_i}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n} \right) \right. \\ & \quad \left. \times \prod_{j=1}^m \left[ \binom{n+p}{k_j} x_j^{k_j} (1-x_j)^{n+p-k_j} \right] \right] \\ &= \frac{\partial}{\partial x_i} \left[ \sum_{k_1, \dots, k_m=0}^{n+p} f \left( \frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_i + \alpha_i}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n} \right) \right. \\ & \quad \left. \times \left[ \binom{n+p}{k_i} x_i^{k_i} (1-x_i)^{n+p-k_i} \right] \prod_{\substack{j=1 \\ j \neq i}}^m \left[ \binom{n+p}{k_j} x_j^{k_j} (1-x_j)^{n+p-k_j} \right] \right] \\ &= \sum_{k_i=1}^{n+p} \sum_{k_1, \dots, k_{i-1}, k_{i+1}, \dots, k_m=0}^{n+p} f \left( \frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_i + \alpha_i}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n} \right) \\ & \quad \times \frac{(n+p)!}{(k_i-1)!(n+p-k_i)!} x_i^{k_i-1} (1-x_i)^{n+p-k_i} \prod_{\substack{j=1 \\ j \neq i}}^m \left[ \binom{n+p}{k_j} x_j^{k_j} (1-x_j)^{n+p-k_j} \right] \\ &= \sum_{k_i=0}^{n+p-1} \sum_{k_1, \dots, k_{i-1}, k_{i+1}, \dots, k_m=0}^{n+p} f \left( \frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_i + \alpha_i}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n} \right) \end{aligned}$$

$$\begin{aligned}
& \times \frac{(n+p)!}{k_i!(n+p-k_i-1)!} x_i^{k_i} (1-x_i)^{n+p-k_i-1} \prod_{\substack{j=1 \\ j \neq i}}^m \left[ \binom{n+p}{k_j} x_j^{k_j} (1-x_j)^{n+p-k_j} \right] \\
& = \sum_{k_i=0}^{n+p-1} \sum_{k_1, \dots, k_{i-1}, k_{i+1}, \dots, k_m=0}^{n+p} f \left( \frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_i + 1 + \alpha_i}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n} \right) \\
& \times \frac{(n+p)(n+p-1)!}{k_i!(n+p-k_i-1)!} x_i^{k_i} (1-x_i)^{n+p-k_i-1} \prod_{\substack{j=1 \\ j \neq i}}^m \left[ \binom{n+p_j}{k_j} x_j^{k_j} (1-x_j)^{n+p_j-k_j} \right] \\
& - \sum_{k_i=0}^{n+p-1} \sum_{k_1, \dots, k_{i-1}, k_{i+1}, \dots, k_m=0}^{n+p} f \left( \frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_i + \alpha_i}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n} \right) \\
& \times \frac{(n+p)(n+p-1)!}{k_i!(n+p-k_i-1)!} x_i^{k_i} (1-x_i)^{n+p-k_i-1} \prod_{\substack{j=1 \\ j \neq i}}^m \left[ \binom{n+p}{k_j} x_j^{k_j} (1-x_j)^{n+p-k_j} \right].
\end{aligned}$$

Now, we get

$$\begin{aligned}
& \frac{\partial B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x})}{\partial x_i} \\
& = (n+p) \sum_{k_i=0}^{n+p-1} \sum_{k_1, \dots, k_{i-1}, k_{i+1}, \dots, k_m=0}^{n+p} \\
& \quad \left( f \left( \frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_i + 1 + \alpha_i}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n} \right) \right. \\
& \quad \left. - f \left( \frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_i + \alpha_i}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n} \right) \right) \\
& \times \frac{(n+p-1)!}{k_i!(n+p-k_i-1)!} x_i^{k_i} (1-x_i)^{n+p-k_i-1} \prod_{\substack{j=1 \\ j \neq i}}^m \left[ \binom{n+p}{k_j} x_j^{k_j} (1-x_j)^{n+p-k_j} \right].
\end{aligned}$$

Then, by triangle inequality,

$$\begin{aligned}
& \left| \frac{\partial B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x})}{\partial x_i} \right| \\
& \leq (n+p) \sum_{k_i=0}^{n+p-1} \sum_{k_1, \dots, k_{i-1}, k_{i+1}, \dots, k_m=0}^{n+p}
\end{aligned}$$

$$\begin{aligned} & \left| f\left(\frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_i + 1 + \alpha_i}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n}\right) \right. \\ & \left. - f\left(\frac{k_1 + \alpha_1}{b_n}, \dots, \frac{k_i + \alpha_i}{b_n}, \dots, \frac{k_m + \alpha_m}{b_n}\right) \right| \\ & \times \frac{(n + p - 1)!}{k_i!(n + p - k_i - 1)!} x_i^{k_i} (1 - x_i)^{n + p - k_i - 1} \prod_{\substack{j=1 \\ j \neq i}}^m \left[ \binom{n + p}{k_j} x_j^{k_j} (1 - x_j)^{n + p - k_j} \right]. \end{aligned}$$

Using (4.2), we have

$$\begin{aligned} & \left| \frac{\partial B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x})}{\partial x_i} \right| \\ & \leq (n + p) \sum_{k_i=0}^{n+p-1} \sum_{k_1, \dots, k_{i-1}, k_{i+1}, \dots, k_m=0}^{n+p} \omega^{(i)}\left(f; \frac{1}{b_n}\right) \frac{(n + p - 1)!}{k_i!(n + p - k_i - 1)!} \\ & \times x_i^{k_i} (1 - x_i)^{n + p - k_i - 1} \prod_{\substack{j=1 \\ j \neq i}}^m \left[ \binom{n + p}{k_j} x_j^{k_j} (1 - x_j)^{n + p - k_j} \right] \\ & = (n + p) \sum_{k_i=0}^{n+p-1} \omega^{(i)}\left(f; \frac{1}{b_n}\right) \frac{(n + p - 1)!}{k_i!(n + p - k_i - 1)!} x_i^{k_i} (1 - x_i)^{n + p - k_i - 1} \\ & \leq (n + p) \omega^{(i)}(f; \delta) \sum_{k_i=0}^{n+p-1} \left( \left(1 + \frac{1}{\delta b_n}\right) \frac{(n + p - 1)!}{k_i!(n + p - k_i - 1)!} x_i^{k_i} (1 - x_i)^{n + p - k_i - 1} \right) \\ & = (n + p) \omega^{(i)}(f; \delta) \left\{ 1 + \frac{1}{\delta b_n} \right\} = \omega^{(i)}(f; \delta) \left\{ n + p + \frac{n + p}{\delta b_n} \right\}. \end{aligned}$$

For any pair of points  $x, y$  in  $[0, 1]$ , we can write

$$\begin{aligned} \int_x^y \left| \frac{\partial B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x})}{\partial x_i} \right| dx_i & \leq \omega^{(i)}(f; \delta) \left\{ n + p + \frac{n + p}{\delta b_n} \right\} \int_x^y dx_i \\ \int_x^y \left| \frac{\partial B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x})}{\partial x_i} \right| dx_i & \leq \omega^{(i)}(f; \delta) |x - y| \left\{ n + p + \frac{n + p}{\delta b_n} \right\}. \end{aligned}$$

By choosing  $\delta_n := \frac{1}{n+p}$ , we obtain

$$\int_x^y \left| \frac{\partial B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x})}{\partial x_i} \right| dx_i \leq \omega^{(i)}(f; \delta) |x-y| \left\{ \frac{1}{\delta_n} + \frac{n+p}{\delta b_n} \right\}. \quad (5.1)$$

Then the sequences  $\delta_n$  decreases to zero as  $n \rightarrow \infty$ . Also  $\delta_{n-1} \leq 2\delta_n$  is satisfied for  $n = 2, 3, \dots$ . Hence for a given  $0 < \delta \leq 1$  there exists  $n \in \mathbb{N}$  such that

$$\delta_n \leq \delta \leq \delta_{n-1} \leq 2\delta_n. \quad (5.2)$$

Using (5.2) in (5.1), we have

$$\int_x^y \left| \frac{\partial B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x})}{\partial x_i} \right| dx_i \leq \left\{ 2 + \frac{n+p}{b_n} \right\} \frac{1}{\delta} \omega^{(i)}(f; \delta) |x-y|. \quad (5.3)$$

On the other hand, since we have

$$\begin{aligned} |f(\mathbf{x}) - f(\mathbf{y})| &\leq |f(\mathbf{x}) - f(y_1, x_2, \dots, x_m)| \\ &+ |f(y_1, x_2, \dots, x_m) - f(y_1, y_2, \dots, x_m)| + \dots \\ &+ |f(y_1, \dots, y_{m-1}, \dots, x_m) - f(\mathbf{y})| \end{aligned}$$

and

$$\begin{aligned} |f(\mathbf{x}) - f(y_1, x_2, \dots, x_m)| &\leq \left| f(\mathbf{x}) - B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) \right| \\ &+ \left| f(y_1, x_2, \dots, x_m) - B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, x_2, \dots, x_m) \right| \\ &+ \int_{x_1}^{y_1} \left| \frac{\partial}{\partial x} B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; x, x_2, \dots, x_m) \right| dx, \\ |f(y_1, x_2, \dots, x_m) - f(y_1, y_2, x_3, \dots, x_m)| \\ &\leq \left| f(y_1, x_2, \dots, x_m) - B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, x_2, \dots, x_m) \right| \\ &+ \left| f(y_1, y_2, \dots, x_m) - B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, y_2, \dots, x_m) \right| \\ &+ \int_{x_2}^{y_2} \left| \frac{\partial}{\partial x} B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, x, \dots, x_m) \right| dx \\ &\vdots \\ |f(y_1, y_2, \dots, x_m) - f(y_1, y_2, \dots, y_m)| \\ &\leq \left| f(y_1, \dots, y_{m-1}, x_m) - B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, \dots, y_{m-1}, x_m) \right| \\ &+ \left| f(y_1, y_2, \dots, y_m) - B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, y_2, \dots, y_m) \right| \end{aligned}$$

$$+ \int_{x_m}^{y_m} \left| \frac{\partial}{\partial x} B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, y_2, \dots, x) \right| dx$$

we get, for all fixed  $n \in \mathbb{N}$

$$\begin{aligned} & |f(\mathbf{x}) - f(y_1, \dots, y_m)| \\ & \leq \left| f(\mathbf{x}) - B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) \right| \\ & + \left| f(y_1, x_2, \dots, x_m) - B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, x_2, \dots, x_m) \right| \\ & + \left| f(y_1, x_2, \dots, x_m) - B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, x_2, \dots, x_m) \right| \\ & + \left| f(y_1, y_2, \dots, x_m) - B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, y_2, \dots, x_m) \right| \\ & + \dots + \left| f(y_1, \dots, y_{m-1}, y_m) - B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, \dots, y_m) \right| \\ & + \int_{x_1}^{y_1} \left| \frac{\partial}{\partial x} B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; x, x_2, \dots, x_m) \right| dx \tag{5.4} \\ & + \int_{x_2}^{y_2} \left| \frac{\partial}{\partial x} B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, x, \dots, x_m) \right| dx \end{aligned}$$

$$+ \dots + \int_{x_m}^{y_m} \left| \frac{\partial}{\partial x} B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; y_1, y_2, \dots, x) \right| dx. \tag{5.5}$$

Using (5.2) and (5.3) in (5.5), we obtain

$$\begin{aligned} |f(\mathbf{x}) - f(\mathbf{y})| & \leq 2mM\delta^\gamma + \sum_{i=1}^m \left( 2 + \frac{n+p}{b_n} \right) \frac{1}{\delta} \omega^{(i)}(f; \delta) \left( \sum_{j=1}^m (x_j - y_j)^2 \right)^{1/2}, \\ & \leq 2mM\delta^\gamma + \left( 2 + \frac{n+p}{b_n} \right) \frac{m}{\delta} \omega(f; \delta) \left( \sum_{j=1}^m (x_j - y_j)^2 \right)^{1/2} \\ & \leq K_1 \left( \delta^\gamma + \frac{\omega(f; \delta)}{\delta} \left( \sum_{j=1}^m (x_j - y_j)^2 \right)^{1/2} \right), \end{aligned}$$

where  $K_1 = \max \left\{ 2mM, m \left( 2 + \frac{n+p}{b_n} \right) \right\}$ .

Therefore, taking  $\left( \sum_{j=1}^m (x_j - y_j)^2 \right)^{1/2} \leq h$  with  $0 < h \leq 1$  and considering the definition of  $\omega$ , we write

$$\omega(f; h) \leq K_1 \left( \delta^\gamma + \frac{h}{\delta} \omega(f; \delta) \right), \quad 0 < h, \delta \leq 1. \tag{5.6}$$

Then, by (5.6) we have  $K_2 h^\gamma$ . Hence, we get

$$\omega(f; h) \leq K_2 h^\gamma \quad (0 < \gamma < 1). \quad (5.7)$$

From (5.7), we obtain  $f \in Lip\gamma$ . We get the desired result.  $\square$

In a similar manner, we can state the following theorem:

**Theorem 7.** *If the inequality*

$$\left| B_{n,p}^{(\alpha_1, \dots, \alpha_m)}(f; \mathbf{x}) - f(x_1, \dots, x_{j-1}, y_j, x_{j+1}, \dots, x_m) \right| \leq M_j \left( \frac{1}{n+p} \right)^{\gamma_j}$$

is satisfied for  $0 < \gamma_j \leq 1$  and for some constants  $M_j$ , ( $j = 1, 2, \dots, m$ ), then

$$f \in \bigcap_{j=1}^m Lip_{M_j \gamma_j}.$$
