A TEXT című folyóirat internacionális és a lehető legtágabb értelemben vett interdiszciplináris folyóiratként látott napvilágot. Lehetőséget kívánt és kíván adni a legkülönfélébb — szövegekkel, konverzációkkal, 'kommunikatív eseményekkel' stb. foglalkozó — tanulmányok megjelentetésére.

Célja, hogy előmozdítja egy multidiszciplináris szövegtudomány kifejlődését s különböző tudományok szövegek iránt érdeklődő képviselőinek együttműködését. E cél érdekében elsősorban a sajátosan interdiszciplináris tanulmányok létrejöttét támogatja. Ebben a kontextusban különös hangsúlyt kapnak az általános elméleti kérdésekkel és a különféle metodológiai problémákkal foglalkozó írások.

A különféle szövegtípusokat illetően a folyóirat elősegíteni kívánja olyan tanulmányok megszületését, amelyek a napjainkban égető szociális kérdésekkel foglalkozó szövegek elemzésére irányulnak.
