This issue of the *Journal* marks, in a sense, the end of an era. Almost thirty-three years ago, in 1933, John Cobb Cooper, the then Chairman of the Committee on Aeronautical Law of the American Bar Association, became associated with the *Journal* as an advisor. Beginning with Volume 4, Professor Cooper, one of the true pioneers in the fields of aviation and space law, has continuously served the *Journal* as advisor, associate editor, or member of the Editorial Advisory Board. He has also contributed a number of distinguished articles for publication. In 1962, the *Journal* was both pleased and honored to publish a group of commemorative essays in honor of Professor Cooper's 75th birthday, written especially for the occasion by international leaders in aviation and space law (28 J. Air L. & Com. 327-404).

It is with regret, then, that we announce that effective with the publication of this issue Professor John Cobb Cooper's formal connection with the *Journal* will cease. Because of considerations of health, Professor Cooper, who recently celebrated his 78th birthday, has found it necessary to curtail many of his numerous responsibilities and activities, including the *Journal*.

In his recent letter advising of his decision to resign from the Editorial Advisory Board, Professor Cooper stated, "I have deemed it a pleasure as well as an honor to be associated with the *Journal* and I leave that connection . . . with many very pleasant memories." We consider it an honor to have been associated with Professor Cooper in this endeavor. We wish him health and happiness for the years to come and want him to know that we will continue to rely on him, informally now, for his generous support and guidance in our future efforts.
