

His publications include *Malpractice in Psychotherapy* and more than four dozen law review articles and reviews.

Thomas L. Greaney is a Professor of Law at Saint Louis University, St. Louis, Missouri. In 1993 he received a Fulbright Fellowship to study competition law in the European Community. Timothy Stoltzfus Jost holds the Newton D. He is the author of numerous articles and books on health law and policy and was a member of the State Medical Licensure Board of Ohio for five years.
