## Annual Report

For the Fiscal Year July 1, 1967 - June 30, 1968

With quarterly publication now well established, the Journal continues to show a gain in readership which is satisfying from an editorial, if not a financial point of view.

This past fiscal year brought a 9.4% increase in the number of paid subscriptions, bringing the total to 1028. Renewals increased by 11% over the previous reporting period. New general subscriptions (excluding UNM law students) were up over 50% from 99 in 1966-67 to 153 in 1967-68. The only category of subscribers to show a decline was UNM law students, whose subscriptions have been on a voluntary basis for several years now. Thirty-four students paid \$2. each for a school-year subscription to the Journal. This is about one-fifth of the student body. The eight seniors who comprised the editorial board received complimentary subscriptions during their year of service; and we continued to send complimentary copies to our Board of Advisors, campus executive offices, indexing services, etc. Back issues were again in popular demand this year, with 38 full sets (684 copies) sold out of a total of 945 back issues sold this year.

Two additional listings have increased to nineteen the number of publications in which the Journal is indexed or advertised. These are: Rydata, Journal of the American Water Resources Association, Urbana, Illinois; and Standard Periodical Directory, New York, New York. The Library of Congress, Index to Legal Periodicals, USDA Bibliography of Agriculture, and the Journal of Economic Abstracts are among the seventeen others indexing, publishing abstracts from, or carrying advertising for the Journal.

Requests for permission to reprint entire articles were received during this fiscal year from: United States Department of the Interior, Bureau of Land Management; The University of Chicago Library; Rocky Mountain Mineral

Law Foundation; and Professor Joseph L. Sax of the University of Michigan. Articles requested for reprinting were: "Administration of the Mining Laws in Areas of Conflict" by Irving Senzel, 7 Natural Resources J. 225 (1967); "Recreational Rights and Titles to Beds on Western Lakes and Streams" by Ralph W. Johnson and Russell A. Austin Jr., 7 Natural Resources J. 1 (1967); "The Mining Law and Multiple Use" by Jerry A. O'Callaghan, 7 Natural Resources J. 241 (1967); "Strategy and Organization in Public Land Policy" by George R. Hall, 7 Natural Resources J. 162 (1967); and "A Review and Revitalization: Concepts of Ground Water Production & Management: The California Experience" by Robert I. Reis, 7 Natural Resources J. 63 (1967).

We have received an occasional compliment along the way, such as: "I cannot let this occasion pass without congratulating you on the excellent quality of the Journal. The four issues published during this fiscal year included the article "Benefit-Cost Analysis and the National Oceanographic Program" by James A. Crutchfield, Robert W. Kates, and W. R. Derrick Sewell, which probably sold more single copies of the issue in which appeared than any other article we have ever published. We began receiving orders six months prior to publication in July, 1967, and we receive them still. "Megalopolis, Resource Conserver or Resource Waster?" by economics Professor Joseph J. Spengler of Duke, also gained attention and response in the form of comments and rebuttals, two of which we plan to publish during this next year. Our New Mexico Section carried another article in our series on constitutional revision, "Constitutional Limitations on the Exercise of Judicial Functions by Administrative Agencies", in addition to an article on "An Administrative Procedure Act for New Mexico", one on "Indian Industrial Development and the Courts", and another on "The Perils of Intestate Succession in New Mexico ...". The articles on constitutional revision and administrative procedure were written by the Journal's faculty editor-in-chief. Attorney William C. Schaab contributed the Indian industrial development article, and former UNM law professor Denny Ingram co-authored with former UNM law student Ted Parnell on intestate perils.

Our symposium on "Resources of the Sea", which has been eighteen months in preparation, will be published in our July 1968 issue, and will be followed in October by a symposium on "Shale Oil Development". Featured in our July issue will be Lewis Alexander of the Law of the Sea Institute; Francis T. Christy, Resources for the Future; David B. Brooks, Chief, Economic Analysis, U.S. Bureau of Mines; Oliver Stone, General Attorney, Shell Oil Company, New York; and Professor L.F.E. Goldie of Loyola at Los Angeles. Contributors to the October issue will be B. Delworth Gardner of Utah State; Morris Garnsey of Colorado; Walter Mead of University of California at Santa Barbara, George Miron, Solicitor's Office, U.S. Department of the Interior; and Henry Steele of the University of Houston. Our two additional issues during the fiscal year will be devoted to general, varied topics, with planned continuation of recent resources cases comments, and our New Mexico Section.

Four issues were printed during this fiscal year, at a total printing cost of \$11,810.97. This was an increase of \$550.00 over the previous fiscal year when four issues were also printed. The actual cost of getting each Journal to its reader averaged \$2.43 during this fiscal year (printing and mailing only). Our annual general subscription fee of \$9.00 brings in \$2.25 per copy. Our agency rate of \$7.65 comes to only \$1.91 per copy. We are giving serious consideration to raising the subscription rate to \$10. for four issues, which would bring in an additional \$.25 per single copy sold on subscription basis, and we are studying the advisability of continuing the 15% discount we have been allowing subscription agencies.
