## The NRLC Launches the WESTERN WATER POLICY PROGRAM (WWPP) under the direction of Senior Research Associate, Doug Kenney

In January, the Center formed the WWPP to promote sustainable, equitable, and practical solutions to the pressing water problems of the region, particularly with respect to the challenges of population growth and climate change (see WWPP website: <http://www.colorado.edu/law/centers/nrlc/programs/wwpp.htm>). The first event organized under this new structure was the Colorado River conference held March 21<sup>st</sup> (see synopsis on page 2).

In addition, the WWPP will consolidate and build upon the Center's quarter-century of work on western water law and policy issues. One of the WWPP's initial activities is the compilation and posting of the many research reports, books, and conference materials produced by or for the Center, beginning with our first water conference in 1981. When the project is completed this summer, approximately 750 documents will be available for download (for free) from the NRLC-WWPP website, which is currently under development as part of the updating of the NRLC website. The WWPP is directed by NRLC Senior Research Associate Doug Kenney, who is profiled on page 4 of this newsletter.

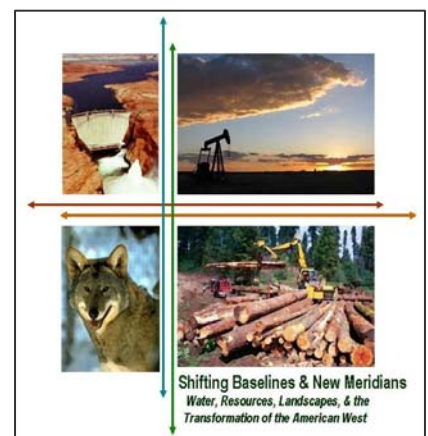

## Recent Events at NRLC

### Colorado River Symposium

On March 21<sup>st</sup>, the Center's Western Water Policy Program brought together four leading Colorado River experts along with an audience of approximately 70 water professionals to discuss "**Securing Environmental Flows on the Colorado River in an Era of Climate Change: Issues, Challenges, and Opportunities.**" Presentations by Brad Udall (Director, NOAA/CU Western Water Assessment), Terry Fulp (Deputy Regional Director U.S. Bureau of Reclamation's Lower Colorado River Basin), Robert Adler (Professor of Law, University of Utah), and Jennifer Pitt (Senior Resource Analyst, Environmental Defense) provided an overview of the complex issues, and set the stage for the follow-up workshop held later that afternoon. The event was part of the Center's long-standing "Hot Topics in Natural Resources" series.

## NRLC RESEARCH

### Oil and Gas Best Management Practices Database Launch Expected Summer 2008

The Center continues to gather resources and partners for its free-access, internet-based oil and gas BMP project. NRLC staff are gleaning environmentally responsible management practices from a variety of government, industry and environmental group documents and websites to populate the database. When it "goes live" this summer, users will be able to search for recommended management practices by a variety of criteria, including:

- general resource categories (such as water quality, vegetation, wildlife);
- more specific categories (such as riparian areas, sage grouse);
- location (such as oil/gas field, state recommending the practice, state in which the practice is being used); and
- through a general text search.

### Water Rights and Climate Change

Several ongoing NRLC projects are focused on the nexus of climate change and western water resources, and in most cases are conducted in part through the Center's partnership with the NOAA/CU Western Water Assessment. Current projects include:

- an examination of the influence of earlier snowmelt on the functioning of prior appropriation water rights (which sometimes include specific calendar dates);
- the opportunities for temporary water transfers that are responsive to climate trends; and
- the future of the Colorado River in a future likely to feature significant reductions in streamflows.

The Center is also contributing to the Colorado Foundation for Water Education's *Citizen's Guide to Climate Change*. Also in development is a second phase of research that will focus on the City of Aurora's efforts to cope with drought [see Kenney, D. et al., 2008. "Residential Water Demand Management: Lessons from Aurora, Colorado." *Journal of the American Water Resources Association*, 44(1):192-207, February.]

### Red Lodge Clearinghouse Website Activities

In May 2007, the Center was awarded the responsibility for the Red Lodge Clearinghouse (RLCH) website by the Liz Claiborne and Art Ortenberg Foundation. In September, **Lauren Ris** joined the Center as Project Manager for the RLCH.

The RLCH website serves a broad community concerned with responsible management of western natural resources. The RLCH's services have included highlighting important resource issues and providing a variety of "how to" advice, legal primers, leads on funding sources, and stories from active collaborative groups. Over the course of the past year, the Center has focused on expanding the RLCH to reach a broader community of users affected by the recent expansion and maturation of collaborative resource management.

One of the developments for the website this year has been the launching of **a series on natural resource problem-solving**. While the RLCH has historically provided resources to those addressing resource conflicts through collaboration, this new focus is to explicitly explore the process of collaboration as well as other approaches that may accompany, enhance, or even replace a collaborative process. Each edition of the series highlights a different way to participate in decision-making including the notice and comment process, public meetings, administrative appeals, alternative dispute resolution litigation, and of course collaboration.

To make the RLCH site more interactive, several new features have been incorporated, including:

- **A Discussion Forum** for posting of comments or asking questions.
- **Enhanced Article Sharing** that allows users to directly forward or print articles without having to copy and paste the URL address into emails.
- **Ability to Rate** that allows site users to provide feedback about the usefulness of materials.
- **RSS feeds** which allows site visitors to subscribe to receive new alerts about site postings.
- **Registering** which provides the option to "register" on for submitting news articles, events, and links.

## Staff Profile



**Doug Kenney** has been with the NRLC since 1996, and is Senior Research Associate and Director of the Western Water Policy Program. Doug not only leads much of the Center's work on water law and policy, but has been instrumental in linking that research to issues of population growth and climate change, in part through his role as Deputy Director of the CU/NOAA Western Water Assessment. He is also a faculty member within the CU Environmental Studies program, a Research Affiliate in CU's Center for Science and Technology Policy Research, and is a CU delegate to the Universities Council on Water Resources.

Doug has written extensively on several water-related issues, including river basin and watershed-level planning, law and policy reform, the design of institutional arrangements, and alternative strategies for solving complex resource issues. Many of these themes featured prominently in a book Doug edited for the Center entitled *In Search of Sustainable Water Management: International Lessons for the American West and Beyond* (2005, Edward Elgar Publishing).

Much on the speaking circuit; at last count, he has given presentations in 20 states, 5 nations, and on 3 continents, and has served in an advisory capacity to U.S. Dept of Interior agencies, EPA, the US Forest Service, special commissions and to state and national governments and NGOs in Asia, Africa and Latin America. Some career highlights include work to defuse interstate water conflicts [Doug remarks "I'm only batting 2 of 4 so far"], meeting with Maasai tribesmen in villages throughout Kenya to discuss wildlife conservation options, and giving lectures about water management to government officials in Seoul and Hanoi. "The great irony," Doug observes, "is that my opinions seem to carry the most weight the further I travel away from the American West, which I'm hoping is more reflective of the intractability of local water issues than my reputation among my western colleagues."

Doug has a B.A. in biology from the Univ. of Colorado, a M.S. in Natural Resources Policy & Administration from the Univ. of Michigan, and a Ph.D. in Renewable Natural Resource Studies from the Univ. of Arizona.

## Environmental Law Society (ELS) Update

On January 31, for *Focus the Nation*—the national climate change awareness day in which over 1,900 institutions participated—the ELS hosted **Vickie Patton**, Deputy General Counsel at Environmental Defense. Ms. Patton delivered a fantastic talk on the dynamic legal landscape of climate change. ELS also hosted a Focus the Nation social event where students calculated their ecological footprints and participated in an environmental trivia contest.

In continuing our Climate Change Education Initiative, ELS hosted attorney and Environmental Studies doctoral student **Marilyn Averill** who discussed her recent trip to the United Nations Climate Change Conference in Bali. While in Bali, Marilyn represented the University of Colorado, which has been approved as an observer organization by the Secretariat for the UN's Framework Convention on Climate Change.

The ELS recently secured a \$41,000 grant from *Sustainable CU – The Environmental Improvement Initiative* to install a solar panel array on the roof of the Wolf Law Building. The ELS is also working with the Dean's Office and Facilities Management to implement standards and policies for operations, events, purchasing, communications, transportation, and grounds to achieve long-term goals of zero-waste, carbon-neutrality, and environmental awareness.
