RATIONALE

Governments, and civil societies, are changing in response to the growing importance of:

- business & industry,
- "not for profits" or non governmental organizations (NGOs), and
- globalization.

This interdisciplinary symposium will address and evaluate such changes. The symposium will begin by tracing the extent, and manner in which, business, NGOs and globalization are changing the geo-political, and socio-economic boundaries of national and international governance. In general, it will raise the questions: Have "not for profits" or NGOs, and market forces, gone too far in diminishing the role of the public sector, and the nation state? Is the prevailing faith in the increasingly important role played by business and NGOs misplaced?

Second, the symposium will undertake four case studies with a view to identifying the functions that each sector is best suited to perform. Specifically, the symposium will employ the prism of environmental policy, science, and law in examining the role played by NGOs in addressing:

- Genetically modified organisms (GMO's);
- Dams;
- Wildlife and Species, &
- Indigenous peoples
