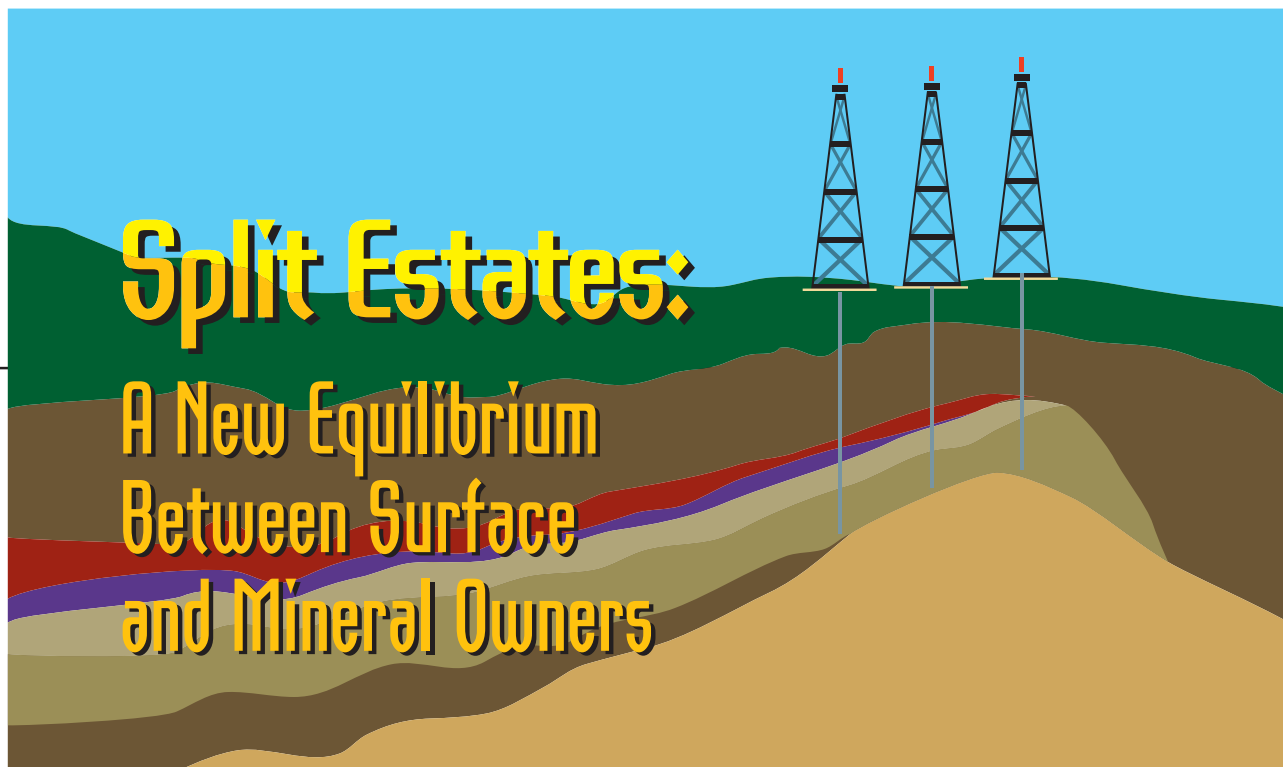

He served as a member of the Council of the Oil, Gas and Mineral Law Section of the State Bar of Texas. He is currently a trustee of the Rocky Mountain Mineral Law Foundation and the Energy and Mineral Law Foundation and chair of the Advisory Board of the Institute of Local Government of the Center of American and International Law. Professor Kramer has published over 25 Law Review articles and has contributed chapters to several legal treatises.
