Backward stochastic differential equations with unbounded generators

Abstract

In this paper we consider two classes of backward stochastic differential equations. Firstly, under a Lipschitz-type condition on the generator of the equation, which can also be unbounded, we give sufficient conditions for the existence of a unique solution pair. The method of proof is that of Picard iterations and the resulting conditions are new. We also prove a comparison theorem. Secondly, under the linear growth and continuity assumptions on the possibly unbounded generator, we prove the existence of the solution pair. This class of equations is more general than the existing ones.

Keywords: BSDEs, Unbounded generator, Existence, Uniqueness, Comparison theorem.

1. Introduction

Let $(\Omega, \mathscr{F}, (\mathscr{F}_t, t \ge 0), \mathbb{P})$ be a given complete filtered probability space on which a k-dimensional standard Brownian motion $(W(t), t \ge 0)$ is defined. We assume that \mathscr{F}_t is the augmentation of $\sigma\{W(s) : 0 \le s \le t\}$ by all the \mathbb{P} -null sets of \mathscr{F} . Consider the backward stochastic differential equation (BSDE):

$$y(t) = \xi + \int_{t}^{T} f(s, y(s), z(s)) ds - \int_{t}^{T} z(s) dW(s), \quad t \in [0, T], \quad (1)$$

where ξ is a given \mathscr{F}_T -measurable \mathbb{R}^d -valued random variable, and the generator $f: \Omega \times (0,T) \times \mathbb{R}^d \times \mathbb{R}^{d \times k} \to \mathbb{R}^d$ is a progressively measurable function.

Linear equations of the type (1) were introduced by Bismut [5] in the context of stochastic linear quadratic control. The problem of existence and uniqueness of solution to the nonlinear equations (1) was solved by Pardaoux and Peng [34] under the global Lipschitz condition on f, i.e. under the assumption that there exists a real constant c > 0 such that

$$|f(t, y_1, z_1) - f(t, y_2, z_2)| \le c(|y_1 - y_2| + |z_1 - z_2|),$$
(2)

for all $y_1, y_2 \in \mathbb{R}^d$, $z_1, z_2 \in \mathbb{R}^{d \times k}$, (t, ω) a.e.. Since then, the BSDEs have been studied extensively, and have found wide applicability in areas such as mathematical finance, stochastic control, and stochastic controllability; see, for example, [10], [17], [29], [31], [42], [37], [20], [21], [22] [41], and the references therein. One direction of research has been to weaken the assumption of global Lipschitz condition (2) by assuming only local Lipschitz condition (see [1]), or non-Lipschitz condition of a particular form (see [30], [39]). In [16] and [12] the authors permit for the generator function f to be unbounded (they also consider a more general driving process than the Brownian motion). They assume the following global Lipschitz-type condition: there exist non-negative processes $c_1(\cdot)$ and $c_2(\cdot)$ such that

$$|f(t, y_1, z_1) - f(t, y_2, z_2)| \le c_1(t)|y_1 - y_2| + c_2(t)|z_1 - z_2|,$$
(3)

for all $y_1, y_2 \in \mathbb{R}^d$, $z_1, z_2 \in \mathbb{R}^{d \times k}$, (t, ω) a.e.. Clearly, this condition has great similarity with (2). However, different from (2), here the processes $c_1(\cdot)$ and $c_2(\cdot)$ are not assumed to be bounded. The linear BSDEs with possibly unbounded coefficients are considered in [43], using a very different approach as compared to [16], [12]. The interest in these equations is not only theoretical, but is also motivated by applications in mathematical finance. Indeed, some very important interest rate models are given by stochastic differential equations (see, for example, [44], [11], [4]). The problem of market completeness (and thus of pricing and hedging of derivatives) in such models gives rise to BSDEs with possibly unbounded coefficients (see [43] for details).

The first contribution of the present paper, as contained in the section 2, is to consider the problem of existence and uniqueness of a solution pair $(y(\cdot), z(\cdot))$ for (1) under condition (3). We do so under certain new conditions on the coefficients $c_1(\cdot), c_2(\cdot)$, which are similar to those of [16], but in general are not comparable. Moreover, our method of proof is different, since it is a modification of the Picard iteration procedure of [34] rather than being based on a fixed point theorem as in [16]. We also give a comparison theorem for

this class of equations. This generalises the classical result of Peng [35], [36], to the case of BSDEs with possibly unbounded coefficients.

Another important weakening of the assumptions on the generator, as compared to [34], was given in [27] (see also [23]). There it assumed that the generator is continuous with respect to y and z, and it satisfies the linear growth condition

$$|f(t, y, z)| \le c(1 + |y| + |z|), \tag{4}$$

for all $y \in \mathbb{R}$, $z \in \mathbb{R}^k$, (t, ω) a.e.. Under such conditions, it was shown that equation (1) admits a solution pair. In more recent papers [39], [40], the linear growth condition (4) has been generalised to

$$|f(t, y, z)| \le c[q(t) + |y| + |z|],$$
(5)

for all $y \in \mathbb{R}$, $z \in \mathbb{R}^k$, (t, ω) a.e.. Here, different from (4), the process $q(\cdot)$ is not assumed to be bounded.

The generator of BSDEs with a *quadratic* growth on the control variable z satisfies the condition:

$$|f(t, y, z)| \le k_0 + k_1 |y| + k_2 |z|^2.$$
(6)

An existence result for these equations was first given in [19] where k_0 and k_1 are constant, k_2 is a given function of y, and the terminal value ξ is assumed bounded. In [6], [7], the assumption of a bounded ξ was replaced with an integrability condition on the exponential of ξ , k_0 was permitted to be an unbounded process, whereas k_1 and k_2 were assumed constant (see further, for example, [2], [8], [9], [13], [14], [45], where a nonlinear growth in y is also permitted in some cases). In [3], [18], [32], [33], the coefficient k_1 could also be an unbounded process. Under further assumptions on f, the uniqueness of the solution pair has been proved (see, for example, [9], [13], [14]). We are not aware of an existence result for these types of BSDEs with coefficient k_2 being an unbounded process.

The second contribution of the present paper, which is contained in section 3, is to consider a generator which is continuous in y and z, but with a weaker linear growth condition than (5). We assume that

$$|f(t, y, z)| \le c_0(t) + c_1(t)|y| + c_2(t)|z|,$$
(7)

for all $y \in \mathbb{R}$, $z \in \mathbb{R}^k$, (t, ω) a.e.. Here the processes $c_0(\cdot), c_1(\cdot), c_2(\cdot)$, are not assumed to be bounded. By using the results of section 2, and appropriately modifying the approach of [2], [27], we prove the existence of a solution pair for (1). Note that due to the unbounded nature of the process $c_2(t)$, conditions (6) and (7) are in general not comparable if k_2 is a constant.

We conclude this introductory section with some notations:

- $|\cdot|$ is the Euclidian norm.
- $c_0(\cdot), c_1(\cdot), c_2(\cdot)$ are given \mathbb{R} -valued progressively measurable processes.

• $\gamma(\cdot), \overline{\gamma(\cdot)}$ and $\gamma(\cdot)$ are given \mathbb{R} -valued positive progressively measurable processes.

- $1 < \beta_1, \widetilde{\beta}_1 \in \mathbb{R}, 1 < \beta_2, \widetilde{\beta}_2 \in \mathbb{R}$, are given constants.
- $4 < \overline{\beta}_1 \in \mathbb{R}, 1 < 90\overline{\beta_1}^2/(\overline{\beta_1}^2 16) < \overline{\beta_2} \in \mathbb{R}$, are given constants.

• $\alpha_1(t) \equiv \gamma(t) + \beta_1 c_1^2(t) + \beta_2 c_2^2(t), \ \alpha_2(t) \equiv \overline{\gamma(t)} + \overline{\beta_1} c_1(t) + \overline{\beta_2} c_2^2(t)$, and $\widetilde{\alpha}(t) \equiv \gamma(t) + \widetilde{\beta_1} c_1^2(t) + \widetilde{\beta_2} c_2^2(t)$ are assumed positive.

•
$$p_1(t) \equiv \exp\left[\int_0^t \alpha_1(s)ds\right], \ p_2(t) \equiv \exp\left[\int_0^t \alpha_2(s)ds\right] \text{ and } \widetilde{p}(t) \equiv \exp\left[\int_0^t \widetilde{\alpha}(s)ds\right]$$

• $L_{\mathscr{F}}(0,T;\mathbb{R}^d)$ is the space of \mathscr{F}_t -progressively measurable \mathbb{R}^d -valued processes $\varphi(\cdot)$ such that $\mathbb{E}\int_0^T |\varphi(t)| dt < \infty$.

• $M^2(\Omega, \mathscr{F}_T, \mathbb{P}; \mathbb{R}^d)$ is the space of all \mathscr{F}_T -measurable \mathbb{R}^d -valued random variables ζ such that $\mathbb{E}[|\zeta|^2] < \infty$.

• $M^2(0,T;\mathbb{R}^d)$ is the space of \mathscr{F}_t -progressively measurable \mathbb{R}^d -valued processes $\varphi(\cdot)$ such that $\mathbb{E} \int_0^T |\varphi(t)|^2 dt < \infty$.

• $\widehat{M_i}^2(\Omega, \mathscr{F}_T, \mathbb{P}; \mathbb{R}^d)$ (resp. $\widetilde{M}^2(\Omega, \mathscr{F}_T, \mathbb{P}; \mathbb{R}^d)$) is the space of all \mathscr{F}_T -measurable \mathbb{R}^d -valued random variables ξ such that $\mathbb{E}[p_i(T)|\xi|^2] < \infty$ (resp. $\mathbb{E}[\widetilde{p}(T)|\xi|^2] < \infty$), i = 1, 2.

• $\widehat{M_i}^2(0,T;\mathbb{R}^d)$ (resp. $\widetilde{M}^2(0,T;\mathbb{R}^d)$) is the space of \mathscr{F}_t -progressively measurable \mathbb{R}^d -valued processes $\varphi(\cdot)$ such that $\mathbb{E}\int_0^T p_i(t)|\varphi(t)|^2 dt < \infty$ (reps. $\widetilde{\|\varphi\|} \equiv \mathbb{E}\int_0^T \widetilde{p}(t)|\varphi(t)|^2 dt < \infty$), i = 1, 2.

• $\widehat{H}_i^2(0,T;\mathbb{R}^d)$ (resp. $\widetilde{H}^2(0,T;\mathbb{R}^d)$) is the space of càdlàg \mathscr{F}_t -adapted \mathbb{R}^d -valued processes $\varphi(\cdot)$ such that $\mathbb{E}\left[\sup_{t\in[0,T]}p_i(t)|\varphi(t)|^2\right]<\infty$ (resp. $\mathbb{E}\left[\sup_{t\in[0,T]}\widetilde{p}(t)|\varphi(t)|^2\right]<\infty$), i=1,2.

2. Unbounded Lipschitz-type generator

In this section, we give sufficient conditions for the existence and uniqueness of a solution pair for (1). We say that the progressively measurable function f and the random variable ξ , or the pair (f, ξ) , satisfies *conditions* A1 (resp. *conditions* A2) if:

(i)
$$\xi \in \widehat{M}_1^2(\Omega, \mathscr{F}_T, \mathbb{P}; \mathbb{R}^d)$$
 (resp. $\xi \in \widehat{M}_2^2(\Omega, \mathscr{F}_T, \mathbb{P}; \mathbb{R}^d)$);

(ii) $|f(t, y_1, z_1) - f(t, y_2, z_2)| \le c_1(t)|y_1 - y_2| + c_2(t)|z_1 - z_2|$, for all $y_1, y_2 \in \mathbb{R}^d$, $z_1, z_2 \in \mathbb{R}^{d \times k}$, (t, ω) a.e.;

(iii)
$$\left[f(\cdot,0,0)\alpha_1(\cdot)^{-\frac{1}{2}}\right] \in \widehat{M}_1^2(0,T;\mathbb{R}^d) \text{ (resp. } \left[f(\cdot,0,0)\alpha_2(\cdot)^{-\frac{1}{2}}\right] \in \widehat{M}_2^2(0,T;\mathbb{R}^d))$$

The sufficient conditions for the solvability of (1), as given in [16], are similar to our conditions A2. Indeed, if we choose $\overline{\gamma}(t) = 0$, $\overline{\beta}_1 = \overline{\beta}_2 \equiv \beta$, where β is *large enough*, then conditions A2 are those of [16]. Clearly, due to the process $\overline{\gamma}(t)$ our conditions A2 are more general then those of [16]. The importance of this process is that assumption (iii) above can be suitable weakened by choosing large values for this process, which is not an option in [16]. Moreover, even if we take $\overline{\gamma}(t) = 0$, our assumption (i) is weaker than that of [16]. Indeed, the parameter β of [16] should be bigger than 446.05 (in [16] it is only claimed that this coefficient should be *large enough*²). This is clearly not the case in conditions A2 where the coefficient $\overline{\beta}_1$ is only required to be greater than 4.

The conditions A1 are new. In general, these are not comparable with conditions A2. However, in certain special cases we can compare them. For

example, if $c_1(t) = 0$, $1 < \beta_2 < \overline{\beta}_2$, $\gamma(t) = \overline{\gamma}(t)$, then $\widehat{M}_1^2(\Omega, \mathscr{F}_T, \mathbb{P}; \mathbb{R}^d) \subset \widehat{M}_2^2(\Omega, \mathscr{F}_T, \mathbb{P}; \mathbb{R}^d)$, and thus the above assumption (i) on the random variable ξ is weaker in the case of conditions A1. Similarly, if $c_2(t) = 0$, $\gamma(t) = \overline{\gamma}(t)$, $\overline{\beta}_1 = 2\beta_1$, then the above assumption (i) on the random variable ξ is weaker in the case of conditions A2.

2.1. Solvability

In this section we give sufficient conditions for the existence and uniqueness of a solution pair for (1). Our method of proof is different from [16] being based on Picard iterations, and similarly to [34], we begin with a simpler form of (1) and progress towards the general case. The proofs of the results under conditions A1 and A2 are different and are thus given separately in most cases, but there are also similarities between them.

Lemma 2.1. Let $\phi(\cdot) \in \widehat{H}_1^2(0,T;\mathbb{R}^d)$, $\psi(\cdot) \in \widehat{M}_1^2(0,T;\mathbb{R}^{d\times k})$ be given, and assume that $\sqrt{\alpha_1(\cdot)}\phi(\cdot) \in \widehat{M}_1^2(0,T;\mathbb{R}^d)$. If the pair (f,ξ) satisfies the conditions A1, then:

(i) there exists a unique solution pair $(y(\cdot), z(\cdot)) \in \widehat{H}_1^2(0, T; \mathbb{R}^d) \times \widehat{M}_1^2(0, T; \mathbb{R}^{d \times k})$ of equation

$$y(t) = \xi + \int_{t}^{T} f(s, \phi(s), \psi(s)) ds - \int_{t}^{T} z(s) dW(s), \quad t \in [0, T], \quad (8)$$

and $\sqrt{\alpha_1(\cdot)}y(\cdot) \in \widehat{M}_1^2(0,T;\mathbb{R}^d).$

(ii) if $y^+(t) \equiv \mathbb{1}_{[y(t)>0]}y(t)$, the processes

$$\int_t^T p_1(s)y(s)z(s)dW(s) \quad and \quad \int_t^T p_1(s)y^+(s)z(s)dW(s),$$

are martingales.

Proof. (i) By making use of the Cauchy-Schwartz inequality, we first show

$$\begin{aligned} & \text{that } \int_{0}^{T} f(s,\phi(s),\psi(s))ds \text{ belongs to } M^{2}(\Omega,\mathscr{F}_{T},\mathbb{P};\mathbb{R}^{d}):\\ & \mathbb{E}\left|\int_{0}^{T} f(s,\phi(s),\psi(s))ds\right|^{2} = \mathbb{E}\left|\int_{0}^{T} \sqrt{p_{1}^{-1}(s)\alpha_{1}(s)} \frac{\sqrt{p_{1}(s)}f(s,\phi(s),\psi(s))}{\sqrt{\alpha_{1}(s)}}ds\right|^{2} \\ &\leq \mathbb{E}\left\{\left[\int_{0}^{T} p_{1}^{-1}(s)\alpha_{1}(s)ds\right]\left[\int_{0}^{T} \frac{p_{1}(s)|f(s,\phi(s),\psi(s))|^{2}}{\alpha_{1}(s)}ds\right]\right\} \\ &\leq \mathbb{E}\int_{0}^{T} \frac{p_{1}(s)|f(s,\phi(s),\psi(s))|^{2}}{\alpha_{1}(s)}ds \end{aligned} \tag{9} \\ &= \mathbb{E}\int_{0}^{T} \frac{p_{1}(s)}{\alpha_{1}(s)}|f(s,\phi(s),\psi(s)-f(s,0,0)+f(s,0,0)|^{2}ds \\ &\leq \mathbb{E}\int_{0}^{T} \frac{p_{1}(s)}{\alpha_{1}(s)}[|f(s,\phi(s),\psi(s)-f(s,0,0)|+|f(s,0,0)|]^{2}ds \\ &\leq \mathbb{E}\int_{0}^{T} \frac{p_{1}(s)}{\alpha_{1}(s)}[c_{1}(s)]\phi(s)|+c_{2}(s)|\psi(s)|+|f(s,0,0)|]^{2}ds \\ &\leq \mathbb{E}\int_{0}^{T} \frac{p_{1}(s)}{\alpha_{1}(s)}[3c_{1}^{2}(s)]\phi(s)|^{2}+3c_{2}^{2}(s)|\psi(s)|^{2}+3|f(s,0,0)|^{2}|ds \\ &= \mathbb{E}\int_{0}^{T} \frac{3p_{1}(s)}{\beta_{1}} \frac{\beta_{1}c_{1}^{2}(s)}{\gamma(s)+\beta_{1}c_{1}^{2}(s)+\beta_{2}c_{2}^{2}(s)}|\phi(s)|^{2}ds + \frac{3p_{1}(s)}{\beta_{2}} \frac{\beta_{2}c_{2}^{2}(s)}{\gamma(s)+\beta_{1}c_{1}^{2}(s)+\beta_{2}c_{2}^{2}(s)}|\psi(s)|^{2}ds \\ &+ 3\mathbb{E}\int_{0}^{T} \frac{p_{1}(s)|f(s,0,0)|^{2}}{\alpha_{1}(s)}ds \\ &\leq \frac{3}{\beta_{1}}\mathbb{E}\int_{0}^{T} p_{1}(s)|\phi(s)|^{2}ds + \frac{3}{\beta_{2}}\mathbb{E}\int_{0}^{T} p_{1}(s)|\psi(s)|^{2}ds + 3\mathbb{E}\int_{0}^{T} \frac{p_{1}(s)|f(s,0,0)|^{2}}{\alpha_{1}(s)}ds < \infty \end{aligned}$$

Since $\xi \in \widehat{M}_1^2(\Omega, \mathscr{F}_T, \mathbb{P}; \mathbb{R}^d)$ implies that $\xi \in M^2(\Omega, \mathscr{F}_T, \mathbb{P}; \mathbb{R}^d)$, it follows from Lemma 2.1 of [34] that (8) has a unique solution pair $(y(\cdot), z(\cdot)) \in$ $M^2(0, T; \mathbb{R}^d) \times M^2(0, T; \mathbb{R}^{d \times k})$. Moreover, since we proved that (9) is finite, it follows from Lemma 6.2 ³ of [16] that in fact $(y(\cdot), z(\cdot)) \in \widehat{H}_1^2(0, T; \mathbb{R}^d) \times \widehat{M}_1^2(0, T; \mathbb{R}^{d \times k})$ and $[\sqrt{\alpha_1(\cdot)}y(\cdot)] \in \widehat{M}_1^2(0, T; \mathbb{R}^d)$.

(ii) The proof follows closely that in [46] (pp. 307), and since it is short, we include it here for completeness. From the Burkholder-Davis-Gundy inequality (see, for example, Theorem 1.5.4 in [42]), there exists a constant K such that

$$\mathbb{E}\left[\sup_{t\in[0,T]}\left|\int_{0}^{t}p_{1}(s)y(s)z(s)dW(s)\right|\right] \leq K\mathbb{E}\left[\int_{0}^{T}|\sqrt{p_{1}(s)}y(s)|^{2}|\sqrt{p_{1}(s)}z(s)|^{2}ds\right]^{\frac{1}{2}}$$
$$\leq K\mathbb{E}\left[\sup_{t\in[0,T]}|\sqrt{p_{1}(t)}y(t)|^{2}\int_{0}^{T}\sqrt{p_{1}(s)}z(s)|^{2}ds\right]^{\frac{1}{2}}$$
$$\leq \frac{K}{2}\mathbb{E}\left[\sup_{t\in[0,T]}|\sqrt{p_{1}(t)}y(t)|^{2}+\int_{0}^{T}|\sqrt{p_{1}(s)}z(s)|^{2}ds\right] < \infty,$$

where the last step follows from the fact that $y(\cdot) \in \widehat{H}_1^2(0,T;\mathbb{R}^d), z(\cdot) \in \widehat{M}_1^2(0,T;\mathbb{R}^{d\times k})$, proved in part (i). The conclusion then follows from Corollary 7.22 of [26]. Since $\sup_{t\in[0,T]} |\sqrt{p_1(t)}y^+(t)|^2 \leq \sup_{t\in[0,T]} |\sqrt{p_1(t)}y(t)|^2$, the conclusion follows even for $\int_0^t p_1(s)y^+(s)z(s)dW(s)$.

Lemma 2.2. Let $\phi(\cdot) \in \widehat{H}_2^2(0,T;\mathbb{R}^d)$, $\psi(\cdot) \in \widehat{M}_2^2(0,T;\mathbb{R}^{d\times k})$ be given, and assume that $\sqrt{\alpha_2(\cdot)}\phi(\cdot) \in \widehat{M}_2^2(0,T;\mathbb{R}^d)$. If the pair (f,ξ) satisfies the conditions A2, then:

(i) there exists a unique solution pair $(y(\cdot), z(\cdot)) \in \widehat{H}_2^2(0, T; \mathbb{R}^d) \times \widehat{M}_2^2(0, T; \mathbb{R}^{d \times k})$ of equation

$$y(t) = \xi + \int_t^T f(s, \phi(s), \psi(s)) ds - \int_t^T z(s) dW(s), \quad t \in [0, T],$$
(10)
and $\sqrt{\alpha_2(\cdot)} y(\cdot) \in \widehat{M}_2^2(0, T; \mathbb{R}^d).$

(ii) if $y^+(t) \equiv \mathbb{1}_{[y(t)>0]}y(t)$, the processes $\int_t^T p_2(s)y(s)z(s)dW(s) \quad and \quad \int_t^T p_2(s)y^+(s)z(s)dW(s),$

are martingales.

Proof. The proof of part (ii) is the same as the proof of part (ii) of the previous lemma. We thus focus on part (i). We have

$$\begin{split} &-d\,p_{2}(t)|y_{1}(t)-y_{2}(t)|^{2} \\ \leq [-\alpha_{2}(t)p_{2}(t)|y_{1}(t)-y_{2}(t)|^{2}-p_{2}(t)|z_{1}(t)-z_{2}(t)|^{2}]dt - 2p_{2}(t)(y_{1}(t)-y_{2}(t))'(z_{1}(t)-z_{2}(t))dW(t) \\ &+ 2p_{2}(t)|y_{1}(t)-y_{2}(t)|\left[c_{1}(t)|y_{1}(t)-y_{2}(t)\right]+c_{2}(t)|z_{1}(t)-z_{2}(t)|\right]dt \\ \leq [-\alpha_{2}(t)p_{2}(t)|y_{1}(t)-y_{2}(t)|^{2}-p_{2}(t)|z_{1}(t)-z_{2}(t)|^{2}]dt - 2p_{2}(t)(y_{1}(t)-y_{2}(t))'(z_{1}(t)-z_{2}(t))dW(t) \\ &+ 2c_{1}p_{2}(t)|y_{1}(t)-y_{2}(t)|^{2}dt + \overline{\beta_{2}}c_{2}^{2}p_{2}(t)|y_{1}(t)-y_{2}(t)|^{2}dt + \overline{\beta_{2}}^{-1}p_{2}(t)|z_{1}(t)-z_{2}(t)|^{2}dt \\ \leq (\beta_{2}^{-1}-1)p_{2}(t)|z_{1}(t)-z_{2}(t)|^{2}dt - 2p_{2}(t)(y_{1}(t)-y_{2}(t))'(z_{1}(t)-z_{2}(t))dW(t) \\ \leq -2p_{2}(t)(y_{1}(t)-y_{2}(t))'(z_{1}(t)-z_{2}(t))dW(t). \end{split}$$

Then the expectation of integral-form of this inequality becomes

$$\mathbb{E}\left[p_2(t)|y_1(t) - y_2(t)|^2\right] \le \mathbb{E}\left[\int_t^T -2p_2(s)(y_1(s) - y_2(s))'(z_1(s) - z_2(s))dW(s)\right].$$

Since the right-hand side is a martingale by Lemma 2.1 (ii), the conclusion follows.

(*Existence*) Let $y_0(t) \equiv 0, \forall t \in [0, T]$, and for $n \ge 1$ consider the sequence of equations:

$$y_n(t) = \xi + \int_t^T f(s, y_{n-1}(s), z_n(s)) ds - \int_t^T z_n(s) dW(s), \quad t \in [0, T].$$
(17)

From Lemma 2.3 we know that these equations have unique solution pairs $\{(y_n(\cdot), z_n(\cdot)) \in \widehat{H}_2^2(0, T; \mathbb{R}^d) \times \widehat{M}_2^2(0, T; \mathbb{R}^{d \times k})\}_{n \ge 1}$. By Lemma 6.2 of [16], we have following estimates:

$$\mathbb{E}\left[\int_{0}^{T} p_{2}(t)|y_{n+1}(t) - y_{n}(t)|^{2}\alpha_{2}(t)dt\right] \\
\leq 8 \mathbb{E}\left[\int_{0}^{T} p_{2}(t)\frac{|f(t, y_{n}(t), z_{n+1}(t)) - f(t, y_{n-1}(t), z_{n}(t))|^{2}}{\alpha_{2}(t)}dt\right],$$
(18)

and

$$\mathbb{E}\left[\int_{0}^{T} p_{2}(t)|z_{n+1}(t) - z_{n}(t)|^{2}dt\right] \leq 45 \mathbb{E}\left[\int_{0}^{T} p_{2}(t)\frac{|f(t, y_{n}(t), z_{n+1}(t)) - f(t, y_{n-1}(t), z_{n}(t))|^{2}}{\alpha_{2}(t)}dt\right].$$
(19)

By the Lipschitz condition, we have

$$\begin{split} & \mathbb{E}\left[\int_{0}^{T} p_{2}(t) \frac{|f(t, y_{n}(t), z_{n+1}(t)) - f(t, y_{n-1}(t), z_{n}(t))|^{2}}{\alpha_{2}(t)} dt\right] \\ &\leq \mathbb{E}\int_{0}^{T} \frac{p_{2}(t)}{\alpha_{2}(t)} [c_{1}(t)|y_{n}(t) - y_{n-1}(t)| + c_{2}(t)|z_{n+1}(t) - z_{n}(t)|]^{2} dt \\ &\leq 2\mathbb{E}\int_{0}^{T} \frac{p_{2}(t)}{\alpha_{2}(t)} [c_{1}^{2}(t)|y_{n}(t) - y_{n-1}(t)|^{2} + c_{2}^{2}(t)|z_{n+1}(t) - z_{n}(t)|^{2}] dt \\ &\leq 2\mathbb{E}\int_{0}^{T} \frac{p_{2}(t)}{\beta_{1}^{2}} \frac{\overline{\beta_{1}}c_{1}(t)}{\overline{\gamma(t)} + \overline{\beta_{1}}c_{1}(t) + \overline{\beta_{2}}c_{2}^{2}(t)} (\overline{\gamma(t)} + \overline{\beta_{1}}c_{1}(t) + \overline{\beta_{2}}c_{2}^{2}(t))|y_{n}(t) - y_{n-1}(t)|^{2} dt \\ &\quad + 2\mathbb{E}\int_{0}^{T} \frac{p_{2}(t)}{\overline{\beta_{2}}} \frac{\overline{\beta_{2}}c_{2}^{2}(t)}{\overline{\gamma(t)} + \overline{\beta_{1}}c_{1}(t) + \overline{\beta_{2}}c_{2}^{2}(t)} |z_{n+1}(t) - z_{n}(t)|]^{2} ds \\ &\leq \frac{2}{\overline{\beta_{1}}^{2}} \mathbb{E}\int_{0}^{T} p_{2}(t)\alpha_{2}(t)|y_{n}(t) - y_{n-1}(t)|^{2} dt + \frac{2}{\overline{\beta_{2}}}\mathbb{E}\int_{0}^{T} p_{2}(t)|z_{n+1}(t) - z_{n}(t)|]^{2} dt. \end{split}$$

Substituting it into (19), we have

$$\mathbb{E}\left[\int_{0}^{T} p_{2}(t)|z_{n+1}(t) - z_{n}(t)|^{2}dt\right]$$

$$\leq \frac{90}{\overline{\beta_{1}}^{2}} \mathbb{E}\int_{0}^{T} p_{2}(t)\alpha_{2}(t)|y_{n}(t) - y_{n-1}(t)|^{2}dt + \frac{90}{\overline{\beta_{2}}} \mathbb{E}\int_{0}^{T} p_{2}(t)|z_{n+1}(t) - z_{n}(t)|]^{2}dt.$$

Let $\overline{\beta_2} > 90$. Then we have

$$\mathbb{E}\left[\int_{0}^{T} p_{2}(t)|z_{n+1}(t) - z_{n}(t)|^{2}dt\right] \leq \frac{\frac{90}{\overline{\beta_{1}}^{2}}}{\left(1 - \frac{90}{\overline{\beta_{2}}}\right)} \mathbb{E}\int_{0}^{T} p_{2}(t)\alpha_{2}(t)|y_{n}(t) - y_{n-1}(t)|^{2}dt.$$
(20)

Substituting it into (19), we obtain

$$\begin{split} & \mathbb{E}\left[\int_{0}^{T} p_{2}(t)|y_{n+1}(t) - y_{n}(t)|^{2}\alpha_{2}(t)dt\right] \\ \leq & \frac{16}{\overline{\beta_{1}}^{2}} \mathbb{E}\int_{0}^{T} p_{2}(t)\alpha_{2}(t)|y_{n}(t) - y_{n-1}(t)|^{2}dt + \frac{16}{\overline{\beta_{2}}} \mathbb{E}\int_{0}^{T} p_{2}(t)|z_{n+1}(t) - z_{n}(t)|]^{2}dt \\ \leq & \frac{16}{\overline{\beta_{1}}^{2}} \mathbb{E}\int_{0}^{T} p_{2}(t)\alpha_{2}(t)|y_{n}(t) - y_{n-1}(t)|^{2}dt + \frac{16}{\overline{\beta_{2}}}\frac{\frac{90}{\overline{\beta_{1}}^{2}}}{\left(1 - \frac{90}{\overline{\beta_{2}}}\right)} \mathbb{E}\int_{0}^{T} p_{2}(t)\alpha_{2}(t)|y_{n}(t) - y_{n-1}(t)|^{2}dt \end{split}$$

$$= \left[\frac{16}{\overline{\beta_1}^2} + \frac{16}{\overline{\beta_2}} \frac{\frac{90}{\overline{\beta_1}^2}}{\left(1 - \frac{90}{\overline{\beta_2}}\right)}\right] \mathbb{E} \int_0^T p_2(t)\alpha_2(t)|y_n(t) - y_{n-1}(t)|^2 dt.$$

Let $\kappa = \left[\frac{16}{\overline{\beta_1}^2} + \frac{16}{\overline{\beta_2}} \frac{\frac{90}{\overline{\beta_1}^2}}{\left(1 - \frac{90}{\overline{\beta_2}}\right)}\right]$, i.e. $\overline{\beta}_1 > 4$ and $\overline{\beta}_2 > \frac{90\overline{\beta}_1^2}{\overline{\beta_1}^2 - 16}$. Then the conclusion follows similarly to the proof of existence in Lemma 2.3.

2.2. Comparison theorem

The following results generalise Peng's comparison theorem ([35], [36]) to equations with a possibly unbounded generator. Similarly to [35], [36], we assume that d = 1. In addition to equation (1), let us consider two further equations

$$\widehat{y}_{1}(t) = \widehat{\xi}_{1} + \int_{t}^{T} [\widehat{f}_{1}(s, \widehat{y}_{1}(s), \widehat{z}_{1}(s))] ds - \int_{t}^{T} \widehat{z}_{1}(s) dW(s), \quad t \in [0, T],$$

$$\widehat{y}_{2}(t) = \widehat{\xi}_{2} + \int_{t}^{T} [\widehat{f}_{2}(s, \widehat{y}_{2}(s), \widehat{z}_{2}(s))] ds - \int_{t}^{T} \widehat{z}_{2}(s) dW(s), \quad t \in [0, T].$$

We assume that the pair $(\hat{f}_1, \hat{\xi}_1)$ satisfies conditions A1, whereas the pair $(\hat{f}_2, \hat{\xi}_2)$ satisfies conditions A2. Based on Theorem 2.1, this means that there exist unique solution pairs $(\hat{y}_1(\cdot), \hat{z}_1(\cdot)) \in \hat{H}_1^2(0, T; \mathbb{R}) \times \widehat{M}_1^2(0, T; \mathbb{R}^{1 \times k})$ and $(\hat{y}_2(\cdot), \hat{z}_2(\cdot)) \in \hat{H}_2^2(0, T; \mathbb{R}) \times \widehat{M}_2^2(0, T; \mathbb{R}^{1 \times k})$. The following differences will appear in the proof:

$$\begin{aligned} Y_1(t) &\equiv y(t) - \hat{y}_1(t), \quad Z_1(t) \equiv z(t) - \hat{z}_1(t), \\ Y_2(t) &\equiv y(t) - \hat{y}_2(t), \quad Z_2(t) \equiv z(t) - \hat{z}_2(t). \end{aligned}$$

Theorem 2.2. (Comparison theorem) (i) If $\widehat{\xi}_1 \geq \xi$ and $\widehat{f}_1(t, y, z) \geq f(t, y, z)$, a.s. $\forall (t, y, z) \in [0, T] \times \mathbb{R} \times \mathbb{R}^{1 \times k}$, then $\widehat{y}_1(t) \geq y(t)$, $\forall t \in [0, T]$, a.s..

(ii) If $\hat{\xi}_2 \geq \xi$ and $\hat{f}_2(t, y, z) \geq f(t, y, z)$, a.s. $\forall (t, y, z) \in [0, T] \times \mathbb{R} \times \mathbb{R}^{1 \times k}$, then $\hat{y}_2(t) \geq y(t)$, $\forall t \in [0, T]$, a.s..

Proof. (i) The equation of the difference $Y_1(t)$ is

$$-dY_1(t) = [f(t, y(t), z(t)) - \hat{f}_1(t, \hat{y}_1(t), \hat{z}_1(t))]dt - Z_1(t)dW(t).$$

Denoting by $Y_1^+(t) \equiv \mathbb{1}_{[Y_1(t)>0]}Y_1(t)$, and using Tanaka-Meyer formula (see Theorem 6.1.2 in [38]), we obtain

$$-dY_1^+(t) = -\mathbb{1}_{[Y_1(t)>0]}dY_1(t) - \frac{1}{2}dL(t),$$

where L(t) is the local time of $Y_1(\cdot)$ at 0. Since $\int_0^T |Y_1(t)| dL(t) = 0$, a.s. (see Proposition 6.1.3 in [38]), we have

$$-d[Y_1^+(t)]^2 = 2Y_1^+(t)\mathbb{1}_{[Y_1(t)>0]}[f(t,y(t),z(t)) - \widehat{f}_1(t,\widehat{y}_1(t),\widehat{z}_1(t))]dt$$
$$-\mathbb{1}_{[Y_1(t)>0]}Z_1^2(t)dt - \mathbb{1}_{[Y_1(t)>0]}2Y_1^+(t)Z_1(t)dW(t).$$

Using Itô formula, we obtain

$$\begin{split} &-dp_{1}(t)[Y_{1}^{+}(t)]^{2} \\ = &-\alpha_{1}(t)p_{1}(t)[Y_{1}^{+}(t)]^{2}dt + 2p_{1}(t)Y_{1}^{+}(t)\mathbb{1}_{[Y_{1}(t)>0]}[f(t,y(t),z(t)) - \hat{f}_{1}(t,\hat{y}_{1}(t),\hat{z}_{1}(t))]dt \\ &-\mathbb{1}_{[Y_{1}(t)>0]}p_{1}(t)Z_{1}^{2}(t)dt - 2p_{1}(t)Y_{1}^{+}(t)Z_{1}(t)dW(t) \\ \leq &-\alpha_{1}(t)p_{1}(t)[Y_{1}^{+}(t)]^{2}dt + 2p_{1}(t)Y_{1}^{+}(t)\mathbb{1}_{[Y_{1}(t)>0]}[f(t,y(t),z(t)) - \hat{f}_{1}(t,y(t),z(t)) \\ &+ \hat{f}_{1}(t,y(t),z(t)) - \hat{f}_{1}(t,\hat{y}_{1}(t),\hat{z}_{1}(t))]dt \\ &-\mathbb{1}_{[Y_{1}(t)>0]}p_{1}(t)Z_{1}^{2}(t)dt - 2p_{1}(t)Y_{1}^{+}(t)Z_{1}(t)dW(t) \\ \leq &[-\alpha_{1}(t)p_{1}(t)[Y_{1}^{+}(t)]^{2} + 2p_{1}(t)Y_{1}^{+}(t)\mathbb{1}_{[Y_{1}(t)>0]}[f(t,y(t),z(t)) - \hat{f}_{1}(t,y(t),z(t))] \\ &-\mathbb{1}_{[Y_{1}(t)>0]}p_{1}(t)Z_{1}^{2}(t)]dt - \mathbb{1}_{[Y_{1}(t)>0]}2p_{1}(t)Y_{1}^{+}(t)Z_{1}(t)dW(t) + \beta_{1}p_{1}(t)c_{1}^{2}(t)[Y_{1}^{+}(t)]^{2}dt \\ &+ \beta_{1}^{-1}p_{1}(t)[Y_{1}^{+}(t)]^{2}dt + \beta_{2}c_{2}^{2}(t)p_{1}(t)[Y_{1}^{+}(t)]^{2}dt + \beta_{2}^{-1}\mathbb{1}_{[Y_{1}(t)>0]}p_{1}(t)Z_{1}^{2}(t)dt \\ \leq &\beta_{1}^{-1}p_{1}(t)[Y_{1}^{+}(t)]^{2}dt - 2p_{1}(t)Y_{1}^{+}(t)Z_{1}(t)dW(t), \end{split}$$

which in integral form becomes

$$p_1(t)[Y_1^+(t)]^2 \le \int_t^T \beta_1^{-1} p_1(s)[Y_1^+(s)]^2 ds - \int_t^T 2p_1(s)Y_1^+(s)Z_1(s)dW(s).$$

The stochastic integral on the right-hand side is a martingale due to Lemma 2.1 (ii). Therefore,

$$\mathbb{E}[p_1(t)[Y_1^+(t)]^2] \le \mathbb{E}\int_t^T \beta_1^{-1} p_1(s)[Y_1^+(s)]^2 ds,$$

and the conclusion follows from Gronwall's lemma.

(ii) In a similar way to the proof of part (i), we have

$$\begin{split} &-dp_{2}(t)[Y_{2}^{+}(t)]^{2} \\ &= -\alpha_{2}(t)p_{2}(t)[Y_{2}^{+}(t)]^{2}dt + 2p_{2}(t)Y_{2}^{+}(t)\mathbb{1}_{[Y_{2}(t)>0]}[f(t,y(t),z(t)) - \hat{f}_{2}(t,\hat{y}_{2}(t),\hat{z}_{2}(t))]dt \\ &-\mathbb{1}_{[Y_{2}(t)>0]}p_{2}(t)Z_{2}^{2}(t)dt - 2p_{2}(t)Y_{2}^{+}(t)Z_{2}(t)dW(t) \\ &\leq -\alpha_{2}(t)p_{2}(t)[Y_{2}^{+}(t)]^{2}dt + 2p_{2}(t)Y_{2}^{+}(t)\mathbb{1}_{[Y_{2}(t)>0]}[f(t,y(t),z(t)) - \hat{f}_{2}(t,y(t),z(t)) \\ &+ \hat{f}_{2}(t,y(t),z(t)) - \hat{f}_{2}(t,\hat{y}_{2}(t),\hat{z}_{2}(t))]dt \\ &-\mathbb{1}_{[Y_{2}(t)>0]}p_{2}(t)Z_{2}^{2}(t)dt - 2p_{2}(t)Y_{2}^{+}(t)Z_{2}(t)dW(t) \\ &\leq [-\alpha_{2}(t)p_{2}(t)[Y_{2}^{+}(t)]^{2} + 2p_{2}(t)Y_{2}^{+}(t)\mathbb{1}_{[Y_{2}(t)>0]}[f(t,y(t),z(t)) - \hat{f}_{2}(t,y(t),z(t))] \\ &-\mathbb{1}_{[Y_{2}(t)>0]}p_{2}(t)Z_{2}^{2}(t)]dt - \mathbb{1}_{[Y_{2}(t)>0]}2p_{2}(t)Y_{2}^{+}(t)Z_{2}(t)dW(t) + 2p_{2}(t)c_{1}(t)[Y_{2}^{+}(t)]^{2}dt \\ &+ \overline{\beta}_{2}c_{2}^{2}(t)p_{2}(t)[Y_{2}^{+}(t)]^{2}dt + \overline{\beta}_{2}^{-1}\mathbb{1}_{[Y_{2}(t)>0]}p_{2}(t)Z_{2}^{2}(t)dt \\ &\leq -2\mathbb{1}_{[Y_{2}(t)>0]}p_{1}(t)Y_{2}^{+}(t)Z_{2}(t)dW(t), \end{split}$$

which in integral form becomes

$$p_2(t)[Y_2^+(t)]^2 \le -\int_t^T 2\mathbb{1}_{[Y_2(s)>0]} p_2(s)Y_2^+(s)Z_2(s)dW(s).$$

Since the stochastic integral on the right-hand side is a martingale due to Lemma 2.1 (ii), we have

$$\mathbb{E}[p_2(t)[Y_2^+(t)]^2] \le 0,$$

which concludes the proof.

3. Unbounded continuous generator

In this section, we consider the one-dimensional version of equation (1) with a continuous f with respect to y and z, which satisfies a linear growth condition rather than the Lipschitz-type condition. The main idea here, as in [27], is to approximate the generator f by an infinite sequence of Lipschitz-type approximating functions. Each such a function generates a BSDE, and we show that the solutions to such a sequence of BSDEs converge to the solution of (1).

We say that the progressively measurable function f and the random variable ξ , or the pair (f, ξ) , satisfies *conditions* A3 if:

(i)' d = 1 and f(t, y, z) is a continuous function of y and z;

(ii)' $|f(t, y, z)| \leq c_0(t) + c_1(t)|y| + c_2(t)|z|$, for all $y \in \mathbb{R}, z \in \mathbb{R}^k$, (t, ω) a.e.;

(iii)' $\xi \in \widetilde{M}^2(\Omega, \mathscr{F}_T, \mathbb{P}; \mathbb{R});$ (iv)' $c_0(\cdot) \in \widetilde{M}^2(0, T; \mathbb{R})$ and $\left[c_0(\cdot)\widetilde{\alpha}(\cdot)^{-\frac{1}{2}}\right] \in \widetilde{M}^2(0, T; \mathbb{R}).$

As already mentioned in the introduction, our assumption (ii)' permits for random and possibly unbounded coefficients $c_1(\cdot)$ and $c_2(\cdot)$, which is not the case in [39] and [40]. The results of the previous section are our main tools in dealing with the problem of solvability. We focus on utilizing Theorem 2.1 (i) and Theorem 2.2 (i) only, as similar results can be obtained by applying Theorem 2.1 (ii) and Theorem 2.2 (ii).

We introduce the sequence of functions

$$f_n(t, y, z) \equiv \sup_{(u,v) \in \mathbb{R}^{1+k}} \{ f(t, u, v) - [c_1(t) + n] | u - y| - [c_2(t) + n] | v - z| \}, \quad n \ge 1,$$

which are clearly well-defined. Their main properties are summarized in the following result.

Lemma 3.1. (i) Linear growth: for any $y \in \mathbb{R}$, $z \in \mathbb{R}^k$, $|f_n(t, y, z)| \leq c_0(t) + c_1(t)|y| + c_2(t)|z|$;

(ii) Monotonicity: f_n is a decreasing function of n;

(iii) Lipschitz condition: for any $y_1, y_2 \in \mathbb{R}, z_1, z_2 \in \mathbb{R}^k$,

$$|f_n(t, y_1, z_1) - f_n(t, y_2, z_2)| \le [c_1(t) + n]|y_1 - y_2| + [c_2(t) + n]|z_1 - z_2|;$$

(iv) Convergence: for any $y \in \mathbb{R}$, $z \in \mathbb{R}^k$, $\lim_{n \to \infty} f_n(t, y, z) = f(t, y, z)$.

Proof. (i) By the linear growth of f, for all $y \in \mathbb{R}$, $z \in \mathbb{R}^k$, we have

$$f_n(t, y, z) \le \sup_{(u,v) \in \mathbb{R}^{1+k}} \{ |f(t, u, v)| - [c_1(t) + n] |u - y| - [c_2(t) + n] |v - z| \}$$

$$\leq c_0(t) + \sup_{(u,v)\in\mathbb{R}^{1+k}} \{c_1(t)|u| + c_2(t)|v| - [c_1(t) + n]|u - y| - [c_2(t) + n]|v - z|\}$$

$$\leq c_0(t) + \sup_{(u,v)\in\mathbb{R}^{1+k}} \{c_1(t)|u| + c_2(t)|v| - c_1(t)(|u| - |y|) - c_2(t)(|v| - |z|)\}$$

$$\leq c_1(t) + c_2(t)|y| + c_3(t)|z|.$$

The inequality $f_n(t, y, z) \ge -c_0(t) - c_1(t)|y| - c_2(t)|z|$ can be proved similarly.

- (ii) This follows from the definition of f_n itself.
- (iii) By inequality $|\sup_{i\in I} a_i \sup_{i\in I} b_i| \le \sup_{i\in I} |a_i b_i|$, with I being an

arbitrary index set, we have

$$\begin{split} |f_n(t, y_1, z_1) - f_n(t, y_2, z_2)| \\ &= \bigg| \sup_{(u,v) \in \mathbb{R}^{1+k}} \{f(t, u, v) - [c_1(t) + n] | u - y_1| - [c_2(t) + n] | v - z_1| \} \\ &- \sup_{(u,v) \in \mathbb{R}^{1+k}} \{f(t, u, v) - [c_1(t) + n] | u - y_2| - [c_2(t) + n] | v - z_2| \} \bigg| \\ &\leq \sup_{(u,v) \in \mathbb{R}^{1+k}} \big| \{ [c_1(t) + n] (|u - y_2| - |u - y_1|) + [c_2(t) + n] (|v - z_2| - |v - z_1|) \} \bigg| \\ &\leq \sup_{(u,v) \in \mathbb{R}^{1+k}} \big| \{ [c_1(t) + n] | u - y_2 - u + y_1| + [c_2(t) + n] | v - z_2 - v + z_1| \} \big| \\ &= [c_1(t) + n] |y_1 - y_2| + [c_2(t) + n] |z_1 - z_2|. \\ & \text{(iv) For any } n \ge 1, \text{ there exists } (u_n, v_n) \in \mathbb{R}^{1+k} \text{ such that} \\ & f_n(t, y, z) \le f(t, u_n, v_n) - [c_1(t) + n] | u_n - y| - [c_2(t) + n] | v_n - z| + n^{-1}. \end{split}$$

In other words,

$$f_n(t, y, z) + [c_1(t) + n]|u_n - y| + [c_2(t) + n]|v_n - z| \le f(t, u_n, v_n) + n^{-1}.$$

Note that in order to make the left-hand side of above inequality finite as $n \to \infty$, it is necessary to have $\lim_{n\to\infty} (u_n, v_n) = (y, z)$. And then

$$\lim_{n \to \infty} f_n(t, y, z) \le f(t, y, z).$$

On the other hand, by the definition of f_n , we have $f_n(t, y, z) \ge f(t, y, z)$. Hence

$$\lim_{n \to \infty} f_n(t, y, z) = f(t, y, z).$$

Using functions $\{f_n\}_{n\geq 1}$ as generators, we introduce the following sequence of equations

$$\widetilde{y}_n(t) = \xi + \int_t^T f_n(s, \widetilde{y}_n(s), \widetilde{z}_n(s)) ds - \int_t^T \widetilde{z}_n(s) dW(s), \quad t \in [0, T].$$
(21)

Lemma 3.2. If conditions A3 hold, then equations (21) have unique solution pairs $(\tilde{y}_n(\cdot), \tilde{z}_n(\cdot)) \in \widetilde{H}^2(0, T; \mathbb{R}) \times \widetilde{M}^2(0, T; \mathbb{R}^k)$, for any $n \ge 1$.

Proof. We only need to show that the assumptions of the previous section, which ensure the applicability of Theorem 2.1 (i), hold. Thus,

$$\mathbb{E}\left[e^{\int_0^T \{\widetilde{\gamma(t)} + \widetilde{\beta_1}[c_1(t) + n]^2 + \widetilde{\beta_2}[c_2(t) + n]^2\}dt} |\xi|^2\right] \le e^{2Tn^2(\widetilde{\beta_1} + \widetilde{\beta_2})} \mathbb{E}[\widetilde{p}(T)|\xi|^2] < \infty,$$

and

$$\begin{split} & \mathbb{E} \int_{0}^{T} e^{\int_{0}^{t} \{\widetilde{\gamma(t)} + \widetilde{\beta_{1}}[c_{1}(t)+n]^{2} + \widetilde{\beta_{2}}[c_{2}(t)+n]^{2}\} ds} \frac{|f_{n}(t,0,0)|^{2}}{\widetilde{\gamma(t)} + \widetilde{\beta_{1}}[c_{1}(t)+n]^{2} + \widetilde{\beta_{2}}[c_{2}(t)+n]^{2}} dt \\ & \leq \mathbb{E} \int_{0}^{T} e^{2n^{2}t(\widetilde{\beta_{1}} + \widetilde{\beta_{2}})} \widetilde{p}(t) \frac{|c_{0}(t)|^{2}}{\widetilde{\gamma(t)} + \widetilde{\beta_{1}}[c_{1}(t)+n]^{2} + \widetilde{\beta_{2}}[c_{2}(t)+n]^{2}} dt \\ & \leq 2e^{2n^{2}T(\widetilde{\beta_{1}} + \widetilde{\beta_{2}})} \mathbb{E} \int_{0}^{T} \widetilde{p}(t) \frac{|c_{0}(t)|^{2}}{\widetilde{\alpha(t)}} dt < \infty. \end{split}$$

Our main task now is to prove that the sequence of solutions $\{\widetilde{y}_n(\cdot), \widetilde{z}_n(\cdot)\}_{n\geq 1}$, converges to the solution $(y(\cdot), z(\cdot))$ of (1). We first present two useful lemmas.

Lemma 3.3. Let the conditions A3 hold. There exists a constant κ , independent of n, such that $\|\widetilde{y_n}\| \leq \kappa$ and $\|\widetilde{z_n}\| \leq \kappa$, for all $n \geq 1$.

Proof. From the fact that the sequence f_n is decreasing, and Theorem 2.2 (i), we know that $\tilde{y}_1(t) \geq \tilde{y}_2(t) \geq ..., \forall t \in [0, T]$ a.s.. Hence, there exists a constant κ_1 such that

$$\kappa_1 \ge \widetilde{\|\widetilde{y}_1\|} \ge \widetilde{\|\widetilde{y}_2\|} \ge \dots$$

By making use the linear growth property of f_n , we obtain

$$\begin{split} &-d\widetilde{p}(t)|\widetilde{y}_{n}(t)|^{2} \\ = &-\widetilde{\alpha}(t)\widetilde{p}(t)|\widetilde{y}_{n}(t)|^{2}dt - \widetilde{p}(t)|\widetilde{z}_{n}(t)|^{2}dt - 2\widetilde{p}(t)\widetilde{y}_{n}(t)\widetilde{z}_{n}(t)dW(t) \\ &+ 2\widetilde{p}(t)\widetilde{y}_{n}(t)f_{n}(t,\widetilde{y}_{n}(t),\widetilde{z}_{n}(t))dt \\ \leq &-\widetilde{\alpha}(t)\widetilde{p}(t)|\widetilde{y}_{n}(t)|^{2}dt - \widetilde{p}(t)|\widetilde{z}_{n}(t)|^{2}dt - 2\widetilde{p}(t)\widetilde{y}_{n}(t)\widetilde{z}_{n}(t)dW(t) \\ &+ 2\widetilde{p}(t)|\widetilde{y}_{n}(t)||f_{n}(t,\widetilde{y}_{n}(t),\widetilde{z}_{n}(t))|dt \\ \leq &-\widetilde{\alpha}(t)\widetilde{p}(t)|\widetilde{y}_{n}(t)|^{2}dt - \widetilde{p}(t)|\widetilde{z}_{n}(t)|^{2}dt - 2\widetilde{p}(t)\widetilde{y}_{n}(t)\widetilde{z}_{n}(t)dW(t) \\ &+ 2\widetilde{p}(t)|\widetilde{y}_{n}(t)|^{2}dt - \widetilde{p}(t)|\widetilde{y}_{n}(t)| + c_{2}(t)|\widetilde{z}_{n}(t)|]dt \\ \leq &-\widetilde{\alpha}(t)\widetilde{p}(t)|\widetilde{y}_{n}(t)|^{2}dt - \widetilde{p}(t)|\widetilde{z}_{n}(t)|^{2}dt - 2\widetilde{p}(t)\widetilde{y}_{n}(t)\widetilde{z}_{n}(t)dW(t) \\ &+ \widetilde{p}(t)|\widetilde{y}_{n}(t)|^{2}dt + \widetilde{p}(t)c_{0}^{2}(t)dt + \widetilde{\beta}_{1}c_{1}^{2}(t)\widetilde{p}(t)|\widetilde{y}_{n}(t)|^{2}dt + (\widetilde{\beta}_{1})^{-1}\widetilde{p}(t)|\widetilde{y}_{n}(t)|^{2}dt \\ &+ \widetilde{\beta}_{2}c_{2}^{2}(t)\widetilde{p}(t)|\widetilde{y}_{n}(t)|^{2} + (\widetilde{\beta}_{2})^{-1}\widetilde{p}(t)|\widetilde{z}_{n}(t)|^{2}dt \\ \leq &- \left[1 - (\widetilde{\beta}_{2})^{-1}\right]\widetilde{p}(t)|\widetilde{z}_{n}(t)|^{2}dt + \widetilde{p}(t)c_{0}^{2}(t)dt \\ &+ \left[1 + (\widetilde{\beta}_{1})^{-1}\right]\widetilde{p}(t)|\widetilde{y}_{n}(t)|^{2}dt - 2\widetilde{p}(t)\widetilde{y}_{n}(t)\widetilde{z}_{n}(t)dW(t), \end{split}$$

which in integral form becomes

$$\begin{split} \int_{t}^{T} \widetilde{p}(s) |\widetilde{z}_{n}(s)|^{2} ds &\leq \frac{\widetilde{p}(T)\xi^{2}}{\left[1 - (\widetilde{\beta}_{2})^{-1}\right]} + \frac{\int_{t}^{T} \widetilde{p}(s)c_{0}^{2}(s)ds}{\left[1 - (\widetilde{\beta}_{2})^{-1}\right]} \\ &+ \frac{\left[1 + (\widetilde{\beta}_{1})^{-1}\right]}{\left[1 - (\widetilde{\beta}_{2})^{-1}\right]} \int_{t}^{T} \widetilde{p}(s) |\widetilde{y}_{n}(t)|^{2} ds - \frac{2\int_{t}^{T} \widetilde{p}(s)\widetilde{y}_{n}(s)\widetilde{z}_{n}(s)dW(t)}{\left[1 - (\widetilde{\beta}_{2})^{-1}\right]} \end{split}$$

From Lemma 2.1, we know that the stochastic integral on the right-hand side is a martingale. Taking the expectation of both sides gives

$$\begin{aligned} \widetilde{\|\widetilde{z}_{n}\|} &\leq \frac{\mathbb{E}[\widetilde{p}(T)\xi^{2}]}{\left[1-(\widetilde{\beta}_{2})^{-1}\right]} + \frac{\mathbb{E}\int_{0}^{T}\widetilde{p}(s)c_{0}^{2}(s)ds}{\left[1-(\widetilde{\beta}_{2})^{-1}\right]} + \frac{\left[1+(\widetilde{\beta}_{1})^{-1}\right]}{\left[1-(\widetilde{\beta}_{2})^{-1}\right]} \widetilde{\|\widetilde{y}_{n}\|} \quad (22) \\ &\leq \frac{\mathbb{E}[\widetilde{p}(T)\xi^{2}]}{\left[1-(\widetilde{\beta}_{2})^{-1}\right]} + \frac{\mathbb{E}\int_{0}^{T}\widetilde{p}(s)c_{0}^{2}(s)ds}{\left[1-(\widetilde{\beta}_{2})^{-1}\right]} + \frac{\left[1+(\widetilde{\beta}_{1})^{-1}\right]}{\left[1-(\widetilde{\beta}_{2})^{-1}\right]}\kappa_{1} = \kappa_{2}. \end{aligned}$$

Finally, $\kappa = \max(\kappa_1, \kappa_2)$.

Lemma 3.4. Let the conditions A3 hold. The pair of processes $(\widetilde{y}_n(\cdot), \widetilde{z}_n(\cdot))_{n\geq 1}$ converges to $(\widetilde{y}(\cdot), \widetilde{z}(\cdot))$ in $\widetilde{M}^2(0, T; \mathbb{R}) \times \widetilde{M}^2(0, T; \mathbb{R}^k)$.

Proof. Let us consider a measurable and Lipchitz function $g(t, y, z) = -[c_0(t) + c_1(t)|y| + c_2(t)|z|]$. From Lemma 3.1 (iii) and Theorem 2.1 (i) we know the following BSDEs have a unique adapted solution on $\widetilde{H}^2(0, T; \mathbb{R}) \times \widetilde{M}^2(0, T; \mathbb{R}^k)$:

$$\widetilde{y}_n(t) = \xi + \int_t^T f_n(s, \widetilde{y}_n(s), \widetilde{z}_n(s)) ds - \int_t^T \widetilde{z}_n(s) dW(s), \quad t \in [0, T],$$

and

$$K(t) = \xi + \int_{t}^{T} g(s, K(s), L(s)) ds - \int_{t}^{T} L(s) dW(s), \quad t \in [0, T].$$

By Comparison Theorem 2.2 (i), we have

$$K(t) \leq \widetilde{y}_n(t) \leq \widetilde{y}_{n-1}(t) \leq \widetilde{y}_1(t), \ \forall n \geq 1.$$

Hence $\{\widetilde{y}_n(t)\}_{n\geq 1}$ is decreasing and bounded in $\widetilde{M}^2(0,T;\mathbb{R})$. Then by dominated convergence theorem, we know that $\{\widetilde{y}_n(t)\}_{n\geq 1}$ converges pointwisely to $\widetilde{y}(t)^*$ in $\widetilde{M}^2(0,T;\mathbb{R})$. Applying the Itô's formula to $p(t)|\widetilde{y}_n(t) - \widetilde{y}_m(t)|^2$ and writing in integral

form, we have

$$\widetilde{p}(t)|\widetilde{y}_{n}(t) - \widetilde{y}_{m}(t)|^{2} + \int_{t}^{T} \widetilde{p}(s)|\widetilde{z}_{n}(s) - \widetilde{z}_{m}(s)|^{2}ds$$

$$= \int_{t}^{T} 2\widetilde{p}(s)(\widetilde{y}_{n}(s) - \widetilde{y}_{m}(s))[f_{n}(s,\widetilde{y}_{n}(s),\widetilde{z}_{n}(s)) - f_{m}(s,\widetilde{y}_{m}(s),\widetilde{z}_{m}(s))]ds \quad (23)$$

$$+ \int_{t}^{T} -2\widetilde{p}(s)(\widetilde{y}_{n}(s) - \widetilde{y}_{m}(s))(\widetilde{z}_{n}(s) - \widetilde{z}_{m}(s))dW(s).$$

Taking expectations on both sides, from Lemma 2.1 (ii) and using the linear

growth property of f_n and f_m , we have

$$\begin{split} & \mathbb{E}\left[\int_{t}^{T}\widetilde{p}(s)|\widetilde{z}_{n}(s)-\widetilde{z}_{m}(s)|^{2}ds\right] \\ &\leq 2\mathbb{E}\left[\int_{t}^{T}\widetilde{p}(s)(\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s))[f_{n}(s,\widetilde{y}_{n}(s),\widetilde{z}_{n}(s))-f_{m}(s,\widetilde{y}_{m}(s),\widetilde{z}_{m}(s))]ds\right] \\ &\leq 2\mathbb{E}\left[\int_{t}^{T}\sqrt{\widetilde{\alpha}(s)\widetilde{p}(s)}(\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s))\frac{\sqrt{\widetilde{p}(s)}}{\sqrt{\widetilde{\alpha}(s)}}[f_{n}(s,\widetilde{y}_{n}(s),\widetilde{z}_{n}(s))-f_{m}(s,\widetilde{y}_{m}(s),\widetilde{z}_{m}(s))]ds\right] \\ &\leq 2\left(\mathbb{E}\left[\int_{t}^{T}\widetilde{\alpha}(s)\widetilde{p}(s)|\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s)|^{2}ds\right]\right)^{\frac{1}{2}} \\ &\quad \cdot\left(\mathbb{E}\left[\int_{t}^{T}\frac{\widetilde{p}(s)}{\widetilde{\alpha}(s)}|f_{n}(s,\widetilde{y}_{n}(s),\widetilde{z}_{n}(s))-f_{m}(s,\widetilde{y}_{m}(s),\widetilde{z}_{m}(s))|^{2}ds\right]\right)^{\frac{1}{2}} \\ &\leq 2\sqrt{2}\left(\mathbb{E}\left[\int_{t}^{T}\widetilde{\alpha}(s)\widetilde{p}(s)|\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s)|^{2}ds\right]\right)^{\frac{1}{2}}\left(\mathbb{E}\left[\int_{t}^{T}\frac{\widetilde{p}(s)}{\widetilde{\alpha}(s)}\left[|c_{0}(s)+c_{1}(s)|\widetilde{y}_{n}(s)|+c_{2}(s)|\widetilde{z}_{m}(s)||^{2}\right]ds\right]\right)^{\frac{1}{2}} \\ &\leq 2\sqrt{6}\left(\mathbb{E}\left[\int_{t}^{T}\widetilde{\alpha}(s)\widetilde{p}(s)|\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s)|^{2}ds\right]\right)^{\frac{1}{2}}\left(\mathbb{E}\left[\int_{t}^{T}\frac{\widetilde{p}(s)}{\widetilde{\alpha}(s)}\left[2c_{0}^{2}(s)+c_{1}^{2}(s)|\widetilde{y}_{n}(s)|^{2}+c_{2}^{2}(s)|\widetilde{z}_{m}(s)|^{2}\right]ds\right]\right)^{\frac{1}{2}} \end{split}$$

$$\leq 2\sqrt{6} \left(\mathbb{E}\left[\int_{t}^{T} \widetilde{\alpha}(s)\widetilde{p}(s) |\widetilde{y}_{n}(s) - \widetilde{y}_{m}(s)|^{2} ds \right] \right)^{\frac{1}{2}} \left(\mathbb{E}\left[\int_{t}^{T} \widetilde{p}(s) \left[\frac{2c_{0}^{2}(s)}{\widetilde{\alpha}(s)} + |\widetilde{y}_{n}(s)|^{2} + |\widetilde{z}_{n}(s)|^{2} + |\widetilde{z}_{m}(s)|^{2} \right] ds \right] \right)^{\frac{1}{2}}$$

$$\leq 2\sqrt{6}\,\widetilde{\kappa}\left(\mathbb{E}\left[\int_t^T \widetilde{\alpha}(s)\widetilde{p}(s)|\widetilde{y}_n(s) - \widetilde{y}_m(s)|^2 ds\right]\right)^{\frac{1}{2}},$$

where $\widetilde{\kappa} \equiv \left(4\kappa + \left\|\widetilde{c_0(\cdot)\alpha(\cdot)^{-\frac{1}{2}}}\right\|\right)^{\frac{1}{2}}$. Therefore, this, together with the fact that $\{\widetilde{y}_n(t)\}_{n\geq 1}$ pointwisely converges in $\widetilde{M}^2(0,T;\mathbb{R})$, implies that $\{\widetilde{z}_n(t)\}_{n\geq 1}$ is a Cauchy sequence in $\widetilde{M}^2(0,T;\mathbb{R}^k)$ and then converges to $\widetilde{z}(t)^*$ in the same space.

Now we present the main result in this section.

Theorem 3.1. (Existence) Equation (1) has an adapted solution $(\tilde{y}(\cdot), \tilde{z}(\cdot)) \in \widetilde{M}^2(0, T; \mathbb{R}) \times \widetilde{M}^2(0, T; \mathbb{R}^k)$, which is also a maximal solution, i.e. for any other solution $(\bar{y}(\cdot), \bar{z}(\cdot))$ of equation (1), we have $\tilde{y}(\cdot) \geq \bar{y}(\cdot)$.

Proof. Similar to previous calculation in Lemma 3.4, taking supremum over t for equation (23) and using the Burkholder-Davis-Gundy's inequality, we

have

$$\begin{split} & \mathbb{E}\left[\sup_{t\in[0,T]}\widetilde{p}(t)|\widetilde{y}_{n}(t)-\widetilde{y}_{m}(t)|^{2}\right] \\ \leq \mathbb{E}\left[\sup_{t\in[0,T]}\int_{t}^{T}2\widetilde{p}(s)(\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s))[f_{n}(s,\widetilde{y}_{n}(s),\widetilde{z}_{n}(s))-f_{m}(s,\widetilde{y}_{m}(s),\widetilde{z}_{m}(s))]ds\right] \\ & + \mathbb{E}\left[\sup_{t\in[0,T]}\int_{t}^{T}-2\widetilde{p}(s)(\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s))(\widetilde{z}_{n}(s)-\widetilde{z}_{m}(s))dW(s)\right] \\ \leq 2\mathbb{E}\left[\int_{0}^{T}\widetilde{p}(s)|\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s)||f_{n}(s,\widetilde{y}_{n}(s),\widetilde{z}_{n}(s))-f_{m}(s,\widetilde{y}_{m}(s),\widetilde{z}_{m}(s))|ds\right] \\ & + K\mathbb{E}\left[\int_{0}^{T}|\sqrt{\widetilde{p}(s)}(\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s))|^{2}|\sqrt{\widetilde{p}(s)}(\widetilde{z}_{n}(s)-\widetilde{z}_{m}(s))|^{2}ds\right]^{\frac{1}{2}} \\ \leq 2\left(\mathbb{E}\left[\int_{t}^{T}\widetilde{\alpha}(s)\widetilde{p}(s)|\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s)|^{2}ds\right]\right)^{\frac{1}{2}} \\ & \cdot \left(\mathbb{E}\left[\int_{t}^{T}\frac{\widetilde{p}(s)}{\widetilde{\alpha}(s)}|f_{n}(s,\widetilde{y}_{n}(s),\widetilde{z}_{n}(s))-f_{m}(s,\widetilde{y}_{m}(s),\widetilde{z}_{m}(s))|^{2}ds\right]\right)^{\frac{1}{2}} \\ & + \frac{K}{2}\mathbb{E}\left[\sup_{t\in[0,T]}|\sqrt{\widetilde{p}(s)}(\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s))|^{2}+\int_{t}^{T}|\sqrt{\widetilde{p}(s)}(\widetilde{z}_{n}(s)-\widetilde{z}_{m}(s))|^{2}ds\right] \\ \leq 2\sqrt{6}\,\widetilde{\kappa}\left(\mathbb{E}\left[\int_{t}^{T}\widetilde{\alpha}(s)\widetilde{p}(s)|\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s)|^{2}ds\right]\right)^{\frac{1}{2}} \\ & + \frac{K}{2}\mathbb{E}\left[\sup_{t\in[0,T]}\widetilde{p}(s)|\widetilde{y}_{n}(s)-\widetilde{y}_{m}(s)|^{2}+\int_{t}^{T}\widetilde{p}(s)|\widetilde{z}_{n}(s)-\widetilde{z}_{m}(s)|^{2}ds\right]. \end{split}$$

Therefore by Lemma 3.4, for any $t \in [0, T]$, $\{\widetilde{y}_n(t)\}_{n \ge 1}$ converges uniformly in $\widetilde{M}^2(0, T; \mathbb{R})$ to y(t) in the same space. Since $\{\widetilde{y}_n(t)\}_{n \ge 1}$ is continuous, by the uniform convergence theorem, $\widetilde{y}(t)$ is a continuous process.

Now we show that the sequence of processes $\{f_n(t, \tilde{y}_n(t), \tilde{z}_n(t))\}_{n\geq 1}$ converges to $\{f(t, \tilde{y}(t), \tilde{z}(t))\}$ in $L_{\mathscr{F}}(0, T; \mathbb{R})$. Note that for any positive and large enough δ ,

$$\mathbb{E}\left[\int_{0}^{T} |f_{n}(s, \tilde{y}_{n}(s), \tilde{z}_{n}(s)) - f(s, \tilde{y}(s), \tilde{z}(s))|ds\right] \\
= \mathbb{E}\left[\int_{0}^{T} |f_{n}(s, \tilde{y}_{n}(s), \tilde{z}_{n}(s)) - f(s, \tilde{y}(s), \tilde{z}(s))| \mathbb{1}_{\left\{\frac{c_{1}(s)|\tilde{y}_{n}(s)| + c_{2}(s)|\tilde{z}_{n}(s)|}{c_{0}^{2}(s) + c_{1}^{2}(s) + c_{2}^{2}(s)} \le \delta\right\}} ds\right] \\
+ \mathbb{E}\left[\int_{0}^{T} |f_{n}(s, \tilde{y}_{n}(s), \tilde{z}_{n}(s)) - f(s, \tilde{y}(s), \tilde{z}(s))| \mathbb{1}_{\left\{\frac{c_{1}(s)|\tilde{y}_{n}(s)| + c_{2}(s)|\tilde{z}_{n}(s)|}{c_{0}^{2}(s) + c_{1}^{2}(s) + c_{2}^{2}(s)} \le \delta\right\}} ds\right] \\
\leq \mathbb{E}\left[\int_{0}^{T} |f_{n}(s, \tilde{y}_{n}(s), \tilde{z}_{n}(s)) - f(s, \tilde{y}_{n}(s), \tilde{z}_{n}(s))| \mathbb{1}_{\left\{\frac{c_{1}(s)|\tilde{y}_{n}(s)| + c_{2}(s)|\tilde{z}_{n}(s)|}{c_{0}^{2}(s) + c_{1}^{2}(s) + c_{2}^{2}(s)} \le \delta\right\}} ds\right] \\
+ \mathbb{E}\left[\int_{0}^{T} |f(s, \tilde{y}_{n}(s), \tilde{z}_{n}(s)) - f(s, \tilde{y}(s), \tilde{z}(s))| \mathbb{1}_{\left\{\frac{c_{1}(s)|\tilde{y}_{n}(s)| + c_{2}(s)|\tilde{z}_{n}(s)|}{c_{0}^{2}(s) + c_{1}^{2}(s) + c_{2}^{2}(s)} \le \delta\right\}} ds\right] \\
+ \mathbb{E}\left[\int_{0}^{T} |f_{n}(s, \tilde{y}_{n}(s), \tilde{z}_{n}(s)) - f(s, \tilde{y}(s), \tilde{z}(s))| \mathbb{1}_{\left\{\frac{c_{1}(s)|\tilde{y}_{n}(s)| + c_{2}(s)|\tilde{z}_{n}(s)|}{c_{0}^{2}(s) + c_{1}^{2}(s) + c_{2}^{2}(s)} \ge \delta\right\}} ds\right] \\$$

$$(24)$$

By (ii), (iii) and (iv) in Lemma 3.1, assumption (i)' and the Dini's Theorem, as $n \to \infty$, we have

$$\sup_{\left\{\frac{c_1(s)|\widetilde{y}_n(s)|+c_2(s)|\widetilde{z}_n(s)|}{c_0^2(s)+c_1^2(s)+c_2^2(s)} \le \delta\right\}} |f_n(t,\widetilde{y}(t),\widetilde{z}(t)) - f(t,\widetilde{y}(t),\widetilde{z}(t))| \longrightarrow 0.$$

Therefore by the dominated convergence theorem, the first term in right hand side uniformly converges to 0. Due to assumption (i)', at least along a subsequence, the second term in the right hand side converges to 0. For the final term in the right hand side, by Lemma 3.1 (iii), assumption (ii)' and Lemma 3.3, together with the fact that $a \mathbb{1}_{\{X>a\}} < X$ for any nonnegative random variable X and a > 0, we have

$$\begin{split} & \mathbb{E}\left[\int_{0}^{T}|f_{n}(t,\tilde{y}_{n}(s),\tilde{z}_{n}(s)) - f(t,\tilde{y}(s),\tilde{z}(s))|\mathbb{1}_{\left\{\frac{c_{1}(s)|\tilde{y}_{n}(s)|+c_{2}(s)|\tilde{z}_{n}(s)|}{c_{0}^{2}(s)+c_{1}^{2}(s)+c_{2}^{2}(s)}>\delta\right\}}ds\right] \\ &\leq \mathbb{E}\left[\int_{0}^{T}|2c_{0}(s) + c_{1}(s)|\tilde{y}_{n}(s)| + c_{2}(s)|\tilde{z}_{n}(s)| + c_{1}(s)|\tilde{y}(s)| + c_{2}(s)|\tilde{z}(s)] \mathbb{1}_{\left\{\frac{c_{1}(s)|\tilde{y}_{n}(s)|+c_{2}(s)|\tilde{z}_{n}(s)|}{c_{0}^{2}(s)+c_{1}^{2}(s)+c_{2}^{2}(s)}>\delta\right\}}ds\right] \\ &\leq \mathbb{E}\left[\int_{0}^{T}|2c_{0}(s) + c_{1}(s)|\tilde{y}_{n}(s)| + c_{2}(s)|\tilde{z}_{n}(s)| + c_{1}(s)|\tilde{y}(s)| + c_{2}(s)|\tilde{z}(s)] \mathbb{1}_{\left\{\frac{c_{1}(s)|\tilde{y}_{n}(s)|+c_{2}(s)|\tilde{z}_{n}(s)|}{c_{0}^{2}(s)+c_{1}^{2}(s)+c_{2}^{2}(s)}|\tilde{z}_{n}(s)|}ds\right] \\ &= \frac{1}{\delta}\mathbb{E}\left[\int_{0}^{T}\frac{1}{c_{0}^{2}(s) + c_{1}^{2}(s)+c_{2}^{2}(s)}|2c_{0}(s)c_{1}(s)|\tilde{y}_{n}(s)| + c_{1}^{2}(s)|\tilde{y}_{n}(s)|^{2} + c_{1}(s)c_{2}(s)|\tilde{y}_{n}(s)||\tilde{z}_{n}(s)| \\ &+ c_{1}^{2}(s)|\tilde{y}_{n}(s)||\tilde{y}(s)| + c_{1}(s)c_{2}(s)|\tilde{y}_{n}(s)||\tilde{z}(s)| + 2c_{0}(s)c_{2}(s)|\tilde{z}_{n}(s)| + c_{1}(s)c_{2}(s)|\tilde{y}_{n}(s)||\tilde{z}_{n}(s)| \\ &+ c_{2}^{2}(s)|\tilde{z}_{n}(s)|^{2} + c_{1}(s)c_{2}(s)|\tilde{y}_{n}(s)||\tilde{z}_{n}(s)| + c_{2}^{2}(s)|\tilde{z}_{n}(s)||\tilde{z}(s)||\tilde{z}_{n}(s)| \\ &+ c_{2}^{2}(s)|\tilde{z}_{n}(s)|^{2} + c_{1}(s)c_{2}(s)|\tilde{y}_{n}(s)||\tilde{z}_{n}(s)| + c_{2}^{2}(s)|\tilde{z}_{n}(s)||\tilde{z}_{n}(s)|^{2} \\ &+ c_{1}^{2}(s)|\tilde{y}_{n}(s)|^{2} + c_{1}^{2}(s)c_{2}(s)|\tilde{y}_{n}(s)||\tilde{z}_{n}(s)| + c_{2}^{2}(s)|\tilde{z}_{n}(s)||\tilde{z}_{n}(s)|^{2} \\ &+ c_{1}^{2}(s)|\tilde{y}_{n}(s)|^{2} + c_{2}^{2}(s)|\tilde{z}_{n}(s)|^{2}|ds\right] \\ &\leq \frac{1}{\delta}\mathbb{E}\left[\int_{0}^{T}\frac{1}{c_{0}^{2}(s)+c_{1}^{2}(s)+c_{2}^{2}(s)|\tilde{z}_{n}(s)|^{2} + |\tilde{y}(s)|^{2} + |\tilde{y}(s)|^{2} + |\tilde{y}(s)|^{2}|ds\right] \\ &\leq \frac{1}{\delta}\mathbb{E}\left[\int_{0}^{T}[2+4|\tilde{y}_{n}(s)|^{2} + 4|\tilde{z}_{n}(s)|^{2} + |\tilde{y}(s)|^{2} + |\tilde{z}(s)|^{2}|ds\right] \\ &\leq \frac{1}{\delta}\mathbb{E}\left[\int_{0}^{T}[2+4|\tilde{y}_{n}(s)|^{2} + 4|\tilde{z}_{n}(s)|^{2} + |\tilde{y}(s)|^{2} + |\tilde{z}(s)|^{2}|ds\right] \\ &\leq \frac{1}{\delta}\mathbb{E}\left[\int_{0}^{T}[2+4|\tilde{y}_{n}(s)|^{2} + 4|\tilde{z}_{n}(s)|^{2} + |\tilde{y}(s)|^{2} + |\tilde{z}(s)|^{2}|ds\right] \\ &\leq \frac{1}{\delta}\mathbb{E}\left[\int_{0}^{T}[2+4|\tilde{y}_{n}(s)|^{2} + 4|\tilde{z}_{n}(s)|^{2} + |\tilde{y}(s)|^{2} + |\tilde{z}(s)|^{2}|ds\right] \\ &\leq \frac{1}{\delta}\mathbb{E}\left[\int_{0}^{T}[2+4|\tilde{y}_{n}(s)$$

where $\bar{\kappa}$ is a constant independent of *n*. Hence taking limits in the following

equation

$$\widetilde{y}_n(t) = \xi + \int_t^T f_n(s, \widetilde{y}_n(s), \widetilde{z}_n(s)) ds - \int_t^T \widetilde{z}_n(s) dW(s), \quad t \in [0, T].$$

we deduce that $(\widetilde{y}(t), \widetilde{z}(t)) \in \widetilde{M}^2(0, T; \mathbb{R}) \times \widetilde{M}^2(0, T; \mathbb{R}^k)$ is an adapted solution of equation (1).

Furthermore, suppose that $(\bar{y}(t), \bar{z}(t)) \in \widetilde{M}^2(0, T; \mathbb{R}) \times \widetilde{M}^2(0, T; \mathbb{R}^k)$ is any solution of equation (1). By the comparison theorem 2.2, we have $\tilde{y}_n(t) \geq \bar{y}(t)$ for any $n \geq 1$ and then $\tilde{y}(t) \geq \bar{y}(t)$. Hence $\tilde{y}(t)$ is a maximal solution of equation (1).

4. Conclusions

We have considered two classes of BSDEs with possibly unbounded generator. The first class has a Lipschitz-type generator, whereas the second class has a continuous generator that satisfies a certain linear growth condition. In both cases we have given sufficient conditions for solvability. We expect that these results will prove to be useful in tackling more difficult problems with unbounded generator, such as the BSDEs with a quadratic growth and the Riccati BSDE, which play a fundamental role in stochastic control.

Appendix

Here we include the derivation of the lower bound for the parameter β that appears in [16]. We do so for the readers' convenience, since in Theorem 6.1 of [16] no explicit lower bound is given, it is only assumed that parameter β should be *large enough*. The notation of [16] will be used.

Equation (6.5) of [16] states that for some constants k and k' the following holds

$$\|(y,\eta)\|_{\beta}^{2} = k\|\xi\|_{\beta}^{2} + \frac{k'}{\beta} \left\|\frac{f}{\alpha}\right\|_{\beta}^{2}, \qquad (25)$$

where the definitions of these norms are given in [16], and are just weighted Euclidian norms. From equation (5.5) of [16], which gives the definition of

the norm $\|(y,\eta)\|_{\beta}^2$, and the conclusions of Lemma 6.2 of [16], we obtain

$$\begin{aligned} \|(y,\eta)\|_{\beta}^{2} &= \|\alpha y\|_{\beta}^{2} + \|\eta\|_{\beta}^{2} \\ &\leq \frac{2}{\beta} \|\xi\|_{\beta}^{2} + \frac{8}{\beta^{2}} \left\|\frac{f}{\alpha}\right\|_{\beta}^{2} + 18\|\xi\|_{\beta}^{2} + \frac{45}{\beta} \left\|\frac{f}{\alpha}\right\|_{\beta}^{2} \\ &= \left(18 + \frac{2}{\beta}\right) \|\xi\|_{\beta}^{2} + \left(\frac{45}{\beta} + \frac{8}{\beta^{2}}\right) \left\|\frac{f}{\alpha}\right\|_{\beta}^{2}. \end{aligned}$$
(26)

Comparing (25) and (26) gives $k' = 45 + \frac{8}{\beta}$.

Equation (6.16) of [16] states that for some constants \tilde{k} and \tilde{k}' the following holds

$$\|(\delta Y, \delta Z, \delta N)\|_{\beta}^{2} \leq \tilde{k} \|\delta \xi\|_{\beta}^{2} + \frac{\tilde{k}'}{\beta} \left\|\frac{\delta_{2}f}{\alpha}\right\|_{\beta}^{2}.$$
 (27)

Here, different from [16], we have used the *tilde* notation for the constants k and k' in order to avoid the clash of notation with these constants introduced in the previous paragraph. By inequality (6.5) of [16], we obtain that

$$\begin{aligned} \|(\delta Y, \delta Z, \delta N)\|_{\beta}^{2} &\leq k \|\delta \xi\|_{\beta}^{2} + \frac{k'}{\beta} \left\| \frac{\varphi_{t}}{\alpha_{t}^{2}} \right\|_{\beta}^{2} \\ &\leq k \|\delta \xi\|_{\beta}^{2} + \frac{3k'}{\beta} \left(\|\alpha \delta Y\|_{\beta}^{2} + \|m^{*} \delta Z\|_{\beta}^{2} + \left\| \frac{\delta_{2} f}{\alpha} \right\|_{\beta}^{2} \right) \\ &\leq k \|\delta \xi\|_{\beta}^{2} + \frac{3k'}{\beta} \left(k \|\delta \xi\|_{\beta}^{2} + \frac{k'}{\beta} \left\| \frac{\delta_{2} f}{\alpha} \right\|_{\beta}^{2} + \left\| \frac{\delta_{2} f}{\alpha} \right\|_{\beta}^{2} \right) \\ &= \left(k + \frac{3kk'}{\beta} \right) \|\delta \xi\|_{\beta}^{2} + \frac{3k'}{\beta} \left(\frac{k'}{\beta} + 1 \right) \left\| \frac{\delta_{2} f}{\alpha} \right\|_{\beta}^{2}. \end{aligned}$$
(28)

Comparing (27) and (28) gives $\tilde{k'} = 3k' \left(\frac{k'}{\beta} + 1\right)$.

The inequality at the end of page 35 of [16] is

$$\|\alpha\delta Y\|_{\beta}^{2} + \|m^{*}\delta Z\|_{\beta}^{2} \le \frac{\hat{k}'}{\beta} \|\alpha\delta y\|_{\beta}^{2} + \|m^{*}\delta z\|_{\beta}^{2},$$
(29)

where we have used the *hat* notation for the constant k' in order to avoid the clash of notation with this constant introduced earlier. Similarly to the previous paragraph we obtain

$$\|(\delta Y, \delta Z)\|_{\beta}^{2} = \|\alpha \delta Y\|_{\beta}^{2} + \|m^{*} \delta Z\|_{\beta}^{2} \leq \frac{\widetilde{k'}}{\beta} \left\|\frac{\varphi}{\alpha}\right\|_{\beta}^{2}$$
$$\leq \frac{3\widetilde{k'}}{\beta} \|\alpha \delta y\|_{\beta}^{2} + \|m^{*} \delta z\|_{\beta}^{2}.$$
(30)

Comparing (29) and (30) gives $\hat{k'} = 3\tilde{k'} = 9k'\left(\frac{k'}{\beta} + 1\right)$. In order to apply the contraction mapping principle, it is necessary to have $\frac{\hat{k'}}{\beta} < 1$, i.e.

$$9\left(\frac{45}{\beta} + \frac{8}{\beta^2}\right)\left(\frac{45}{\beta} + \frac{8}{\beta^2} + 1\right) < 1.$$

By solving above inequality for $\beta > 0$, we obtain that by *large enough* in [16] it is meant that $\beta > 446.05$.
