Proposal to Accept Description of General Education with Definition, Purpose and Objectives, pp 23-24, SUE Report, (89-3).

1. Dr. Sutton moved and Dr. Shank seconded the motion to amend the Description of General Education with Definition. Dr. Baumgardner and Mr. James Johnson discussed how their committee interpreted "common." There was discussion about the word "common" in the description. The motion passed with a voting as follows:

p. 23 SUE Report

2nd paragraph under General Education), 3rd line, strike word "common." 3rd paragraph, 4th line, strike word "common."

2. Dr. Shank moved and Dr. Sutton seconded the motion to amend the Description of General Education with Definition. Voting will be later. The amendment: p. 23 and 24, SUE. p. 23 bottom of page change "nine" to "ten." p. 24 - Add 10. Wellness: contributions to and understanding of physical, social, intellectual, and emotional well being and sense of self and their relationship to quality of community life. There was discussion about wellness. Dr. Baumgardner stated that she believed wellness was covered in the other objectives, including 6. Social Responsibility. Dr. Foster stated his definition of "social responsibility." It was suggested that this proposal be worked into the original objectives. Dr. Shank withdrew this proposal.

3. Dr. Downs moved and Dr. Shank seconded the motion to amend the Description of General Education with Definition. The motion passed unanimously. Amendment p. 24 8. First sentence after "Multicultural awareness:" strike "introduction to" and insert "understanding of" . . . Last 2 sentences - strike all words after "and the expressions" and revise to read "and the many forms of expressions of that diversity."
