MINUTES OF MARCH 16, 1993

Dr. Noll (Nibbelin) moved to approve the minutes of the March 16, 1993, meeting as published. Motion carried.

UPDATES FROM DEAN IVARIE

Dean Ivarie updated the committee on the following:

- 1. Favorable response received from Parkland College concerning the recent proposal to drop Mat 2120 as a prerequisite for Com 2810.
- 2. Fin 3710 and Mar 3470 are being offered at Parkland this summer for undergraduates as well as for Phase I students in the MBA program. The Graduate Committee has been asked to make a recommendation concerning the offering of an MBA program at Parkland in the near future.
- The final decision concerning our accreditation will be announced 3. on April 19 at 2:00 p.m. Pacific time. Provost Hill will announce the results to the LCOB faculty and staff at approximately 4:15 p.m. in the Faculty/Staff Lounge.
- 4. Faculty Senate forums are being held throughout the next week concerning college restructuring. Responses to the three models proposed are to be directed to the Faculty Senate by April 13.

BUSINESS ADMINISTRATION MINOR

Christie Roszkowski reported that of the 36 surveys mailed to department chairs and deans, 16 were returned. The Subcommittee on the Business Minor submitted two options for consideration by the Curriculum Committee. Option I would require 21 hours of all required courses, while Option II would also require 21 hours but would allow for some electives to be selected from a group of courses. The fact that Ecn 2801 and Ecn 2802 are currently required as prerequisites for Fin 3710 and Mar 3470 would actually bring the number of hours required for the minor up to 27. Further discussion on this issue will take place at the next meeting.

CHEMISTRY WITH MANAGEMENT OPTION PROGRAM

The subcommittee submitted a proposal to be recommended to the Chemistry Department of the business courses to be taken in that program. Dr. Nantz (Marlow) moved to forward the following list of recommended courses to the Chemistry Department to become part of the Chemistry with Management Option program. Motion carried.
