CMN 3950 PROPOSAL

T. Hawkins followed up on the CMN 3950 proposal and reported to the committee.

REVISED COURSE PROPOSAL – FCS 4838

The revised course proposal for FCS 4838 was voted on and approved, effective Spring 2007.

REVISED COURSE PROPOSAL - SOC 5100

Jeanne Snyder and Janet Cosbey presented the revised course proposal for SOC 5100, Sociological Aspects of Gerontology, effective Spring 2006. This course is changing from SOC 4800 to SOC 5100 to include only graduate students. Assessment data gathered from the student exit interviews indicated that Sociological Aspects of Gerontology would best be geared toward graduate students only, with greater course emphasis on research and presentations. This revised proposal has been approved by the College of Sciences Curriculum Committee.

C. Roszkowski (Moore) moved to place SOC 5100, as amended, on the agenda for vote. All approved. To accommodate CGS deadlines, T. Moore (Slavik) moved to approve the proposal and waive the curriculum committee bylaws requirement of waiting one meeting before a vote s taken. All approved.

REVISION TO M.A. IN GERONTOLOGY PROGRAM

leanne Snyder presented the proposal to replace SOC 4800 with SOC 5100 in the M.A. in Gerontology core, effective Spring 2006. The ore would be strengthened and scholarly rigor enhanced by requiring only 5000-level courses in the core. The proposed change would allow for an additional elective in the 4750-4999 level range.

C. Roszkowski (Slavik) moved to place the change in the M.A. in Gerontology program on the agenda for vote. All approved. To accommodate CGS deadlines, J. Slavik (Roszkowski) moved to approve the program change and waive the curriculum committee bylaws requirement of waiting one meeting before a vote is taken. All approved.

NEW BUSINESS

The deadline to have revisions approved by CAA for inclusion in the hard copy of the 2006-2007 catalog is November 11. The process of approving technology-delivered sections of previously approved courses was discussed and it was the consensus of the committee that these proposals be handled through Executive Action.
