NEW COURSE PROPOSAL – INT 3803, SUSTAINABLE CONSTRUCTION

In the absence of an INT faculty member to present the details of the new course proposal, the committee made some general comments pertaining to the proposal. Drage will communicate with the School of Technology Curriculum Committee and provide them with details of the discussion. The proposal will be on the agenda for the next meeting.

NEW COURSE PROPOSAL - TEC 5373, JAVA APPLICATION IN TECHNOLOGY

Dr. Liu and Dr. Bai presented the proposal stating that although the graduate program was very strong, programming was missing from the curriculum, and that this new course would provide practical and useful programming information to the student. Nantz stated that this course was not discussed with the School of Business before being proposed, and that there was significant overlap in terms of topics between this new course and MIS 3330 and 4330. Dean Hoadley raised the question of whether or not the overlap issue would be a problem since this new course is a graduate level course. Dr. Liu distributed a revised list of course topics to the committee. The committee suggested that he incorporate these topics into the proposal and advised him to state on the proposal why graduate students in technology need a different course than the JAVA courses taught in the School of Business. Dr. Liu and Dr. Bair agreed to present a revised proposal at the next meeting.
