Poverty

Annual earned income falls below a standard threshold of minimum subsistence for an individual or for a family, depending on the number of adults and children. For these data, the federal poverty threshold for an individual is \$11, 170 and \$23,050 for a family of four.



The level of income above the Federal Poverty Line where families and individuals are eligible for SNAP (Food Stamp) Benefits



Food Assistance Gap between SNAP Eligibility and Food Insecurity for all Families and Families with Children

Families fall in a food assistance gap when their income is greater than the eligibility threshold for governmental support through SNAP but too low to place them out of food insecurity.

The gap for all families is 10.6%, and for families with children, 14.5% of all families with children remain at-risk.
