# Mating, Kinship, and Population Structure in Illinois Beaver Populations

The North American beaver, *Castor canadensis*, is considered to be an ecosystem engineer because of its ability to modify riparian habitat and alter species composition. Beavers have historically been reported

to be a monogamous species, living in discrete colonies that consist of an adult male and female, young of the year and juveniles from the previous breeding season. Yet monogamy is rare in mammals and molecular studies have not been conducted to confirm the purported mating system and colony composition of beavers. To that end, I developed 9 microsatellite markers specific to the beaver and used these to elucidate patterns of mating and kinship within and between colonies in 2 disparate populations. Average relatedness assessed using Relatedness software varied widely in both populations, ranging from 0.037 to 0.636 in central Illinois and from 0.155 to 0.406 in southern Illinois. Colonies were composed primarily of first- and second-order relatives, but included unrelated individuals. Extra-pair mating frequently occurred between members of neighboring colonies in southern Illinois. Distance between colonies was not found to be a strong predictor of relatedness in either population. Finally, tests of genetic differentiation between populations revealed a significant FST value of  $0.0676 \pm 0.0119$ , indicating moderate population subdivision. This study was the first of its kind to use molecular methods to investigate mating and kinship patterns in beavers and revealed that beavers are not always genetically monogamous as previously believed. Future research in other populations is needed to test predictions regarding ecological conditions, such as habitat, winter temperature, and colony density, which may influence mating patterns and colony composition.

# The Interdialect Approach to Second Dialect Acquisition: Theory, Process, and Results

This project outlines the theory, process, and results behind an original approach to second dialect acquisition termed the "Interdialect Approach." To begin, the historical origins and development of the non-standard dialect African-American English (AAE) are outlined, focusing particularly on the evolution of the

dialect and the importance of its historical examination in relation to current studies, research, and emerging non-traditional teaching methods for second dialect acquisition.

This multi-faceted approach is clearly defined and offered as an effective method for teaching non-standard English speakers. For the purpose of this work, the "Interdialect Approach" was used with AAE speakers as is noted in the discussion of two research studies of the non-standard dialect. What is more intriguing and valuable is that the "Interdialect Approach" to second dialect acquisition can be applied to all non-standard dialects of the English language, as it gives both educators and students the framework needed to identify the linguistic, phonological, and grammatical characteristics of non-standard English speaking students. The "Interdialect Approach" places these students in the "Interdialect Stage," or the stage between dialects; furthermore, students in this stage are recognized as developmental, showing identifiable patterns of transition and signs of improvement.

Not only does the "Interdialect Approach" give a framework to identify these progressive learners, but it also offers key teaching methods, which educators can use to bring non-standard English speakers to proficiency in the target dialect, Mainstream or Standard English. Beyond offering various methods for improvement, the "Interdialect Approach" also offers promising methods of evaluation to establish the validity and usefulness of this approach to second dialect acquisition. Through a discussion of the significant improvements made through this approach, the conclusion that the "Interdialect Approach" is valuable and unique in adding to existing research and providing practical and useful methods for teaching non-standard English speakers becomes evident.

# Word Retrieval Treatment Using Collaborative Referencing

The use of collaborative referencing tasks as a supplement to traditional speech therapy for two individuals (one male and one female) with nonfluent aphasia due to cerebrovascular accident (CVA) was investigated. The participants' spouses served as communication partners for the collaborative referencing task. Stimuli consisted of three sets of ten pictures of individuals performing actions. Participants and spouses alternated serving as director and matcher for six trials each session. Each picture set was targeted until participants reached 80% accuracy across two trials at identifying pictures. Analysis of transcripts showed that participants and communication partners followed the three phases of the collaborative referencing model (initiation, refashioning, and acceptance) when they did not initially agree on a verb label for a picture. The participants in this study made gains in verb retrieval across each session. In addition, gains were shown to be maintained when picture sets were reintroduced. Cueing strategies were used by communication partners when the participant with aphasia was unable to name an accepted verb label. Descriptive analysis determined that sentence completion, description, and gesture cues were effective for eliciting correct responses for Participant 1 and phonemic and question cues were effective for eliciting correct responses for Participant 2. For these participants, collaborative referencing was a viable supplement to traditional speech therapy services. In cases in which therapy sessions are limited, this model may be an important way to supplement services provided by the speech language pathologist.




