 - a. Clinic Director
 - i. Connectivity issues with the University's internet have disrupted recordings in the ISR system. Until further notice, please use digital cameras if you need something recorded. Amy (Tech GA) will inform clinicians of the issue and provide any updates on the system.
 - b. Chair
 - i. The Spring Textbook List was circulated during the meeting. New textbook requests need to be submitted with this list.
 - ii. Documents shared with site visitors for the upcoming visit were reviewed with faculty. Content in the faculty handbook and strategic plan were highlighted in relation to accreditation standards. These are all working documents and resources for faculty; please share any suggestions for additions.
 - iii. The university-wide Vitalization process is ongoing. Reports from subcommittees are due to the President November 1. Recommendations will be passed through the Provost, Dean, and to the Chair, at which time Angela will need to respond to the recommendations. Given the focus on financial efficiency in the current state budget environment, managing expenses will likely need to be part of the response. Angela reviewed several options for increasing cost efficiency discussed over the past two years, then introduced the option of a non-clinical graduate degree for international students. This option would not require individualized clinical training and would bring in tuition revenue at the increased international rates. Faculty were asked to share input individually to Angela, and/or during next week's faculty meeting regarding exploration of this option.
