# SPACING PROPERTIES OF THE ZEROS OF ORTHOGONAL POLYNOMIALS ON CANTOR SETS VIA A SEQUENCE OF POLYNOMIAL MAPPINGS

#### Abstract

Let $\mu$ be a probability measure with an infinite compact support on $\mathbb{R}$. Let us further assume that $F_{n}:=f_{n} \circ \ldots \circ f_{1}$ is a sequence of orthogonal polynomials for $\mu$ where $\left(f_{n}\right)_{n=1}^{\infty}$ is a sequence of nonlinear polynomials. We prove that if there is an $s_{0} \in \mathbb{N}$ such that 0 is a root of $f_{n}^{\prime}$ for each $n>s_{0}$ then the distance between any two zeros of an orthogonal polynomial for $\mu$ of a given degree greater than 1 has a lower bound in terms of the distance between the set of critical points and the set of zeros of some $F_{k}$. Using this, we find sharp bounds from below and above for the infimum of distances between the consecutive zeros of orthogonal polynomials for singular continuous measures.


## 1. Introduction

In the last ten years, there has been an explosion of interest in spacing of the zeros of orthogonal polynomials on the real line. For probability (unit Borel) measures having a non-trivial absolutely continuous part (with respect to the Lebesgue measure on $\mathbb{R}$ ), there are many results (see e.g. [4, 16, $17,21,27,29]$ ) concerning the fine structure of the zeros of orthogonal polynomials. Breuer in [7] gives an example of a measure such that it is purely singular on $(-2,2)$ yet it has a strong clock behavior (see e.g. Section 1 in [4] for a discussion on clock behavior) in ( $-2,2$ ) (follows from Theorem 1.2 in [7] and Theorem 23.1 in [23]). Simon and Krüger, in [15], discuss the zero spacing of the orthogonal polynomials for the Cantor-Lebesgue measure of the Cantor ternary set. To our knowledge, there was no prior work except [15] on the structure of zeros for the purely singular continuous measure case provided that the support is a Cantor set. Here, our main aim is to give some

[^0]examples of singular continuous measures for which the minimal distance between the consecutive zeros of the associated orthogonal polynomials can be computed accurately.

Throughout, measures that we consider are probability measures, unless specified otherwise, with a compact support in $\mathbb{C}$ and we set $\mathbb{N}=\{1,2, \ldots\}$ and $\mathbb{N}_{0}=\mathbb{N} \cup\{0\}$. Let $\mu$ be a measure with $\operatorname{Card}(\operatorname{supp}(\mu)) \geqq n>1$ for some $n \in \mathbb{N}$. Then for each $m \in \mathbb{N}$ with $m \leqq n-1$, the monic polynomial $P_{m}(\cdot ; \mu)$ of degree $m$ satisfying

$$
\left\|P_{m}(\cdot ; \mu)\right\|_{L_{2}(\mathbb{C}, \mu)}^{2}=\inf _{Q_{m} \in \mathcal{P}_{m}} \int\left|Q_{m}(z)\right|^{2} d \mu(z)>0
$$

is called the $m$-th monic orthogonal polynomial for $\mu$. Here, $\|\cdot\|_{L_{2}(\mathbb{C}, \mu)}$ is the standard norm in $L_{2}(\mathbb{C}, \mu)$ and $\mathcal{P}_{m}$ is the set of all monic polynomials of degree $m$.

Let us suppose that $\mu$ is a measure with an infinite support on $\mathbb{R}$. If we let $P_{-1}(x ; \mu) \equiv 0$ and $P_{0}(x ; \mu) \equiv 1$ then there are two sequences $\left(a_{n}\right)_{n=1}^{\infty}$ and $\left(b_{n}\right)_{n=1}^{\infty}$ such that for $n \geqq 0$ we have

$$
x P_{n}(x ; \mu)=P_{n+1}(x ; \mu)+b_{n+1} P_{n}(x ; \mu)+a_{n}^{2} P_{n-1}(x ; \mu)
$$

where $a_{n+1}>0$ and $b_{n+1} \in \mathbb{R}$. The coefficients $\left(a_{n}, b_{n}\right)_{n=1}^{\infty}$ are called the recurrence coefficients associated with $\mu$. Both $\left(a_{n}\right)_{n=1}^{\infty}$ and $\left(b_{n}\right)_{n=1}^{\infty}$ are bounded sequences. Conversely, if we are given $\left(a_{n}, b_{n}\right)_{n=1}^{\infty}$ where $\left(a_{n}\right)_{n=1}^{\infty}$ and $\left(b_{n}\right)_{n=1}^{\infty}$ are bounded sequences with $a_{n}>0$ and $b_{n} \in \mathbb{R}$, then as a result of the spectral theorem there is a unique measure $\mu$ such that the associated recurrence coefficients are $\left(a_{n}, b_{n}\right)_{n=1}^{\infty}$. For a deeper discussion on the theory of orthogonal polynomials we refer the reader to [24,28].

The plan of the paper is as follows. In Section 2, we briefly summarize recent results from $[2,3]$ and well-known facts on the orthogonal polynomials associated with discrete measures. In Section 3, we discuss spacing of the zeros of orthogonal polynomials for fairly general measures. The only new result in that section is Theorem 3.2. In the last section, we focus on the zero spacing of orthogonal polynomials for the equilibrium measure of the Cantor set $K(\gamma)$ which was introduced in [14].

## 2. Preliminaries

For the basic concepts of potential theory, we refer the reader to [20]. Convergence of measures is considered in the weak star topology. For a compact set $K \subset \mathbb{C}$ with the logarithmic capacity $\operatorname{Cap}(K)>0$, we denote the equilibrium measure of $K$ by $\rho_{K}$.

Let $\left(f_{n}\right)_{n=1}^{\infty}$ be a sequence of nonlinear polynomials. Throughout, for each $n \in \mathbb{N}$ we use the following notation: $f_{n}(z)=\sum_{j=0}^{d_{n}} a_{n, j} \cdot z^{j}$ where
$d_{n} \geqq 2, \quad a_{n, j} \in \mathbb{C}$ for $j=0, \ldots, d_{n}$ and $a_{n, d_{n}} \neq 0$. The composition $f_{n} \circ f_{n-1} \ldots \circ f_{1}$ will be denoted by $F_{n}$ and $\tau_{n}$ is used to denote the leading coefficient of $F_{n}$. The normalized counting measure on the roots (counting multiplicity) of $F_{n}(z)-a=0$ is denoted by $\nu_{n}^{a}$ where $a \in \mathbb{C}$.

The next result is a more general version of Theorem 3.3 in [3] and implies Theorem 2.8 of [2]. In these theorems the limit sequence is the equilibrium measure of some prescribed sets.

Theorem 2.1. Let $\left(f_{n}\right)_{n=1}^{\infty}$ be a sequence of nonlinear polynomials. Suppose further that there is an $a \in \mathbb{C}$ such that $\nu_{n}^{a} \rightarrow \mu$ as $n \rightarrow \infty$ where $\mu$ is a probability measure and $\operatorname{supp}(\mu)$ is an infinite compact set in $\mathbb{C}$. Then we have the following identities:
(a) $P_{1}(z ; \mu)=z+\frac{1}{d_{1}} \frac{a_{1, d_{1}-1}}{a_{1, d_{1}}}$.
(b) $P_{d_{1} \cdots d_{l}}(z ; \mu)=\frac{1}{\tau_{l}}\left(F_{l}(z)+\frac{1}{d_{l+1}} \frac{a_{l+1, d_{l+1}-1}}{a_{l+1, d_{l+1}}}\right)$ for all $l \in \mathbb{N}$.

Proof. The proof is almost the same as that of Theorem 3.3 in [3]. In the proof of Theorem 3.3 omit the first line, replace the equilibrium measure of $J_{\left(f_{n}\right)}$ by $\mu$ where it is necessary. Then we have the proof of this theorem.

In the last section, we focus on a concrete family of measures but the techniques used in the last two sections are applicable to some extent for many other measures supported on $\mathbb{R}$ provided that the associated orthogonal polynomials satisfy (a) and (b) of the above theorem. For a systematic way to construct such measures we refer the reader to Section 4 in [3].

If $\mu$ is a measure with an infinite support on $\mathbb{R}$ then the zeros of $P_{n}(\cdot ; \mu)$ are simple and real. We enumerate the zeros $\left(x_{j, n}(\mu)\right)_{j=1}^{n}$ of $P_{n}(\cdot ; \mu)$ so that they satisfy

$$
x_{1, n}(\mu)<x_{2, n}(\mu)<\cdots<x_{n, n}(\mu)
$$

Define $x_{0, n}(\mu)$ as the leftmost point and $x_{n+1, n}(\mu)$ as the rightmost point of $\operatorname{supp}(\mu)$, respectively. Then (see e.g. (2) in p. 358 of [10] and Theorem 2.3 in $[28])$, for $1 \leqq i \leqq n$ we have $x_{i, n}(\mu) \in\left(x_{0, n}, x_{n+1, n}\right)$. The next theorem (see for example Proposition 1.1 in [5] for a proof) will be used many times in the subsequent sections.

TheOrem 2.2. Let $\lambda$ be a measure with $\operatorname{supp}(\lambda)=\left\{c_{i, r}\right\}_{i} \subset \mathbb{R}$ where $r \in \mathbb{N}$ with $r>1$ and $i=1, \ldots, r$ provided that $c_{1, r}<c_{2, r}<\cdots<c_{r, r}$. Then, the zeros of $P_{s}(\cdot ; \lambda)$ lie in $\left(c_{1, r}, c_{r, r}\right)$ and they are real and simple where $1 \leqq s<r$. Moreover, in each interval $\left[c_{j, r}, c_{j+1, r}\right]$ there is at most one zero of $P_{s}(\cdot ; \lambda)$ where $j \in\{1, \ldots, r-1\}$.

We can reduce the infinite support case to the finite case by a classical technique. By doing that, we can use results such as Theorem 2.2 which
are valid for discrete measures. Assume that $\mu$ is a measure with an infinite support on $\mathbb{R}$ and let $r \in \mathbb{N}$. Then there is a unique measure $\mu^{(r)}$ with $\operatorname{supp}\left(\mu^{(r)}\right)=\left\{x: P_{r}(x ; \mu)=0\right\}$ such that for any polynomial $\pi$ with $\operatorname{deg} \pi \leqq 2 r-1$ we have

$$
\int \pi(x) d \mu(x)=\int \pi(x) d \mu^{(r)}(x)
$$

In particular,

$$
\begin{equation*}
P_{s}(\cdot ; \mu)=P_{s}\left(\cdot ; \mu^{(r)}\right) \tag{2.1}
\end{equation*}
$$

holds for all $1 \leqq s<r$ provided that $r>1$. See Theorem 2.5 in [28] for the proof.

## 3. Some general results

For a measure $\mu$ having an infinite support on $\mathbb{R}$, let $Z_{n}(\mu):=\{x$ : $\left.P_{n}(x ; \mu)=0\right\}$ and $Y_{n}(\mu):=\left\{x: P_{n}^{\prime}(x ; \mu)=0\right\}$. For $n>1$ with $n \in \mathbb{N}$, we define $M_{n}(\mu)$ by

$$
M_{n}(\mu):=\inf _{\substack{x, x^{\prime} \in Z_{n}(\mu) \\ x \neq x^{\prime}}}\left|x-x^{\prime}\right|
$$

If $\operatorname{supp}(\mu)$ is a Cantor set on $\mathbb{R}$ then the maximal distance between the consecutive zeros of any associated orthogonal polynomial is not so interesting since this value is bounded below (see e.g. (iii) in p. 358 of [10]) by the half of the length of the largest gap of $\operatorname{supp}(\mu)$. We only discuss $M_{n}(\cdot)$ here. By $d(A, B)$ we denote the Euclidean distance between the sets $A, B \subset \mathbb{C}$. The next proposition is a direct consequence of Theorem 3.3.3 in [25].

Proposition 3.1. Let $\mu$ be a measure with an infinite support on $\mathbb{R}$. Then for any fixed $l, m, n \in \mathbb{N}$ with $l>m>n>1$, we have

$$
d\left(Z_{l}(\mu), Z_{m}(\mu)\right)=\inf _{\substack{1 \leqq i \leqq l \\ 1 \leqq j \leqq m}}\left|x_{i, l}(\mu)-x_{j, m}(\mu)\right| \leqq M_{n}(\mu)
$$

Theorem 3.2. Let $\mu$ be a measure with an infinite support on $\mathbb{R}$ and let $\left(f_{n}\right)_{n=1}^{\infty}$ be a sequence of nonlinear polynomials. Assume further that there exists an $s_{0} \in \mathbb{N}$ such that $f_{l}^{\prime}(0)=0$ for all $l>s_{0}$ and $P_{d_{1} \cdots d_{m}}(\cdot ; \mu)=F_{m}(\cdot) / \tau_{m}$ holds for all $m \in \mathbb{N}$. Then for all $k, k^{\prime} \in \mathbb{N}_{0}$ with $k>k^{\prime}$ the following holds:

$$
d\left(Z_{d_{1} \cdots d_{s_{0}+k}}(\mu), Y_{d_{1} \cdots d_{s_{0}+k}}(\mu)\right) \leqq d\left(Z_{d_{1} \cdots d_{s_{0}+k}}(\mu), Z_{d_{1} \cdots d_{s_{0}+k^{\prime}}}(\mu)\right)
$$

Proof. Let us fix $k$ and $k^{\prime}$. If $k>k^{\prime}+1$ then for any $z \in \mathbb{C}$,

$$
\begin{gathered}
P_{d_{1} \cdots d_{s_{0}+k}}^{\prime}(z ; \mu)=F_{s_{0}+k}^{\prime}(z) / \tau_{s_{0}+k} \\
=\left(\left(f_{s_{0}+k} \circ f_{s_{0}+k-1} \circ \ldots \circ f_{s_{0}+k^{\prime}+1}\right) \circ F_{s_{0}+k^{\prime}}\right)^{\prime}(z) / \tau_{s_{0}+k} \\
=\frac{F_{s_{0}+k^{\prime}}^{\prime}(z) \cdot\left(f_{s_{0}+k} \circ f_{s_{0}+k-1} \circ \ldots \circ f_{s_{0}+k^{\prime}+1}\right)^{\prime}\left(F_{s_{0}+k^{\prime}}(z)\right)}{\tau_{s_{0}+k}} \\
=\frac{\left(F_{s_{0}+k^{\prime}}^{\prime} \cdot\left(f_{s_{0}+k^{\prime}+1}^{\prime} \circ F_{s_{0}+k^{\prime}}\right) \cdot\left(f_{s_{0}+k} \circ \ldots \circ f_{s_{0}+k^{\prime}+2}\right)^{\prime}\left(f_{s_{0}+k^{\prime}+1} \circ F_{s_{0}+k^{\prime}}\right)\right)(z)}{\tau_{s_{0}+k}}
\end{gathered}
$$

holds. Since $f_{s_{0}+k^{\prime}+1}^{\prime}(0)=0$ and $P_{d_{1} \cdots d_{s_{0}+k^{\prime}}}(z ; \mu)=F_{s_{0}+k^{\prime}}(z) / \tau_{s_{0}+k^{\prime}}$ hold, we have

$$
Z_{d_{1} \cdots d_{s_{0}+k^{\prime}}}(\mu) \subset Y_{d_{1} \cdots d_{s_{0}+k}}(\mu)
$$

If $k=k^{\prime}+1$ then

$$
P_{d_{1} \cdots d_{s_{0}+k}}^{\prime}(z ; \mu)=\frac{F_{s_{0}+k^{\prime}}^{\prime}(z) \cdot\left(f_{s_{0}+k^{\prime}+1}^{\prime} \circ F_{s_{0}+k^{\prime}}\right)(z)}{\tau_{s_{0}+k}}
$$

Thus, $Z_{d_{1} \cdots d_{s_{0}+k^{\prime}}}(\mu) \subset Y_{d_{1} \cdots d_{s_{0}+k}}(\mu)$ holds similarly. Hence, we have

$$
d\left(Z_{d_{1} \cdots d_{s_{0}+k}}(\mu), Y_{d_{1} \cdots d_{s_{0}+k}}(\mu)\right) \leqq d\left(Z_{d_{1} \cdots d_{s_{0}+k}}(\mu), Z_{d_{1} \cdots d_{s_{0}+k^{\prime}}}(\mu)\right)
$$

The next proposition gives an upper bound for $M_{n}(\mu)$. It is a straightforward consequence of classical results and we give the proof for the convenience of the reader.

Proposition 3.3. Let $\mu$ be a measure with an infinite support on $\mathbb{R}$ and let $n \in \mathbb{N}$ be given. Then for any $r \in \mathbb{N}$ satisfying $r>1$ and $r \geqq n$, we have

$$
\begin{equation*}
M_{r}(\mu) \leqq \inf _{0 \leqq i \leqq n-1}\left|x_{i+2, n}(\mu)-x_{i, n}(\mu)\right| \tag{3.1}
\end{equation*}
$$

Proof. For $r=n$, (3.1) follows from the definition of $M_{r}(\mu)$. So, let us pick an $r \in \mathbb{N}$ with $r>n$. Let $j \in\{0, \ldots, n-1\}$ be chosen so that

$$
\left|x_{j+2, n}(\mu)-x_{j, n}(\mu)\right|=\inf _{0 \leqq i \leqq n-1}\left|x_{i+2, n}(\mu)-x_{i, n}(\mu)\right|
$$

There are two cases to consider.
First, assume that $x_{j, n}(\mu)=x_{0, n}(\mu)$ or $x_{j+2, n}(\mu)=x_{n+1, n}(\mu)$ holds. Let $x_{j, n}(\mu)=x_{0, n}(\mu)$. Using Theorem 2.2 for $\lambda=\mu^{(r)}$, we have

$$
x_{0, n}(\mu)<x_{1, r}(\mu)<x_{1, n}(\mu)<x_{r, r}(\mu)<x_{n+1, n}(\mu)
$$

If we use Theorem 2.2 , for $\lambda=\mu^{(r)}$ we see that $\left[x_{1, r}(\mu), x_{2, r}(\mu)\right]$ may contain at most one element from $\left\{x_{1, n}(\mu), \ldots, x_{n, n}(\mu)\right\}$. Therefore, $M_{r}(\mu)$ $\leqq\left|x_{2, r}(\mu)-x_{1, r}(\mu)\right| \leqq\left|x_{2, n}(\mu)-x_{0, n}(\mu)\right|$. For the case, $j+2=n+1$, a similar argumentation shows that

$$
M_{r}(\mu) \leqq\left|x_{r, r}(\mu)-x_{r-1, r}(\mu)\right| \leqq\left|x_{n+1, n}(\mu)-x_{n-1, n}(\mu)\right|
$$

Now, let us assume that $x_{j, n}(\mu) \neq x_{0, n}(\mu)$ and $x_{j+2, n} \neq x_{n+1, n}$. Using Theorem 2.2 for $\lambda=\mu^{(r)}$, we have

$$
x_{1, r}(\mu)<x_{j, n}(\mu)<x_{j+1, n}(\mu)<x_{j+2, n}(\mu)<x_{r, r}(\mu)
$$

Thus, there is a $k_{1} \in \mathbb{N}$ with $1<k_{1}<r$ such that $x_{k_{1}, r}(\mu) \in\left[x_{j, n}(\mu)\right.$, $\left.x_{j+1, n}(\mu)\right]$ because otherwise there is an $i \in\{1, \ldots, r-1\}$ such that $\left[x_{j, n}(\mu)\right.$, $\left.x_{j+1, n}(\mu)\right] \subset\left(x_{i, r}(\mu), x_{i+1, r}(\mu)\right)$ and this would imply that $\left[x_{i, r}(\mu)\right.$, $\left.x_{i+1, r}(\mu)\right]$ contains two zeros of $P_{n}\left(\cdot ; \mu^{(r)}\right)$ which is impossible again by Theorem 2.2. On the other hand, $x_{k_{1}, r}(\mu)$ cannot be the only zero of $P_{r}(\cdot ; \mu)$ in $\left[x_{j, n}(\mu), x_{j+2, n}(\mu)\right]$. This would imply that $\left(x_{k_{1}-1, r}(\mu), x_{k_{1}+1, r}(\mu)\right)$ contains at least three zeros of $P_{n}(\cdot ; \mu)$ but this is impossible by Theorem 2.2 as $\left[x_{k_{1}-1, r}(\mu), x_{k_{1}+1, r}(\mu)\right]=\left[x_{k_{1}-1, r}\left(\mu^{(r)}\right), x_{k_{1}+1, r}\left(\mu^{(r)}\right)\right]$ may contain at most 2 zeros of $P_{n}\left(\cdot ; \mu^{(r)}\right)$ if we let $\lambda=\mu^{(r)}$. Hence there is a $k_{2} \in \mathbb{N}$ with $1<k_{2}<r$ and $k_{2} \neq k_{1}$ such that $x_{k_{2}, r}(\mu) \in\left[x_{j, n}(\mu), x_{j+2, n}(\mu)\right]$. Thus, $M_{r}(\mu) \leqq\left|x_{k_{2}, r}(\mu)-x_{k_{1}, r}(\mu)\right| \leqq\left|x_{j+2, n}(\mu)-x_{j, n}(\mu)\right|$. This shows that (3.1) holds.

## 4. Zero spacing of orthogonal polynomials for a special family

In this section, we study the spacing of the zeros of orthogonal polynomials for $\rho_{K(\gamma)}$ where $K(\gamma)$ is a Cantor set introduced in [14].

The construction and results in this and the next paragraph can be found in [14]. Let, here and in the sequel, $\gamma_{0}:=1$ and $\gamma=\left(\gamma_{k}\right)_{k=1}^{\infty}$ be a sequence satisfying $0<\gamma_{k}<1 / 4$ for all $k \in \mathbb{N}$ provided that $\sum_{k=1}^{\infty} 2^{-k} \log \left(1 / \gamma_{k}\right)<\infty$. We define $\left(f_{n}\right)_{n=1}^{\infty}$ by

$$
f_{1}(z):=2 z(z-1) / \gamma_{1}+1 \quad \text { and } \quad f_{n}(z):=z^{2} /\left(2 \gamma_{n}\right)+1-1 /\left(2 \gamma_{n}\right)
$$

for $n>1$. Let $E_{0}:=[0,1]$ and $E_{n}:=F_{n}^{-1}([-1,1])$ where $F_{n}$ stands for $f_{n} \circ \ldots \circ f_{1}$ as in Section 2. Then, $E_{n}$ is a union of $2^{n}$ disjoint non-degenerate compact intervals in $[0,1]$ and $E_{n} \subset E_{n-1}$ for all $n \in \mathbb{N}$. It turns out that, $K(\gamma):=\cap_{s=0}^{\infty} E_{s}$ is a non-polar Cantor set in $[0,1]$ where $\{0,1\} \subset K(\gamma)$. It is also shown in [3] that $K(\gamma)$ is a generalized polynomial Julia set in the sense of Brück and Büger, see e.g. [8], that is $K(\gamma)=\partial\left\{z: F_{n}(z) \rightarrow \infty\right\}$ provided that inf $\gamma_{k}>0$.

Let us look more carefully at the construction. We denote the connected components of $E_{n}$ by $I_{j, n}$ and the length of $I_{j, n}$ by $l_{j, n}$ for $j=1, \ldots, 2^{n}$, call these intervals as basic intervals of $n$-th level, define $a_{j, n}$ and $b_{j, n}$ by $\left[a_{j, n}, b_{j, n}\right]:=I_{j, n}$. Let $I_{1,0}:=E_{0}$ and $a_{j_{1}, n}>a_{j_{2}, n}$ if $j_{1}>j_{2}$. Then we have $I_{2 j-1, n+1} \cup I_{2 j, n+1} \subset I_{j, n}$ for all $n \in \mathbb{N}_{0}$ where $a_{2 j-1, n+1}=a_{j, n}$ and $b_{2 j, n+1}=b_{j, n}$. Denoting the gap $\left(b_{2 j-1, n+1}, a_{2 j, n+1}\right)$ by $H_{j, n}$, for $1 \leqq j \leqq 2^{n}$ and $n \in \mathbb{N}_{0}$, it follows that

$$
K(\gamma)=[0,1] \backslash\left(\bigcup_{n=0}^{\infty} \bigcup_{1 \leqq j \leqq 2^{n}} H_{j, n}\right)
$$

Using Theorem 11 in [12], we see that $\rho_{E_{n}}\left(I_{j, n}\right)=1 / 2^{n}$ for all $1 \leqq j \leqq 2^{n}$ and $n \in \mathbb{N}_{0}$. Furthermore, $\rho_{E_{k}}\left(I_{j, n}\right)=1 / 2^{n}$ for $k>n$ since $I_{j, n} \cap E_{k}$ consists of $2^{k-n}$ basic disjoint intervals of $k$-th level. Since $\left(E_{k}\right)_{k=0}^{\infty}$ is a decreasing sequence of sets with $\cap_{s=0}^{\infty} E_{s}=K(\gamma)$, by part (ii) of Theorem A. 16 in [22] (see also the proof of Corollary 3.2 in [1]), it follows that

$$
\rho_{K(\gamma)}\left(I_{j, n}\right)=\rho_{K(\gamma)}\left(I_{j, n} \cap K(\gamma)\right)=1 / 2^{n}
$$

The latter in particular implies that $\rho_{K(\gamma)}([0, r]) \in \mathbb{Q}$ for all $r \in \mathbb{R}$ with $r \notin K(\gamma)$.

It follows from the definition of equilibrium measure that supp $\left(\rho_{K(\gamma)}\right) \subset$ $K(\gamma)$. We also have $K(\gamma) \subset \operatorname{supp}\left(\rho_{K(\gamma)}\right)$ since for any $x \in K(\gamma)$ and $\varepsilon>0$ the open ball $B_{\varepsilon}(x)$ contains a basic interval $I_{j, n}$. From the above paragraph $\rho_{K(\gamma)}\left(I_{j, n} \cap K(\gamma)\right)>0$ and therefore $K(\gamma)=\operatorname{supp}\left(\rho_{K(\gamma)}\right)$.

In [2], it was shown that

$$
P_{d_{1} \cdots d_{m}}\left(z ; \rho_{K(\gamma)}\right)=P_{2^{m}}\left(z ; \rho_{K(\gamma)}\right)=F_{m}(z) / \tau_{m}
$$

for all $m \in \mathbb{N}$. Moreover, the recurrence coefficients have a simple form by Theorem 4.3 in [2]. Let us denote the Lebesgue measure on the real line by $|\cdot|$. By Lemma 6 in [14], $\left|\operatorname{supp}\left(\rho_{K(\gamma)}\right)\right|=|K(\gamma)|=0$ if $0<\gamma_{k}<1 / 32$ for all $k \in \mathbb{N}$. Using spectral theory techniques developed for orthogonal polynomials this result was generalized in [2]. If $\gamma$ satisfies $0<\gamma_{k} \leqq 1 / 6$ for all $k$ then, by [2], $\lim \inf a_{n}=0$ where $\left(a_{n}\right)_{n=1}^{\infty}$ is the sequence of recurrence coefficients for $\rho_{K(\gamma)}$. The latter, by [11], implies that $\rho_{K(\gamma)}$ has no nontrivial absolutely continuous part. Using the fact that $K(\gamma)=\operatorname{supp}\left(\rho_{K(\gamma)}\right)$, we see that $\rho_{K(\gamma)}$ is purely singular continuous provided that $0<\gamma_{k} \leqq 1 / 6$ for all $k \in \mathbb{N}$. Moreover, since $\left|\operatorname{supp}\left(\rho_{K(\gamma)}\right)\right|>0$ guarantees that (see [18] and Section 1 of [19]) $\rho_{K(\gamma)}$ has a non-trivial absolutely continuous part, $|K(\gamma)|=0$ holds true for such a $\gamma$.

Conversely, if $\gamma=\left(\gamma_{k}\right)_{k=1}^{\infty}$ satisfies $\sum_{k=1}^{\infty} \sqrt{\left(1-4 \gamma_{k}\right)}<\infty$ then $|K(\gamma)|$ $>0$ by [3]. This was actually shown for the stretched version $K_{1}(\gamma)$ of $K(\gamma)$ but the same condition is valid for $K(\gamma)$. In the proof and the statement of Theorem 6.2 in [3], if we take $Z_{0}=1 / 2, \varepsilon_{k}=1 / 4-\gamma_{k}$ and put $K(\gamma)$ instead of $K_{1}(\gamma)$ then we have the condition that makes $K(\gamma)$ a Parreau-Widom set. At the end of the paper we return to this condition and discuss it in a slightly more detailed way.

For a given sequence $\gamma=\left(\gamma_{k}\right)_{k=1}^{\infty}, f_{1}$ has two inverse branches $v_{1,1}, v_{2,1}$ : $[-1,1] \rightarrow[0,1]$ with

$$
v_{1,1}(t)=1 / 2-(1 / 2) \sqrt{1-2 \gamma_{1}+2 \gamma_{1} t} \quad \text { and } \quad v_{2,1}(t)=1-v_{1,1}(t)
$$

where $\left(f_{n}\right)_{n=1}^{\infty}$ is defined as in the beginning of this section. For each $n>1, f_{n}$ has two inverse branches $v_{1, n}, v_{2, n}:[-1,1] \rightarrow[-1,1]$ such that $v_{1, n}(t)=\sqrt{1-2 \gamma_{n}+2 \gamma_{n} t}$ and $v_{2, n}(t)=-v_{1, n}(t)$. Note that $v_{1, n}([-1,1])$ $\cap v_{2, n}([-1,1])=\emptyset$ for all $n \in \mathbb{N}$. By the fundamental theorem of algebra, for each $a \in \mathbb{C}, F_{n}(z)=a$ has at most $2^{n}$ different solutions and therefore $\left\{v_{i_{1}, 1} \circ \ldots \circ v_{i_{n}, n}\right\}_{i_{n} \in\{1,2\}}$ gives the total set of inverse branches of $F_{n}=$ $f_{n} \circ \ldots \circ f_{1}$ on $[-1,1]$. In addition to this, for each $I_{j, n}$ there is a unique choice of $i_{l} \in\{1,2\}$ for $l=1, \ldots, n$ giving $\left(v_{i_{1}, 1} \circ \ldots \circ v_{i_{n}, n}\right)([-1,1])=I_{j, n}$ and in particular $I_{1, n}=\left(v_{1,1} \circ v_{1,2} \circ \ldots \circ v_{1, n}\right)([-1,1])$.

Now, let $u(t)=1 / 2-(1 / 2) \sqrt{1-4 t}$ for $0 \leqq t \leqq 1 / 4$. Then

$$
\left(v_{i_{1}, 1} \circ \ldots \circ v_{i_{n}, n}\right)(t)=g_{1}\left(\gamma_{1} \cdot g_{2}\left(\gamma_{2} \ldots \gamma_{n-1} \cdot g_{n}(\tilde{t})\right)\right) \quad \text { for all } \quad t \in[-1,1]
$$

where $g_{l}=u$ if $i_{l}=1$ and $g_{l}=1-u$ if $i_{l}=2$ for $l=1, \ldots, n$, and $\tilde{t}=\left(\gamma_{n}-\right.$ $\left.\gamma_{n} t\right) / 2$. This last representation of inverse branches, which was used also in Section 3 of [14], simplifies the calculations since we have only two functions $u$ and $1-u$ instead of $2^{n}$ different functions. The function $u$ has a couple of nice properties that we will exploit many times. The last two of them are from [14].

Proposition 4.1. The following hold:
(a) $u$ and $u^{\prime}$ are strictly increasing. In particular, $u$ is strictly convex.
(b) $U_{n}:=u\left(\gamma_{1} \cdot u\left(\gamma_{2} \ldots \gamma_{n-1} \cdot u\left(\gamma_{n}\right)\right)\right)=\left(1-\cos \left(\pi / 2^{n}\right)\right) / 2$ for all $n \in \mathbb{N}$ where we take $\gamma_{k}=1 / 4$ for all $k$. The number $\left(1-\cos \left(\pi / 2^{n}\right)\right) / 2$ is the leftmost critical point of $F_{n}(z)$ and $F_{n}(z) / \tau_{n}=2^{-2^{n}} T_{2^{n}}(2 z-1)$ by Example 1 of [14] where $T_{2^{n}}$ is the $2^{n}$-th monic Chebyshev polynomial of the first kind.
(c) $u(a t) \leqq a u(t)$ for all $0 \leqq t \leqq 1 / 4$ and $0 \leqq a \leqq 1$.
(d) $t \leqq u(t)$ for $0 \leqq t \leqq 1 / 4$.

The next two lemmas easily follow from the properties mentioned in this section and the theorems from the previous one.

Lemma 4.2. Let $\gamma=\left(\gamma_{k}\right)_{k=1}^{\infty}$ be given. For all $n \in \mathbb{N}$, we have

\begin{gathered}
d\left(Z_{2^{n}}\left(\rho_{K(\gamma)}\right), Y_{2^{n}}\left(\rho_{K(\gamma)}\right)\right) \\
\geqq \inf _{\substack{i_{j} \in\{1,2\} \\
t \in\{-1,1\}}}\left|\left(v_{i_{1}, 1} \circ \ldots \circ v_{i_{n}, n}\right)(t)-\left(v_{i_{1}, 1} \circ \ldots \circ v_{i_{n}, n}\right)(0)\right| \\
=\inf _{\substack{g_{i} \in\{u, 1-u\} \\
\tilde{t} \in\left\{0, \gamma_{n}\right\}}}\left|g_{1}\left(\gamma_{1} \cdot g_{2}\left(\ldots \gamma_{n-1} \cdot g_{n}(\tilde{t})\right)\right)-g_{1}\left(\gamma_{1} \cdot g_{2}\left(\ldots \gamma_{n-1} \cdot g_{n}\left(\gamma_{n} / 2\right)\right)\right)\right| .
\end{gathered}
$$

Proof. Let us choose an $n \in \mathbb{N}$. Note that, $\left|F_{n}(z)\right|>1$ for all $z$ satisfying $P_{2^{n}}^{\prime}\left(z ; \rho_{K(\gamma)}\right)=F_{n}^{\prime}(z) / \tau_{n}=0$. Moreover $F_{n}\left(I_{j, n}\right)=[-1,1]$ and thus $Y_{2^{n}}\left(\rho_{K(\gamma)}\right) \cap I_{j, n}=\emptyset$ for each $1 \leqq j \leqq 2^{n}$. This implies that

$$
d\left(x_{j, 2^{n}}\left(\rho_{K(\gamma)}\right), Y_{2^{n}}\left(\rho_{K(\gamma)}\right)\right) \geqq d\left(x_{j, 2^{n}}\left(\rho_{K(\gamma)}\right),\left\{a_{j, n}, b_{j, n}\right\}\right)
$$

Hence, the first inequality holds. The second one follows from the definition of $g_{i}$.

Lemma 4.3. Let $\gamma=\left(\gamma_{k}\right)_{k=1}^{\infty}$ and $r \in \mathbb{N}$ be given. Then, for any $k \in \mathbb{N}$ with $r \geqq 2^{k}$,

$$
\begin{gathered}
M_{r}\left(\rho_{K(\gamma)}\right) \leqq \inf _{0 \leqq i \leqq 2^{k}-1}\left|x_{i+2,2^{k}}\left(\rho_{K(\gamma)}\right)-x_{i, 2^{k}}\left(\rho_{K(\gamma)}\right)\right| \\
\leqq\left|x_{2,2^{k}}\left(\rho_{K(\gamma)}\right)-x_{0,2^{k}}\left(\rho_{K(\gamma)}\right)\right| \leqq l_{1, k-1},
\end{gathered}
$$

holds.
Proof. By using Proposition 3.3 for $\mu=\rho_{K(\gamma)}$ and $n=2^{k}$, it can be seen that the first inequality holds. The last one holds true since $\left[x_{0,2^{k}}\left(\rho_{K(\gamma)}\right), x_{2,2^{k}}\left(\rho_{K(\gamma)}\right)\right]=\left[0, x_{2,2^{k}}\left(\rho_{K(\gamma)}\right)\right] \subset I_{1, k-1}$ for all $k \in \mathbb{N}$.

Now, let us prove an auxiliary result which is an analogue of Lemma 5.2 from [3]. For a given $\gamma=\left(\gamma_{k}\right)_{k=1}^{\infty}$, we denote the product $\gamma_{0} \ldots \gamma_{n}$ by $\delta_{n}$ for $n \in \mathbb{N}_{0}$.

Lemma 4.4. Let $\gamma=\left(\gamma_{k}\right)_{k=1}^{\infty}$ be given. Then

$$
\begin{equation*}
\delta_{s} \leqq l_{1, s} \leqq \frac{\pi^{2}}{4} \cdot \delta_{s} \tag{4.1}
\end{equation*}
$$

holds for all $s \in \mathbb{N}_{0}$.

Proof. For $s=0$, (4.1) holds trivially. So, let $s \geqq 1$. Observe that

$$
\begin{gather*}
l_{1, s}=u\left(\gamma_{1} \cdot u\left(\gamma_{2} \ldots \gamma_{s-1} \cdot u\left(\gamma_{s}\right)\right)\right)-u\left(\gamma_{1} \cdot u\left(\gamma_{2} \ldots \gamma_{s-1} \cdot u(0)\right)\right)  \tag{4.2}\\
=u\left(\gamma_{1} \cdot u\left(\gamma_{2} \ldots \gamma_{s-1} \cdot u\left(\gamma_{s}\right)\right)\right)  \tag{4.3}\\
=u\left(\left(4 \gamma_{1}\right) \cdot(1 / 4) \cdot u\left(\left(4 \gamma_{2}\right) \cdot(1 / 4) \ldots \gamma_{s-1} \cdot u\left(\left(4 \gamma_{s}\right) \cdot(1 / 4)\right)\right)\right) \\
\leqq 4^{s} \delta_{s} U_{s}
\end{gather*}
$$

The three equalities above are straightforward and the last inequality follows from the parts (b) and (c) of Proposition 4.1. Since $1-\cos x \leqq x^{2} / 2$ for all $x \in[0, \infty)$, we have

$$
U_{s}=\left(1-\cos \left(\pi / 2^{s}\right)\right) / 2 \leqq\left(4^{-s} \pi^{2}\right) / 4
$$

Using this and (4.5), the right part of (4.1) follows. Using (d) in Proposition 4.1, it is elementary to see that $\delta_{s} \leqq u\left(\gamma_{1} \cdot u\left(\gamma_{2} \ldots \gamma_{s-1} \cdot u\left(\gamma_{s}\right)\right)\right)$. This and (4.3) give the left part of (4.1).

The next lemma will allow us to find a lower bound for $M_{n}(\rho(K(\gamma)))$.
Lemma 4.5. Let $\gamma=\left(\gamma_{k}\right)_{k=1}^{\infty}$ be given. Then for any choice of $g_{i} \in$ $\{u, 1-u\}$, for $i=1, \ldots, n$, we have

$$
\begin{gather*}
\inf _{\tilde{t} \in\left\{0, \gamma_{n}\right\}}\left|g_{1}\left(\gamma_{1} \cdot g_{2}\left(\ldots \gamma_{n-1} \cdot g_{n}(\tilde{t})\right)\right)-g_{1}\left(\gamma_{1} \cdot g_{2}\left(\ldots \gamma_{n-1} \cdot g_{n}\left(\gamma_{n} / 2\right)\right)\right)\right|  \tag{4.6}\\
\geqq u\left(\gamma_{1} \cdot u\left(\gamma_{2} \cdot \ldots \gamma_{n-1} \cdot u\left(\gamma_{n} / 2\right)\right)\right) \geqq l_{1, n+1} \geqq \delta_{n+1}
\end{gather*}
$$

Proof. Let $n \in \mathbb{N}$ be given. Then $l_{1, n+1} \geqq \delta_{n+1}$ by Lemma 4.4. Since $u(t) \leqq 1 / 2$, we have $\gamma_{n} \cdot u\left(\gamma_{n+1}\right) \leqq \gamma_{n} / 2$. Using the part (c) of Proposition 4.1 we see that

$$
u\left(\gamma_{1} \cdot u\left(\gamma_{2} \ldots u\left(\gamma_{n} / 2\right)\right)\right) \geqq u\left(\gamma_{1} \cdot u\left(\gamma_{2} \ldots \gamma_{n} \cdot u\left(\gamma_{n+1}\right)\right)\right)=l_{1, n+1}
$$

holds and thus the second inequality in (4.6) follows.
In order to prove the first inequality in (4.6), it suffices to show that for a given $c \in\left[0, \gamma_{n} / 2\right]$, and $g_{i} \in\{u, 1-u\}, i=1, \ldots, n$, the following inequality holds:

$$
\begin{equation*}
\left|g_{1}\left(\gamma_{1} \ldots \gamma_{n-1} \cdot g_{n}\left(c+\gamma_{n} / 2\right)\right)-g_{1}\left(\gamma_{1} \ldots \gamma_{n-1} \cdot g_{n}(c)\right)\right| \tag{4.7}
\end{equation*}
$$

$$
\geqq u\left(\gamma_{1} \cdot u\left(\gamma_{2} \cdot \ldots \gamma_{n-1} \cdot u\left(\gamma_{n} / 2\right)\right)\right)
$$

Let

$$
\begin{gathered}
q_{n+1-k}:=g_{k}\left(\gamma_{k} \cdot g_{k+1}\left(\ldots \gamma_{n-1} \cdot g_{n}\left(c+\gamma_{n} / 2\right)\right)\right), \\
t_{n+1-k}:=g_{k}\left(\gamma_{k} \cdot g_{k+1}\left(\ldots \gamma_{n-1} \cdot g_{n}(c)\right)\right) \\
r_{n+1-k}:=u\left(\gamma_{k} \cdot u\left(\gamma_{k+1} \ldots \gamma_{n-1} \cdot u\left(\gamma_{n} / 2\right)\right)\right), \quad s_{k}:=\left|q_{k}-t_{k}\right|
\end{gathered}
$$

for $k=1, \ldots, n$. If $n=1$ then $s_{n} \geqq r_{n}$ holds since from strict convexity of $u$ we have

$$
\begin{equation*}
\left|g_{1}\left(c+\gamma_{1} / 2\right)-g_{1}(c)\right|=u\left(c+\gamma_{1} / 2\right)-u(c) \geqq u\left(\gamma_{1} / 2\right)-u(0) \tag{4.8}
\end{equation*}
$$

Suppose that $n>1$. We want to show that $s_{n} \geqq r_{n}$. Let us proceed by induction. For $k=1, s_{k} \geqq r_{k}$ since

$$
\left|g_{n}\left(c+\gamma_{n} / 2\right)-g_{n}(c)\right| \geqq u\left(\gamma_{n} / 2\right)
$$

holds. Suppose that the induction hypothesis holds for all $k=1, \ldots m$ provided that $m \leqq n-1$. Using, strict convexity of $u$ in (4.12) and the fact that $u$ is increasing in (4.14) we have

$$
\begin{gather*}
s_{m+1}=\left|q_{m+1}-t_{m+1}\right|  \tag{4.9}\\
=\left|g_{n-m}\left(\gamma_{n-m} \cdot q_{m}\right)-g_{n-m}\left(\gamma_{n-m} \cdot t_{m}\right)\right|  \tag{4.10}\\
=\left|u\left(\gamma_{n-m} \cdot q_{m}\right)-u\left(\gamma_{n-m} \cdot t_{m}\right)\right|  \tag{4.11}\\
\geqq u\left(\gamma_{n-m} \cdot\left|q_{m}-t_{m}\right|\right)  \tag{4.12}\\
=u\left(\gamma_{n-m} \cdot s_{m}\right)  \tag{4.13}\\
\geqq u\left(\gamma_{n-m} \cdot r_{m}\right)  \tag{4.14}\\
=r_{m+1} \tag{4.15}
\end{gather*}
$$

Hence, $s_{n} \geqq r_{n}$ holds if we take $m=n-1$ above. This gives (4.7) and completes our proof.

Eventually, we are ready to prove the main result of the paper.

TheOrem 4.6. Let $\gamma=\left(\gamma_{k}\right)_{k=1}^{\infty}$ and $n \in \mathbb{N}$ with $n>1$ be given. Furthermore, let $s$ be the integer satisfying $2^{s-1} \leqq n<2^{s}$. Then

$$
\begin{equation*}
\delta_{s+2} \leqq M_{n}\left(\rho_{K(\gamma)}\right) \leqq \frac{\pi^{2}}{4} \cdot \delta_{s-2} \tag{4.16}
\end{equation*}
$$

holds. In particular, if $\inf _{k} \gamma_{k}=c>0$ then we have

$$
\begin{equation*}
c^{2} \cdot \delta_{s} \leqq M_{n}\left(\rho_{K(\gamma)}\right) \leqq \frac{\pi^{2}}{4 c^{2}} \cdot \delta_{s} \tag{4.17}
\end{equation*}
$$

Proof. First, let us prove (4.16). Recall that for all $m>1, f_{m}^{\prime}(0)=0$ and $d_{i}=2$ for all $i \in \mathbb{N}$. Using Theorem 3.2 for $\mu=\rho_{K(\gamma)}, s_{0}=s, k=1$ and $k^{\prime}=0$, we have

$$
d\left(Z_{2^{s+1}}\left(\rho_{K(\gamma)}\right), Y_{2^{s+1}}\left(\rho_{K(\gamma)}\right)\right) \leqq d\left(Z_{2^{s+1}}\left(\rho_{K(\gamma)}\right), Z_{2^{s}}\left(\rho_{K(\gamma)}\right)\right)
$$

Using Proposition 3.1, for $\mu=\rho_{K(\gamma)}, l=2^{s+1}, m=2^{s}$, it can be seen that

$$
d\left(Z_{2^{s+1}}\left(\rho_{K(\gamma)}\right), Z_{2^{s}}\left(\rho_{K(\gamma)}\right)\right) \leqq M_{n}\left(\rho_{K(\gamma)}\right)
$$

Hence $d\left(Z_{2^{s+1}}\left(\rho_{K(\gamma)}\right), Y_{2^{s+1}}\left(\rho_{K(\gamma)}\right)\right) \leqq M_{n}\left(\rho_{K(\gamma)}\right)$ holds. By Lemma 4.2 and Lemma 4.5, the term on the left part of this last inequality is bounded below by $\delta_{s+2}$. This gives the first inequality in (4.16).

Using Lemma 4.3 for $r=n$ and $k=s-1$ and then Lemma 4.4, we deduce that

$$
M_{n}\left(\rho_{K(\gamma)}\right) \leqq l_{1, s-2} \leqq\left(\pi^{2} / 4\right) \delta_{s-2}
$$

This completes the proof of (4.16).
Combining the first inequality of (4.16) and the fact that $c^{2} \leqq \gamma_{s+1} \cdot \gamma_{s+2}$, the first inequality in (4.17) follows. Observe that $1 / c^{2} \geqq 1 /\left(\gamma_{s-1} \cdot \gamma_{s-2}\right)$. Hence, the second inequality in (4.16) implies that of (4.17). So, we are done.

REMARK 4.7. If there is a $c$ with $0<c \leqq \gamma_{k} \leqq 1 / 6$ for all $k \in \mathbb{N}$, then $\rho_{K(\gamma)}$ is purely singular continuous. Moreover (4.17) is satisfied and $|K(\gamma)|=0$ holds.

If $\gamma=\left(\gamma_{k}\right)_{k=1}^{\infty}$ satisfies $\sum_{k=1}^{\infty} \sqrt{\left(1-4 \gamma_{k}\right)}<\infty$ then there is a $c$ such that $0<c \leqq \gamma_{k}<1 / 4$ holds for all $k \in \mathbb{N}$ and $K(\gamma)$ is a Parreau-Widom set (see e.g. [9] for the definition) by [3]. Thus, (see [9,19] for the proof) $\rho_{K(\gamma)}$ and the Lebesgue measure restricted to $K(\gamma)$ are mutually absolutely continuous. Yet, (4.17) gives a pretty accurate description of $\left(M_{n}\left(\rho_{K(\gamma)}\right)\right)_{n=2}^{\infty}$.

For a $\gamma=\left(\gamma_{k}\right)_{k=1}^{\infty}$ with $\sum_{k=1}^{\infty} \gamma_{k}<\infty$ and $\gamma_{k} \leqq 1 / 32$ for all $k \in \mathbb{N}$, a special Hausdorff measure $\Lambda_{h}$ defined in [1] and $\rho_{K(\gamma)}$ are mutually absolutely
continuous. In this case, $K(\gamma)$ is of Hausdorff dimension zero (can be seen by using 2.3 in [1]) and we only have (4.16).

The term $\delta_{n}$ plays an important role to characterize the smoothness properties of the Green function $G_{\overline{\mathbb{C}} \backslash K(\gamma)}$ with pole at infinity (see Section 5 in [3] and [13]). For an overview of the smoothness properties of the Green function for the complement of homogeneous Cantor sets, we refer the reader to [26]. It is unclear that whether there is, in general, a meaningful relation between the spacing properties of orthogonal polynomials for $\rho_{K}$ and the supremum of the Hölder exponents making $G_{\overline{\mathbb{C}} \backslash K}$ Hölder continuous provided that $K \subset \mathbb{R}$ is a non-polar compact set.

It seems that similar results to Theorem 4.6 can be obtained for the equilibrium measure of the Julia set $J(f) \subset \mathbb{R}$ of a quadratic polynomial of the form $f(z)=z^{2}-c$ with $c>2$. If we let $f_{n}:=f$ for all $n \in \mathbb{N}$ then by [6], $F_{n}(z)=P_{2^{n}}\left(z ; \rho_{J(f)}\right)$ and $f_{n}^{\prime}(0)=0$ holds. Besides, the inverse branches of $f$ are $f_{ \pm}(t)= \pm \sqrt{t+c}$ and possibly they lead to similar calculations.
