Dialogue on Facebook pages of grocery stores: customer engagement or customer enragement?

Abstract The pervasiveness of social media is compelling businesses to review their way of managing customer experiences. However, there is a dearth of research as to why customers interact with businesses on social media in the grocery sector. This paper aims to explore how and why customers react to corporate messages on Facebook pages of Tesco and Walmart. Netnography approach was adopted to gain an insight into the various ways customers engage with the grocery stores on its Facebook pages. This study reveals that social media empower customers, influence the relationships customers have with grocery stores and generate customer engagement. Findings also show that the social customer is both a curse and a blessing to Tesco and Walmart as they can create or destroy value for the business. This paper contributes to knowledge by (1) uncovering the various ways customers react to company and customer initiated messages posted on corporate Facebook pages, (2) showing how value can be created and destroyed and (3) proposing a model illustrating how the main constructs of the study are interconnected: social media, relationship marketing, customer empowerment, and customer engagement.

Introduction

The social media revolution has impacted the business world, urging companies to adapt to a new social order (Arnaboldi and Coget 2016). By providing a two-way many-to-many communication system, social media enable consumers to connect, produce, and share media content in an unprecedented manner (Daugherty and Hoffman, 2014). Social media have empowered customers by giving them a voice to spread their opinions on products and services to a very wide audience and at an incredible speed (Constantinides et al. 2008). The surge in popularity of social media platforms has multiplied and facilitated the online interactions between businesses and consumers (Goh et al. 2012). Social media offer businesses new ways to talk to consumers (Thornhill et al. 2017) and provide an online platform where customers can easily connect and interact with a brand (Lovett and Staelin 2016). Businesses can also monitor consumers' conversations and attitudes towards a brand on social media (Srinivasan et al. 2015).

3 The potential benefits of adopting social media platforms have appealed to
4 businesses of all sizes across several industries (Valerio Ureña et al. 2015). Dreading
5 to lose the social media battle, managers have hastily integrated social media within
6 their business strategies (Schultz and Peltier 2013). Businesses have strongly
7 increased spending on social media, from 5.6% of marketing budgets in 2009 to a
8 forecasted growth of 20.9% by 2021 (Moorman 2016). However, many managers are
9 still uncertain of the opportunities and threats relating to social networks owing to the
10 lack of knowledge of their structure and operation (Kaplan and Haenlein 2010). In
11 today's digital era, marketers agree that social media are powerful tools, which can
12 spread and amplify word of mouth (Shamhuyenzva et al. 2016). Yet most
13 marketers ignore how to harness the power of social media (Divol et al. 2012).
14 Customers increasingly use social networking sites (SNSs) to discuss brands, products
15 and services, to seek or give advice, however it's still a mystery for marketers to
16 know when, where and how to influence these online conversations (Divol et al.
17 2012). Governments also understand the power of marketing via social media as they
18 support and guide local business to adapt to the new age of technology (Queensland
19 Government)

22 Extant literature covers the field of social media as a marketing tool to build
23 relationship with customers; however there is a dearth of research on the use of social
24 media in the grocery sector though practitioners in this field are increasingly
25 incorporating social media in their marketing strategy (Tarnowski 2011). Building
26 relationships in self-service outlets like grocery stores have until now been
27 challenging since there are reduced opportunities for interpersonal interactions
28 (Keeling et al. 2011). However, social media offer the possibility to grocery stores to
29 interact in real time with customers both inside and outside the stores (Tarnowski
30 2011). Therefore, it is critical for retailers within this sector to understand the
31 opportunities and challenges offered by social media. Additionally, it is becoming
32 very difficult for grocery stores to ignore the social media revolution since according
33 to a survey carried out in the United Kingdom; only 15 percent of supermarket
34 purchases were the result of traditional advertising, while 25 percent of purchases
35 were influenced by social platforms and blogs (Snow 2012).

38 Research has been carried out to understand motivations of customers for
39 interacting with businesses in the apparel sector (Anderson et al. 2014) where
40 customers are highly involved in the purchase. These authors suggested further
41 research to understand motivations of customers to connect with retailers in various
42 sectors. This paper therefore aims to fill this gap by analysing the motivations of
43 customers to interact with grocery stores, which sell mostly low involvement products
44 by analysing responses of customers to customer and company initiated messages.
45

47 This paper aims to uncover the reasons customers engage with grocery stores
48 on social media and to show how customer interactions on social media can be both a
49 blessing and a curse. Focusing on Facebook postings in a retail environment this
50 paper furthers the debate on marketing communications in and through a social media
51 environment. This research is significant in that it brings valuable information to
52 managers as to the expectations of customers who interact with companies via social
53 media. This might enable companies to reengineer their social media strategies to
54 derive more meaningful conversations, gaining higher levels of customer engagement
55 and ultimately increasing sales and customer loyalty. In this paper, we provide a brief

3 literature of social media, and customer engagement. We outline the netnographic
4 method and present a model based on the findings of the study focusing on the
5 challenges and opportunities that these phenomena present to retailers of the grocery
6 sector. We then conclude, present the limitations and suggest future research
7 directions.

10 **Literature Review**

11 **Social Media**

12
13
14 Social media are a collection of Internet-based applications that build on the
15 ideological and technological foundations of Web 2.0 (Kaplan and Haenlein 2010)
16 and mobile technology (Kietzmann et al. 2011) and they allow the creation and
17 exchange of user-generated content (UGC). Being an open platform enabling multi-
18 way communication, social media are fast and affordable (Arnaboldi and Coget
19 2016). Social media empower customers and virtual communities to send and
20 broadcast information to a global audience cheaply and instantaneously on the net
21 (Arnaboldi and Coget 2016). Hailed as a societal revolution, social media stem from
22 the concepts of Web 2.0 and UGC (Kizildag et al. 2017). The proliferation of UGC
23 platforms (e.g. TripAdvisor, Yelp) and SNSs (e.g. Facebook, Twitter, Instagram) and
24 Web 2.0 outlets (e.g. Wikis, podcasts, blogs) has assisted businesses to customise
25 their products and services, marketing strategies, and customer relationship strategies
26 to meet the specific needs of consumer groups (Kizildag et al. 2017). Social media
27 have transformed the internal organisational structure of businesses by changing the
28 way businesses communicate to the world (Kizildag et al. 2017).

33 **Customer empowerment in the social media age**

34
35 Customer empowerment is defined as a “process in which [businesses and customers]
36 systematically interact, learn, share information and integrate resources to jointly
37 create value” (Van Dijk et al., 2014, p. 110). The ubiquity of Web 2.0 technologies
38 and social media has led online users to be exposed to various digital sources of
39 information that are initiated, produced, disseminated, and consumed by online users
40 as a way to educate one another about products, services, brands, and issues (Chauhan
41 and Pillai 2013). Ease of access to information and the ability for customers to
42 communicate among themselves provide them with a feeling of empowerment and a
43 wish to play a bigger role in exchanging ideas and viewpoints with businesses (Hoyer
44 et al., 2010). Individuals also leverage social networks and blogs to create,
45 recommend and share information hence outspreading the reach of marketing
46 influence (Hanna et al. 2011). Consumers in the digital age use the Internet and social
47 media platforms to find information about products and services, to engage with the
48 businesses they purchase from, and to connect with other customers who may provide
49 valuable insights (Hanna et al. 2011). Traditional management methods can no longer
50 be used with consumers on social media as they expect firms to listen to them, engage
51 and respond accordingly (Kietzmann et al. 2011).

55 When brands and consumers co-create brand stories, brand owners do not have
56 full control of their brands (Mangold and Faulds 2009) as consumer-generated brand
57 contents can spread as quickly as those created by companies (Yan 2011). In this

3 social media era, marketers find themselves at the mercy of customers who can post
4 comments about their brands. As this new marketing paradigm evolves, there is
5 genuine excitement about the potential of social media to add value for businesses,
6 but also apprehension about the difficulty of seizing the full promise of this new
7 medium (Lipsman et al. 2012).
8

9 **Relationship Marketing using social media**

11 Relationship marketing sets the company-customer relationship in the center of
12 attention as it recognises long-term value of building relationships with customers
13 (Bruhn 2003). Social media are used to develop and nurture brand communities
14 (Sheth 2017). Social networking sites are increasingly being used by businesses to
15 establish their marketing network, since social media platforms facilitate the
16 establishment of communication and ongoing real time conversations (Coulter and
17 Roggeveen 2012). Social media communication emanating from the business is a key
18 element of the company's promotion mix (Mangold and Faulds 2009). The growth of
19 social media usage among consumers provides marketers the opportunity to move
20 forward relationships from dialogue to triologue – in which consumers engage in
21 meaningful conversations and relationships with one another and with the company
22 (Porter et al., 2011). Social media offer both businesses and customers innovative
23 ways of engaging with one another (Schivinski and Dabrowski 2014). Marketers
24 communicate through social media to engage with loyal customers, pass on
25 information, influence beliefs and attitudes about products and monitor the
26 conversations to learn about their users (Brodie et al. 2013). These users consciously
27 join groups of like-minded individuals who interact around a focal brand in brand
28 communities (Veloutsou 2009). Brand communities are “specialized, non-
29 geographically bound community, based on a structured set of social relationships
30 among admirers of a brand” (Muniz and O’Guinn 2001 p. 421).
31

34 Responding to this trend, businesses are setting up online brand communities to
35 engage with their customers (Ul Islam and Rahman 2017). With the advent of Internet
36 technology, communities of consumers shifted online, and over 50 percent of the top
37 100 global brands have an online brand community (Manchanda et al. 2012). 97% of
38 the Fortune 500 companies used social media as a communication tool in 2013, with
39 83% of these companies with an active Twitter account and 80% having a corporate
40 Facebook page (Barnes and Lescault 2014). Because of the significant presence of
41 potential customers on Facebook, businesses and brands invest in having a brand
42 presence by establishing a brand community on Facebook where consumers and fans
43 can interact with the business using the ‘like’, ‘share’ and ‘comment’ options (Ho
44 2014).

47 **Online brand communities on Facebook**

49 Corporate Facebook pages are online brand communities since fans who have ‘liked’
50 the page share a common interest (Pöyry et al. 2013). Research has identified that
51 large companies use their Facebook pages to (1) promote their products and services
52 such as launching new products and announcing sales promotions; (2) promote
53 sponsored events for e.g. donations or sponsoring sports activities; (3) carry out
54 surveys to get feedback from their fans; (4) make informational announcements for
55 e.g. new opening hours or new business locations; and (5) post fun messages usually
56

3 in a question style linked to a recent or forthcoming event (Dekay 2012). A recent
4 study in South Africa on Generation Z revealed that they updated their profile
5 regularly and this then is advantageous for marketers to target the segment for their
6 products or services (Duffett 2017).
7

8 Customers connect to a Facebook brand page because (1) they consume the
9 products and services of the company, (2) they hope to get discounts and promotions,
10 (3) they want to show to others that they like a particular brand, (4) they want to get
11 information about the brand before others do, and (5) they wish to have access to
12 exclusive content (Pereira et al. 2014).
13

14 Four benefits that customers gain from using social networks are: (1) social
15 benefits by interacting with other members of the community, (2) informational
16 benefits by accessing information about the products and services of the company, (3)
17 hedonic benefits by enjoying and having fun on the social network for e.g. games, and
18 finally (4) economic benefits by obtaining promotional deals. These benefits
19 encourage community members to continue visiting and being active on social
20 networking sites, therefore offering opportunities to firms to strengthen relationships
21 with their customers (Park and Kim 2014).
22
23

24 **Co-creation and Co-destruction on social media platforms**

25 Co-creation is one of the virtues of the new age marketing enabled by social media.
26 The evolution in connective technologies enables customers to actively participate in
27 value creation (Agarwal and Rahman, 2017). Also, businesses provide consumers
28 with tools and technology to participate and co-create value for themselves and other
29 customers (Agarwal and Rahman, 2017). Value co-creation is the joint value creation
30 activity that occurs through collaborative activities of firms and customers (Blasco-
31 Arcas et al. 2014). However, for marketers who need to manage their brands, UGC
32 and social media do not only provide opportunities but also threats (Vanden Bergh et
33 al. 2011). Social media and UGC are a potential threat to the efforts of organisations
34 to build, manage and protect their brands because such content is outside their
35 immediate control (Fournier and Avery 2011). Interestingly, technologies and tools of
36 Web 2.0 seem to ease the co-creation of value by the company and the customer
37 (Thackeray et al. 2008).
38
39
40

41 The open-comment platform of Facebook and the anonymity offered by the
42 Internet produce the ideal conditions for public outrage to be vented on corporate
43 walls (Champoux et al. 2012). Furthermore, social media have empowered customers
44 and the public by giving them a voice and weakened the position of companies by
45 rendering them vulnerable to customer attacks, negative publicity and corporate
46 reputation damage (Schulze Horn et al. 2015). The voice of the customer in brand
47 communities may be a threat to the organisation if it carries a negative content (Lee et
48 al. 2014). Social media users can generate huge waves of outrage within a short
49 period of time when reacting to a questionable activity or statement of an organisation
50 (Pfeffer et al. 2014). Such a phenomenon is qualified as an online firestorm, which is
51 “the sudden discharge of large quantities of messages containing negative word of
52 mouth and complaint behaviour against a person, company, or group in social media
53 networks” (Pfeffer et al. 2014, 118).

3 Despite the threats posed by the democratisation of communication, marketers
4 are increasingly using social media to connect and engage with their customers.
5 Customer engagement is believed to be the key outcome of social media campaigns
6 (Malhotra 2012). The negative impact of posts that criticize the service or product
7 can be used by organizations to gauge their performance and take advantage to
8 promote new changes and or explain their position.
9

10 **Customer Engagement**

11
12 In this increasingly connected world, social media channels provide new opportunities
13 to engage customers (Alexander and Jaakkola 2016). By giving access to online
14 content and communication through virtual tools, social media enable and facilitate
15 consumer experiences, which may generate customer engagement with specific
16 brands (Vivek et al. 2012). Though customer engagement has various interpretations,
17 it is often viewed as a motivational concept, with varying intensity. It encompasses an
18 object (i.e. a brand) and a subject (i.e. the customer) (Dessart et al. 2015), and has
19 either a positive or negative valence (Brodie et al. 2011a; Hollbeck and Chen 2014).
20
21

22
23 Customer engagement embraces the connection that users form with
24 businesses, following their experiences with the products, services and activities of
25 the business (Hollbeck 2011). Vivek et al. (2012) differentiate between customer-
26 initiated and firm initiated customer engagement. Customer-initiated engagement
27 occurs primarily due to the internal motivational state of customers without any clear
28 company actions. While firm-initiated customer engagement arises when businesses
29 explicitly adopt strategies to trigger customer engagement, for example, by
30 encouraging customers to share a video or to 'like' the brand on Facebook. Unlike
31 conventional marketing actions, firm-initiated engagement initiatives do not aim to
32 sell but to build relationships with customers by being interactive and prompting
33 participative experiences (Gill et al. 2017).
34

35
36 van Doorn et al. (2010 p. 253) define customer engagement behaviours as “the
37 customer’s behavioral manifestations toward a brand or firm, beyond purchase,
38 resulting from motivational drivers”. Forms of engagement include posting a
39 comment on a company’s Facebook page, writing a review on TripAdvisor,
40 interacting in a brand community, or referring a product to another customer. Other
41 researchers argued that customer engagement also incorporates the transactional
42 behaviour i.e. buying (Kumar et al. 2010; Pansari and Kumar 2017).
43

44
45 Hollebeck (2011 p. 790) defines customer brand engagement as “the level of a
46 customer's motivational, brand-related and context dependent state of mind
47 characterized by specific levels of cognitive, emotional and behavioural activity in
48 direct brand interactions”. In this definition of customer engagement, there are the
49 three dimensions that have been extensively cited in the literature, namely the
50 cognitive, emotional and behavioural perspectives (Brodie et al. 2011a; Hollbeck
51 2013). From a cognitive standpoint, engagement is a positive state of mind that is
52 represented by high commitment, energy, and loyalty towards a firm (Porter et al.
53 2011), for e.g. the person's level of concentration or engrossment in the brand
54 (Hollbeck 2011). From a behavioural viewpoint, engagement refers to actions toward
55 a firm that go beyond transactions (Porter et al. 2011), for e.g. participation, vigour
56 and interaction with the focal brand (Hollbeck 2013). From an emotional perspective,
57
58

3 customer engagement may be characterised by feelings of an individual towards a
4 brand (Vivek et al. 2012), for e.g. a customer's level of brand-related inspiration
5 and/or pride (Hollbeek 2011). A study by Leppäniemi et al. (2016) found that
6 customers' decisions to share information with other customers are emotional in
7 nature since these are founded on former positive experiences with the grocery store.
8 Hollbeek (2013) posits that the level of engagement and the resulting customer value
9 is different depending on whether the brand is perceived as utilitarian or hedonic.
10 Utilitarian value is increased when customers gain functional and instrumental
11 benefits with little or no emotion involved for example when buying staple food or a
12 washing machine. Hedonic value is experienced when a customer buys a
13 product/service for the affective gratifications that it brings to the user for example
14 entertainment, relaxation or escapism.
15

16
17 Unlike authors who have used multidimensional perspectives, van Doorn et al.
18 (2010) focus only on the behavioural dimension of customer engagement. According
19 to these scholars, customer engagement consists of behaviours, which go beyond
20 transactions (van Doorn et al. 2010). Customers engage in several behaviours that
21 boost their relationship with the brand. Behavioural manifestations do not only mean
22 purchases, but also include other activities of the customer such as word of mouth,
23 customer co-creation and complaining behaviour (Bijmolt et al. 2010),
24 recommendations, helping other customers, blogging, writing reviews and even
25 engaging in legal actions (van Doorn et al. 2010). By moving along the customer
26 engagement cycle, value is generated both for the customer and the company.
27 However, when organisations fail to engage customers, they have to face the potential
28 threat of customer enragement (Leeflang et al. 2014), a situation where customers can
29 easily become value destroyers instead of value creators for companies (Verhoef et al.
30 2013). This forces businesses to be increasingly reactive, or even pro-active, to avoid
31 negative brand image consequences which in turn may lead to increased value co-
32 destruction (Beckers et al. 2017). When seeking customer engagement, managers
33 need to consider the potential dark side of customer engagement, and be equipped to
34 deal with customer enragement in case the engagement campaign backfires (Beckers
35 et al. 2017).
36

38 39 **Methodology**

40
41 A netnographic study was undertaken to observe reactions of customers to company
42 posts on Facebook pages of grocery stores. Netnography is a participant-observation
43 method used for data collection to research the consumer behaviour of online
44 communities and cultures present on the Internet (Kozinets 2012). Kozinets (2009)
45 states that netnography attempts to provide understanding of a community and its
46 interactions and communications within that community. A non-participant
47 netnography research similar to Colliander and Wien (2013) was adopted. This
48 netnographic research aims to analyse the reactions of customers to messages posted
49 by grocery stores on their official Facebook pages. Moreover, netnography involves
50 observing customers, supermarkets and hypermarkets on the Internet unobtrusively
51 and provides a "window into naturally occurring behavior" that other marketing
52 research tools cannot do (Kozinets 2002 p. 62). For a rigorous and reliable research
53 approach, we have adhered to the five stages and recommended procedures: (1)
54 making entrée, (2) data collection and analysis, (3) providing trustworthy
55

3 interpretation, (4) research ethics, and finally (5) member checks (Kozinets et al.
4 2010).

5
6 For the entrée, Tesco and Walmart were chosen, as they are the major grocery
7 stores worldwide according to the March 2013 Global Food Retail report.
8 Additionally Tesco and Walmart adopt an international strategy and have stores in
9 several countries. Both grocery stores have set up official Facebook pages where
10 comments are posted in English and correspond to the criteria set by Kozinets et al.
11 (2010) to be considered as online communities. Kozinets et al. (2010) advise to select
12 online communities which (1) entice many individuals to actively post, (2) provide
13 data that can be analyzed, and (3) have interactions that are relevant to the research
14 questions. Facebook pages of Tesco and Walmart are appropriate sources of data
15 because of their wide popularity, pervasive nature and their interactive public writing
16 space, which allowed grocery stores to post information on their official pages for
17 customers to read, respond and interact with.
18
19

20 For data collection, we downloaded conversations occurring on the official
21 Facebook pages of Tesco and Walmart from 6 April 2014 to 6 May 2014. Similar to
22 the study of Colliander and Wien (2013), we opted for a non-participant observation
23 netnography and collected data during a one-month period. The data captured during
24 a one-month period is used to convey conversations at one particular point in time.
25 This data provides a good baseline study on which future retail netnographic studies
26 can be built and will serve as good base for a justifiable research method for
27 comparative analysis. Saturation of data occurred during that period (Kozinets 2002).
28 The data were saved in word documents, the data added up to 8008 pages of texts
29 using Arial font size 11. The data were analysed through the qualitative software,
30 NVivo. Qualitative content analysis was used to extract themes from the datasets as
31 recommended by Kozinets (2002). This netnographic qualitative study offers a
32 comparative analysis of Facebook postings linked to themes identified in Tables 1 and
33 2. Similar to the study of Stavros et al. (2014), the unit of analysis consisted of the
34 content of the Facebook pages of Tesco and Walmart and the coding units were the
35 individual posts and comments by customers of these grocery stores. Constant
36 comparative method was used to perform the qualitative data analysis (Straus &
37 Corbin, 1990) in order to generate insights. We first applied open coding (Miles &
38 Huberman, 1994) to bring meaning to the data, closely examining and comparing data
39 for similarities and differences. Each code represented a distinct aspect of the
40 phenomenon being studied. We then used axial coding (Miles & Huberman, 1994) to
41 interconnect the various categories identified in the previous stage in order to uncover
42 any fundamental underlying trends and patterns. By interpreting the comments posted
43 by customers on the official Facebook pages of Tesco and Walmart, we were able to
44 identify the different ways customers reacted to company-initiated messages and
45 customer-initiated messages.

51 The third step of netnography is to provide trustworthy interpretation.
52 Research is reckoned to be reasonable and trustworthy when conventional procedures
53 of netnography are followed while collecting and analysing data (Kozinets 2002).
54 Triangulation of data was used to enhance credibility of the study. Triangulation is
55 achieved through the use of a large number of customers who have posted comments
56
57

59

(Lincoln and Guba 1985). We also collected data from two different grocery stores to achieve site triangulation, which minimizes the impact of local factors pertaining to a specific grocery store on this research.

We adopted the ethical procedure recommended by Langer and Beckman (2005) for non-participant netnography. Comments posted on the Facebook page of Tesco and Walmart are publicly available data with no password restriction, therefore we did not need to obtain permission before using these data. However, we respected the anonymity and privacy of the participants.

Finally, the fifth step is carrying out member checks (Kozinets 2002). Member check is a technique whereby part or all of the research findings are given to the participants of the research in order to seek their comments (Lincoln and Guba 1985). However, we did not carry out member checks since this research is conducted entirely unobtrusively, and Langer and Beckman (2005) argue that in such conditions, member checks are not required.

Findings and Discussions

When customers respond to company posts or initiate conversations on the Facebook pages of Tesco and Walmart, they provide insights into the reasons why they engage with businesses on social media. Based on the themes identified in Tables 1 and 2, the reactions of customers to company-initiated messages and customer-initiated messages were identified as illustrated in Figure 1. The reactions of customers to posts on Facebook pages of Tesco and Walmart reveal that social media empower customers, influence the relationships customers have with grocery stores and generate customer engagement.

Empowered customers within the grocery sector

While interacting with Tesco and Walmart on their official Facebook page, customers perceive that they have been empowered since they can voice out their opinions to the virtual brand community and they can also add or destroy value for the business. Co-creation of products and modification of products are not areas in which customers can add value in the grocery sector, since grocery stores do not manufacture products but only source products from their suppliers to sell to final customers. However, this study reveals that customers of Tesco and Walmart add value to the relationship by suggesting products that they would like to have, by informing the grocery stores of their needs and wants, by recommending products to their peers, and by giving advice to other customers as illustrated by the following quote:

“Let's all go to tescos [sic] where allegra [sic] gets her best cloths [sic] their [sic] all half price she thinks that's nice”

Additionally, Facebook has given a voice to the customer, which extends far beyond the circle of relatives, friends and colleagues known to the customer. By giving a voice to the customer, Facebook has empowered customers since it is easier for customers to post complaints on the page, to criticise actions of the company, than

3 to call the company or write a letter of complaint. Einwiller and Steilen (2015) argue
4 that nowadays the creation and exchange of UGC on social media sites are rather easy
5 and effortless. Moreover, customers can observe other customers posting complaints
6 on Facebook pages of other companies, which may make it easier for them to
7 complain (Einwiller and Steilen 2015). Relatedly, in this study, over 65% of UGC on
8 the Facebook page of Tesco and Walmart consisted of complaints and criticisms.
9 When a customer posts a complaint or a criticism, it creates a snowball effect leading
10 other customers to complain as well (Schulze Horn et al. 2015). We find that when
11 customers of Tesco and Walmart complain on Facebook, they at times gain support
12 from other customers. This is in line with findings of Einwiller and Steilen (2015)
13 who say that since the complaint is publicly available on social media, the unsatisfied
14 customer could spread his or her dissatisfaction and potentially gain support from
15 other dissatisfied parties. So just one unhappy customer can cause a lot of harm to the
16 corporate reputation of the organisation and customers are aware of this power they
17 hold as illustrated below
18

20 *“As a loyal employee and a loyal customer who can influence many other customers*
21 *locally and via FaceBook,I [sic] hope we DO NOT carry the G.M.O. salmon that*
22 *many other stores/companies are refusing to sell.”*
23

24 **Relationship building within the grocery sector**

25
26 As the modern food retail industry is booming worldwide and competition in this
27 sector is rife, grocery retailers aim to provide superior customer value to gain
28 customer satisfaction. To improve the satisfaction levels of customers, retailers are
29 increasingly using social media to enrich their shopping experience (Pookulangara
30 and. Koesler 2011). Tesco and Walmart have set up their official Facebook pages to
31 communicate, interact and engage their customers to strengthen the relationship with
32 them.
33

34
35 In this study, customers comment on the relationship they have with grocery
36 stores by posting comments in which they have expressed satisfaction and loyalty
37 towards Tesco and Walmart. This study reveals that customers tend to post positive
38 comments in which they inform the company and other customers about the product
39 or service that they have bought and how satisfied they are with the purchase as
40 illustrated in the following quote:
41

42 *“Thanks for Tesco, And all the local & express Store's [sic], i [sic] for one*
43 *appreciate polite staff and bargain prices every day thanks Tesco, I'me [sic] a BIG*
44 *FAN !! [sic]”*
45

46
47 Emotional bonding is a prerequisite to strong brand relationships (Fournier
48 and Avery 2011). Customers of Tesco and Walmart have demonstrated their
49 emotional commitment to the firm by posting comments in which they express their
50 affection and attachment to the firm for e.g. by using the word 'love'. These
51 emotional bonds therefore provide a sustainable competitive advantage (Harridge-
52 March and Quinton 2009) as shown below.
53

54 *“Love tescos [sic] have shopped there for the last 29yrs [sic] since I had my first son.*
55 *£1 delivery slots will definitely make me shop on line!! [sic]”*

3 However, this study has also revealed numerous cases of dissatisfied
4 customers who have either complained about a product or service or criticised an
5 action of the organisation and who have vouched that they are terminating the
6 relationship with the grocery stores as illustrated by the following quote:
7

8 *“Why am I being plastered with ads from this miserable store? I hate walmart [sic]!!!!*
9

10 When retailers fail to meet expectations of customers, the relationship is
11 broken and customers turn to competitors (Zeithaml et al. 1996). However, engaging
12 with customers on Facebook, Tesco and Walmart can help build and maintain
13 relationships with them.
14

15 **Customer Engagement within the grocery sector**

16 Tesco and Walmart aim to engage customers on their official Facebook pages. This
17 study reveals that the three most extensively cited dimensions of customer
18 engagement occur on the Facebook page of Tesco and Walmart: cognitive, emotional
19 and behavioural. Cognitive engagement occurs at Tesco and Walmart, whenever
20 customers post comments in which they provide information and help to other
21 customers, or when they give advice to other customers. Another form of cognitive
22 engagement is when customers post comments about their satisfaction and loyalty
23 towards the stores. Customers express their satisfaction in terms of utilitarian value
24 gained by engaging with the stores as illustrated below:
25
26
27

28 *“Walmart the best store in the whole world, everything that I need is there, yeah [sic]*
29 *because after looking in the other stores website comparing prices at end Walmart is*
30 *the [sic] my favourite and I finished my day in Walmart.”*
31

32 In this statement, the customer explicitly states the utilitarian values she gains
33 while shopping at Walmart and these utilitarian values reinforce the relationship with
34 the grocery store. The perceived increase in utilitarian value increases the level of
35 customer engagement of the customer who feels the need to communicate her
36 satisfaction with the other community members. Similarly Hollbeck (2013) found that
37 customer engagement increases utilitarian value.
38
39

40 Emotional engagement also occurs whenever customers post comments about
41 their feelings and emotions. Customers use four main ways of expressing emotions on
42 the Facebook pages of Tesco and Walmart: enthusiasm, humour, sarcasm and
43 scepticism. Enthusiasm and humour bring hedonic value to the online community as
44 depicted by the following quote:
45

46 *“No golden egg for me but I had a lovely virtual walk around Kensington gardens,*
47 *Kew Gardens, Loch Ness, Snowden and many other places. So thank you for giving*
48 *me a couple of fun hours visiting places that I might not have seen xxx TY [sic]”*
49

50 In this quote, the customer refers to the hedonic value she has while
51 interacting on the Facebook page of Tesco. This finding is consistent with Hollbeck
52 (2013) who argues that customer engagement boosts hedonic value.
53
54

55 While sarcasm and scepticism destroy value and even damage the image of
56 the store as represented by the following quote:
57

4 *“So all this advert is really telling us is that you have been ripping us off for years.*
5 *Thank you for that , [sic] after all Every Little Helps.....your shareholders.”*
6

7 Emotional engagement influences the nature of the relationship between the
8 customer and the business (Brodie et al. 2011a).
9

10 Behavioural engagement occurs when customers request for more
11 information, entertainment, additional incentives and when they participate by
12 responding to posts of the stores. This study reveals that customers converse with
13 other customers on Facebook, share advertisement, give advice to other customers,
14 get or provide feedback to other customers, criticise other customers, help other
15 customers, make themselves or someone else known to other customers and also
16 provide support and encouragement to other customers as shown in Table 3.
17

21 When customers are engaged, the levels of utilitarian and hedonic value that
22 they perceive to experience increase (Hollebeek 2013). However, findings reveal that
23 engaged customers also post negative comments, which may harm the organisation.
24 When this occurs, instead of engaging customers, retailers generate customer
25 enagement (Leeflang et al. 2014). This study reveals that customers destroy value
26 when they post comments to complain, to criticise, to provide information about
27 competitors, to warn customers against a product/service, and to boycott a store as
28 illustrated in Table 3. When UGC contains negative brand information, it may
29 damage a brand (Cheong and Morrison 2008).
30

31 32 **Influence of Social Media on the Grocery Sector** 33

34 From the findings of this study, it can be concluded that the four main constructs of
35 the study are interconnected: social media, relationship marketing, customer
36 empowerment, and customer engagement. In the retail sector, more specifically the
37 grocery sector, Facebook generates online customer engagement which influences the
38 relationships customers have with Tesco and Walmart. Empowered customers use
39 Facebook to convey their satisfaction or dissatisfaction to Tesco and Walmart as well
40 as to the members of the community by posting comments. The interconnectedness of
41 the constructs is depicted in Figure 2.
42

43 The model depicts the reactions of customers to messages posted on the
44 Facebook pages of Tesco and Walmart. This study shows that customers interact with
45 the grocery stores by ‘liking’, ‘sharing’ and ‘commenting’ posts on the Facebook
46 page. By using Facebook to communicate with their customers, Tesco and Walmart
47 compensate for the lack of interpersonal interactions within the store. Customers use
48 the Facebook page to post queries, to complain, to criticise, and to make suggestions
49 to the grocery stores. These interactions enhance the relationship between the two
50 parties and give rise to the personification of the brand, a situation in which the
51 grocery store acts as a human friend of the store’s fans on Facebook.
52
53

54 This study also reveals that online customer engagement can either create
55 value or destroy value. Positive online customer engagement results in co-creation of
56
57

3 value, which leads to a stronger relationship between the grocery stores and their
4 customers. While negative online customer engagement also known as online
5 customer enagement leads to co-destruction of value, which weakens the relationship
6 between the parties.

10 In this social media era, whether the customer is satisfied or dissatisfied with
11 the products and services of the grocery stores, the customer feels empowered as
12 Facebook and social media offer a voice to the customer. When the customer has a
13 positive customer experience, he/she wants to share this experience with the other
14 members of the virtual community. Therefore, the happy and satisfied customer goes
15 back to the Facebook page and posts a positive message, which may eventually
16 positively influence the members of the online community. Conversely, when the
17 customer experiences a negative outcome resulting in online customer enagement,
18 he/she wants to share his/her experience with the other members of the virtual
19 community. Hence, the disgruntled and angry customer posts a negative comment on
20 the Facebook page. This customer backlash may damage the image of the grocery
21 stores and negatively influence the other members of the online community. Online
22 customer enagement brings co-destruction of value, which damages the relationship
23 between the two parties.
24
25

26 Within the social media realm, customers feel empowered, as social media
27 platforms have given them a voice. Whether the customers are satisfied or not, they
28 feel empowered since they can influence the other community members. Satisfied
29 customers post positive comments to share their positive experience, while
30 disgruntled customers turn to Facebook to complain or to express their discontent.
31 Therefore, it is vital that retailers understand how to harness social media to enhance
32 the shopping experience of customers.
33
34

35 **Conclusion**

36 Social media have profoundly transformed the marketing landscape by providing
37 opportunities to businesses to communicate and interact with their customers, but also
38 challenging them by giving a voice and more power to customers. The aim of this
39 paper was to analyse the reactions of customers on Facebook pages of Tesco and
40 Walmart. Exploring the rich and complex world of social media through Facebook
41 postings has served to demonstrate the shifting landscape in which marketing
42 communications operate. This paper shows the various ways customers engage with
43 grocery stores as illustrated in Tables 1 and 2. When customers engage positively
44 with the grocery store, value is created and the relationship is enhanced. However,
45 when customer enagement occurs, customers destroy value by taking actions, which
46 harm the business such as posting complaints and criticisms or asking customers to
47 boycott the store, thus endangering the relationships with customers. Social media
48 have empowered customers who use Facebook to express their satisfactions or
49 dissatisfactions on the official Facebook pages of Tesco and Walmart.
50

53 This research makes several contributions to the literature on the use of social
54 media, more specifically Facebook in the grocery sector. However, few studies have
55 attempted to analyse customer perceptions on the relationship building potential of
56

3 social media. This research has analysed customer reactions to both company initiated
4 messages and customer initiated messages on the Facebook pages of grocery stores,
5 bridging the gap between social media literature and relationship marketing literature
6 within the grocery sector from the customers' perspectives. This paper is unique in
7 that it shows the interconnectedness of social media, relationship marketing, customer
8 empowerment and customer engagement in the grocery sector. It has also identified
9 ways customers co-create and co-destroy value in the grocery sector.
10

11 This paper has brought to light several implications for retailers. This study
12 suggests that online brand community members want to interact with brands, and this
13 interaction motivates them to pursue a relationship with the brand. Facebook fan
14 pages should be designed to encourage conversations among consumers about
15 marketing messages. Retailers should closely monitor the dialogue on social media
16 platforms to identify the best time to participate in the conversation and respond to
17 customers' comments to strengthen the bonds between the brand and its customers.
18 Additionally, retailers should encourage customer co-creation on their Facebook page
19 and should also harness customer relationship management (CRM) 2.0 by using all
20 the information provided by customers in their comments to personalise the
21 communication with them.
22
23

24 Retailers need to be aware that in this digital era, customers view social media
25 platforms as a direct communication channel with the brand. These customers are
26 looking for convenience and expect retailers to respond in 'real-time' to their queries.
27 It is obvious from this study that customers perceive the official Facebook page of
28 Tesco and Walmart as a customer service channel. Therefore retailers should attend to
29 the queries and complaints of customers efficiently on Facebook, so that unsatisfied
30 customers can be turned into loyal customers. As social media have made it easier for
31 customers to complain, retailers should use this as an opportunity to positively
32 influence the perceptions of customers by showing to them how they listen and
33 resolve customer issues.
34
35

36 Retailers need to be cautious when starting conversations on social media
37 platforms. In particular, retailers should be aware of the 'wild west' nature of social
38 media (Tench and Jones 2015) and be ready to counteract customer enragement or
39 any online firestorms (Pfeffer, 2013) to avoid co-destruction of value.
40
41

42 The limitation of the paper is related to the nature of the netnography method,
43 which constrained the analysis to those customers who have commented on
44 Facebook, therefore neglecting other sources such as offline customer feedback or
45 anti brand communities. Future research might consider these other online sources
46 where customers exchange information on brands. This paper has focused on two
47 businesses, which are active on social media, and therefore it could be interesting to
48 compare between a passive and an active company on social media. Another avenue
49 for future research could be to focus on one grocery store operating in several
50 countries to identify differences and similarities between social media communication
51 in different country contexts. This will provide the opportunity to look at how
52 communication is customised to specific locations i.e. the influence of place and
53 culture.

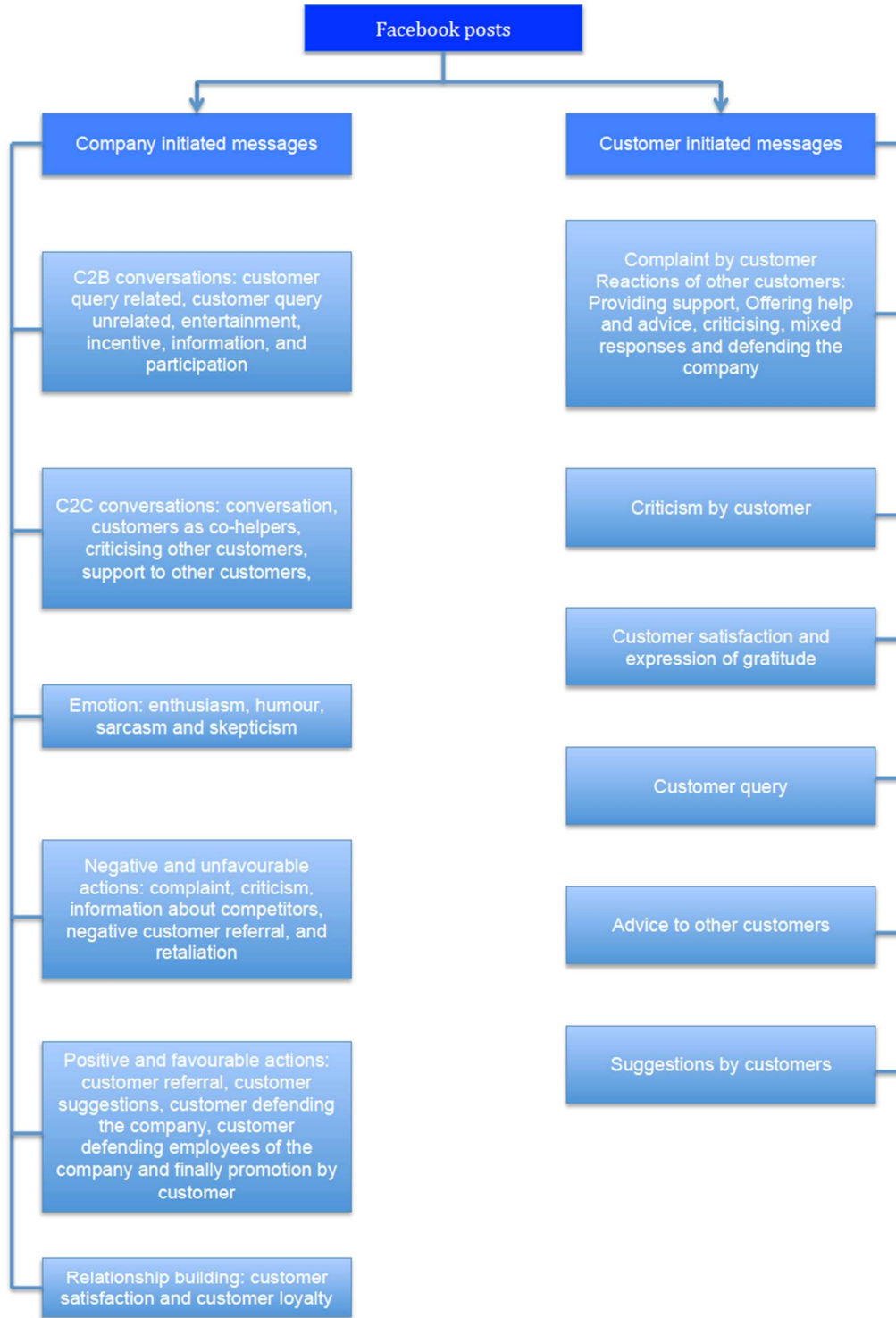


Fig. 1. Customer reactions to messages posted on Facebook pages of Tesco and Walmart.

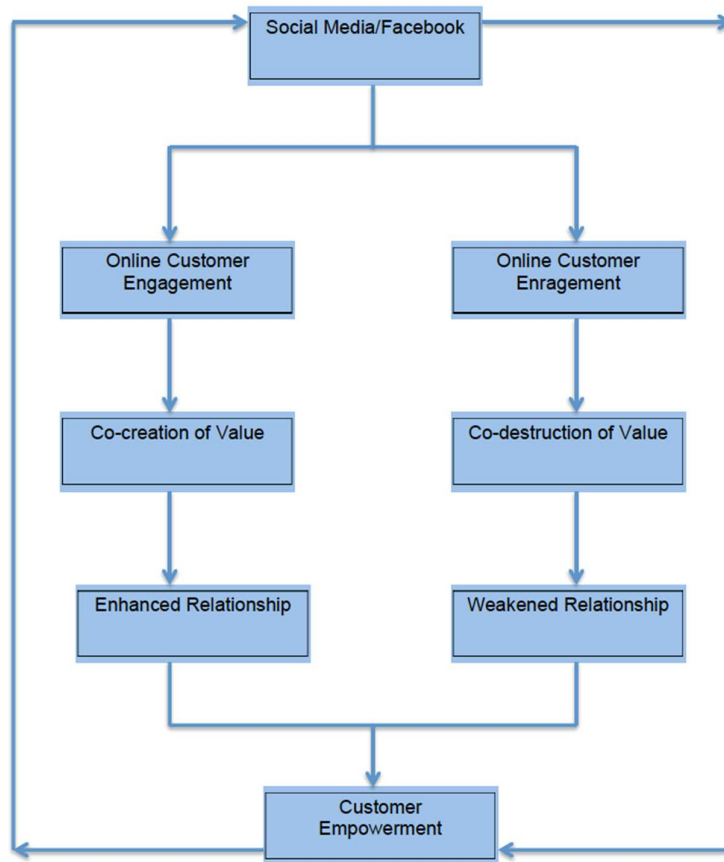


Fig. 2. Creation and Destruction of value on Facebook pages of Tesco and Walmart.
