The Depository Services Program

- **1927**
- Communications policy required federal agencies provide the DSP with copies of their publications for distribution to member libraries
- Ensured that free public access to published government information is available
- Agreements with over 800 libraries within and outside Canada

Compliance

- DSP operates under Treasury Board guidelines
 - DSP can request but not demand publications
 - Different environment in the U.S
- Federal Depository Library Program (FDLP) is legally mandated in Title 44, Chapter 19 of the US Code.
 - Agencies are required by law to submit their publications to the US Superintendent of Documents

Library Advisory Committee (LAC)

- 1978: Formal agreement was created between depository libraries and the DSP
 - shift towards a standardized depository system
- □ 1981: DSP-LAC was established to:
 - Monitor the program
 - Assess participation
 - Draft retention guidelines
 - Advise the DSP on operations, policies, practices, plans, directions and services.

"The preservation of legacy material on Government of Canada websites and the future of government publishing in Canada are major concerns, given the recent removal of, or intention to remove, significant collections from Government of Canada websites. Gaps in the public record of information are occurring without consultation with stakeholders."

- 2001: Common Look and Feel (CLF 1.0)
- 2010: Crown Copyright Licensing Program (CCL) changed use statements in late 2010
 - Permission to reproduce Government of Canada works, in part or in whole, and by any means, for personal or public non-commercial purposes, or for cost-recovery purposes, is not required, unless otherwise specified in the material you wish to reproduce.
- 2011 Jodhan v. Canada (Attorney General)
 - "This declaration does not apply to stored government historical and/or archived information which is stored in a database and which the government shall retrieve and provide in an accessible format upon request;"

Budget 2012: DSP

- Libraries no longer be able to order hard-copy publications via the DSP
- Government departments are only obligated to send electronic copies of their publications
- DSP no longer a central point for ordering and distributing physical formats
- □ DSP will only maintain its "e-library collection"


Budget 2012: DSP

- Decentralization of publication distribution -
 - i)Individual departments and agencies need to be contacted directly for respective hard copy information products.
- Expiration of the Depository Library Agreements
- Depository libraries are no longer subject to terms of Agreement (including retention guidelines)

Budget 2012: DSP

- □ Letter sent to all depository libraries of notice to terminate agreement effective December 31, 2013
- □ All foreign exchange agreements ended March 2014
- Publishing and Depository Services will no longer administer
 crown copyright and licensing for the Government of Canada
- Weekly Checklist only available online
- □ Library Advisory Committee changed to DSP Advisory Committee

Canada's Action Plan on Open Government



ROT: Redundant, Outdated, Trivial

STEP 1:

Redundant

Your institution, organization, or program is **not** the authoritative source for the content. The Web page (of websites including Web applications) is duplicated elsewhere on a website.

Outdated

Orphan pages: there is either no way to navigate to the page, or there is no business owner.

- Outdated pages: Topics that are no longer relevant.
- Discontinued programs, past events.
- Things that are written in the wrong tense ("will be" for a date in the past).
- Not a Web-friendly document (e.g. just a list of bullets or links without any context).

Trivial

- Web page (of websites including Web applications) is not relevant or informative for the audience.
- Web analytics show low to no page views or visits.
- Title of the Web page (of websites including Web applications) doesn't match the content.

Vision and Principles

- One integrated Government of Canada site
- Information architecture will:
 - Be user-centric organized by key themes/topics audiences and tasks based on research and testin
 - Include all Government information and service
 - Include engagement capabilities

Process

- Short-term: The IA Working Group will outline a and approval
- Long-term: The Action Plan will outline the task final information architecture for implementati
 - Content inventory (including list of services/topics)
 - Usability testing
 - Top tasks

The Aboriginal Canada Portal was developed in 2001, when it was more difficult to find Aboriginal resources and services on the internet. There are now a wide variety of Aboriginal resources online and the rise of search engines and social media have rendered the Portal web site obsolete.

Two of the more popular components of the Aboriginal Canada Portal site were improved and transferred to the Aboriginal Affairs and Northern Development Canada (AANDC) departmental web site.

Impact

- Loss of organizational memory
- Deprofessionalization

Publishing and Depository Services

- Integrated Services Branch
- Government Information Services Sector of Public Works and Development Canada
- Publishing and Depository Services:
 - Access to 120, 000 Government of Canada e-publication
 - Provides access to Government of Canada publications created in portable electronic formats
 - As of April 1, 2014, PDS no longer sells, warehouses or distributes tangible format publications on behalf of the Government of Canada
 - Tangible formats of publications must be requested directly from the author departments
 - DSP will continue to catalogue publications in tangible formats if we receive them, and they will be included in the Weekly checklist
 - Newly received e-publications will also be included in the weekly checklist

- □ The DSP-AC provides advice and information to the DSP on issues of interest to both the DSP and the library community.
- The DSP-AC makes recommendations to the DSP on matters of interest to the stakeholder library community and user communities.

To preserve and provide perpetual access to digital content originally published by government agencies in Canada:


- Decentralized and distributed preservation (Lots of Copies Keeps Stuff Safe)

- Perpetual access
- Affordable and sustainable
