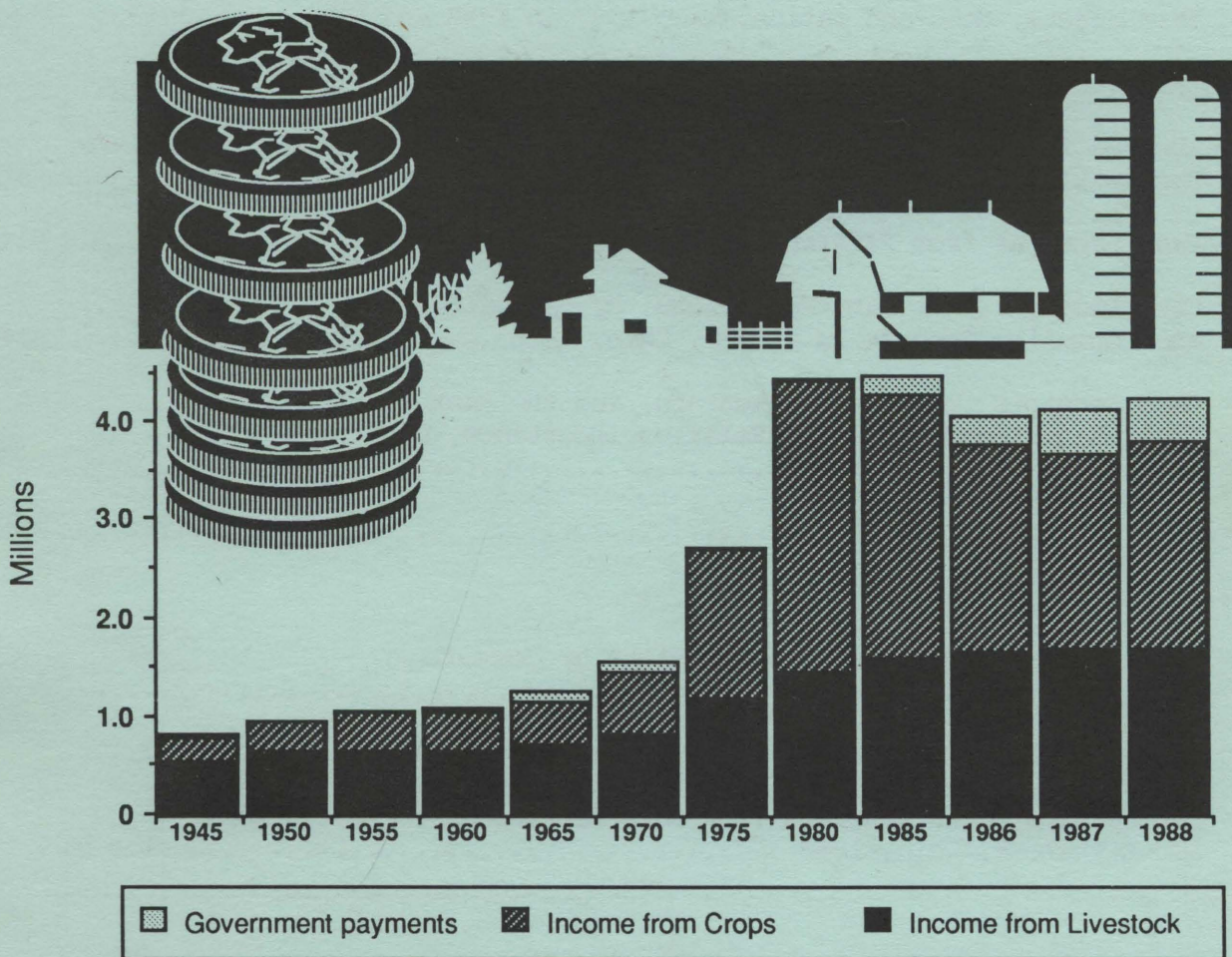

OHIO CASH RECEIPTS FROM FARMING IN OHIO, 1988

Cash receipts from marketing Ohio livestock, livestock products, and crops totaled \$3.6 billion in 1988, a 4 percent increase from a year earlier and 13 percent less than the record high established in 1980. The 1988 cash receipts ranked third highest on record; only 1980 and 1985 cash receipts were higher- both exceeded \$4 billion.

In 1988 livestock and livestock products earned \$1.60 billion in cash receipts, the third largest amount recorded in this category. This is down 1 percent from a year earlier and 1 percent below the record high. The record high was reached in 1984 at \$1.63 billion. The percentage of total cash receipts earned by livestock and livestock products was 44.2 percent. This is 2.3 points lower than in 1987.

Crops cash receipts, at \$2.02 billion for 1988, are up 9 percent from 1987 and 28 percent below the record high set in 1980 (\$2.82 billion). The percentage of total cash receipts attributed to crops in 1987 was 55.8 up 2.3 percentage points from a year earlier. Crops cash receipts reached a record high 67.3 percent of total cash receipts in 1980 and has exceeded 50 percent since 1973.

Government payments totaled \$381.9 million, down 12 percent from the record high \$431.9 million received in 1987. This represents 10 percent of all cash income and 50 percent of net farm income after inventory adjustments. If government payments were ranked among the commodities, they would be fifth on the list for 1988 surpassed only by soybeans, milk, corn and cattle. Ohio farmers received \$1.4 billion in government payments from 1945 through 1982. Since 1982 government payments totaled \$1.6 billion.

The top five ranked commodities which usually produce at least 75 percent of all cash receipts again reached 76.5 percent. Corn fell from its usual number one position to third place capturing only 15.1 percent of total cash receipts. Soybeans moved up a notch from its usual number two position garnering 24.0 percent of cash receipts. Dairy products earned less in absolute dollars from 1987 to 1988 but enough to surpass corn and move up from third to second place with 15.9 percent of cash receipts. Cattle and calves moved up to fourth position accounting for 11.1 percent of receipts followed by hogs holding fifth position with 10.4 percent of cash receipts.

Gross farm income for 1988 at \$4.12 billion was down 2 percent (\$67.1 million) from a year earlier. Cash income was up from a year earlier. Within the cash income category crops income advanced 9 percent, livestock income declined 1 percent and government payments dropped 12 percent. Value of inventory had a major negative impact on gross farm income; it declined \$259.2 million in 1988.

County rankings based on total cash receipts were unchanged from 1987 to 1988 for the first four positions with Mercer, Darke, Wayne and Licking holding first through fourth respectively. Fulton moved up one notch to fifth place. Auglaize gained two position into sixth place. Putnam fell two rungs to seventh. Union moved up one to eighth place. Clark and Madison moved into the top ten's last two positions replacing Holmes which was seventh last year and Seneca which was tenth. The number one county was unchanged in six of the eight commodity categories. Wayne retained first place in dairy products and cattle and calves; Darke kept first spot in hogs and soybeans; Mercer held on to first place in poultry and other livestock; and Wood stayed number one for wheat. Fayette nudged Darke out of first place for corn and Lorain moved ahead of Lake in the other crops category.

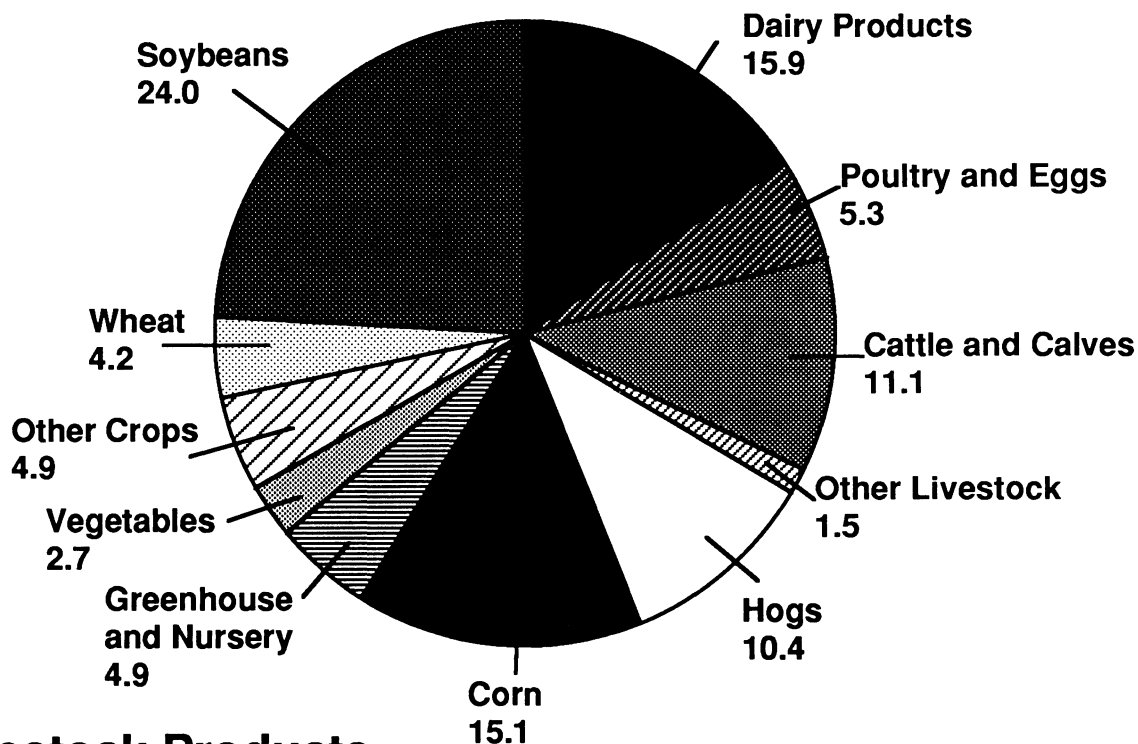

FIGURE II: GROSS AND NET INCOME, OHIO

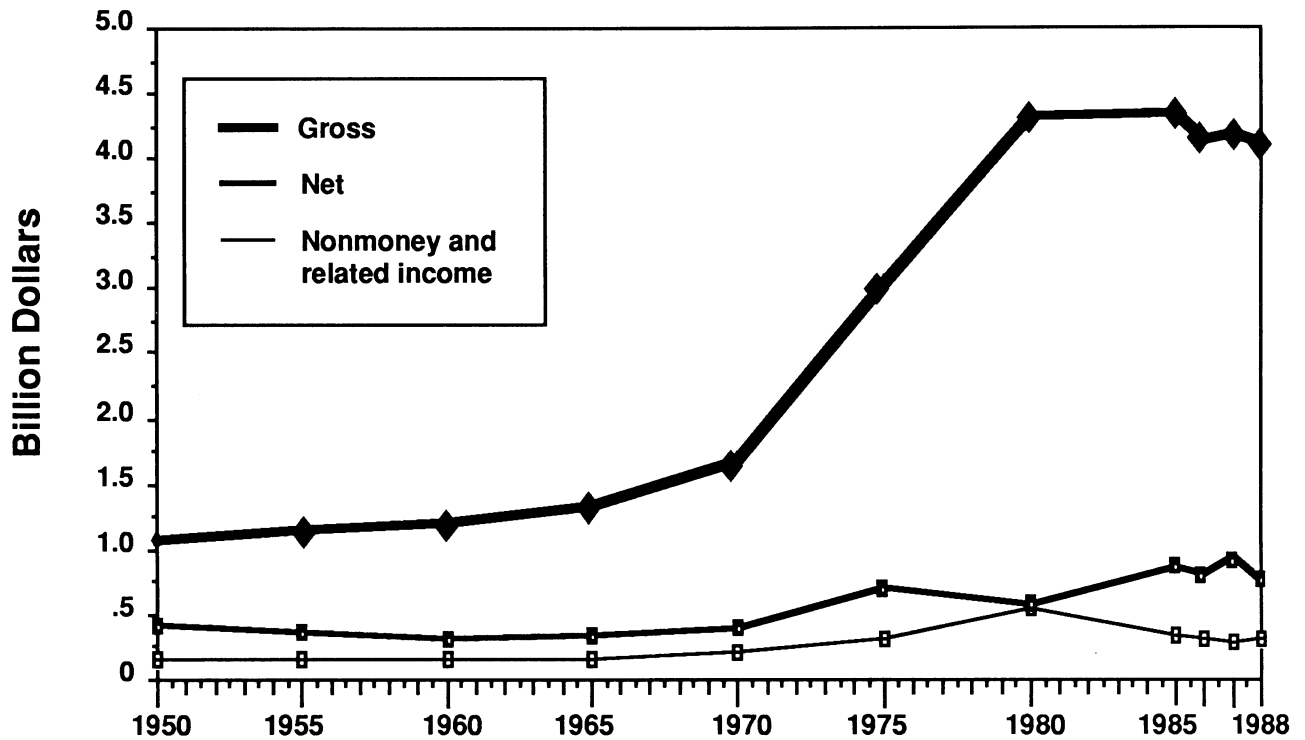

PROCEDURE

Ohio estimates of cash receipts from farm marketings were published initially in 1927 and annually since 1929. These county estimates of cash receipts are published by the Department of Agricultural Economics and Rural Sociology of the Ohio State University and the Ohio Agricultural Research and Development Center in cooperation with the National Agricultural Statistics Service of the United States Department of Agriculture. This bulletin contains 1988 Ohio county and state cash receipts estimates and revised 1985-1987 State estimates. County production and inventory estimates of various commodities are published annually in the Ohio Agricultural Statistics bulletin.

Current cash receipts estimates for Ohio and other States appear in the USDA's ECONOMIC INDICATORS OF THE FARM SECTOR: State Income and Balance Sheet Statistics, 1988. These estimates are prepared by the Economic Research Service of the U.S. Department of Agriculture, from basic data provided by the National Agricultural Statistics Service, the Census of Agriculture, and other sources. Estimates presented in this publication may differ from previously published data due to revisions in marketings, in shipments, inventory numbers, and other data, as more complete information becomes available. Cash receipts for some commodities were combined to avoid disclosure of individual operation data.

Cash receipts from farm marketings of farm products represent calendar year gross receipts from commercial market sales as well as loans (net of redemptions) made or guaranteed by CCC and purchases under price support programs. The value of home consumption and production expenses is excluded. County estimates of cash receipts from marketings are derived by allocating State estimates to counties on the basis of crop reporting and Census marketings by Agricultural Statistics districts. Check data such as county dairy production from the milk market administrators are also used.

The definition of a farm includes a place which has annual sales of agricultural products of \$1,000 or more. This definition has been used since the 1974 Census of Agriculture. The average cash receipts per farm will aid in the comparison of counties with similar farm practices better than a comparison of total cash receipts.

This bulletin has been prepared through the efforts of many people, including personnel of agricultural agencies throughout Ohio. The greatest recognition is due to the large number of Ohio farmers and agri-businessmen for their interest and help in providing the basic data used in compiling this information.

1988 Total Cash Receipts

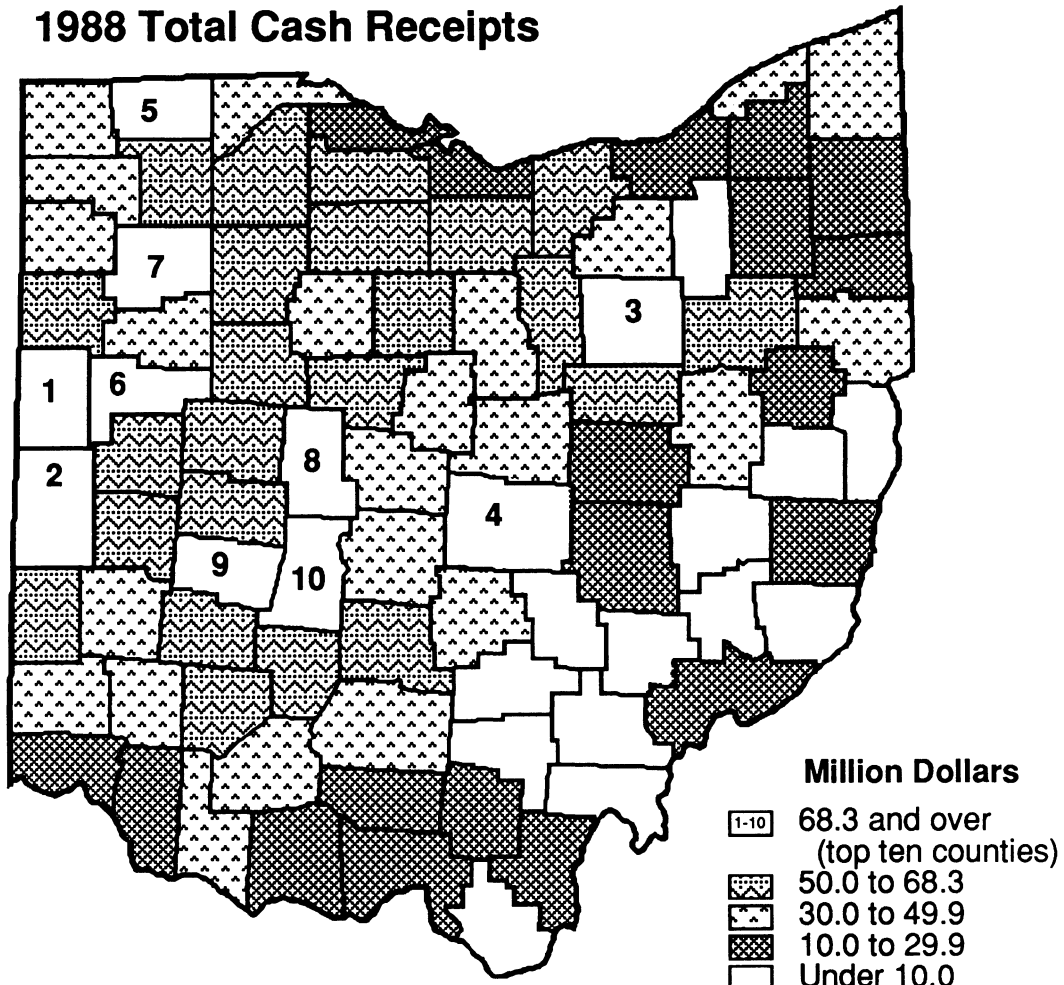
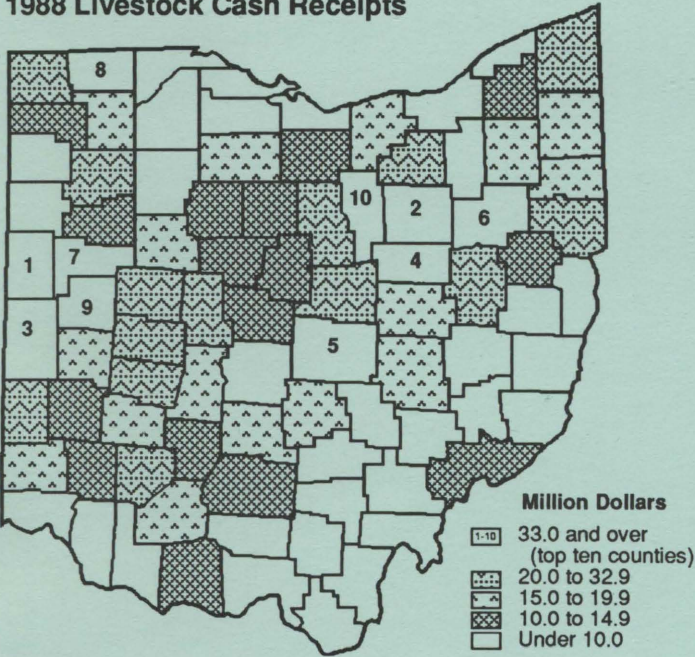
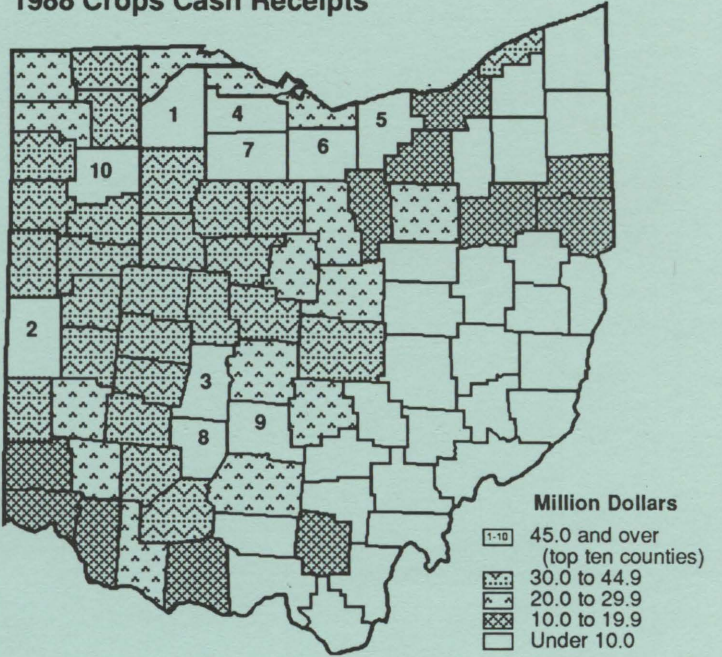


FIGURE III CASH RECEIPTS FROM THE FARM MARKETS OHIO 1988

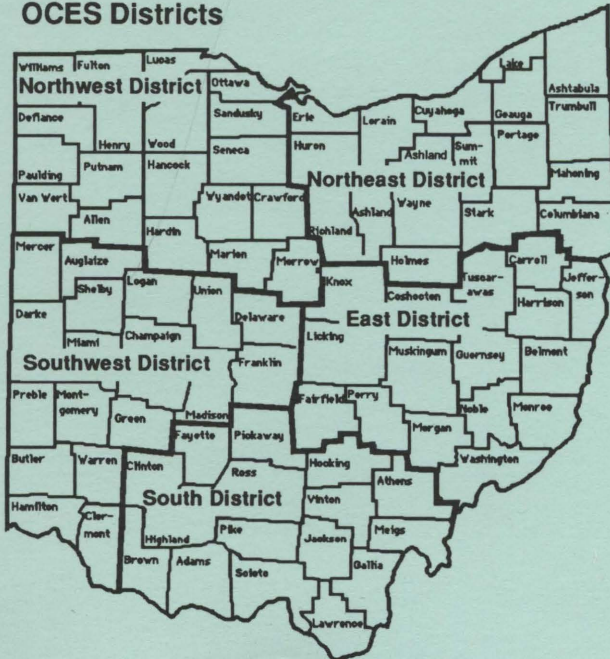
1988 Livestock Cash Receipts
