#### **Abstrak**

Penelitian ini bertujuan untuk menjelaskan bagaimana keberanian seorang wanita digambarkan didalam novel The Pelican Brief (1994) karya John Grisham menggunakan eksistensialis perspektiv. Novel The Pelican Brief (1994) dianalisis mengacu pada 3 poin. The second source of data is the searching from books, journal, author biographies, and sources related to the analysis. Darby Shaw's effort to overcome the assassination case was a form of her consciousness to reveal the truth and justice. Her willingness to solve the case can be depicted through this perspective. There are some finding on how woman's bravery depicted in the novel. Those are:

#### a) Freedom

Freedom is the power or right to act. De Beauvoir effectively changes the existential focus from a concern with one's own freedom into a concern that necessarilyincorporates the freedom of others. Freedom becomes both the defining characteristic of human existence and also its ethical ideal. It is also asserted by Yunus (2011) that freedom was "is the essence of human beings; usually humans are always free to create him-self. Humans are free to organize, select and can give meaning to reality"

Everyone has a freedom to do or to be whatever they want to be. And also the main character in the novel named Darby Shaw, she has a freedom to propose what she feel was right. Darby's freedom in showing her thought to point out the truth about the assassination case described in the novel. It reflects in the novel when Darby choises to learn who the mastermind of the murder case which happened to the two Supreme Court Justices:

- "In a cluttered study carrel on the fifth level of the law library, between the racks of thick, seldom-used law books, Darby Shaw scanned a prinout of the Supreme Court's docket." (page 62)

- "She compiled a neat list of possible suspects, but they would be obvious to everyone." (page 62)

That is the description which taken from the novel when Darby choosed to learn about anything related to the victims of the assassination case to find information about that.

#### b) Choice

Choice is a decision that we have to make a decision on something. Choice can be true or wrong. The option to choose is something that we no longer just value but now *expect*. It means that to make choices we have to be in clear mind. According Sarte (1984:17) "....and it is this choice that controls the way that we interpret the objects that we deal with in everyday life."

A choice whis has been selected by Darby is she chooses to be brave to opened the case that was happening at that time. The case was the assassination case. She makes make a research and looking for the bundle of the Justice Rosernberg and Jensen then she know the case which is still unfinished. Darby Shaw expect that the death case is not caused by the politics but the greed. She make a research about the cause of the death and who are the people who did that. It is reflected in the novel when Darby has made the research about the assassination case:

- Callahan had more wine, and sank deeper in the sofa. "So, Ms. Shaw, who done it?" (page 87)
  - "Professionals. Haven't you read the papers?" (page 87)
  - "Of course. But who's behind the professionals?" (87)
  - "I don't know. After last niht, the unanimous choice seems to be the Underground Army." (page 87)
  - "But you're not convinced." (87)
  - "No. There have been no arrest. I'm not convinced" (87)
- Callahan suggest Darby to share the brief to FBI

"Well, why don't you call the FBI and share your insights with them? I'm sure they're sitting by the phone."

That is the conversation between Darby and Mr. Callahan, her proffesor and also her lover. They were discussed about the brief that Darby made. Then Callahan suggested to Darby to give it to the FBI.

#### c) Responsibilities.

Responsibilities are such an awareness to do something that attached to one's self. Responsibilities are related to and the implication of a duty. When we are given a freedom to choose something or make a choice then we have to be responsible. "De Beauvoir's point is that the individual must accept the responsibility that begins with the other's need" (O'flynn, 2009).

By reading the whole story of the novel the researcher knows that Darby Shaw was very responsible for what has become her decision. She believes that she will get through it and solve the problem well. When she decided to make brief to uncovering the case then she got thread from unknown people she kept survive by herself. And she was still trying to find another evidence to strengthen her brief. Darby remains responsible with what she has decided and dare to take the risk. It reflects in the novel when Darby starts get threat from unknown people but she still fight for the truth and take the risk:

- "I don't know. I'm just scared."
  - "It's okay. I swear I'm not recording this and I swear I won't trace it. Now, What's on your mind?"
  - "Well, I think I may know who killed them."
- Grantham was standing. "That's some pretty valuable knowledge.'
  - "It could get me killed. Do you think they're following me?"

- "I don't know.' The voice trailed off, as if he was looking over his shoulder.
- "She rather liked the city at this moment. It had a million hotel rooms, almost as many alleys and lives and bars, and it always had crowds of people strolling along Bourbon, Chartres, Dauphine, and Royal. (page 155)
- "She would move from hotel to hotel for a few days, until when? She didn't know when. She didn't know why. Moving just seemed intelligent under the circumstances." (page 155)

The researcher can find a correlation between the perspective, the theory of bravery, and the reasons why woman's bravery specifically addressed by the author. John Grisham as the author of the novel was interest with criminal and law. He has graduated from law school in Mississippi University. He also has a history in polical career. He became a lawyer and also selected as Mississippi Representing the Democratic Party. Since he was young he liked to read.
