- 5790 Mercury thermometers collected
- 105,275 Fluorescent lamps collected & recycled
- 500 Mercury auto switches removed & disposed of.

GLNPO P2 Funding Results (Cont.)

- 451 PCB Transformers removed from service & properly disposed.
- 262,073 lbs of Pesticides properly disposed of.
- 7041 lbs. Household haz waste collected & disposed of.
- Thousands of pounds of electronics & computer equipment containing led, mercury & other precious metals have been collected & recycled.
