# Common coupled fixed point theorems for Geraghty-type contraction mappings using monotone property

#### **Abstract**

In this paper, we prove common coupled fixed point theorems under a Geraghty-type condition using monotone instead of the often used mixed monotone property. Also we give some sufficient conditions for the uniqueness of a common coupled fixed point. An example illustrating our results is provided.

#### 1 Introduction

As the Banach contraction principle (BCP) is a power tool for solving many problems in applied mathematics and sciences, it has been improved and extended in many ways. In particular, Geraghty proved in 1973 [1] an interesting generalization of BCP which has had a lot of applications.

The notion of a coupled fixed point was firstly introduced and studied by Opoitsev [2, 3] and then by Guo and Lakshmikantham in [4]. In 2006, Bhaskar and Lakshmikantham [5] were the first to introduce the notion of mixed monotone property. They also studied and proved the following classical coupled fixed point theorems for mappings by using this property under contractive type conditions.

**Theorem 1.1** ([5]) Let  $(X,d,\leq)$  be a partially ordered complete metric space and let  $F: X \times X \to X$  be a continuous mapping having the mixed monotone property, i.e., for any  $x,y \in X$ ,

$$x_1, x_2 \in X$$
,  $x_1 \leq x_2 \Rightarrow F(x_1, y) \leq F(x_2, y)$ 

and

$$y_1, y_2 \in X$$
,  $y_1 \leq y_2 \Rightarrow F(x, y_1) \succeq F(x, y_2)$ 

*hold.* Assume that there exists  $k \in [0,1)$  such that

$$d\big(F(x,y),F(u,v)\big) \leq \frac{k}{2} \big[d(x,u) + d(y,v)\big] \tag{1.1}$$



holds for all  $x, y, u, v \in X$  with  $x \succeq u$  and  $y \preceq v$ . If there exist  $x_0, y_0 \in X$  such that

$$x_0 \leq F(x_0, y_0), \qquad y_0 \geq F(y_0, x_0),$$

then there exist  $x, y \in X$  such that x = F(x, y) and y = F(y, x), i.e., F has a coupled fixed point.

**Theorem 1.2** ([5]) *If the continuity assumption for the mapping F is replaced by the assumption that the space*  $(X, d, \preceq)$  *has the following properties:* 

- 1. if  $\{x_n\}$  is a non-decreasing sequence with  $\{x_n\} \to x$ , then  $x_n \leq x$  for all  $n \geq 1$ ,
- 2. if  $\{y_n\}$  is a non-increasing sequence with  $\{y_n\} \to y$ , then  $y_n \succeq y$  for all  $n \ge 1$ .

Then the same conclusion as in the previous theorem holds.

Due to the important role of Theorems 1.1 and 1.2 for the investigation of solutions of nonlinear differential and integral equations, several authors have studied various generalizations of these results (see, *e.g.*, papers [6–18] and the references cited therein). Almost all of them used the mixed monotone property or, in the case of additional mapping  $g: X \to X$ , the so-called g-mixed monotone property.

Recently, in [19–21], the author established common coupled fixed point theorems by using (g-)monotone property instead of (g-)mixed monotone property. These kinds of results can be applied in another type of situations, so they give an opportunity to widen the field of applications. In particular the so-called tripled fixed point results (and, more generally, n-tupled results) can be more easily handled using monotone property instead of mixed monotone property (see, e.g., [22–24]).

The aim of this work is to prove some common coupled fixed point theorems for Geraghty-type contraction mappings by using monotone and *g*-monotone property instead of mixed monotone and *g*-mixed monotone property. An illustrative example is presented in this work showing how our results can be used in proving the existence of a common coupled fixed point, while the results of many other papers cannot.

#### 2 Preliminaries

In this section, we give some definitions that are useful for our main results in this paper. Throughout this paper  $(X, \leq)$  denotes a partially ordered set. By  $x \geq y$ , we mean  $y \leq x$ . Let  $f, g: X \to X$  be mappings. A mapping f is said to be g-non-decreasing (resp., g-non-increasing) if, for all  $x, y \in X$ ,  $gx \leq gy$  implies  $fx \leq fy$  (resp.,  $fy \leq fx$ ). If g is an identity mapping, then f is said to be non-decreasing (resp., non-increasing).

**Definition 2.1** Let  $(X, \leq)$  be a partially ordered set and let  $F: X \times X \to X$  and  $g: X \to X$  be two mappings. The mapping F is said to have the *g-monotone property* if F is monotone *g*-non-decreasing in both of its arguments, that is, for any  $x, y \in X$ ,

$$x_1, x_2 \in X$$
,  $gx_1 \leq gx_2 \implies F(x_1, y) \leq F(x_2, y)$ 

and

$$y_1, y_2 \in X$$
,  $gy_1 \leq gy_2 \Rightarrow F(x, y_1) \leq F(x, y_2)$ 

hold. If in the previous relations *g* is the identity mapping, then *F* is said to have the *monotone property*.

**Definition 2.2** ([5, 12]) Let X be a nonempty set and  $F: X \times X \to X$ ,  $g: X \to X$  be two mappings. An element  $(x, y) \in X \times X$  is called:

- (C<sub>1</sub>) a coupled fixed point of F if x = F(x, y) and y = F(y, x);
- $(C_2)$  a coupled coincidence point of mappings g and F if

$$gx = F(x, y)$$
 and  $gy = F(y, x)$ ,

and in this case (gx, gy) is called a *coupled point of coincidence*;

 $(C_3)$  a common coupled fixed point of mappings g and F if

$$x = gx = F(x, y)$$
 and  $y = gy = F(y, x)$ .

**Definition 2.3** ([25]) Let (X, d) be a metric space and let  $g: X \to X$ ,  $F: X \times X \to X$ . The mappings *g* and *F* are said to be *compatible* if

$$\lim_{n\to\infty} d\big(gF(x_n,y_n),F(gx_n,gy_n)\big) = 0 \quad \text{and} \quad \lim_{n\to\infty} d\big(gF(y_n,x_n),F(gy_n,gx_n)\big) = 0$$

hold whenever  $\{x_n\}$  and  $\{y_n\}$  are sequences in X such that  $\lim_{n\to\infty} F(x_n,y_n) = \lim_{n\to\infty} gx_n$ and  $\lim_{n\to\infty} F(y_n, x_n) = \lim_{n\to\infty} gy_n$ .

#### 3 Main results

Let  $\Theta$  denote the class of all functions  $\theta:[0,\infty)\times[0,\infty)\to[0,1)$  which satisfy the following conditions:

- $(\theta_1)$   $\theta(s,t) = \theta(t,s)$  for all  $s,t \in [0,\infty)$ ;
- $(\theta_2)$  for any two sequences  $\{s_n\}$  and  $\{t_n\}$  of nonnegative real numbers,

$$\theta(s_n,t_n)\to 1 \quad \Rightarrow \quad s_n,t_n\to 0.$$

The following are examples of some functions belonging to  $\Theta$ .

- (1)  $\theta(s,t) = k$  for  $s,t \in [0,\infty)$ , where  $k \in [0,1)$ . (2)  $\theta(s,t) = \begin{cases} \frac{\ln(1+ks+lt)}{ks+lt}, & s>0 \text{ or } t>0, \\ r \in [0,1), & s=0,t=0, \end{cases}$  where  $k,l \in (0,1)$ . (3)  $\theta(s,t) = \begin{cases} \frac{\ln(1+\max\{s,t\})}{\max\{s,t\}}, & s>0 \text{ or } t>0, \\ r \in [0,1), & s=0,t=0. \end{cases}$

Now, we will prove our main result.

**Theorem 3.1** Let  $(X,d,\preceq)$  be a complete partially ordered metric space and let  $g:X\to X$ and  $F: X \times X \to X$  be such that F has the g-monotone property. Suppose that the following hold:

- (i) g is continuous and g(X) is closed;
- (ii)  $F(X \times X) \subset g(X)$  and g and F are compatible;
- (iii) there exist  $x_0, y_0 \in X$  such that  $gx_0 \leq F(x_0, y_0)$  and  $gy_0 \leq F(y_0, x_0)$ ;
- (iv) there exists  $\theta \in \Theta$  such that for all  $x, y, u, v \in X$  satisfying  $gx \leq gu$  and  $gy \leq gv$  or  $gx \succeq gu \ and \ gy \succeq gv$ ,

$$d(F(x,y),F(u,v)) \le \theta(d(gx,gu),d(gy,gv)) \max\{d(gx,gu),d(gy,gv)\}$$
(3.1)

holds true;

(v) (a) F is continuous or (b) if, for an increasing sequence  $\{x_n\}$  in X,  $x_n \to x \in X$  as  $n \to \infty$ , then  $x_n \le x$  for all  $n \in \mathbb{N}$ .

Then there exist  $u, v \in X$  such that gu = F(u, v) and gv = F(v, u), i.e., g and F have a coupled coincidence point.

*Proof* Starting from  $x_0$ ,  $y_0$  (condition (iii)) and using that  $F(X \times X) \subset g(X)$  (condition (ii)), we can construct sequences  $\{x_n\}$  and  $\{y_n\}$  in X such that

$$gx_n = F(x_{n-1}, y_{n-1})$$
 and  $gy_n = F(y_{n-1}, x_{n-1})$  for  $n = 1, 2, ...$ 

If  $gx_{n_0} = gx_{n_0-1}$  and  $gy_{n_0} = gy_{n_0-1}$  for some  $n_0 \in \mathbb{N}$ , then  $(gx_{n_0-1}, gy_{n_0-1})$  is a coupled point of coincidence for g and F. Therefore, in what follows, we will assume that for each  $n \in \mathbb{N}$ ,  $gx_n \neq gx_{n-1}$  or  $gy_n \neq gy_{n-1}$  holds.

By (iii),  $gx_0 \le F(x_0, y_0) = gx_1$  and  $gy_0 \le F(y_0, x_0) = gy_1$ , hence the g-monotone property of F implies that  $gx_1 = F(x_0, y_0) \le F(x_1, y_1) = gx_2$  and  $gy_1 = F(y_0, x_0) \le F(y_1, x_1) = gy_2$ . Proceeding by induction we get that  $gx_{n-1} \le gx_n$  and  $gy_{n-1} \le gy_n$  hold for each  $n \in \mathbb{N}$ . Hence, the contractive condition (3.1) can be used to conclude that

$$d(gx_n, gx_{n+1}) = d(F(x_{n-1}, y_{n-1}), F(x_n, y_n))$$

$$\leq \theta(d(gx_{n-1}, gx_n), d(gy_{n-1}, gy_n)) \max\{d(gx_{n-1}, gx_n), d(gy_{n-1}, gy_n)\}$$
(3.2)

and

$$d(gy_{n}, gy_{n+1}) = d(F(y_{n-1}, x_{n-1}), F(y_{n}, x_{n}))$$

$$\leq \theta (d(gy_{n-1}, gy_{n}), d(gx_{n-1}, gx_{n})) \max \{d(gy_{n-1}, gy_{n}), d(gx_{n-1}, gx_{n})\}$$

$$= \theta (d(gx_{n-1}, gx_{n}), d(gy_{n-1}, gy_{n})) \max \{d(gx_{n-1}, gx_{n}), d(gy_{n-1}, gy_{n})\}$$
(3.3)

for all  $n \in \mathbb{N}$ . From (3.2) and (3.3), we get

$$\max \left\{ d(gx_{n}, gx_{n+1}), d(gy_{n}, gy_{n+1}) \right\}$$

$$\leq \theta \left( d(gx_{n-1}, gx_{n}), d(gy_{n-1}, gy_{n}) \right) \max \left\{ d(gx_{n-1}, gx_{n}), d(gy_{n-1}, gy_{n}) \right\}$$

$$\leq \max \left\{ d(gx_{n-1}, gx_{n}), d(gy_{n-1}, gy_{n}) \right\}$$

$$(3.4)$$

for all  $n \in \mathbb{N}$ . Thus the sequence  $d_n := \max\{d(gx_{n-1}, gx_n), d(gy_{n-1}, gy_n)\}$  is decreasing. It follows that  $d_n \to d$  as  $n \to \infty$  for some  $d \ge 0$ . Next, we claim that d = 0.

Assume on the contrary that d > 0; then from (3.4) we obtain that

$$\frac{\max\{d(gx_n,gx_{n+1}),d(gy_n,gy_{n+1})\}}{\max\{d(gx_{n-1},gx_n),d(gy_{n-1},gy_n)\}} \leq \theta\left(d(gx_{n-1},gx_n),d(gy_{n-1},gy_n)\right) < 1.$$

On taking limit as  $n \to \infty$ , we get

$$\theta(d(gx_{n-1},gx_n),d(gy_{n-1},gy_n)) \to 1 \text{ as } n \to \infty.$$

Since  $\theta \in \Theta$ , we have

$$d(gx_{n-1}, gx_n) \rightarrow 0$$
 and  $d(gy_{n-1}, gy_n) \rightarrow 0$ 

as  $n \to \infty$  and hence

$$d_n = \max\{d(gx_{n-1}, gx_n), d(gy_{n-1}, gy_n)\} \to 0 \quad \text{as } n \to \infty,$$
 (3.5)

which contradicts the assumption d > 0. Therefore, we can conclude that  $d_n = \max\{d(gx_{n-1}, gx_n), d(gy_{n-1}, gy_n)\} \to 0$  as  $n \to \infty$ .

Next, we show that  $\{gx_n\}$  and  $\{gy_n\}$  are Cauchy sequences. On the contrary, assume that at least one of  $\{gx_n\}$  or  $\{gy_n\}$  is not a Cauchy sequence. Then there is  $\epsilon > 0$  for which we can find subsequences  $\{gx_{n_k}\}$ ,  $\{gx_{m_k}\}$  of  $\{gx_n\}$  and  $\{gy_{n_k}\}$ ,  $\{gy_{m_k}\}$  of  $\{gy_n\}$  with  $n_k > m_k \ge k$  such that

$$\max\left\{d(gx_{n_k}, gx_{m_k}), d(gy_{n_k}, gy_{m_k})\right\} \ge \epsilon \tag{3.6}$$

and

$$\max\{d(gx_{n_k-1}, gx_{m_k}), d(gy_{n_k-1}, gy_{m_k})\} < \epsilon. \tag{3.7}$$

Using (3.6), (3.7) and the triangle inequality, we have

$$\begin{split} \epsilon &\leq r_k := \max \left\{ d(gx_{n_k}, gx_{m_k}), d(gy_{n_k}, gy_{m_k}) \right\} \\ &\leq \max \left\{ d(gx_{n_k}, gx_{n_{k-1}}), d(gy_{n_k}, gy_{n_{k-1}}) \right\} + \max \left\{ d(gx_{n_{k-1}}, gx_{m_k}), d(gy_{n_{k-1}}, gy_{m_k}) \right\} \\ &< \max \left\{ d(gx_{n_k}, gx_{n_{k-1}}), d(gy_{n_k}, gy_{n_{k-1}}) \right\} + \epsilon. \end{split}$$

On taking limit as  $k \to \infty$ , we have

$$r_k = \max\{d(gx_{n_k}, gx_{m_k}), d(gy_{n_k}, gy_{m_k})\} \to \epsilon.$$

$$(3.8)$$

By the triangle inequality, we get

$$\begin{split} r_k &= \max \left\{ d(gx_{n_k}, gx_{m_k}), d(gy_{n_k}, gy_{m_k}) \right\} \\ &\leq \max \left\{ d(gx_{n_k}, gx_{n_{k+1}}), d(gy_{n_k}, gy_{n_{k+1}}) \right\} + \max \left\{ d(gx_{n_{k+1}}, gx_{m_{k+1}}), d(gy_{n_{k+1}}, gy_{m_{k+1}}) \right\} \\ &+ \max \left\{ d(gx_{m_k+1}, gx_{m_k}), d(gy_{m_k+1}, gy_{m_k}) \right\} \\ &= \max \left\{ d(gx_{n_k}, gx_{n_{k+1}}), d(gy_{n_k}, gy_{n_{k+1}}) \right\} + \max \left\{ d(gx_{m_k+1}, gx_{m_k}), d(gy_{m_k+1}, gy_{m_k}) \right\} \\ &+ \max \left\{ d(gx_{n_k}, gx_{m_{k+1}}), d(gy_{n_k}, gy_{m_{k+1}}) \right\} \\ &\leq \max \left\{ d(gx_{n_k}, gx_{n_{k+1}}), d(gy_{n_k}, gy_{m_{k+1}}) \right\} + \max \left\{ d(gx_{m_k+1}, gx_{m_k}), d(gy_{m_k+1}, gy_{m_k}) \right\} \\ &+ \theta \left( d(gx_{n_k}, gx_{m_k}), d(gy_{n_k}, gy_{m_k}) \right) \max \left\{ d(gx_{n_k}, gx_{m_k}), d(gy_{n_k}, gy_{m_k}) \right\} \\ &= d_{n_k+1} + d_{m_k+1} + \theta \left( d(gx_{n_k}, gx_{m_k}), d(gy_{n_k}, gy_{m_k}) \right) r_k \\ &\leq d_{n_k+1} + d_{m_k+1} + r_k \end{split}$$

(the usage of contractive condition (3.1) was possible since the sequences  $\{gx_n\}$  and  $\{gy_n\}$  are increasing). Now, we have

$$r_k \le d_{n_k+1} + d_{m_k+1} + \theta (d(gx_{n_k}, gx_{m_k}), d(gy_{n_k}, gy_{m_k})) r_k \le d_{n_k+1} + d_{m_k+1} + r_k.$$

On taking limit as  $k \to \infty$  and using (3.5) and (3.8), we get

$$\theta(d(gx_{n_k},gx_{m_k}),d(gy_{n_k},gy_{m_k})) \rightarrow 1.$$

Using the properties of function  $\theta$ , we obtain

$$d(gx_{n_k}, gx_{m_k}) \rightarrow 0$$
 and  $d(gy_{n_k}, gy_{m_k}) \rightarrow 0$ 

as  $k \to \infty$ , which imply that

$$\lim_{k\to\infty} r_k = \lim_{k\to\infty} \left( \max\left\{ d(gx_{n_k}, gx_{m_k}), d(gy_{n_k}, gy_{m_k}) \right\} \right) = 0,$$

which contradicts with  $\epsilon > 0$ .

Therefore, we get that  $\{gx_n\}$  and  $\{gy_n\}$  are Cauchy sequences. Since g(X) is a closed subset of a complete metric space, there exist  $u, v \in g(X)$  such that

$$\lim_{n\to\infty} gx_n = \lim_{n\to\infty} F(x_n, y_n) = u \quad \text{and} \quad \lim_{n\to\infty} gy_n = \lim_{n\to\infty} F(y_n, x_n) = v.$$

By condition (ii), the compatibility of g and F implies that

$$\lim_{n\to\infty} d\big(gF(x_n,y_n),F(gx_n,gy_n)\big) = 0 \quad \text{and} \quad \lim_{n\to\infty} d\big(gF(y_n,x_n),F(gy_n,gx_n)\big) = 0.$$
 (3.9)

Consider the two possibilities given in condition (v).

(a) Suppose that *F* is continuous. Using the triangle inequality we get that

$$d(gu, F(gx_n, gy_n)) < d(gu, gF(x_n, y_n)) + d(gF(x_n, y_n), F(gx_n, gy_n)).$$

Passing to the limit as  $n \to \infty$  and using (3.9) and the continuity of g and F, we get that d(gu, F(u, v)) = 0, *i.e.*, gu = F(u, v). In a similar way, gv = F(v, u) is obtained.

(b) In this case  $gx_n \leq u = gx$  and  $gy_n \leq v = gy$  for some  $x, y \in X$  and each  $n \in \mathbb{N}$ . Using (3.1) we get

$$d(F(x,y),gx) \le d(F(x,y),gx_{n+1}) + d(gx_{n+1},gx)$$

$$= d(F(x,y),F(x_n,y_n)) + d(gx_{n+1},gx)$$

$$\le \theta(d(gx,gx_n),d(gy,gy_n)) \max\{d(gx,gx_n),d(gy,gy_n)\} + d(gx_{n+1},gx)$$

$$\to 0$$

as  $n \to \infty$ . Hence, gx = F(x, y) and similarly gy = F(y, x).

Note that in this case continuity and compatibility assumptions were not needed in the proof.  $\Box$ 

**Remark 3.2** In Theorem 3.1, the condition that F has the g-monotone property is a substitution for the g-mixed monotone property that was used in most of the coupled fixed point results so far. Note that this condition is maybe more natural than the mixed g-monotone property and can be used in various examples.

Putting  $g = I_X$ , where  $I_X$  is an identity mapping on X in Theorem 3.1, we obtain the following.

**Corollary 3.3** *Let*  $(X, d, \preceq)$  *be a partially ordered complete metric space and let*  $F: X \times X \to X$  *have the monotone property. Suppose that the following hold:* 

- (i) there exist  $x_0, y_0 \in X$  such that  $x_0 \leq F(x_0, y_0)$  and  $y_0 \leq F(y_0, x_0)$ ;
- (ii) there exists  $\theta \in \Theta$  such that for all  $x, y, u, v \in X$  satisfying  $(x \leq u \text{ and } y \leq v)$  or  $(u \leq x \text{ and } v \leq y)$ ,

$$d(F(x,y),F(u,v)) \le \theta(d(x,u),d(y,v)) \max\{d(x,u),d(y,v)\}$$

holds true:

(iii) (a) F is continuous or (b) if  $\{x_n\}$  is an increasing sequence in X and  $x_n \to x$  as  $n \to \infty$ , then  $x_n \le x$  for all n.

Then there exist  $x, y \in X$  such that x = F(x, y) and y = F(y, x), i.e., F has a coupled fixed point.

Taking  $\theta(t_1, t_2) = k$  with  $k \in [0, 1)$  for all  $t_1, t_2 \in [0, \infty)$  in Theorem 3.1 and Corollary 3.3, we obtain the following corollary.

**Corollary 3.4** Let  $(X,d,\preceq)$  be a complete partially ordered metric space and let  $g:X\to X$  and  $F:X\times X\to X$  be such that F has the g-monotone property. Suppose that the following hold:

- (i) g is continuous and g(X) is closed;
- (ii)  $F(X \times X) \subset g(X)$  and g and F are compatible;
- (iii) there exist  $x_0, y_0 \in X$  such that  $gx_0 \leq F(x_0, y_0)$  and  $gy_0 \leq F(y_0, x_0)$ ;
- (iv) there exists  $k \in [0,1)$  such that for all  $x, y, u, v \in X$  satisfying  $(gx \leq gu \text{ and } gy \leq gv)$  or  $(gu \leq gx \text{ and } gv \leq gy)$ ,

$$d(F(x,y),F(u,v)) \le k \max\{d(gx,gu),d(gy,gv)\}$$
(3.10)

holds true;

(v) (a) F is continuous or (b) if  $\{x_n\}$  is an increasing sequence in X and  $x_n \to x$  as  $n \to \infty$ , then  $x_n \le x$  for all n.

Then there exist  $u, v \in X$  such that gu = F(u, v) and gv = F(v, u), i.e., g and F have a coupled coincidence point.

**Corollary 3.5** *Let*  $(X,d,\leq)$  *be a partially ordered complete metric space and let*  $F:X\times X\to X$ . *Suppose that the following hold:* 

- (i) *F satisfies the monotone property*;
- (ii) there exist  $x_0, y_0 \in X$  such that  $x_0 \leq F(x_0, y_0)$  and  $y_0 \leq F(y_0, x_0)$ ;
- (iii) there exists  $k \in [0,1)$  such that for all  $x, y, u, v \in X$  satisfying  $(x \le u \text{ and } y \le v)$  or  $(u \le x \text{ and } v \le y)$ ,

$$d(F(x,y),F(u,v)) \le k \max\{d(x,u),d(y,v)\}$$

holds true;

(iv) (a) F is continuous or (b) if  $\{x_n\}$  is an increasing sequence in X and  $x_n \to x$  as  $n \to \infty$ , then  $x_n \le x$  for all n.

Then there exist  $x, y \in X$  such that x = F(x, y) and y = F(y, x), i.e., F has a coupled fixed point.

**Remark 3.6** Since, for  $k, l \ge 0, k + l \le 1$ ,

$$kd(gx,gu) + ld(gy,gv) \le \max\{d(gx,gu),d(gy,gv)\},\$$

Corollary 3.4 remains valid if the right-hand side of condition (3.10) is replaced by kd(gx, gu) + ld(gy, gv) for some  $k, l \ge 0$ , k + l < 1.

Now, reasoning on Theorem 3.1, some questions arise naturally. To be precise, one can ask the following.

**Question** Is it possible to find a sufficient condition for the existence and uniqueness of the coupled common fixed point of *g* and *F*?

Motivated by the interest in this research, we give a positive answer to this question adding to Theorem 3.1 some hypotheses.

For the given partial order  $\leq$  on the set X, we shall denote also by  $\leq$  the order on  $X \times X$  given by

$$(x_1, y_1) \leq (x_2, y_2) \Leftrightarrow x_1 \leq x_2 \text{ and } y_1 \leq y_2.$$

**Theorem 3.7** *In addition to the hypotheses of Theorem 3.1 assume that* 

(vi) for any two elements (x, y),  $(u, v) \in X \times X$ , there exists  $(w, z) \in X \times X$  such that (F(w, z), F(z, w)) is comparable to both (F(x, y), F(y, x)) and (F(u, v), F(v, u)).

Then g and F have a unique common coupled fixed point, i.e., there exists unique  $(p,q) \in X \times X$  such that p = gp = F(p,q) and q = gq = F(q,p).

*Proof* Theorem 3.1 implies that there exists a coupled coincidence point  $(x, y) \in X \times X$ , that is, gx = F(x, y) and gy = F(y, x). Suppose that there exists another coupled coincidence point  $(u, v) \in X \times X$  and hence gu = F(u, v) and gv = F(v, u). We will prove that gx = gu and gy = gv.

From condition (vi) we get that there exists  $(w,z) \in X \times X$  such that (F(w,z),F(z,w)) is comparable to both (F(x,y),F(y,x)) and (F(u,v),F(v,u)). Put  $w_0=w$ ,  $z_0=z$  and, analogously to the proof of Theorem 3.1, choose sequences  $\{w_n\}$ ,  $\{z_n\}$  in X satisfying

$$gw_n = F(w_{n-1}, z_{n-1})$$
 and  $gz_n = F(z_{n-1}, w_{n-1})$ 

for  $n \in \mathbb{N}$ . Starting from  $x_0 = x$ ,  $y_0 = y$  and  $u_0 = u$ ,  $v_0 = v$ , choose sequences  $\{x_n\}$ ,  $\{y_n\}$  and  $\{u_n\}$ ,  $\{v_n\}$  satisfying  $gx_n = F(x_{n-1}, y_{n-1})$ ,  $gy_n = F(y_{n-1}, x_{n-1})$  and  $gu_n = F(u_{n-1}, v_{n-1})$ ,  $gv_n = F(v_{n-1}, u_{n-1})$  for  $n \in \mathbb{N}$ . Taking into account the properties of coincidence points, it is easy to see that it can be done so that  $x_n = x$ ,  $y_n = y$  and  $u_n = u$ ,  $v_n = v$ , *i.e.*,

$$gx_n = F(x, y),$$
  $gy_n = F(y, x)$  and  $gu_n = F(u, v),$   $gv_n = F(v, u)$  for all  $n \in \mathbb{N}$ .

Since (F(x,y),F(y,x))=(gx,gy) and  $(F(w,z),F(z,v))=(gw_1,gz_1)$  are comparable, then, for example,  $gx \leq gw_1$ ,  $gy \leq gz_1$  and in a similar way,  $gx \leq gw_n$ ,  $gy \leq gz_n$ . Thus, we can apply the contractive condition (3.1) to obtain

$$d(gx, gw_{n+1}) = d(F(x, y), F(w_n, z_n))$$

$$\leq \theta(d(gx, gw_n), d(gy, gz_n)) \max\{d(gx, gw_n), d(gy, gz_n)\}$$

and

$$d(gy, gz_{n+1}) = d(F(z_n, w_n), F(y, x))$$

$$\leq \theta(d(gy, gz_n), d(gx, gw_n)) \max\{d(gy, gz_n), d(gx, gw_n)\}$$

$$= \theta(d(gx, gw_n), d(gy, gz_n)) \max\{d(gx, gw_n), d(gy, gz_n)\}.$$

This implies that

$$\max \{d(gx, gw_{n+1}), d(gy, gz_{n+1})\}$$

$$\leq \theta (d(gx, gw_n), d(gy, gz_n)) \max \{d(gx, gw_n), d(gy, gz_n)\}$$

$$< \max \{d(gx, gw_n), d(gy, gz_n)\}. \tag{3.11}$$

Therefore, we get that the sequence  $d_n := \max\{d(gx, gw_n), d(gy, gz_n)\}$  is decreasing and hence  $d_n \to d$  as  $n \to \infty$  for some  $d \ge 0$ . Now, we prove that d = 0. Assume to the contrary that d > 0; then from (3.11) we have

$$\frac{\max\{d(gx, gw_{n+1}), d(gy, gz_{n+1})\}}{\max\{d(gx, gw_n), d(gy, gz_n)\}} \le \theta(d(gx, gw_n), d(gy, gz_n)) < 1.$$

Taking the limit as  $n \to \infty$  in the above inequality, we have

$$\theta(d(gx, gw_n), d(gy, gz_n)) \to 1 \text{ as } n \to \infty.$$

By the property  $(\theta_2)$  of  $\theta \in \Theta$ , we get

$$d(gx, gw_n) \to 0$$
 and  $d(gy, gz_n) \to 0$ 

as  $n \to \infty$ . Now we have

$$d_n := \max\{d(gx, gw_n), d(gy, gz_n)\} \to 0$$
 as  $n \to \infty$ ,

which contradicts with d > 0. Therefore, we conclude that  $d_n = \max\{d(gx, gw_n), d(gy, gz_n)\} \to 0$  as  $n \to \infty$  and then

$$\lim_{n\to\infty}d(gx,gw_n)=0\quad\text{and}\quad \lim_{n\to\infty}d(gy,gz_n)=0.$$

In a similar way, we have

$$\lim_{n\to\infty}d(gu,gw_n)=0\quad\text{and}\quad \lim_{n\to\infty}d(gv,gz_n)=0.$$

By the triangle inequality, we have

$$d(gx,gu) \le d(gx,gw_n) + d(gw_n,gu)$$
 and  $d(gy,gv) \le d(gy,gz_n) + d(gz_n,gv)$ 

for all  $n \in \mathbb{N}$ . Taking  $n \to \infty$  in the above two inequalities, we get that d(gx, gu) = 0 and d(gy, gv) = 0. Therefore, we have gx = gu and gy = gv.

Now we let p := gx and q := gy. Hence we have

$$gp = g(gx) = gF(x, y)$$
 and  $gq = g(gy) = gF(y, x)$ .

By the definition of sequences  $\{x_n\}$  and  $\{y_n\}$  we have

$$gx_n = F(x, y) = F(x_{n-1}, y_{n-1})$$
 and  $gy_n = F(y, x) = F(y_{n-1}, x_{n-1})$ 

for all  $n \in \mathbb{N}$ . So we have

$$\lim_{n\to\infty} F(x_n,y_n) = \lim_{n\to\infty} gx_n = F(x,y) \quad \text{and} \quad \lim_{n\to\infty} F(y_n,x_n) = \lim_{n\to\infty} gy_n = F(y,x).$$

Since g and F are compatible, we have

$$\lim_{n\to\infty}d(gF(x_n,y_n),F(gx_n,gy_n))=0,$$

that is, gF(x, y) = F(gx, gy). Therefore, we get

$$gp = gF(x, y) = F(gx, gy) = F(p, q)$$

and in a similar way

$$gq = gF(y,x) = F(gy,gx) = F(q,p).$$

This implies that (p,q) is another coincidence point. By the property we have just proved, it follows that gp = gx = p and gq = gy = q. So,

$$p = gp = F(p,q)$$
 and  $q = gq = F(q,p)$ ,

and (p,q) is a common coupled fixed point of g and F. For the uniqueness of the common coupled fixed point, we can proceed easily.

**Corollary 3.8** In addition to the hypotheses of Corollary 3.4 assume that (vi) for any two elements (x,y),  $(u,v) \in X \times X$ , there exists  $(w,z) \in X \times X$  such that (F(w,z),F(z,w)) is comparable to both (F(x,y),F(y,x)) and (F(u,v),F(v,u)).

Then g and F have a unique common coupled fixed point.

**Theorem 3.9** In addition to the hypotheses of Corollary 3.3, let the condition (vi) of Theorem 3.7 be satisfied. Then the coupled fixed point of F is unique. Moreover, if for the terms of sequences  $\{x_n\}$ ,  $\{y_n\}$  defined by  $x_n = F(x_{n-1}, y_{n-1})$  and  $y_n = F(x_{n-1}, y_{n-1})$ ,  $x_n \leq y_n$  holds for n sufficiently large, then the coupled fixed point of F has the form (x,x).

*Proof* We have only to prove the last statement. Suppose that for *n* sufficiently large,  $x_n \leq y_n$ . Then, by (3.1) (with  $g = I_X$ ), we get

$$d(x_{n+1}, y_{n+1}) = d(F(x_n, y_n), F(y_n, x_n))$$

$$\leq \theta(d(x_n, y_n), d(x_n, y_n)) d(x_n, y_n).$$
(3.12)

This implies that

$$d(x_{n+1}, y_{n+1}) < d(x_n, y_n),$$

that is, the sequence  $d_n := d(x_n, y_n)$  is decreasing. Hence  $d_n \to d$  as  $n \to \infty$  for some  $d \ge 0$ . Next, we prove that d = 0. Assume to the contrary that d > 0; then from (3.12) we have

$$\frac{d(x_{n+1},y_{n+1})}{d(x_n,y_n)} \le \theta\left(d(x_n,y_n),d(x_n,y_n)\right) < 1.$$

Letting  $n \to \infty$ , we get  $\theta(d(x_n, y_n), d(x_n, y_n)) \to 1$ . Since  $\theta \in \Theta$ , we have  $d(x_n, y_n) \to 0$  as  $n \to \infty$ , which contradicts with d > 0. Therefore, we have  $d(x_n, y_n) \to 0$  as  $n \to \infty$ . By the triangle inequality, we have

$$d(x,y) \leq d(x,x_{n+1}) + d(x_{n+1},y_{n+1}) + d(y_{n+1},y)$$

$$= d(x,x_{n+1}) + d(F(x_n,y_n),F(y_n,x_n)) + d(y_{n+1},y)$$

$$\leq d(x,x_{n+1}) + \theta(d(x_n,y_n),d(x_n,y_n))d(x_n,y_n) + d(y_{n+1},y)$$

$$< d(x,x_{n+1}) + d(x_n,y_n) + d(y_{n+1},y).$$

Passing to the limit as  $n \to \infty$ , since  $x_n \to x$ ,  $y_n \to y$  and  $d(x_n, y_n) \to 0$ , we get that  $d(x, y) \le 0$  and thus x = y. This completes the proof.

**Corollary 3.10** In addition to the hypotheses of Corollary 3.5, let the condition (vi) of Theorem 3.7 be satisfied. Then the coupled fixed point of F is unique. Moreover, if for the terms of sequences  $\{x_n\}$ ,  $\{y_n\}$  defined by  $x_n = F(x_{n-1}, y_{n-1})$  and  $y_n = F(x_{n-1}, y_{n-1})$ ,  $x_n \leq y_n$  holds for all n, then the coupled fixed point of F has the form (x,x).

Finally, we give an example showing that our theorem can be used when many results in this field cannot.

**Example 3.11** Let  $X = [0,1] \subseteq \mathbb{R}$  with the usual metric and order. Consider the mappings  $g: X \to X$  and  $F: X \times X \to X$  defined by

$$gx = x^2$$
,  $F(x, y) = \ln\left(1 + \frac{x^2}{2} + \frac{y^2}{2}\right)$ .

Note that *F* does not satisfy the mixed *g*-monotone property of [25] and [12]. Indeed, for  $y_1 = \frac{1}{3} \in X$  and  $y_2 = \frac{1}{2} \in X$ , we have  $gy_1 \leq gy_2$ . But for  $x = 0 \in X$ , we get

$$F(x, y_1) = \ln \frac{19}{18} \le \ln \frac{9}{8} = F(x, y_2).$$

Hence a lot of results in literature that used the g-mixed monotone property cannot be applied in this example. Moreover, g and F do not commute as in [12].

Next, we show that Theorem 3.7 can be used in this example.

Let  $\theta \in \Theta$  be defined by

$$\theta(s,t) = \begin{cases} \frac{\ln(1+\frac{s}{2}+\frac{t}{2})}{\frac{s}{2}+\frac{t}{2}}, & s > 0 \text{ or } t > 0, \\ 0, & s = 0 \text{ and } t = 0. \end{cases}$$

We will show that condition (3.1) holds with the function  $\theta$ . Let x, y, u, v be arbitrary points in X. We obtain that

$$d(F(x,y),F(u,v)) = d\left(\ln\left(1+\frac{x^2}{2}+\frac{y^2}{2}\right),\ln\left(1+\frac{u^2}{2}+\frac{v^2}{2}\right)\right)$$

$$= \left|\ln\left(1+\frac{x^2}{2}+\frac{y^2}{2}\right) - \ln\left(1+\frac{u^2}{2}+\frac{v^2}{2}\right)\right|$$

$$= \left|\ln\left(1+\frac{\frac{x^2}{2}+\frac{y^2}{2}}{1+\frac{u^2}{2}+\frac{v^2}{2}}\right)\right|$$

$$= \left|\ln\left(1+\frac{\left(\frac{x^2}{2}+\frac{y^2}{2}\right)-\left(\frac{u^2}{2}+\frac{v^2}{2}\right)}{1+\frac{u^2}{2}+\frac{v^2}{2}}\right)\right|$$

$$\leq \ln\left(1+\left|\left(\frac{x^2}{2}+\frac{y^2}{2}\right)-\left(\frac{u^2}{2}+\frac{v^2}{2}\right)\right|\right)$$

$$\leq \ln\left(1+\frac{1}{2}|x^2-u^2|+\frac{1}{2}|y^2-v^2|\right)$$

$$= \frac{\ln(1+\frac{1}{2}|x^2-u^2|+\frac{1}{2}|y^2-v^2|)}{\left(\frac{1}{2}|x^2-u^2|+\frac{1}{2}|y^2-v^2|\right)}\left(\frac{1}{2}|x^2-u^2|+\frac{1}{2}|y^2-v^2|\right)$$

$$= \frac{\ln(1+\frac{1}{2}d(gx,gu)+\frac{1}{2}d(gy,gv))}{\left(\frac{1}{2}d(gx,gu)+\frac{1}{2}d(gy,gv)\right)}\left(\frac{1}{2}d(gx,gu)+\frac{1}{2}d(gy,gv)\right)$$

$$= \theta\left(d(gx,gu),d(gy,gv)\right)\left(\frac{1}{2}d(gx,gu)+\frac{1}{2}d(gy,gv)\right)$$

$$\leq \theta\left(d(gx,gu),d(gy,gv)\right)\max\left\{d(gx,gu),d(gy,gv)\right\}.$$

This shows that condition (3.1) holds with the function  $\theta$ .

Next, we check that g and F are compatible. Let  $\{x_n\}$  and  $\{y_n\}$  be two sequences in X such that

$$\lim_{n\to\infty} gx_n = \lim_{n\to\infty} F(x_n, y_n) = a \quad \text{and} \quad \lim_{n\to\infty} gy_n = \lim_{n\to\infty} F(y_n, x_n) = b.$$

Then  $\ln(1+\frac{a}{2}+\frac{b}{2})=a$  and  $\ln(1+\frac{a}{2}+\frac{b}{2})=b$ , wherefrom it follows that a=b=0. Then

$$d(gF(x_n,y_n),F(gx_n,gy_n)) = \left| \left( \ln \left( 1 + \frac{x_n^2}{2} + \frac{y_n^2}{2} \right) \right)^2 - \ln \left( 1 + \frac{x_n^4}{2} + \frac{y_n^4}{2} \right) \right| \to 0 \quad (n \to \infty),$$

and similarly  $d(gF(y_n, x_n), F(gy_n, gx_n)) \rightarrow 0$ .

We can easily check that all other conditions of Theorem 3.7 hold. Therefore, g and F have a unique common coupled fixed point. In this example, we can see that a point  $(0,0) \in X \times X$  is a unique common coupled fixed point of g and F.

**Remark 3.12** We conclude remarking that the approach used in this paper (*i.e.*, using g-monotone instead of g-mixed monotone mappings) has the advantage when considering n-tupled common fixed points for odd n. For example, one can consider mappings  $F: X^3 \to X$  and  $g: X \to X$  and say that the mapping F is g-monotone if F(x, y, z) is g-non-decreasing in all three variables, that is, for all  $x, y, z \in X$ ,

$$x_1, x_2 \in X, \quad g(x_1) \leq g(x_2) \quad \Rightarrow \quad F(x_1, y, z) \leq F(x_2, y, z),$$
  
 $y_1, y_2 \in X, \quad g(y_1) \leq g(y_2) \quad \Rightarrow \quad F(x, y_1, z) \leq F(x, y_2, z),$   
 $z_1, z_2 \in X, \quad g(z_1) \leq g(z_2) \quad \Rightarrow \quad F(x, y, z_1) \leq F(x, y, z_2).$ 

In particular, if  $g = I_X$ , F is said to be monotone. An element  $(x, y, z) \in X^3$  is called a tripled coincidence point of F and g if F(x, y, z) = gx, F(y, z, x) = gy and F(z, x, y) = gz. Moreover, (x, y, z) is called a tripled common fixed point of F and g if

$$F(x, y, z) = gx = x$$
,  $F(y, z, x) = gy = y$  and  $F(z, x, y) = gz = z$ .

In particular, for  $g = I_X$ , the element (x, y, z) is called a tripled fixed point of F.

Results concerning these notions can be found, *e.g.*, in [24]. Such an approach is not possible for mixed monotone mappings when n = 3 (see [26]).

#### Open problems

- In Theorem 3.1, can the set  $\{d(gx, gu), d(gy, gv)\}$  be replaced by other sets?
- Can Theorem 3.1 be improved by replacing the control function  $\theta$  by other functions?
- Can Theorem 3.1 be extended and generalized replacing condition (3.1) by other conditions?
