Thank you for agreeing to appear before the Crime and Public Integrity Policy Committee (the Committee) on **Friday**, **15** April **2016** to provide oral submissions for the inquiry into Serious and Organised Crime Legislation. A copy of the terms of reference and a brochure providing some background information on the Committee, are enclosed for your information.

If the software is not already installed on your device, by clicking the link you will be asked for a permission to download the software free of charge.
- 4. The Committee is inclined to have the meeting open to the public, depending on your preference for this to occur. You may request that all or any part of your evidence is heard 'in camera'. If granted, the public will be cleared from the room, however, Hansard will remain to record your evidence. If greater confidentiality is required the Committee may grant this, but information provided under this condition will not be available for use by the Committee in its final report.
- 5. Evidence provided to the Committee is granted Parliamentary Privilege.
- 6. As this is the first time the Committee will hear evidence by video-link using Skype, Hansaard staff would like to attempt a test trial in the afternoon of Thursday, 14 April 2016. I will send a further meeting request for a 10 minute test trial with the applicable link. For the test trial, please follow the same process as described in paragraph 3 above.
