0 Introduction

Arithmetic subgroups of semi-simple Lie groups have been and still are a major subject of study. They are examples of lattices, i.e. discrete subgroups of finite covolume. Margulis' Arithmeticity Theorem states that for groups with \mathbb{R} -rank greater than or equal to 2, the only lattices are the arithmetic ones (see Margulis [17], Theorem A, p.298).

The situation is very different for the simple Lie groups $\mathrm{PSL}(2, \mathbb{R})$ and $\mathrm{PSL}(2, \mathbb{C})$. There, the arithmetic lattices represent a minority among all lattices, i.e. the cofinite Fuchsian and Kleinian groups. Nevertheless, they provide important examples since one can get the general form of their elements quite explicitly and not only in terms of generators.

The so called semi-arithmetic Fuchsian groups constitute a specific class of Fuchsian groups which can be embedded up to commensurability in arithmetic subgroups of $\mathrm{PSL}(2, \mathbb{R})^r$ (see Schmutz Schaller and Wolfart [21]). These embeddings are of infinite covolume in $\mathrm{PSL}(2, \mathbb{R})^r$. A trivial example is the group $\mathrm{PSL}(2, \mathbb{Z})$ that can be embedded diagonally in any Hilbert modular group. Further examples are the other arithmetic Fuchsian groups and the triangle Fuchsian groups.

While lattices are studied very well, only little is known about discrete subgroups of infinite covolume of semi-simple Lie groups. The main class of examples are Schottky groups. The chief goal of this thesis is to provide and investigate further examples of such subgroups. Namely, we consider subgroups of irreducible lattices in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with the property that the projection to one of the factors is a Fuchsian (or a Kleinian) group. We are in particular interested in those groups whose projection to one of the factors is (a subgroup of) an arithmetic Fuchsian (or Kleinian) group. These are exactly the nonelementary groups with the "smallest" possible limit set. It is somewhat surprising that one can get information about the arithmetic nature of a group from its limit set.

We recall the definition of the limit set. The symmetric space corresponding to $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ is a product of 2- and 3-dimensional real hyperbolic spaces $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. The geometric boundary of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ is the set of equivalence classes of asymptotic geodesic rays. Adding the geometric boundary to $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ yields a compactification of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ compatible with the action of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$. The limit set \mathcal{L}_Γ of a discrete subgroup Γ of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ is the part of the or-

bit closure $\overline{\Gamma(x)}$ in the geometric boundary where x is an arbitrary point in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. Hence the limit set gives us information about the group by looking at its action “far away”.

This thesis is organized as follows. In Section 1 we have compiled some basic facts about Fuchsian and Kleinian groups and especially about Schottky groups. We prove in particular a criterion for a Schottky subgroup of $\mathrm{PSL}(2, \mathbb{C})$ to be Zariski dense over \mathbb{R} .

Section 2 provides a detailed description of the geometric boundary of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. We also introduce the notion of the limit set and state a structure theorem for the regular limit set \mathcal{L}_Γ^{reg} of discrete nonelementary groups Γ due to Link: \mathcal{L}_Γ^{reg} is the product of the Furstenberg limit set F_Γ and the projective limit set P_Γ . We also give a criterion for a subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ to be nonelementary.

Section 3 is devoted to the study of nonelementary groups. We show that the regular limit set of a nonelementary group is not empty. The main result of the section is the following theorem, which is Theorem 3.8 in the text.

Theorem A. *Let Γ be a nonelementary subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$. Then P_Γ is convex and the closure of P_Γ in \mathbb{RP}^{q+r-1} is equal to the limit cone of Γ and in particular the limit cone of Γ is convex.*

This is a result similar to a theorem of Benoist in Section 1.2 in [2]. Note however that while the interior of the limit cone is always nonempty for Zariski dense groups, it can be empty for groups that are just nonelementary.

In Section 4 we describe the irreducible arithmetic subgroups of the group $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ using quaternion algebras.

In Section 5 we consider subgroups (of infinite index) of irreducible arithmetic groups in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$. We start by giving the example of Hecke groups embedded in Hilbert modular groups. In §5.3 we determine the groups with the smallest possible limit set. The main result is a compilation of Theorem 5.10 and Corollary 5.18.

Theorem B. *Let Γ be as in Theorem A and in addition be finitely generated. Then the projective limit set P_Γ consists of exactly one point if and only if Γ is a conjugate by an element in $\mathrm{GL}(2, \mathbb{C})^q \times \mathrm{GL}(2, \mathbb{R})^r$ of a subgroup of*

$$\mathrm{Diag}(S) := \{(\sigma_1(s), \dots, \sigma_{q+r}(s)) \mid s \in S\},$$

where S is an arithmetic Fuchsian or Kleinian group and, for each $i = 1, \dots, q + r$, σ_i denotes either the identity or the complex conjugation.

In particular, Theorem 5.10 shows that the projective limit set P_Γ consists of exactly one point if and only if $p_j(\Gamma)$ is contained in an arithmetic Fuchsian or Kleinian group for one and hence all $j \in \{1, \dots, q + r\}$.

The main ingredients of the proof are the characterization of cofinite arithmetic Fuchsian groups by Takeuchi [24] (and the analogous characterization for cofinite Kleinian groups given by Maclachlan and Reid in [16]), the criterion for Zariski density of Dal'Bo and Kim [7] and a theorem of Benoist [2] stating that for Zariski dense subgroups of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ the projective limit cone has nonempty interior.

There are some differences depending on whether $q = 0$ or $r = 0$ or $qr \neq 0$. The group S and hence $p_j(\Gamma)$ can be an arithmetic Kleinian group only if $r = 0$. And if $q = 0$, we can require that only one of the projections of Γ is nonelementary. This is due to the following fact. If Δ is a subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{R})^r$ and Γ is a subgroup of Δ such that its projection to one factor is nonelementary, then Γ is nonelementary (Lemma 3.5). This is no longer true in the general case as the example in the remark after Corollary 5.12 shows.

We can also avoid the assumption that Γ is nonelementary by using the limit cone as Theorem 5.16 shows.

We then consider the full limit set (instead of P_Γ only) and determine the nonelementary groups with the smallest one. The following theorem is a compilation of Theorem 5.19 and Corollary 5.20.

Theorem C. *Let Γ be a finitely generated subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$ and $r \neq 0$ such that $p_j(\Gamma)$ is nonelementary for some $j = 1, \dots, q + r$. Then \mathcal{L}_Γ is embedded homeomorphically in a circle if and only if $p_j(\Gamma)$ is contained in an arithmetic Fuchsian group.*

Furthermore \mathcal{L}_Γ is homeomorphic to a circle if and only if $p_j(\Gamma)$ is a cofinite arithmetic Fuchsian group.

In the case $r = 0$ we prove the following theorem, which is Theorem 5.21 in the text.

Theorem D. *Let Γ be a subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q$ with $q \geq 2$ and assume that $p_j(\Gamma)$ is a cofinite Kleinian group*

for some $j \in \{1, \dots, q\}$. Then \mathcal{L}_Γ is the image of a differentiable embedding of the 2-sphere S^2 in $\partial(\mathbb{H}^3)^q$ if and only if $p_j(\Gamma)$ is an arithmetic Kleinian group.

In the case $r = 0$ we can also ask the question when the limit set is homeomorphic to a circle and the answer is given by Theorem 5.22, which is stated here as Theorem E.

Theorem E. *Let Γ be a finitely generated subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q$ with $q \geq 2$ such that $p_j(\Gamma)$ is nonelementary. Then \mathcal{L}_Γ is homeomorphic to a circle if and only if $p_j(\Gamma)$ is a cofinite arithmetic Fuchsian group or a quasi-Fuchsian subgroup of an arithmetic Kleinian group for some $j \in \{1, \dots, q\}$.*

In Section 6 we provide examples of “small” groups with a “big” limit set, namely groups where the projection of the regular limit set into the Furstenberg boundary is the whole Furstenberg boundary. These examples come from groups admitting so called modular embeddings.

Finally, in Section 7, we describe the totally geodesic embeddings of \mathbb{H}^2 in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. This is used to answer the question when the modular embedding of a semi-arithmetic group admitting a modular embedding is totally geodesic. Here we give the general statement combining Theorem 7.1, Theorem 7.2 and Theorem 7.3.

Theorem F. *Let Γ be a finitely generated subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$ such that $p_j(\Gamma)$ is nonelementary for some $j \in \{1, \dots, q + r\}$. Then there is a totally geodesic embedding of \mathbb{H}^2 in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ that is left invariant by the action of Γ if and only if $p_j(\Gamma)$ is a subgroup of an arithmetic Fuchsian group.*

1 Subgroups of $\mathrm{PSL}(2, \mathbb{R})$ and $\mathrm{PSL}(2, \mathbb{C})$

In this section we provide some basic facts and notations that are needed in the rest of the thesis. We will mainly work with products of $\mathrm{PSL}(2, \mathbb{R})$ and $\mathrm{PSL}(2, \mathbb{C})$ but in order to do this we need first to introduce the simple factors.

1.1 Subgroups of $\mathrm{PSL}(2, \mathbb{R})$ and the hyperbolic plane

We denote by $\mathrm{SL}(2, \mathbb{R})$ the group of real 2×2 matrices with determinant 1 and by $\mathrm{PSL}(2, \mathbb{R})$ the quotient group $\mathrm{SL}(2, \mathbb{R})/\{\pm 1_2\}$ where 1_2 is the 2×2 identity matrix.

A *Fuchsian group* is a discrete subgroup of $\mathrm{PSL}(2, \mathbb{R})$. On the *hyperbolic plane* $\mathbb{H}^2 := \{z = x + iy \in \mathbb{C} \mid y > 0\}$ endowed with the metric $ds^2 = y^{-2}(dx^2 + dy^2)$ a Fuchsian group acts isometrically and properly discontinuously by fractional linear transformations

$$\{z \mapsto \frac{az + b}{cz + d} \mid a, b, c, d \in \mathbb{R}, ad - bc = 1\} \subseteq \mathrm{Isom}(\mathbb{H}^2).$$

We will change freely between matrices in $\mathrm{SL}(2, \mathbb{R})$ and their action as fractional linear transformations, namely as elements in $\mathrm{PSL}(2, \mathbb{R})$.

A Fuchsian group Γ is called *cofinite* if the associated quotient surface $\Gamma \backslash \mathbb{H}^2$ has finite area.

For $g = \begin{bmatrix} a & b \\ c & d \end{bmatrix} \in \mathrm{PSL}(2, \mathbb{R})$ we set $\mathrm{tr}(g) := |a + d|$. For a subgroup Γ of $\mathrm{PSL}(2, \mathbb{R})$ we then call

$$\mathrm{Tr}(\Gamma) = \{\mathrm{tr}(g) \mid g \in \Gamma\}$$

the *trace set* of Γ .

1.2 Subgroups of $\mathrm{PSL}(2, \mathbb{C})$ and the hyperbolic 3-space

In this section we use Chapter 2 in the book of Maclachlan and Reid [16].

We denote by $\mathrm{SL}(2, \mathbb{C})$ the group of complex 2×2 matrices with determinant 1 and by $\mathrm{PSL}(2, \mathbb{C})$ the quotient group $\mathrm{SL}(2, \mathbb{C})/\{\pm 1_2\}$ where 1_2 is the 2×2 identity matrix. It acts via linear fractional transformations on $\hat{\mathbb{C}} := \mathbb{C} \cup \{\infty\}$

$$z \mapsto \frac{az + b}{cz + d} \text{ with } a, b, c, d \in \mathbb{C}, ad - bc = 1.$$

We will change freely between matrices in $\mathrm{SL}(2, \mathbb{C})$ and their action as fractional linear transformations, namely as elements in $\mathrm{PSL}(2, \mathbb{C})$.

The action of each $g \in \mathrm{PSL}(2, \mathbb{C})$ on $\hat{\mathbb{C}}$ extends to an action on the upper half space

$$\mathbb{H}^3 := \{(x, y, t) \in \mathbb{R}^3 \mid t > 0\}$$

via the Poincaré extension. When \mathbb{H}^3 is equipped with the metric

$$ds^2 = \frac{dx^2 + dy^2 + dt^2}{t^2},$$

then the group $\mathrm{PSL}(2, \mathbb{C})$ is identified with the group of orientation-preserving isometries of the hyperbolic 3-space \mathbb{H}^3 .

The metric on \mathbb{H}^2 is the restriction of the hyperbolic metric on \mathbb{H}^3 to the plane $y = 0$. Since $\mathrm{PSL}(2, \mathbb{C})$ acts transitively on the set of circles and straight lines in \mathbb{C} , the hemispheres and planes in \mathbb{H}^3 , orthogonal to \mathbb{C} , with the restriction of the hyperbolic metric in \mathbb{H}^3 are all models of hyperbolic 2-space.

The geodesic lines in \mathbb{H}^3 are circles and straight lines orthogonal to \mathbb{C} .

For $g = \begin{bmatrix} a & b \\ c & d \end{bmatrix} \in \mathrm{PSL}(2, \mathbb{C})$ we set $\mathrm{tr}(g) := \pm(a + d)$, where the sign is chosen so that $\mathrm{tr}(g) = re^{i\theta}$ mit $\theta \in [0, \pi)$. For a subgroup Γ of $\mathrm{PSL}(2, \mathbb{C})$ we then call

$$\mathrm{Tr}(\Gamma) = \{\mathrm{tr}(g) \mid g \in \Gamma\}$$

the *trace set* of Γ .

For the elements $g \neq \mathrm{Id}$ in $\mathrm{PSL}(2, \mathbb{C})$ there are the following possibilities:

- g is *elliptic* if $\mathrm{tr}(g) \in \mathbb{R}$ and $|\mathrm{tr}(g)| < 2$. The isometry g fixes pointwise a unique geodesic in \mathbb{H}^3 and rotates \mathbb{H}^3 about it.
- g is *parabolic* if $\mathrm{tr}(g) = 2$. It has exactly one fixed point in $\hat{\mathbb{C}}$ and is conjugate to $z \mapsto z + 1$.
- g is *loxodromic* otherwise. It has exactly two different fixed points in $\hat{\mathbb{C}}$ and a fixed geodesic in \mathbb{H}^3 but no fixed points in \mathbb{H}^3 . The isometry g is a screw motion translating along its fixed geodesic and simultaneously rotating about it.

If additionally $\mathrm{tr}(g)$ is in \mathbb{R} , then g is *hyperbolic*. In this case g is just translating along its fixed geodesic without rotating about it.

The *translation length* of a loxodromic g is the distance between a point x on the geodesic fixed by g and its image $g(x)$ under g . If g is elliptic, parabolic or the identity, we define $\ell(g) := 0$.

The following notion of “smallness” for subgroups Γ of $\mathrm{PSL}(2, \mathbb{C})$ is important in the subsequent discussion. The group Γ is *elementary* if it has a finite orbit in its action on $\mathbb{H}^3 \cup \hat{\mathbb{C}}$. Otherwise it is said to be *nonelementary*. Every nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{C})$ contains infinitely many loxodromic elements, no two of which have a common fixed point (see Theorem 5.1.3 in the book of Beardon [1]).

A *Kleinian group* is a discrete subgroup of $\mathrm{PSL}(2, \mathbb{C})$. This condition is equivalent to requiring that Γ acts properly discontinuously on \mathbb{H}^3 .

A Kleinian group Γ is said to be *cofinite* if it has a fundamental domain of finite hyperbolic volume.

A subgroup of $\mathrm{PSL}(2, \mathbb{C})$ that is conjugate to a subgroup of $\mathrm{PSL}(2, \mathbb{R})$ and is discrete will also be called Fuchsian.

1.3 Schottky Groups

A Schottky group is a finitely generated free subgroup of $\mathrm{PSL}(2, \mathbb{C})$ that contains only loxodromic isometries. We will mainly deal with two-generated Schottky groups.

Lemma 1.1. *For each two loxodromic isometries without common fixed points, we can find powers of them that generate a Schottky group. This means that every nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{C})$ has a subgroup that is a Schottky group.*

Proof. Let g and h be the two loxodromic isometries without any common fixed point.

The proof is similar to the proof of Lemma 2.8 in the book of Matsuzaki and Taniguchi [18]. The idea is to consider a fundamental polyhedron Q of the cyclic group generated by g^m , for m big enough, that is bounded by two hemispheres S and S' and such that the fixed points of h are in $\bar{Q} \cap \partial\mathbb{H}^3$. Now we can find n big enough so that the cyclic group generated by h^n has a fundamental polyhedron bounded by two hemispheres that are in $\bar{Q} \setminus (S \cup S')$.

Then from the fact that a nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{C})$ contains infinitely many loxodromic elements, no two of which have a common fixed point, it follows that such a group has a subgroup that is a Schottky group. \square

In a Schottky group there are isometries without common fixed points because it is nonelementary.

Everything above is also true for Fuchsian Schottky groups, i.e for subgroups of $\mathrm{PSL}(2, \mathbb{C})$ that after conjugation become subgroups of $\mathrm{PSL}(2, \mathbb{R})$.

1.3.1 Schottky Groups as Zariski dense subgroups

In this section \mathbb{K} will be either \mathbb{C} or \mathbb{R} .

The following is shown by Cornelissen and Marcolli in [5], Lemma 3.4. For convenience we also propose a different proof here.

Lemma 1.2. *A Schottky group is Zariski dense over \mathbb{K} in $\mathrm{PSL}(2, \mathbb{K})$.*

Proof. Let Γ be a Schottky group in $\mathrm{PSL}(2, \mathbb{K})$ and $\hat{\Gamma}$ its Zariski closure over \mathbb{K} . Then $\hat{\Gamma}$ is an algebraic group and hence a Lie subgroup of $\mathrm{PSL}(2, \mathbb{K})$. Since $\mathrm{PSL}(2, \mathbb{K})$ is connected, it is enough to show that the dimension of $\hat{\Gamma}$ is equal to the dimension of $\mathrm{PSL}(2, \mathbb{K})$ over \mathbb{K} in order to conclude that Γ is Zariski dense in $\mathrm{PSL}(2, \mathbb{K})$.

We will show that the Lie algebra of $\hat{\Gamma}$ is equal to $\mathfrak{sl}(2, \mathbb{K})$, which is the Lie algebra of $\mathrm{PSL}(2, \mathbb{K})$.

First we consider Γ and $\hat{\Gamma}$ as subgroups of $\mathrm{SL}(2, \mathbb{K})$. Then the exponential map from the Lie algebra of $\hat{\Gamma}$ to $\hat{\Gamma}$ is given by the matrix exponential map.

Eventually after conjugating we can assume that one of the generating elements of Γ is $T_1 = \begin{bmatrix} e^x & 0 \\ 0 & e^{-x} \end{bmatrix}$ with $x \neq 0$. The other (or another) generator $T_2 = \begin{bmatrix} a' & b' \\ c' & d' \end{bmatrix}$ of the free discrete group does not have a common fixed point with T_1 and hence $b' \neq 0$ and $c' \neq 0$. Hence their preimages in $\mathfrak{sl}(2, \mathbb{K})$ under the exponential map are $t_1 = \begin{bmatrix} x & 0 \\ 0 & -x \end{bmatrix}$ and $t_2 = \begin{bmatrix} a & b \\ c & -a \end{bmatrix}$ where $b \neq 0$ and $c \neq 0$. Hence also the element

$$t_3 = [t_1, t_2] = t_1 t_2 - t_2 t_1 = \begin{bmatrix} 0 & 2xb \\ -2xc & 0 \end{bmatrix}$$

is in the Lie algebra of $\hat{\Gamma}$. The vectors t_1 , t_2 and t_3 are linearly independent over \mathbb{K} and thus the Lie algebra of $\hat{\Gamma}$ is three dimensional over \mathbb{K} . Hence it is $\mathfrak{sl}(2, \mathbb{K})$.

This means that if we consider Γ and $\hat{\Gamma}$ as subgroups of $\mathrm{PSL}(2, \mathbb{K})$, the Lie algebra of $\hat{\Gamma}$ is still $\mathfrak{sl}(2, \mathbb{K})$. \square

Since every nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{K})$ contains a Schottky group, we have the following

Corollary 1.3. *A nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{K})$ is Zariski dense over \mathbb{K} in $\mathrm{PSL}(2, \mathbb{K})$.*

1.3.2 Schottky groups in $\mathrm{PSL}(2, \mathbb{C})$ that are Zariski dense over \mathbb{R}

In the previous section we showed that a Schottky group Γ in $\mathrm{PSL}(2, \mathbb{C})$ is Zariski dense over \mathbb{C} . Now the question is when Γ is Zariski dense over \mathbb{R} .

By Corollary 3.2.5 in the book of Maclachlan and Reid [16], if $\mathrm{Tr}(\Gamma)$ is a subset of \mathbb{R} , then Γ is conjugate to a subgroup of $\mathrm{PSL}(2, \mathbb{R})$. Then the Zariski closure of Γ over \mathbb{R} is a conjugate of $\mathrm{PSL}(2, \mathbb{R})$. For the case when $\mathrm{Tr}(\Gamma)$ is not a subset of \mathbb{R} we have the following lemma.

Lemma 1.4. *Let Γ be a Schottky group such that $\mathrm{Tr}(\Gamma)$ is not a subset of \mathbb{R} . Then Γ is Zariski dense in $\mathrm{PSL}(2, \mathbb{C})$ over \mathbb{R} .*

Proof. Let $\hat{\Gamma}$ be the Zariski closure of Γ over \mathbb{R} . Then $\hat{\Gamma}$ is an algebraic group and hence a Lie subgroup of $\mathrm{PSL}(2, \mathbb{C})$. Since $\mathrm{PSL}(2, \mathbb{C})$ is connected, it is enough to show that the dimension of $\hat{\Gamma}$ is equal to the dimension of $\mathrm{PSL}(2, \mathbb{C})$ over \mathbb{R} in order to conclude that Γ is Zariski dense in $\mathrm{PSL}(2, \mathbb{C})$ over \mathbb{R} .

We will show that the Lie algebra of $\hat{\Gamma}$ over \mathbb{R} is equal to $\mathfrak{sl}(2, \mathbb{C})$, which is the Lie algebra of $\mathrm{PSL}(2, \mathbb{C})$ considered as a real Lie group.

We use similar arguments as in Lemma 1.2. First we consider Γ and $\hat{\Gamma}$ as subgroups of $\mathrm{SL}(2, \mathbb{C})$. Then the exponential map from the Lie algebra of $\hat{\Gamma}$ to $\hat{\Gamma}$ is given by the matrix exponential map.

After conjugation, since $\mathrm{Tr}(\Gamma)$ is not a subset of \mathbb{R} , we can assume that Γ contains a loxodromic element $T_1 = \begin{bmatrix} e^x & 0 \\ 0 & e^{-x} \end{bmatrix}$ with $x \in \mathbb{C} \setminus \mathbb{R}$ and hence $\mathrm{tr}(T_1) \notin \mathbb{R}$. There is also an isometry T_2 which does not have common fixed points with T_1 and hence is equal to $T_2 = \begin{bmatrix} a' & b' \\ c' & d' \end{bmatrix}$ with $b' \neq 0$ and $c' \neq 0$ (otherwise 0 or ∞ would be a common fixed point). Therefore their preimages in $\mathfrak{sl}(2, \mathbb{C})$ under the exponential map are $t_1 = \begin{bmatrix} x & 0 \\ 0 & -x \end{bmatrix}$ and $t_2 = \begin{bmatrix} a & b \\ c & -a \end{bmatrix}$

where $b \neq 0$ and $c \neq 0$. Then $\mathfrak{sl}(2, \mathbb{C})$ contains

$$\begin{aligned} t_3 &= [t_1, t_2] = t_1 t_2 - t_2 t_1 = \begin{bmatrix} 0 & 2bx \\ -2cx & 0 \end{bmatrix}, \\ t_4 &= [t_1, t_3] = t_1 t_3 - t_3 t_1 = \begin{bmatrix} 0 & 4bx^2 \\ 4cx^2 & 0 \end{bmatrix}, \\ t_5 &= [t_1, t_4] = t_1 t_4 - t_4 t_1 = \begin{bmatrix} 0 & 8bx^3 \\ -8cx^3 & 0 \end{bmatrix}, \\ t_6 &= [t_1, t_5] = t_1 t_5 - t_5 t_1 = \begin{bmatrix} 0 & 16bx^4 \\ 16cx^4 & 0 \end{bmatrix}. \end{aligned}$$

Since $\text{tr}(T_1) = e^x + e^{-x}$ is not real, then x is not only not real but also cannot be a multiple of i . This means that x and x^3 are linearly independent over \mathbb{R} . Hence the linear span of t_3 and t_5 over \mathbb{R} is $\left\{ \begin{bmatrix} 0 & bz \\ -cz & 0 \end{bmatrix} \mid z \in \mathbb{C} \right\}$.

Analogously, the linear span of t_4 and t_6 over \mathbb{R} is $\left\{ \begin{bmatrix} 0 & bz \\ cz & 0 \end{bmatrix} \mid z \in \mathbb{C} \right\}$.

Hence t_3, t_4, t_5 and t_6 span the 4-dimensional real vector subspace of the Lie algebra of $\hat{\Gamma}$

$$U := \left\{ \begin{bmatrix} 0 & z_1 \\ z_2 & 0 \end{bmatrix} \mid z_1, z_2 \in \mathbb{C} \right\}.$$

By taking the commutator of the elements of U with $\begin{bmatrix} 0 & 0 \\ 1 & 0 \end{bmatrix}$, which is also an element in U , we get that the Lie algebra of $\hat{\Gamma}$ contains

$$V := \left\{ \begin{bmatrix} z_1 & 0 \\ 0 & -z_1 \end{bmatrix} \mid z_1 \in \mathbb{C} \right\}.$$

The span of U and V is the 6-dimensional real vector space $\mathfrak{sl}(2, \mathbb{C})$. Hence the Lie algebra of $\hat{\Gamma}$ is $\mathfrak{sl}(2, \mathbb{C})$.

This means that if we consider Γ and $\hat{\Gamma}$ as subgroups of $\text{PSL}(2, \mathbb{C})$, the Lie algebra of $\hat{\Gamma}$ is still $\mathfrak{sl}(2, \mathbb{C})$. \square

Since every nonelementary subgroup of $\text{PSL}(2, \mathbb{C})$ contains a Schottky group, we have the following

Corollary 1.5. (i) *A nonelementary subgroup Γ of $\mathrm{PSL}(2, \mathbb{C})$ is Zariski dense over \mathbb{R} in $\mathrm{PSL}(2, \mathbb{C})$ if and only if $\mathrm{Tr}(\Gamma)$ is not a subset of \mathbb{R} .*

(ii) *The Zariski closure over \mathbb{R} of a nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{C})$ with real traces is a conjugate of $\mathrm{PSL}(2, \mathbb{R})$.*

2 Products of hyperbolic planes and 3-spaces

Let q and r be two nonnegative integers such that $q + r > 0$. We consider the product $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ of q hyperbolic 3-spaces and r hyperbolic planes which is the Cartesian product of q upper half 3-spaces and r upper half planes with the metric

$$ds^2 = \frac{dx_1^2 + dy_1^2 + dt_1^2}{t_1^2} + \dots + \frac{dx_q^2 + dy_q^2 + dt_q^2}{t_q^2} + \frac{dx_{q+1}^2 + dy_{q+1}^2}{y_{q+1}^2} + \dots + \frac{dx_{q+r}^2 + dy_{q+r}^2}{y_{q+r}^2}$$

and we denote by d the corresponding distance function. The Riemannian manifold $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ is a symmetric space of rank $q + r$.

In the next sections we will define the geometric boundary of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ and the limit set of a group acting on $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ by isometries.

2.1 The geometric boundary of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$

For $i = 1, \dots, q$, we denote by $p_i : (\mathbb{H}^3)^q \times (\mathbb{H}^2)^r \rightarrow \mathbb{H}^3$, $(z_1, \dots, z_{q+r}) \mapsto z_i$ the i -th projection of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ into \mathbb{H}^3 , and for $i = q + 1, \dots, q + r$, we denote by $p_i : (\mathbb{H}^3)^q \times (\mathbb{H}^2)^r \rightarrow \mathbb{H}^2$, $(z_1, \dots, z_{q+r}) \mapsto z_i$ the i -th projection of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ into \mathbb{H}^2 . Let $\gamma : [0, \infty) \rightarrow (\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ be a curve in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. Then γ is a geodesic ray in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ if and only if $p_i \circ \gamma$ is a geodesic ray or a point in \mathbb{H}^3 for each $i = 1, \dots, q$ and a geodesic ray or a point in \mathbb{H}^2 for each $i = q + 1, \dots, q + r$. A geodesic γ is *regular* if $p_i \circ \gamma$ is a nonconstant geodesic in \mathbb{H}^3 for each $i = 1, \dots, q$ and a nonconstant geodesic in \mathbb{H}^2 for each $i = q + 1, \dots, q + r$.

Two unit speed geodesic rays γ and δ in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ are said to be asymptotic if there exists a positive number c such that $d(\gamma(t), \delta(t)) \leq c$ for all $t \geq 0$. This is an equivalence relation on the unit speed geodesic rays of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. For any unit speed geodesic γ of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ we denote by $\gamma(+\infty)$ the equivalence class of its positive ray.

We denote by $\partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)$ the set of all equivalence classes of unit speed geodesic rays of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. We call $\partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)$ the *geometric boundary* of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. The *regular boundary* $\partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)_{reg}$ of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ consists of the equivalence classes of regular geodesics.

The geometric boundary $\partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)$ with the cone topology is homeomorphic to the unit tangent sphere of a point in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ (see Eberlein [8], 1.7). (For example $\partial\mathbb{H}^2$ is homeomorphic to S^1 .) The homeomorphism is

given by the fact that for each point x_0 and each unit speed geodesic ray γ in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ there exists a unique unit speed geodesic ray δ with $\delta(0) = x_0$ which is asymptotic to γ .

The group $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ acts on $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ by isometries in the following way. For $g = (g_1, \dots, g_{q+r}) \in \mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$

$$g : (\mathbb{H}^3)^q \times (\mathbb{H}^2)^r \rightarrow (\mathbb{H}^3)^q \times (\mathbb{H}^2)^r, \quad (z_1, \dots, z_{q+r}) \mapsto (g_1 z_1, \dots, g_{q+r} z_{q+r}),$$

where $z_i \mapsto g_i z_i$ is the usual action given by linear fractional transformation, $i = 1, \dots, q+r$.

The action of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ can be extended naturally on $\partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)$. Let g be in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ and ξ be a point in the boundary $\partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)$. If γ is a representative of ξ , then $g(\xi)$ is the equivalence class of the geodesic ray $g \circ \gamma$.

We call g *elliptic* if all g_i are elliptic isometries, *parabolic* if all g_i are parabolic isometries, *loxodromic* if all g_i are loxodromic isometries and *hyperbolic* if all g_i are hyperbolic isometries. In all the other cases we call g *mixed*. Remark that in the hyperbolic and loxodromic isometries, the last r factors are always hyperbolic and the difference between them comes from the factors that are in $\mathrm{PSL}(2, \mathbb{C})$.

If at least one $\ell(g_i)$ is different from zero, then we define the *translation direction* of g as $L(g) := (\ell(g_1) : \dots : \ell(g_{q+r}))$.

2.2 Decomposition of the geometric boundary of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$

In this section we show a natural decomposition of the geometric boundary of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ and in particular of its regular part. This is a special case of a general construction for a large class of symmetric spaces (see e.g. Leuzinger [13] and Link [14]). This decomposition plays a main role in the thesis.

Let $x = (x_1, \dots, x_{q+r})$ be a point in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. We consider the *Weyl chambers* with vertex x in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ given by the product of the images of the geodesics $\delta_i : [0, \infty) \rightarrow \mathbb{H}^3$ with $\delta_i(0) = x_i$ for $i = 1, \dots, q$ and $\delta_i : [0, \infty) \rightarrow \mathbb{H}^2$ with $\delta_i(0) = x_i$ for $i = q+1, \dots, q+r$.

The isotropy group in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ of x is $PSU(2)^q \times PSO(2)^r$. It acts transitively but not simply transitively on the Weyl chambers with vertex x because a fixed Weyl chamber with vertex x is left unchanged by

a group isomorphic to $PSO(2)^q \times \{id\}^r$. Hence the group acting simply transitively on the Weyl chambers with vertex x is $(PSU(2)/PSO(2))^q \times PSO(2)^r$.

Let W be a Weyl chamber with vertex x . In W , two unit speed geodesics $\gamma(t) = (\gamma_1(t), \dots, \gamma_{q+r}(t))$ and $\tilde{\gamma} = (\tilde{\gamma}_1(t), \dots, \tilde{\gamma}_{q+r}(t))$ are different if and only if the corresponding projective points

$$(d_H(\gamma_1(0), \gamma_1(1)) : \dots : d_H(\gamma_{q+r}(0), \gamma_{q+r}(1))) \text{ and}$$

$$(d_H(\tilde{\gamma}_1(0), \tilde{\gamma}_1(1)) : \dots : d_H(\tilde{\gamma}_{q+r}(0), \tilde{\gamma}_{q+r}(1)))$$

are different. Here d_H denotes the hyperbolic distance in \mathbb{H}^3 and \mathbb{H}^2 . The point $(d_H(\gamma_1(0), \gamma_1(1)) : \dots : d_H(\gamma_{q+r}(0), \gamma_{q+r}(1)))$ in \mathbb{RP}^{q+r-1} is a direction in the Weyl chamber and it is the same as $(\|v_1\| : \dots : \|v_{q+r}\|)$, where $v = (v_1, \dots, v_{q+r}) := \gamma'(0)$ is the unit tangent vector of γ in 0.

In other words we can extend the action of Iso_x on the tangent space at x in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. Then Iso_x maps a unit tangent vector at x into a unit tangent vector at x . Let v be a unit tangent vector at x in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. We denote by v_i the i -th projection of v on the tangent spaces at x_i , $i = 1, \dots, q+r$. Then all the vectors w in the orbit of v under Iso_x have $\|w_i\| = \|v_i\|$.

Let v be a vector in the unit tangent sphere at x in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. If v is tangent to a regular geodesic, then the orbit of v is homeomorphic to $(S^2)^q \times (S^1)^r \cong (\partial\mathbb{H}^3)^q \times (\partial\mathbb{H}^2)^r$ because $\partial\mathbb{H}^3 \cong S^2$ and $\partial\mathbb{H}^2 \cong S^1$. The orbit of v under the group $(PSU(2)/PSO(2))^q \times PSO(2)^r$ consists of all unit tangent vectors w at x such that $\|w_i\| = \|v_i\|$ for $i = 1, \dots, q+r$.

The *regular boundary* $\partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)_{reg}$ of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ consists of the equivalence classes of regular geodesics. Hence it is identified with $(\partial\mathbb{H}^3)^q \times (\partial\mathbb{H}^2)^r \times \mathbb{RP}_+^{q+r-1}$ where

$$\mathbb{RP}_+^{q+r-1} := \{(w_1 : \dots : w_{q+r}) \in \mathbb{RP}^{q+r-1} \mid w_1 > 0, \dots, w_{q+r} > 0\}.$$

Here w_1, \dots, w_{q+r} can be thought as the norms of the projections of the regular unit tangent vectors on the simple factors of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$.

$(\partial\mathbb{H}^3)^q \times (\partial\mathbb{H}^2)^r$ is called the *Furstenberg boundary* of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$.

We note that the decomposition of the boundary into orbits under the group Iso_x is independent of the point x .

2.3 The limit set of a group

Let x be a point and $\{x_n\}_{n \in \mathbb{N}}$ a sequence of points in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. We say that $\{x_n\}_{n \in \mathbb{N}}$ converges to a point $\xi \in \partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)$ if $\{x_n\}_{n \in \mathbb{N}}$ is discrete in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ and the sequence of geodesic rays starting at x and going through x_n converges towards ξ in the cone topology. With this topology, $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r \cup \partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)$ is a compactification of $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$.

Let Γ be a subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$. We denote by $\Gamma(x)$ the orbit of x under Γ and by $\overline{\Gamma(x)}$ - its closure. The *limit set* of Γ is $\mathcal{L}_\Gamma := \overline{\Gamma(x)} \cap \partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)$. The limit set is independent of the choice of the point x in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. The *regular limit set* is $\mathcal{L}_\Gamma^{reg} := \mathcal{L}_\Gamma \cap \partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)_{reg}$ and the *singular limit set* is $\mathcal{L}_\Gamma^{sing} := \mathcal{L}_\Gamma \setminus \mathcal{L}_\Gamma^{reg}$.

We denote by F_Γ the projection of \mathcal{L}_Γ^{reg} on the Furstenberg boundary $(\partial\mathbb{H}^3)^q \times (\partial\mathbb{H}^2)^r$ and by P_Γ the projection of \mathcal{L}_Γ^{reg} on \mathbb{RP}_+^{q+r-1} . The projection F_Γ is the *Furstenberg limit set* of Γ and P_Γ is the *projective limit set* of Γ .

Let $h \in \Gamma$ be a loxodromic element or a mixed one with only hyperbolic or elliptic components. There is a unique unit speed geodesic γ in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ such that $h \circ \gamma(t) = \gamma(t+T_h)$ for a fixed $T_h \in \mathbb{R}_{>0}$ and all $t \in \mathbb{R}$. For $y \in \gamma$, the sequence $h^n(y)$ converges to $\gamma(+\infty)$. Hence also for every $x \in (\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$, the sequence $h^n(x)$ converges to $\gamma(+\infty)$. Thus $\gamma(+\infty)$ is in \mathcal{L}_Γ . The sequence $h^{-n}(x)$ converges to $\gamma(-\infty) := -\gamma(+\infty)$ and therefore $\gamma(-\infty)$ is also in \mathcal{L}_Γ . The points $\gamma(+\infty)$ and $\gamma(-\infty)$ are the only fixed points of h in \mathcal{L}_Γ . The point $\gamma(+\infty)$ is the *attractive* fixed point of h and the point $\gamma(-\infty)$ - the *repulsive* fixed point of h .

If h is loxodromic, then for all $i = 1, \dots, q+r$, the projection $p_i \circ \gamma$ is not a point. Hence γ is regular and $\gamma(+\infty) \in \mathcal{L}_\Gamma^{reg}$. The point $\gamma(+\infty)$ can be written as (ξ_F, ξ_P) in our description of the regular geometric boundary where

$$\xi_F := (p_1 \circ \gamma(+\infty), \dots, p_{q+r} \circ \gamma(+\infty))$$

is in the Furstenberg boundary and

$$\xi_P := (d_H(p_1 \circ \gamma(0), p_1 \circ \gamma(1)) : \dots : d_H(p_{q+r} \circ \gamma(0), p_{q+r} \circ \gamma(1)))$$

is in the projective limit set. Here we note that ξ_P is also equal to

$$(d_H(p_1 \circ \gamma(0), p_1 \circ \gamma(T_h)) : \dots : d_H(p_{q+r} \circ \gamma(0), p_{q+r} \circ \gamma(T_h))),$$

which is exactly the translation direction of h .

Thus the translation direction of each loxodromic isometry h in Γ determines a point in the projective limit set P_Γ . This point does not change after conjugation with h or after taking a power h^m of h , because in these cases the translation direction remains unchanged.

Recall that following Katok [10], we call a subgroup Γ of $\mathrm{PSL}(2, \mathbb{C})$ *elementary* if there exists a finite Γ -orbit in $\overline{\mathbb{H}^3} := \mathbb{H}^3 \cup \partial\mathbb{H}^3$ and *nonelementary* if it is not elementary. Since \mathbb{H}^3 and $\partial\mathbb{H}^3$ are Γ -invariant, any Γ -orbit of a point in $\overline{\mathbb{H}^3}$ is either completely in \mathbb{H}^3 or completely in $\partial\mathbb{H}^3$.

We call a subgroup Γ of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ *nonelementary* if for all $i = 1, \dots, q+r$, $p_i(\Gamma)$ is nonelementary, and if for all $g \in \Gamma$ that are mixed, the projections $p_i \circ g$ are either loxodromic or elliptic of infinite order. Since for all $i = 1, \dots, q+r$, $p_i(\Gamma)$ is nonelementary, Γ does not contain only elliptic isometries and thus \mathcal{L}_Γ is not empty.

This definition of nonelementary is more restrictive than the one given by Link in [14]. The definition of a nonelementary subgroup Γ of $\mathrm{PSL}(2, \mathbb{R})^r$ in [14] is the following: The limit set of Γ is nonempty and if $\xi \in \mathcal{L}_\Gamma$ and $\Gamma(\xi)$ denotes its orbit under Γ , then each point in the orbit of ξ under $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ can be *connected* with a geodesic to at least one point in $\Gamma(\xi)$.

Two points ξ and η in $\partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)$ can be *connected* by a geodesic if and only if $\xi = \gamma(\infty)$ and $\eta = \gamma(-\infty)$ for some geodesic γ in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. If ξ and η can be connected by a geodesic then they necessarily lie in the same orbit under $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$. A possible element mapping ξ to η is one that fixes a point on the connecting geodesic and rotates around a geodesic orthogonal to γ by π in each of the first q factors and around the fixed point by π in the other r factors.

Lemma 2.1. *If a subgroup Γ of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ is nonelementary (according to our definition), then it is nonelementary in the sense of Link's definition in [14].*

Proof. Let ξ and η be in the same orbit under $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ and γ and δ their representative geodesic rays. Then ξ and η can be connected by a geodesic if and only if when $p_i \circ \gamma$ and $p_i \circ \delta$ are nonconstant in \mathbb{H}^2 (or \mathbb{H}^3), then $p_i \circ \gamma$ and $p_i \circ \delta$ are not in the same equivalence class in $\partial\mathbb{H}^2$ (or $\partial\mathbb{H}^3$).

Let Γ be nonelementary (according to our definition) and let ξ be in \mathcal{L}_Γ and η a point in the orbit of ξ under $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$. Without loss of generality we can assume that the first k projections of the defining

geodesics of ξ and η are nonconstant. We denote their equivalence classes in $\partial((\mathbb{H}^3)^q \times (\mathbb{H}^2)^r)$ with ξ_i and η_i respectively, $i = 1, \dots, k$. We will show by induction that there is an element $g = (g_1, \dots, g_{q+r})$ of Γ such that $g_i(\xi_i) \neq \eta_i$ for all $i = 1, \dots, k$ and therefore Γ is nonelementary according to Link's definition.

First, for $j = 1$, if $\xi_1 = \eta_1$, we can find $g \in \Gamma$ such that $g_1(\xi_1) \neq \eta_1$. The existence of g follows from the fact that $p_1(\Gamma)$ is nonelementary and thus the orbit of ξ_1 under $p_1(\Gamma)$ is infinite.

Let $g \in \Gamma$ be such that $g_i(\xi_i) \neq \eta_i$ for all $i = 1, \dots, j$, $j < k$. If $g_{j+1}(\xi_{j+1}) \neq \eta_{j+1}$, then g is the searched element. Otherwise, since $p_{j+1}(\Gamma)$ is nonelementary, there is $h = (h_1, \dots, h_r)$ in Γ such that h_{j+1} is loxodromic and does not have ξ_{j+1} as a fixed point. Hence for all $n \in \mathbb{N}$, $h_{j+1}^n(\xi_{j+1}) \neq \eta_{j+1}$.

According to our definition of nonelementary, for $i = 1, \dots, j$, h_i is either loxodromic or elliptic of infinite order. Hence the point $g_i(\xi_i)$ is either fixed point for h_i or has an infinite orbit under h_i . In the first case, for any $n \in \mathbb{N}$, $h_i^n \circ g_i(\xi_i) \neq \eta_i$, and in the second case for n big enough the same is true. Hence $h^n \circ g$ for n big enough is the searched element. \square

Remark. In the proof we used the assumption that for all $g \in \Gamma$ that are mixed, the projections $p_i \circ g$ are either loxodromic or elliptic of infinite order. We can prove the lemma without this assumption on Γ , but then the proof is a little more complicated because we need to consider different cases. And as we will see later we are only interested in groups Γ such that for all $g \in \Gamma$ that are mixed, the projections $p_i \circ g$ are either hyperbolic or elliptic of infinite order.

The next theorem is a special case of Theorem 3 from the introduction of [14]. It describes the structure of the regular limit set of nonelementary discrete subgroups of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$.

Theorem 2.2 ([14]). *Let Γ be a nonelementary discrete subgroup of the group $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ acting on $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. If \mathcal{L}_Γ^{reg} is not empty, then F_Γ is a minimal closed Γ -invariant subset of $(\partial\mathbb{H}^3)^q \times (\partial\mathbb{H}^2)^r$, the regular limit set equals the product $F_\Gamma \times P_\Gamma$ and P_Γ is equal to the closure in \mathbb{RP}_+^{q+r-1} of the set of translation directions of the loxodromic isometries in Γ .*

3 Nonelementary groups

In this part we will show first that the regular limit set of a nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ is not empty and then we prove that its projective limit set is convex. This is a generalization of a result of Benoist in [2]. Finally, we describe the groups in which the projection to one factor is nonelementary.

3.1 The regular limit set in nonempty

To prove that the regular limit set of a nonelementary group is nonempty is equivalent in our case to proving that the group is *strongly nonelementary*, i.e. that it contains a Schottky subgroup. In order to prove this we first need the next lemma.

Recall the definition of translation direction $L(g) := (\ell(g_1) : \dots : \ell(g_{q+r}))$.

Lemma 3.1. *Let Γ be a nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$. Further let g and h be two loxodromic isometries in Γ . Then there are loxodromic isometries g' and h' in Γ with $L(g) = L(g')$ and $L(h) = L(h')$ such that the groups generated by the corresponding components are all Schottky groups with only loxodromic isometries.*

Proof. Let $g = (g_1, \dots, g_{q+r})$ and $h = (h_1, \dots, h_{q+r})$ be the given loxodromic isometries.

Step 1. We can assume that g_1 and h_1 do not have a common fixed point: Since $p_1(\Gamma)$ is nonelementary, there exists a transformation $\tilde{g} = (\tilde{g}_1, \dots, \tilde{g}_{q+r})$ in Γ such that \tilde{g}_1 is loxodromic and \tilde{g}_1 and g_1 do not have any common fixed point. Hence for $n \in \mathbb{N}$ big enough, the isometries g_1 and $\tilde{g}_1^n h_1 \tilde{g}_1^{-n}$ do not have any common fixed point. Since the translation direction does not change under conjugation, we can consider $\tilde{g}^n h \tilde{g}^{-n}$ instead of h .

Step 2. We can assume that g_1 and h_1 generate a Schottky group which contains only loxodromic isometries: Indeed, by the previous step, the isometries g_1 and h_1 do not have a common fixed point, therefore, by Lemma 1.1, for n big enough, g_1^n and h_1^n generate a Schottky group which contains only loxodromic isometries. Since $L(g) = L(g^n)$ and $L(h) = L(h^n)$, we take g^n and h^n instead of g and h .

Step 3. If g and h are as in the first and in the second step, then, for $i = 2, \dots, q+r$, g_i and h_i have no common fixed point. In order to

show this we assume that g_i and h_i have a common fixed point. Possibly after conjugation we can assume that this common fixed point is infinity and hence g_i and h_i are represented by the matrices $\begin{bmatrix} a & b \\ 0 & 1/a \end{bmatrix}$ and $\begin{bmatrix} c & d \\ 0 & 1/c \end{bmatrix}$ for some $a, c \in \mathbb{R}_{>0} \setminus \{1\}$ and $b, d \in \mathbb{R}$. Then

$$[g_i, h_i] = g_i h_i g_i^{-1} h_i^{-1} = \begin{bmatrix} 1 & -cd - abc^2 + a^2cd + ab \\ 0 & 1 \end{bmatrix}.$$

Hence the commutator $[g_i, h_i]$ is either parabolic or the identity. On the other hand $[g_i, h_i]$ has to be loxodromic or elliptic of infinite order because $[g_1, h_1]$ is a loxodromic isometry in the free group generated by g_1 and h_1 . This is a contradiction.

Now we take $g' := g^N$ and $h' := h^N$ for $N \in \mathbb{N}$ big enough so that we can assure that for all $i = 2, \dots, q+r$, the group generated by g'_i and h'_i is a Schottky group with only loxodromic isometries. \square

The next lemma is needed in the proof of Lemma 3.3.

Lemma 3.2. *Let $g \in \mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ be elliptic of infinite order and $h \in \mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ be loxodromic. There are positive integers m and n such that $g^m h^n$ and $h^n g^m$ are loxodromic.*

Proof. Since g is an elliptic isometry of infinite order, there is a sequence m_k such that g^{m_k} converges to Id when $k \rightarrow \infty$. Now if h is loxodromic, then $g^{m_k} h$ converges to h when $k \rightarrow \infty$. Hence $\mathrm{tr}(g^{m_k} h) \xrightarrow{k \rightarrow \infty} \mathrm{tr}(h)$ and there is $K \in \mathbb{N}$ such that for all $k > K$, the isometries $g^{m_k} h$ and $h g^{m_k}$ are loxodromic. If this K is big enough, then for all $n > 0$ and for all $k > K$, the isometries $g^{m_k} h^n$ and $h^n g^{m_k}$ are loxodromic. \square

Lemma 3.3. *Let Γ be a nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$. Then $\mathcal{L}_\Gamma^{\mathrm{reg}}$ is not empty.*

Proof. The idea is to find an element h in Γ such that for all $i = 1, \dots, q+r$, the transformation h_i is loxodromic. Then the attractive and repulsive fixed points of h define a point in the regular limit set.

We are going to use a diagonal argument. For each $i = 1, \dots, q+r$ we choose $g_i = (g_{i1}, \dots, g_{i,q+r}) \in \Gamma$ such that g_{ii} is loxodromic. The isometries g_i do not need to be different. Using g_i , we will gradually construct the searched isometry h . In each step of the construction g_{ii} will stay loxodromic.

First we show that for all $i = 2, \dots, q + r$, we can choose the isometry g_i so that g_{i1} is loxodromic.

If for some $i = 2, \dots, q + r$, g_{i1} is not loxodromic then it is elliptic of infinite order. If g_{i1} is loxodromic, then instead of g_i we take g_1 . In the other case, when g_{i1} is elliptic, instead of g_i we take $g_1^m g_i^n$ where m and n are chosen according to Lemma 3.2 such that $g_{11} g_{i1}^n$ and $g_{1i}^m g_{ii}$ are loxodromic. Then also $g_{11}^m g_{i1}^n$ and $g_{1i}^m g_{ii}^n$ are loxodromic.

Now assume that for $i = k, \dots, q + r$ and for $j = 1, \dots, k - 1$, the isometries g_{ij} and g_{ii} are loxodromic. We will show that for all $i = k + 1, \dots, q + r$, we can choose g_i so that, for $j = 1, \dots, k$, the isometries g_{ij} and g_{ii} are loxodromic.

If for some $i = k + 1, \dots, q + r$, g_{ki} is loxodromic, then instead of g_i we take g_k . In the other case g_{ki} is elliptic of infinite order. First instead of g_k and g_i we consider g'_k and g'_i that we get from Lemma 3.1 after projecting Γ on the first $k - 1$ factors. The types of the isometries remain unchanged under conjugation. Instead of g'_k and g'_i , we will continue to write g_k and g_i .

Then using Lemma 1.1, we take powers of g_k and g_i so that, for all $j = 1, \dots, k - 1$, g_{kj} and g_{ij} generate a Schottky group.

Finally, instead of g_i we take $g_k^m g_i^n$ where m and n are chosen according to Lemma 3.2 such that $g_{kk} g_{ik}^n$ and $g_{ki}^m g_{kk}$ are loxodromic. Then also $g_{kk}^m g_{ik}^n$ and $g_{ki}^m g_{ii}^n$ are loxodromic. \square

Remark. This lemma is also true if we omit the condition for the mixed elements in the definition of a nonelementary group.

If the group Γ is a subgroup of $\mathrm{PSL}(2, \mathbb{R})^r$ we have an even stronger statement.

Lemma 3.4. *Let Γ be a subgroup of $\mathrm{PSL}(2, \mathbb{R})^r$ such that all mixed isometries in Γ have only elliptic and hyperbolic components and $p_j(S)$ is nonelementary for one $j \in \{1, \dots, r\}$. Then \mathcal{L}_Γ^{reg} is not empty.*

Proof. First we show that the subgroup Γ of $\mathrm{PSL}(2, \mathbb{R})^r$ contains a hyperbolic element $h = (h_1, \dots, h_r)$. A proof of this fact is given also by Ricker in [19], in the proof of Proposition 2.

Without loss of generality we can assume that $p_1(\Gamma)$ is nonelementary. In this case Γ contains two isometries g and g' such that g_1 and g'_1 are hyperbolic without common fixed points. We set $\tilde{g} := g' g g'^{-1}$. Then g_1 and \tilde{g}_1 also do not have any common fixed point. Again without loss of generality we can

assume that, for $i = 1, \dots, k$, g_i and \tilde{g}_i are hyperbolic and, for $i = k+1, \dots, r$, elliptic of infinite order. By Lemma 1.1 and by Step 3 from the proof of Lemma 3.1, for n big enough, for all $i = 1, \dots, k$, the isometries g_i^n and \tilde{g}_i^n generate a Schottky group. Hence the isometries $[g_i^n, \tilde{g}_i^n] = g_i^n \tilde{g}_i^n g_i^{-n} \tilde{g}_i^{-n}$ are hyperbolic.

For $i = k+1, \dots, r$, the isometries g_i^n and \tilde{g}_i^n do not commute, because otherwise their commutator $[g_i^n, \tilde{g}_i^n]$ will be the identity, which cannot be a component of a mixed isometry. Therefore g_i^n and \tilde{g}_i^n have different fixed points and by Theorem 7.39.2 in the book of Beardon [1], the commutator $[g_i^n, \tilde{g}_i^n]$ is hyperbolic.

Thus we have proved that $h := g^n \tilde{g}^n g^{-n} \tilde{g}^{-n}$ is a hyperbolic element in Γ .

The attractive and repulsive fixed points of h are points in the regular limit set of $p_1(\Gamma)$. \square

As the next lemma shows, a corollary of the previous lemma is that $p_j(\Gamma)$ is “big” (=nonelementary) if and only if Γ is “big”.

Lemma 3.5. *Let Γ be a subgroup of $\mathrm{PSL}(2, \mathbb{R})^r$ such that all mixed isometries in Γ have only elliptic and hyperbolic components. If $p_j(\Gamma)$ is nonelementary for one $j \in \{1, \dots, r\}$, then Γ is also nonelementary.*

Proof. Again without loss of generality we can assume that $j = 1$. By the previous lemma, Γ contains a hyperbolic element $h = (h_1, \dots, h_r)$. Since $p_1(\Gamma)$ is nonelementary, the group Γ contains an element $g = (g_1, \dots, g_r)$ such that g_1 is hyperbolic and does not have any fixed point in common with h_1 . Then for all $i = 2, \dots, r$, the isometry g_i is either elliptic of infinite order or it is hyperbolic that does not have common fixed points with h_i (see Step 3 from the proof of Lemma 3.1). In both cases some powers of h_i and $g_i h_i g_i^{-1}$ generate a Schottky group (by Lemma 1.1). \square

Unfortunately, the above statement is false for subgroups of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q \geq 1$ and $q + r \geq 2$.

3.2 Groups with a nonelementary projection

In this section we continue the investigation of groups with a nonelementary projection in one factor that was started with Lemma 3.5.

Proposition 3.6. *Let Γ be a subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ such that all mixed isometries in Γ have only elliptic and loxodromic components and*

$p_j(\Gamma)$ is nonelementary for some $j \in \{1, \dots, q+r\}$. Then each projection $p_i(\Gamma)$ to a real factor, i.e. $i = q+1, \dots, q+r$, is nonelementary, and to a complex factor, i.e. $i = 1, \dots, q$, is either nonelementary or consists only of elliptic isometries with a common fixed point.

Proof. For simplicity we will denote $p_i(\Gamma)$ by Γ_i for all $i = 1, \dots, q+r$.

First we show that Γ_i is nonelementary for $i = q+1, \dots, q+r$. If $q+1 \leq j \leq q+r$, then from Lemma 3.5 it follows that all Γ_i are nonelementary for $i = q+1, \dots, q+r$. Otherwise, we see that the proofs of Lemma 3.4 and Lemma 3.5 work for the projections p_i with $i = q+1, \dots, q+r$ independently of the fact that the given nonelementary projection is not among them.

Without loss of generality, we can assume that Γ_{q+r} is nonelementary. We will prove that for $i = 1, \dots, q$, the subgroup Γ_i of $\mathrm{PSL}(2, \mathbb{C})$ is either nonelementary or consists only of elliptic isometries and then by Theorem 4.3.7 in Beardon's book [1], they have a common fixed point. In order to see this, we assume that Γ_i contains a parabolic or loxodromic element g_i . It is the i -th component of an element $g = (g_1 \dots, g_{q+r})$ of Γ . Since Γ_{q+r} is nonelementary, it contains a two-generated Schottky group with only hyperbolic isometries. Let $h = (h_1 \dots, h_{q+r})$ and $\tilde{h} = (\tilde{h}_1 \dots, \tilde{h}_{q+r})$ be the two isometries in Γ such that h_{q+r} and \tilde{h}_{q+r} generate it.

By Theorem 4.3.5 in [1], if h_i and \tilde{h}_i have a common fixed point then their commutator has trace 2, i.e. it is either the identity or parabolic. Since no component of a mixed isometry has trace 2, the commutator of h and \tilde{h} can be only the identity or a parabolic isometry. Therefore the commutator of h_{q+r} and \tilde{h}_{q+r} has trace 2 which is impossible because they generate a free group with only hyperbolic isometries. Hence h_i and \tilde{h}_i do not have a common fixed point in $\partial\mathbb{H}^3$.

If both h_i and \tilde{h}_i are loxodromic, then by Lemma 1.1 we see that they generate a Schottky group and hence Γ_i is nonelementary.

If only one of them, let us say h_i , is loxodromic and the other one \tilde{h}_i is elliptic of infinite order, then there is a power k for which h_i and $\tilde{h}_i^k h_i \tilde{h}_i^{-k}$ do not have a common fixed point and thus some powers of them generate by Lemma 1.1 a Schottky group and hence Γ_i is nonelementary.

If both h_i and \tilde{h}_i are elliptic of infinite order and g_i is loxodromic and does not have common fixed points with at least one of h_i and \tilde{h}_i , we proceed as in the previous case in order to show that Γ_i is nonelementary. Otherwise g_i has one common fixed point with h_i and one with \tilde{h}_i . There is a power k

for which h_i and $\tilde{h}_i^k g_i \tilde{h}_i^{-k}$ do not have any common fixed point and we are in the previous case.

If g_i is parabolic, then after conjugation we can assume that it is $\begin{bmatrix} 1 & 1 \\ 0 & 1 \end{bmatrix}$.

For h_i we have the representation $\begin{bmatrix} a & b \\ c & d \end{bmatrix}$ with $a + d$ real with absolute value less than 2 and for \tilde{h}_i the representation $\begin{bmatrix} \tilde{a} & \tilde{b} \\ \tilde{c} & \tilde{d} \end{bmatrix}$ with $\tilde{a} + \tilde{d}$ real with absolute value less than 2. Since h_i and \tilde{h}_i do not have a common fixed point in $\partial\mathbb{H}^3$, they cannot both fix the point ∞ . Therefore without loss of generality we can assume that c is different from zero. Then

$$g_i^k h_i = \begin{bmatrix} 1 & k \\ 0 & 1 \end{bmatrix} \begin{bmatrix} a & b \\ c & d \end{bmatrix} = \begin{bmatrix} a + kc & b + kd \\ c & d \end{bmatrix}$$

is loxodromic for $k = 1$ if c is not real and hyperbolic for k big enough if c is real. Hence we found a loxodromic element in Γ_i and as in the previous case Γ_i is nonelementary. \square

3.3 The projective limit set is convex

Recall that the projective limit set P_Γ is the projection of L_Γ^{reg} on \mathbb{RP}_+^{q+r-1} . In this section we show that P_Γ is “nice”, i. e. convex.

Lemma 3.7. *Let Γ be a nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$. Then P_Γ is convex in the real projective space \mathbb{RP}^{q+r-1} with its standard metric and in particular P_Γ is path connected.*

Proof. The regular limit set \mathcal{L}_Γ^{reg} is not empty by Lemma 3.3.

Since \mathcal{L}_Γ^{reg} is not empty, P_Γ contains at least one point. We will show that if $(x_1 : \dots : x_{q+r})$ and $(y_1 : \dots : y_{q+r})$ are two different points in P_Γ then the segment $(x_1 + \lambda y_1 : \dots : x_{q+r} + \lambda y_{q+r})$ with $\lambda > 0$ is also contained in P_Γ .

First we consider the case where $(x_1 : \dots : x_{q+r}) = (\ell(g_1) : \dots : \ell(g_{q+r}))$ and $(y_1 : \dots : y_{q+r}) = (\ell(h_1) : \dots : \ell(h_{q+r}))$ for loxodromic transformations g, h in Γ .

By Lemma 3.1 we can assume that for all $i = 2, \dots, q + r$, the group generated by g_i and h_i is a Schottky group with only loxodromic isometries.

Next we proceed as Dal’Bo in the proof of Proposition 4.2 in [6] using Lemma 4.1 from [6]. The latter says that there exists $C > 0$ such that for all

$m, n \in \mathbb{N}$ and all $i = 1, \dots, q+r$,

$$|\ell(g_i^m h_i^n) - m\ell(g_i) - n\ell(h_i)| < C.$$

Hence

$$(\ell(g_1^{km} h_1^{kn}) : \dots : \ell(g_{q+r}^{km} h_{q+r}^{kn})) \xrightarrow{k \rightarrow \infty} (\ell(g_1) + \frac{n}{m}\ell(h_1) : \dots : \ell(g_{q+r}) + \frac{n}{m}\ell(h_{q+r}))$$

and so for each $\lambda > 0$, the point $(\ell(g_1) + \lambda\ell(h_1) : \dots : \ell(g_{q+r}) + \lambda\ell(h_{q+r}))$ is in the closure of the translation directions of the loxodromic isometries of Γ and hence in P_Γ .

In this way we found a path in P_Γ between $(\ell(g_1) : \dots : \ell(g_{q+r}))$ and $(\ell(h_1) : \dots : \ell(h_{q+r}))$.

Now we consider two arbitrary different points x and y in P_Γ . By Link's Theorem 2.2, the translation directions of the loxodromic isometries of Γ are dense in P_Γ . Therefore there are sequences $\{x^i\}$ and $\{y^i\}$ of translation directions of loxodromic isometries in Γ such that $x^i \xrightarrow{i \rightarrow \infty} x$ and $y^i \xrightarrow{i \rightarrow \infty} y$.

We consider the canonical projections of x^i, y^i, x and y in the hyperplane $\{(t_1, \dots, t_{q+r}) \in \mathbb{R}^r \mid t_1 + \dots + t_{q+r} = 1\}$ and denote them by $(x_1^i, \dots, x_{q+r}^i), (y_1^i, \dots, y_{q+r}^i), (x_1, \dots, x_{q+r})$ and (y_1, \dots, y_{q+r}) respectively. Then for all $j = 1, \dots, r$, $x_j^i \xrightarrow{i \rightarrow \infty} x_j$ and $y_j^i \xrightarrow{i \rightarrow \infty} y_j$. Therefore $x_j^i + \lambda y_j^i \xrightarrow{i \rightarrow \infty} x_j + \lambda y_j$ for $\lambda > 0$. Hence

$$(x_1^i + \lambda y_1^i : \dots : x_{q+r}^i + \lambda y_{q+r}^i) \xrightarrow{i \rightarrow \infty} (x_1 + \lambda y_1 : \dots : x_{q+r} + \lambda y_{q+r}), \quad \text{with } \lambda > 0.$$

As already shown above the points $(x_1^i + \lambda y_1^i : \dots : x_{q+r}^i + \lambda y_{q+r}^i)$ are in P_Γ . Hence the points $(x_1 + \lambda y_1 : \dots : x_{q+r} + \lambda y_{q+r})$ with $\lambda > 0$ are also in P_Γ , which is what we wanted to show. \square

Remark. This lemma is also true if we omit the condition for the mixed elements in Γ .

3.4 The limit cone and a theorem of Benoist

The limit cone of a nonelementary group $\Gamma \leq \text{PSL}(2, \mathbb{C})^q \times \text{PSL}(2, \mathbb{R})^r$ with $q+r \geq 2$ is closely related to the projective limit set of Γ .

In this section we first define the limit cone as defined by Benoist in [2] and then show that the limit cone of a nonelementary Γ is the closure of P_Γ in \mathbb{RP}^{q+r-1} and hence convex. We give also a version of the theorem in

Section 1.2 in [2] which motivated the previous result and is used later in the thesis.

The limit cone of Γ is defined via the complete multiplicative Jordan decomposition of the elements of Γ . The multiplicative Jordan decomposition can be found for example in the the book of Eberlein [8].

Each element $g \in \mathrm{SL}(2, \mathbb{C})^q \times \mathrm{SL}(2, \mathbb{R})^r$ can be decomposed in a unique way into $g = e_g h_g u_g$ where e_g is elliptic (all eigenvalues have modulus 1), h_g is hyperbolic (all eigenvalues are real positive), u_g is unipotent (in our case parabolic) and all three commute. The canonical projection of $\mathrm{SL}(2, \mathbb{C})$ into $\mathrm{PSL}(2, \mathbb{C})$ gives the Jordan decomposition for $g \in \mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$.

For instance, if $g \in \mathrm{PSL}(2, \mathbb{C})$ is loxodromic, i.e. one of its representatives is conjugate to $\begin{bmatrix} e^{x+i\phi} & 0 \\ 0 & e^{-x-i\phi} \end{bmatrix}$ with $x, \phi \in \mathbb{R}$ then e_g is conjugate to $\begin{bmatrix} e^{i\phi} & 0 \\ 0 & e^{-i\phi} \end{bmatrix}$ and h_g is conjugate to $\begin{bmatrix} e^x & 0 \\ 0 & e^{-x} \end{bmatrix}$. We have $x = \ell(g)/2$, where $\ell(g)$ is the translation length of g .

With $\lambda(g)$ we denote the unique element in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ that is conjugate to h_g and has diagonal form $\left(\begin{bmatrix} e^{x_1} & 0 \\ 0 & e^{-x_1} \end{bmatrix}, \dots, \begin{bmatrix} e^{x_{q+r}} & 0 \\ 0 & e^{-x_{q+r}} \end{bmatrix} \right)$ with $x_i \geq 0$, $i = 1, \dots, r$. Then the *limit cone* of Γ is the smallest closed cone in the space of diagonal elements in $\mathfrak{sl}(2, \mathbb{C})^q \times \mathfrak{sl}(2, \mathbb{R})^r$ that contains $\log(\lambda(\Gamma))$. E.g. if

$$\lambda(g) = \left(\begin{bmatrix} e^{x_1} & 0 \\ 0 & e^{-x_1} \end{bmatrix}, \dots, \begin{bmatrix} e^{x_{q+r}} & 0 \\ 0 & e^{-x_{q+r}} \end{bmatrix} \right)$$

with $x_1, \dots, x_{q+r} \in \mathbb{R}_{\geq 0}$, then

$$\log(\lambda(g)) = \left(\begin{bmatrix} x_1 & 0 \\ 0 & -x_1 \end{bmatrix}, \dots, \begin{bmatrix} x_{q+r} & 0 \\ 0 & -x_{q+r} \end{bmatrix} \right)$$

and the limit cone contains the line

$$\left(\begin{bmatrix} tx_1 & 0 \\ 0 & -tx_1 \end{bmatrix}, \dots, \begin{bmatrix} tx_{q+r} & 0 \\ 0 & -tx_{q+r} \end{bmatrix} \right), \quad t \in \mathbb{R}.$$

The translation direction of the isometry g given above is $L(g) = (2x_1 : \dots : 2x_{q+r})$. Hence the closure in \mathbb{RP}^{q+r-1} of the translation directions of the hyperbolic and mixed elements of Γ can be identified canonically with the limit cone of Γ .

The interior of the limit cone of Γ is the intersection of the limit cone of Γ with \mathbb{RP}_+^{q+r-1} . Hence it is exactly the projective limit set P_Γ of Γ . In [2] Benoist shows that for Zariski dense groups Γ , the limit cone of Γ is convex and has nonempty interior. This means that the limit cone of Γ is the closure of its interior. Thus for Zariski dense Γ , the limit cone of Γ and $\overline{P_\Gamma}$ are the same. As the next theorem shows, the same is true even if Γ is just nonelementary.

Theorem 3.8. *Let Γ be a nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$. Then P_Γ is convex and the closure of P_Γ in \mathbb{RP}^{q+r-1} is equal to the limit cone of Γ and in particular the limit cone of Γ is convex.*

Proof. By Lemma 3.3, \mathcal{L}_Γ^{reg} is nonempty. We will show that the translation direction of every mixed isometry is the limit point of a sequence of translation directions of loxodromic isometries in Γ . From this it follows that the limit cone of Γ is the closure of P_Γ in \mathbb{RP}^{q+r-1} and since by Lemma 3.7, the projective limit set P_Γ is convex, its closure in the convex set \mathbb{RP}^{q+r-1} is also convex.

Let $h = (h_1, \dots, h_{q+r})$ be a loxodromic and $g = (g_1, \dots, g_{q+r})$ be a mixed isometry in Γ . Without loss of generality we can assume that for $i = 1, \dots, m-1$, the isometries g_i are loxodromic and for $i = m, \dots, q+r$, the isometries g_i are elliptic of infinite order. By Lemma 3.1, we can further assume that for $j = 1, \dots, m-1$, h_j and g_j generate a Schottky group with only loxodromic transformations.

Since g_m is elliptic of infinite order, there is a sequence $\{n_k\}_{k \in \mathbb{N}}$ such that $g_m^{n_k}$ converges to the identity when k goes to infinity. Therefore the trace of $h_m g_m^{n_k}$ converges to the trace of h_m . The trace of h_m is greater than 2 because h_m is loxodromic. Hence for all k greater than some integer N_1 , $\mathrm{tr}(h_m g_m^{n_k}) > 2$ and thus $h_m g_m^{n_k}$ is a loxodromic isometry.

We can find a subsequence $\{n_{k_j}\}_{j \in \mathbb{N}}$ of $\{n_k\}_{k \in \mathbb{N}}$ such that for all $i > m$, the isometries $g_i^{n_{k_j}}$ converge to an isometry \tilde{g}_i in $\mathrm{PSL}(2, \mathbb{C})$ or $\mathrm{PSL}(2, \mathbb{R})$ because g_i are elliptic of infinite order. So without loss of generality we can assume that $g_i^{n_k}$ converge to an isometry \tilde{g}_i in $\mathrm{PSL}(2, \mathbb{C})$ or $\mathrm{PSL}(2, \mathbb{R})$.

According to Dal'bo [6], Lemma 4.1, there exists a constant $C > 0$ such that for all n_k and all $i = 1, \dots, m-1$,

$$|\ell(h_i g_i^{n_k}) - \ell(h_i) - n_k \ell(g_i)| < C.$$

Hence $\frac{\ell(h_i g_i^{n_k})}{n_k \ell(g_i)} \xrightarrow{k \rightarrow \infty} 1$. Therefore $(\ell(h_1 g_1^{n_k}) : \dots : \ell(h_{m-1} g_{m-1}^{n_k}))$ converges to $(\ell(g_1) : \dots : \ell(g_{m-1}))$ when k goes to infinity and additionally, for $i =$

$1, \dots, m-1$, the translation length $\ell(h_i g_i^{n_k})$ converges to ∞ when k goes to infinity.

On the other hand, the sequence $\{(h_m g_m^{n_k}, h_{m+1} g_{m+1}^{n_k}, \dots, h_{q+r} g_{q+r}^{n_k})\}_{k \in \mathbb{N}}$ converges to $(h_m, h_{m+1} \tilde{g}_{m+1}, \dots, h_{q+r} \tilde{g}_{q+r})$ when k goes to infinity. This means that for $i = m, \dots, r$, $\ell(h_i g_i^{n_k})$ remains bounded. Therefore $(\ell(h_1 g_1^{n_k}) : \dots : \ell(h_{q+r} g_{q+r}^{n_k}))$ converges to $L(g) = (\ell(g_1) : \dots : \ell(g_{m-1}) : 0 \dots : 0)$ when k goes to infinity. Hence we found a sequence of isometries whose translation directions converge to $L(g)$ and who have, compared to g , at least one more component that is loxodromic. By repeating the argument for the elements of this sequence, we can find a new sequence of isometries whose translation directions converge to $L(g)$ and who have, compared to g , at least two more components that are loxodromic. This process stops since g has only finitely many components and the resulting sequence consists of loxodromic isometries whose translation directions converge to $L(g)$. Thus $L(g)$ is in the closure of P_Γ in \mathbb{RP}^{q+r-1} . \square

This theorem extends partially the following special case of Benoist's theorem in Section 1.2 in [2].

Theorem 3.9 ([2]). *If Γ is a Zariski dense over \mathbb{R} subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$, $q + r \geq 2$, then the limit cone of Γ is convex and its interior is not empty.*

Remark. Since the limit cone of Γ is identified with $\overline{P_\Gamma}$, the interior of P_Γ is also not empty. This is not always true for nonelementary groups Γ that are not Zariski dense.

4 Irreducible arithmetic groups

A special case of a general result of Margulis is that the irreducible lattices in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ are all arithmetic. We present a construction of the irreducible arithmetic subgroups of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with the help of quaternion algebras. This construction gives a natural connection between some subgroups of $\mathrm{PSL}(2, \mathbb{R})$ or $\mathrm{PSL}(2, \mathbb{C})$ and irreducible arithmetic subgroups of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$.

4.1 Quaternion algebras

For more details concerning the definitions, notations and theorems in this section we refer to Katok's book [10], Chapter 5, and the book of Reid and Maclachlan [16], Chapters 0, 3 and 8. In this section K will always denote a field.

A *central simple algebra* A over K is an algebra over K , which is finite dimensional as a vector space over K , such that

- as a ring, A has an identity element,
- the center of A , which is the set $\{a \in A \mid ax = xa, \forall x \in A\}$, equals K ,
- A is simple, i.e. A has no nontrivial two-sided ideals.

A *quaternion algebra over K* is a central simple algebra over K which is four dimensional as a vector space over K .

Each quaternion algebra is isomorphic to an algebra $A = \left(\frac{a,b}{K}\right)$ with $a, b \in K^* = K \setminus \{0\}$ and a basis $\{1, i, j, k\}$, where $i^2 = a$, $j^2 = b$, $k = ij = -ji$.

We denote by $M(2, F)$ the 2×2 matrices with coefficients in the field F .

An isomorphism between $A = \left(\frac{a,b}{K}\right)$ and $M(2, K(\sqrt{a}))$ is given by the linear map sending the elements of the basis of A to the following matrices:

$$1 \mapsto \begin{bmatrix} 1 & 0 \\ 0 & 1 \end{bmatrix}, \quad i \mapsto \begin{bmatrix} \sqrt{a} & 0 \\ 0 & -\sqrt{a} \end{bmatrix}, \quad j \mapsto \begin{bmatrix} 0 & 1 \\ b & 0 \end{bmatrix}, \quad k \mapsto \begin{bmatrix} 0 & \sqrt{a} \\ -b\sqrt{a} & 0 \end{bmatrix}.$$

Thus if at least one of a and b is positive, then $\left(\frac{a,b}{\mathbb{R}}\right)$ is isomorphic to the matrix algebra $M(2, \mathbb{R})$. If both a and b are negative, then $\left(\frac{a,b}{\mathbb{R}}\right)$ is isomorphic to the Hamilton quaternion algebra $\mathbf{H} = \left(\frac{-1,-1}{\mathbb{R}}\right)$.

If K is an algebraic number field it can be written as $\mathbb{Q}(t)$, where t is a root of a polynomial with rational coefficients and $\mathbb{Q}(t)$ is the smallest field

containing \mathbb{Q} and t . Let $f \in \mathbb{Q}[x]$ be the minimal polynomial of t . If n is the dimension of K considered as a vector space over \mathbb{Q} , then f has degree n .

Let $t_1 = t, t_2, \dots, t_n$ denote the roots of f , then the substitution $t \rightarrow t_i$ induces a field isomorphism $\mathbb{Q}(t) \rightarrow \mathbb{Q}(t_i)$. Conversely, if $\sigma : K = \mathbb{Q}(t) \rightarrow \mathbb{C}$ is a field *embedding*, i.e. $\sigma : K \rightarrow \sigma(K)$ is a field isomorphism, then $\sigma(t)$ is a root of the minimal polynomial of t . Therefore, there are exactly n field embeddings $\sigma : K \rightarrow \mathbb{C}$.

K is a *totally real algebraic number field* if for each embedding of K into \mathbb{C} the image lies inside \mathbb{R} .

Let $A = \left(\frac{a,b}{K}\right)$ be a quaternion algebra. For every $x \in A$, $x = x_0 + x_1i + x_2j + x_3k$, we define the *reduced norm* of x to be

$$\text{Nrd}(x) = x\bar{x} = x_0^2 - x_1^2a - x_2^2b + x_3^2ab,$$

where $\bar{x} = x_0 - x_1i - x_2j - x_3k$.

An element of K is an *algebraic integer* if it satisfies a polynomial with coefficients in K and leading coefficient 1. The algebraic integers of K form a ring and we denote it by \mathcal{O}_K .

An *order* \mathcal{O} in a quaternion algebra A over K is a subring of A containing 1, which is a finitely generated \mathcal{O}_K -module and generates the algebra A over K .

The *group of units* in \mathcal{O} of reduced norm 1 is $\mathcal{O}^1 = \{\varepsilon \in \mathcal{O} \mid \text{Nrd}(\varepsilon) = 1\}$.

We recall that a subgroup of $\text{SL}(2, \mathbb{C})$ is nonelementary if it does not have a finite orbit in its action on $\mathbb{H}^3 \cup \hat{\mathbb{C}}$.

Let Γ be a finitely generated nonelementary subgroup of $\text{SL}(2, \mathbb{C})$. Then the subgroup $\Gamma^{(2)}$ of Γ generated by the set $\{g^2 \mid g \in \Gamma\}$ is a finite index normal subgroup of Γ .

Now we show how we can construct a quaternion algebra and an order starting from a finitely generated nonelementary subgroup of $\text{SL}(2, \mathbb{C})$.

Let Γ be a nonelementary subgroup of $\text{SL}(2, \mathbb{C})$. We denote

$$A\Gamma := \left\{ \sum a_i g_i \mid a_i \in \mathbb{Q}(\text{Tr}(\Gamma)), g_i \in \Gamma \right\}$$

where only finitely many of the a_i are non-zero. By Theorem 3.2.1 from [16], $A\Gamma$ is a quaternion algebra over $\mathbb{Q}(\text{Tr}(\Gamma))$.

Two groups are *commensurable* if their intersection has finite index in both of them. The *commensurability class* of a subgroup Γ of a group G is the set of all subgroups of G that are commensurable with Γ . The following theorem is Corollary 3.3.5 from [16].

Theorem 4.1 ([16]). *Let Γ be a finitely generated nonelementary subgroup of $\mathrm{SL}(2, \mathbb{C})$. The quaternion algebra $A\Gamma^{(2)}$ is an invariant of the commensurability class of Γ .*

The second theorem is Exercise 3.2, No. 1, in [16] and a proof of it can be found in the proof of Theorem 8.3.2 in [16].

Theorem 4.2 ([16]). *Let Γ be a finitely generated nonelementary subgroup of $\mathrm{SL}(2, \mathbb{C})$ such that all traces in Γ are algebraic integers. Let also*

$$\mathcal{O}\Gamma := \left\{ \sum a_i g_i \mid a_i \in \mathcal{O}_{\mathbb{Q}(\mathrm{Tr}(\Gamma))}, g_i \in \Gamma \right\}$$

where only finitely many of the a_i are non-zero. Then $\mathcal{O}\Gamma$ is an order in $A\Gamma$.

4.2 Irreducible arithmetic groups in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$

In this section, following Schmutz and Wolfart [21] and Borel [3], we will describe the irreducible arithmetic subgroups of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$.

Let K be an algebraic number field of degree $n = [K : \mathbb{Q}]$ and let ϕ_i , $i \in \{1, \dots, n\}$, be the n distinct embeddings of K into \mathbb{C} , where $\phi_1 = \mathrm{id}$. Further, we assume that K has q complex places. This means that K has $2q$ different embeddings into \mathbb{C} that can be divided into q pairs of complex conjugated embeddings.

If K is not a subfield of \mathbb{R} , then for $i = 1, \dots, q$, let ϕ_i denote one of the embeddings in the pair and we assume that $\phi_1 = \mathrm{id}$. Let ϕ_i , $i = q+1, \dots, n-q$, be the remaining embeddings of K into \mathbb{C} that are actually embeddings into \mathbb{R} .

Let $A = \left(\frac{a,b}{K}\right)$ be a quaternion algebra over K such that for $q+1 \leq i \leq q+r$, the quaternion algebra $\left(\frac{\phi_i(a), \phi_i(b)}{\mathbb{R}}\right)$ is *unramified*, i.e. isomorphic to the matrix algebra $M(2, \mathbb{R})$, and for $q+r < i \leq n-q$, it is *ramified*, i.e. isomorphic to the Hamilton quaternion algebra \mathbf{H} . In other words, the embeddings

$$\phi_i : K \longrightarrow \mathbb{R}, \quad i = q+1, \dots, q+r$$

extend to embeddings of A into $M(2, \mathbb{R})$ and the embeddings

$$\phi_i : K \longrightarrow \mathbb{R}, \quad i = q+r+1, \dots, n$$

extend to embeddings of A into \mathbf{H} . The embeddings

$$\phi_i : K \longrightarrow \mathbb{C}, \quad i = 1, \dots, q$$

extend to embeddings of A into $M(2, \mathbb{C})$. Note that the embeddings ϕ_i , $i = 1, \dots, q + r$, of A into the matrix algebras $M(2, \mathbb{C})$ and $M(2, \mathbb{R})$ are not canonical. As we will see later, they are canonical up to conjugation and complex conjugation.

In the case when K is a subfield of \mathbb{R} , the definition is analogous. We start with a number r , $1 \leq r \leq n - 2q$, and a quaternion algebra $A = \left(\frac{a, b}{K}\right)$ over K such that for $1 \leq i \leq r$, the embeddings ϕ_i are embeddings of K into \mathbb{R} and the quaternion algebra $\left(\frac{\phi_i(a), \phi_i(b)}{\mathbb{R}}\right)$ is unramified. Each of the embeddings ϕ_i , $i = r + 1, \dots, q + r$, is a representative of a different pair of complex conjugated embeddings. Finally, for $q + r < i \leq n - q$, the quaternion algebra $\left(\frac{\phi_i(a), \phi_i(b)}{\mathbb{R}}\right)$ is *ramified*.

This case is interesting only when K is a totally real algebraic number field because otherwise we can start with $\phi_i(K)$ that is not a subfield of the reals and consider the quaternion algebra $\left(\frac{\phi_i(a), \phi_i(b)}{\mathbb{R}}\right)$. So for simplicity of the notation we will assume that $\phi_1(K), \dots, \phi_q(K)$ are not subfields of \mathbb{R} and $\phi_{q+1}(K), \dots, \phi_{q+r}(K)$ are subfields of \mathbb{R} and q or r can be 0.

Let \mathcal{O} be an order in A and \mathcal{O}^\times the group of units in \mathcal{O} . Define $\Gamma(A, \mathcal{O}) := \phi_1(\mathcal{O}^\times) \subset \mathrm{SL}(2, \mathbb{C})$. If $q = 0$, then $\Gamma(A, \mathcal{O})$ is a subset of $\mathrm{SL}(2, \mathbb{R})$. The canonical image of $\Gamma(A, \mathcal{O})$ in $\mathrm{PSL}(2, \mathbb{C})$ is called a group *derived from a quaternion algebra*. The group $\Gamma(A, \mathcal{O})$ acts by isometries on $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ as follows. An element $g = \phi_1(\varepsilon)$ of $\Gamma(A, \mathcal{O})$ acts via

$$g : (z_1, \dots, z_{q+r}) \mapsto (\phi_1(\varepsilon)z_1, \dots, \phi_{q+r}(\varepsilon)z_{q+r}),$$

where $z_i \mapsto \phi_i(\varepsilon)z_i$ is the usual action given by linear fractional transformation, $i = 1, \dots, q + r$.

For a subgroup S of $\Gamma(A, \mathcal{O})$ we denote by S^* the group

$$\{g^* := (\phi_1(\varepsilon), \dots, \phi_{q+r}(\varepsilon)) \mid \phi_1(\varepsilon) = g \in S\}.$$

Instead of $(\phi_1(\varepsilon), \dots, \phi_{q+r}(\varepsilon))$, we will usually write $(\phi_1(g), \dots, \phi_{q+r}(g))$ or even $(g, \phi_2(g), \dots, \phi_{q+r}(g))$, since ϕ_1 is the identity. The isometries $\phi_1(g), \dots, \phi_{q+r}(g)$ are called *ϕ -conjugates*.

Note that g^* and S^* depend on the chosen embeddings ϕ_i of A into $M(2, \mathbb{C})$ and $M(2, \mathbb{R})$. On the other hand, the type of g^* is determined uniquely by the type of g . This is given by the following lemma.

Lemma 4.3. *Let S be a subgroup of $\Gamma(A, \mathcal{O})$ and S^* be defined as above. For an element $g \in S$ the following assertions are true.*

1. If g is the identity, then g^* is the identity.
2. If g is parabolic, then g^* is parabolic.
3. If g is elliptic of finite order, then g^* is elliptic of the same order.
4. If g is loxodromic, then g^* is either loxodromic or mixed such that, for $i = 1, \dots, r$, $\phi_i(g)$ is either loxodromic or elliptic of infinite order.
5. If g is elliptic of infinite order, then its ϕ -conjugates are loxodromic or elliptic of infinite order.

Proof. If g is the identity, then g^* is the identity too, because each ϕ_i is an isomorphism between A and $\phi_i(A)$.

If g is parabolic, i.e. $\text{tr}(g) = 2$, then g^* is parabolic, because $\phi_i|_{\mathbb{Q}} = \text{id}$ and ϕ_i has a trivial kernel.

If g is elliptic of finite order, then g^* is elliptic of the same order. The trace of an elliptic transformation g of order m is equal to $2 \cos(2\pi k/m)$ where $k, m \in \mathbb{N}$ are relatively prime and $k < m$. By [12], all ϕ -conjugates of g have a trace of the same kind and thus are elliptic of order m .

If g is loxodromic, then g^* is either loxodromic or mixed such that, for $i = 1, \dots, r$, $\phi_i(g)$ is either loxodromic or elliptic of infinite order. This is a consequence of the fact that the isometries of \mathbb{H}^3 (and \mathbb{H}^2) can be only loxodromic, elliptic of infinite order, elliptic of finite order, parabolic or the identity and the last three types of isometries are preserved under ϕ -conjugation. Two examples show the two remaining possibilities. First, if $\text{tr}(g) = 3 + \sqrt{5} > 2$, i.e. g is hyperbolic, then its ϕ -conjugate with trace $3 - \sqrt{5} < 2$ is elliptic of infinite order. The second example is with $\text{tr}(g) = 6 + \sqrt{5}$ and its ϕ -conjugate with trace $6 - \sqrt{5}$ are both hyperbolic. Note that if g is hyperbolic, it could still have a ϕ -conjugate that is purely loxodromic.

If g is elliptic of infinite order, then its ϕ -conjugates are loxodromic or elliptic of infinite order but at least one of them is loxodromic, because otherwise S^* will not be discrete. \square

Hence the mixed isometries in this setting have components that are only loxodromic or elliptic of infinite order. This justifies the condition in our definition of nonelementary that the projections of all mixed isometries can be only loxodromic or elliptic of infinite order.

By Borel [3], Section 3.3, all *irreducible arithmetic subgroups* of the group $\text{PSL}(2, \mathbb{C})^q \times \text{PSL}(2, \mathbb{R})^r$ are commensurable to a $\Gamma(A, \mathcal{O})^*$. They have finite covolume. By Margulis, for $q + r \geq 2$, all irreducible discrete subgroups of

$\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ of finite covolume are arithmetic, which shows the importance of the above construction.

We will mainly consider subgroups of irreducible arithmetic groups.

P. Schmutz and J. Wolfart define in [21] arithmetic groups acting on $(\mathbb{H}^2)^r$. Here we extend the definition for $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$. An *arithmetic group acting on* $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ is a group G that is commensurable to a $\Gamma(A, \mathcal{O})$. It is finitely generated because it is commensurable to the finitely generated group $\Gamma(A, \mathcal{O})$. Then by Theorem 4.1, the quaternion algebra $AG^{(2)}$ of the group $G^{(2)}$ generated by the set $\{g^2 \mid g \in G\}$ is an invariant of the commensurability class of G . Hence $AG^{(2)}$ is isomorphic to A . By Theorem 4.2, $\mathcal{O}G^{(2)}$ is an order in $AG^{(2)}$. Therefore $G^{(2)}$ is a subgroup of $\Gamma(AG^{(2)}, \mathcal{O}G^{(2)})$ and we can define $(G^{(2)})^*$. This explains “acting on $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ ” in the name.

The interest of this approach is that it allows us to consider a subgroup S of $G \subset \mathrm{PSL}(2, \mathbb{C})$ and then the corresponding subgroups $S^{(2)*}$ and $G^{(2)*}$ of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$. In this case q and r are determined by the bigger group G .

4.3 Arithmetic Fuchsian groups

In the case of $r = 1$, the arithmetic subgroups of $\mathrm{PSL}(2, \mathbb{R})$ are *arithmetic Fuchsian group*. Since subgroups of arithmetic groups are sometimes also called arithmetic, we will emphasize the cofiniteness of an arithmetic Fuchsian group by calling it a cofinite arithmetic Fuchsian group. If $r = 1$ then a subgroup of finite index of $\Gamma(A, \mathcal{O})$ and its canonical image in $\mathrm{PSL}(2, \mathbb{R})$ are called *Fuchsian groups derived from a quaternion algebra*.

The following characterization of cofinite arithmetic Fuchsian groups is due to Takeuchi [24].

Theorem 4.4 ([24]). *Let Γ be a cofinite Fuchsian group. Let $\Gamma^{(2)}$ be the subgroup of Γ generated by the set $\{g^2 \mid g \in \Gamma\}$. Then Γ is arithmetic if and only if the following two conditions are satisfied:*

(i) $K := \mathbb{Q}(\mathrm{Tr}(\Gamma^{(2)}))$ is an algebraic number field of finite degree and $\mathrm{Tr}(\Gamma^{(2)})$ is contained in the ring of integers \mathcal{O}_K of K .

(ii) For any embedding φ of K into \mathbb{C} which is not the identity, $\varphi(\mathrm{Tr}(\Gamma^{(2)}))$ is bounded in \mathbb{C} .

Remark. In [24], Takeuchi shows that K is a totally real algebraic number field and the cofinite Fuchsian group $\Gamma^{(2)}$ satisfying (i) and (ii) is derived

from a quaternion algebra over K . And since $\Gamma^{(2)}$ is of finite index in Γ , Γ is arithmetic. Thus Γ is arithmetic if and only if $\Gamma^{(2)}$ is derived from a quaternion algebra.

The above characterization motivated the following definition of semi-arithmetic Fuchsian groups given in [21].

A cofinite Fuchsian group Γ is *semi-arithmetic* if and only if $K := \mathbb{Q}(\text{Tr}(\Gamma^{(2)}))$ is a totally real algebraic number field of finite degree $n = [K : \mathbb{Q}]$ and $\text{Tr}(\Gamma^{(2)})$ is contained in the ring of integers \mathcal{O}_K of K . Γ is called *strictly semi-arithmetic* if Γ is not an arithmetic Fuchsian group.

The following theorem is a characterization of semi-arithmetic Fuchsian groups due to Schmutz Schaller and Wolfart [21].

Theorem 4.5 ([21]). *Let Γ be a cofinite Fuchsian group. Then the following two conditions are equivalent.*

- (i) Γ is semi-arithmetic.
- (ii) Γ is commensurable to a subgroup S of an arithmetic group Δ acting on $(\mathbb{H}^2)^r$.

The initial motivation for the thesis was the question whether it was possible to characterize the arithmetic Fuchsian groups among the semi-arithmetic ones with the help of their trace set.

4.4 Arithmetic Kleinian groups

In the case of $q = 1$ and $r = 0$, we call a group commensurable to $\Gamma(A, \mathcal{O})$ an *arithmetic Kleinian group*. If an arithmetic Kleinian group is additionally a subgroup of finite index of $\Gamma(A, \mathcal{O})$ then it is called *Kleinian group derived from a quaternion algebra*.

The following characterization of cofinite arithmetic Kleinian groups is Theorem 8.3.2 in the book of Maclachlan and Reid [16].

Theorem 4.6 ([16]). *Let Γ be a cofinite Kleinian group. Then Γ is arithmetic if and only if the following three conditions hold.*

- (i) $\mathbb{Q}(\text{Tr}(\Gamma^{(2)}))$ is an algebraic number field with exactly one complex place.
- (ii) $\text{tr}(g)$ is an algebraic integer for all $g \in \Gamma$.
- (iii) $A\Gamma^{(2)}$ is ramified at all real places of $\mathbb{Q}(\text{Tr}(\Gamma^{(2)}))$.

Corollary 8.3.5 in [16] gives additionally that Γ is arithmetic if and only if $\Gamma^{(2)}$ is derived from a quaternion algebra.

This characterization is very similar to Takeuchi's Theorem 4.4. We can see it from the following formulation, which uses Lemma 5.1.3 from [16].

Theorem 4.7 ([16]). *Let Γ be a cofinite Kleinian group. Then Γ is arithmetic if and only if the following two conditions hold.*

(i) *$K = \mathbb{Q}(\mathrm{Tr}(\Gamma^{(2)}))$ is an algebraic number field and $\mathrm{Tr}(\Gamma^{(2)})$ is contained in the ring of integers \mathcal{O}_K of K .*

(ii) *For any embedding φ of K into \mathbb{C} which is neither the identity nor the complex conjugation, $\varphi(\mathrm{Tr}(\Gamma^{(2)}))$ is bounded in \mathbb{C} .*

5 Small limit sets of subgroups of arithmetic groups in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$

A way to measure the size of a group is by the size of its limit set. It is still an open question how exactly to measure the size of the limit set. In our case we can say that a nonelementary group is small if its projective limit set is the smallest possible nonempty one, i.e. it is just a point, or if its Furstenberg boundary is measure 0 and even just a circle.

This chapter contains the main results of this thesis. We study the limit sets of subgroups Γ of arithmetic groups in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$ and determine for which groups the limit sets are the smallest.

First, we will look at the projective limit set of a nonelementary Γ and prove that it consists of exactly one point if and only if $p_j(\Gamma)$ is a subgroup of an arithmetic Fuchsian or Kleinian group for one $j \in \{1, \dots, q + r\}$.

Then we will show that the groups Γ for which $p_j(\Gamma)$ is a subgroup of an arithmetic Fuchsian or Kleinian group are conjugate to an (almost) diagonal embedding of a Fuchsian or Kleinian arithmetic group and in particular that their limit set can be embedded as a topological space in a circle. This is not the case for the other groups.

5.1 Examples: Triangle groups and Hilbert modular groups

A family of examples of nonelementary subgroups of arithmetic groups in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ that are not Schottky groups is provided by the triangle Fuchsian groups. A *Fuchsian triangle group of type (l, m, n)* is a cofinite Fuchsian group generated by elliptic or parabolic elements g, h and s such that $ghs = id$, $g^l = id$, $h^m = id$ and $s^n = id$, where $1/l + 1/m + 1/n < 1$.

For a more geometric definition we consider the group S_0 of reflections on the sides of a hyperbolic triangle with angles π/l , π/m and π/n . Then the subgroup S of S_0 of orientation preserving isometries is a Fuchsian triangle group of type (l, m, n) .

By Proposition 2 in Takeuchi [25], the trace set $\mathrm{Tr}(S)$ is contained in the ring $\mathbb{Z}[2 \cos(\pi/l), 2 \cos(\pi/m), 2 \cos(\pi/n)]$, where $\pi/\infty = 0$. In particular, the field $\mathbb{Q}(\mathrm{Tr}(S))$ coincides with the totally real algebraic number field $\mathbb{Q}(\cos(\pi/l), \cos(\pi/m), \cos(\pi/n))$ and $\mathrm{Tr}(S)$ is contained in the ring of integers of $\mathbb{Q}(\mathrm{Tr}(S))$. Hence S is a semi-arithmetic group. By Takeuchi [25],

only finitely many conjugacy classes of arithmetic triangle groups.

By Theorem 4.5, S is commensurable to a subgroup of an arithmetic group in $\mathrm{PSL}(2, \mathbb{R})^r$.

Examples of arithmetic subgroups Δ of $\mathrm{PSL}(2, \mathbb{R})^r$ are the Hilbert modular groups. Let F be a totally real number field and ϕ_i , $i = 1, \dots, r$, be the r distinct embeddings of F into \mathbb{R} . For $g \in \mathrm{PSL}(2, \mathcal{O}_F)$, $g = \begin{bmatrix} a & b \\ c & d \end{bmatrix}$, we define $\phi_i(g) = \begin{bmatrix} \phi_i(a) & \phi_i(b) \\ \phi_i(c) & \phi_i(d) \end{bmatrix}$. The group $\mathrm{PSL}(2, \mathcal{O}_F)^*$ is an irreducible arithmetic subgroup of $\mathrm{PSL}(2, \mathbb{R})^r$ and is called a *Hilbert modular group* over F . Its quaternion algebra is isomorphic to $(\frac{1,1}{F})$.

The Hilbert modular groups are the only arithmetic groups acting on $(\mathbb{H}^2)^r$ that contain parabolic isometries. Note that $\mathrm{PSL}(2, \mathbb{Z})$ is a subgroup of any Hilbert modular group.

A *Hecke group* is a triangle group of type $(2, m, \infty)$. The Hecke groups are strictly semi-arithmetic except for $m = 3, 4, 6$.

A Hecke group S of type $(2, m, \infty)$ is generated (in $\mathrm{PSL}(2, \mathbb{R})$) by $g = \begin{bmatrix} 0 & 1 \\ -1 & 0 \end{bmatrix}$ and $g = \begin{bmatrix} 1 & 2 \cos(\pi/m) \\ 0 & 1 \end{bmatrix}$, see Katok [10]. Hence all elements in S have entries that are algebraic integers in $\mathbb{Q}(\cos(\pi/m))$. Therefore S is a subgroup of $\mathrm{PSL}(2, \mathcal{O}_F)$ where F is a field which is a finite extension of $\mathbb{Q}(\cos(\pi/m))$. Hence $\mathrm{PSL}(2, \mathcal{O}_F)^*$ has a subgroup Γ such that $p_1(\Gamma) = S$.

5.2 Arithmetic Fuchsian and Kleinian groups as subgroups of arithmetic groups in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$

Let Γ be a subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$. In this section we show that if $p_j(\Gamma)$ is a subgroup of an arithmetic Fuchsian or Kleinian group for some $j \in \{1, \dots, q+r\}$ then the same is true for each nonelementary projection $p_i(\Gamma)$, $i = 1, \dots, q+r$.

Lemma 5.1. *Let Δ be an irreducible arithmetic subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ and Γ a subgroup of Δ such that $p_j(\Gamma)$ is a cofinite arithmetic Fuchsian (or Kleinian) group for some $j \in \{1, \dots, q+r\}$. Then, for all $i = 1, \dots, q+r$, the group $p_i(\Gamma)$ is either elementary or a cofinite arithmetic Fuchsian (or Kleinian) group.*

Proof. Since Δ is arithmetic, it is commensurable to an arithmetic group derived from a quaternion algebra $\Gamma(A, \mathcal{O})^*$. Hence for each $g = (g_1, \dots, g_r)$ in Δ there is a power k such that g^k is in $\Gamma(A, \mathcal{O})^*$.

The group Γ is commensurable to the subgroup $S^* = \Gamma \cap \Gamma(A, \mathcal{O})^*$ of $\Gamma(A, \mathcal{O})^*$. Then for all $i = 1, \dots, q+r$, the groups $p_i(\Gamma)$ and $\phi_i(S)$ are also commensurable. This in particular implies that $\phi_j(S)$ is a cofinite arithmetic Fuchsian (or Kleinian) group.

$\phi_j(S)^{(2)}$ is defined via a quaternion algebra B over a field k that is a subalgebra of A and is ramified at all infinite places except one. This place is real if $\phi_j(S)$ is a cofinite Fuchsian and complex if $\phi_j(S)$ is a cofinite Kleinian group. The group $\phi_j(S)^{(2)}$ is isomorphic to the group of units of reduced norm 1 of an order \mathcal{O}_B in B .

For $i = 1, \dots, q+r$, if $\phi_i(S)$ is nonelementary, then B is unramified for the Galois' isomorphism $\tau_i := \phi_i \circ \phi_j^{-1}$ and hence $\tau_i|_k$ is the identity. Therefore $\phi_i(S)^{(2)} = \tau_i(\phi_j(S))^{(2)}$ is also isomorphic to the group of units of reduced norm 1 of \mathcal{O}_B and hence $\phi_i(S)$ and $p_i(\Gamma)$ are cofinite arithmetic Fuchsian (or Kleinian) groups.

It remains to show that $\phi_i(S)$ is nonelementary if and only if $p_i(\Gamma)$ is nonelementary: Assume that $p_i(\Gamma)$ is nonelementary. Let g and h be two hyperbolic isometries that generate a Schottky group in $p_i(\Gamma)$. The isometries g^{k_1} and h^{k_2} are in $\phi_i(S)$ for some integers k_1 and k_2 . Then g^{k_1} and h^{k_2} generate a Schottky subgroup of $\phi_i(S)$ and therefore $\phi_i(S)$ is nonelementary. The proof of the converse is analogous. \square

Remark. From Proposition 3.6 it follows that $p_{q+1}(\Gamma), \dots, p_{q+r}(\Gamma)$ are nonelementary and hence of the same type as $p_j(\Gamma)$. But they can not be cofinite arithmetic Kleinian groups. Hence it is possible that $p_j(\Gamma)$ is a cofinite arithmetic Kleinian group only if $r = 0$.

The next lemma follows from the previous one.

Lemma 5.2. *Let Δ be an irreducible arithmetic subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ and Γ and $\tilde{\Gamma}$ finitely generated subgroups of Δ such that $p_j(\Gamma)$ is a nonelementary subgroup of the cofinite arithmetic Fuchsian (or Kleinian) $p_j(\tilde{\Gamma})$ for some $j \in \{1, \dots, q+r\}$. Then, for all $i = 1, \dots, q+r$, the group $p_i(\Gamma)$ is either elementary or a nonelementary subgroup of a cofinite arithmetic Fuchsian (or Kleinian) group.*

Proof. If $p_i(\Gamma)$ is nonelementary, then $p_i(\tilde{\Gamma})$ is nonelementary and hence, by the previous lemma, a cofinite arithmetic Fuchsian (or Kleinian) group.

Let $p_i(\Gamma)$ be elementary. By Proposition 3.6, it consists only of elliptic isometries with a common fixed point. Since $p_j(\Gamma)$ has a loxodromic element, $p_i(\Gamma)$ has an elliptic element of infinite order. Hence $p_i(\Gamma)$ is not discrete. Therefore $p_i(\tilde{\Gamma})$ is also not discrete. Since it is either elementary or a discrete arithmetic Fuchsian (or Kleinian) group, it is elementary. \square

5.3 Small projective limit sets

In this section we will determine the groups for which the projective limit set is the smallest possible nonempty one, namely when it is just one point.

We need the following criterion for Zariski density which is a special case of the criterion proved by Dal'Bo and Kim in [7]. For part (iii) we use the fact that there are no continuous isomorphisms between $\mathrm{PSL}(2, \mathbb{R})$ and $\mathrm{PSL}(2, \mathbb{C})$.

Theorem 5.3 ([7]). *(i) Let φ be a surjective homomorphism between two Zariski dense subgroups Γ and Γ' of $\mathrm{PSL}(2, \mathbb{R})$. Then φ can be extended to a continuous automorphism of $\mathrm{PSL}(2, \mathbb{R})$ if and only if the group $\Gamma_\varphi := \{(g, \varphi(g)) \mid g \in \Gamma\}$ is not Zariski dense in $\mathrm{PSL}(2, \mathbb{R}) \times \mathrm{PSL}(2, \mathbb{R})$.*

(ii) Let φ be a surjective homomorphism between two subgroups Γ and Γ' of $\mathrm{PSL}(2, \mathbb{C})$ that are Zariski dense over \mathbb{R} . Then φ can be extended to a continuous automorphism of $\mathrm{PSL}(2, \mathbb{C})$ if and only if the group $\Gamma_\varphi := \{(g, \varphi(g)) \mid g \in \Gamma\}$ is not Zariski dense over \mathbb{R} in $\mathrm{PSL}(2, \mathbb{C}) \times \mathrm{PSL}(2, \mathbb{C})$.

(iii) Let Γ be a subgroup of $\mathrm{PSL}(2, \mathbb{C})$ that is Zariski dense over \mathbb{R} and Γ' a Zariski dense subgroup of $\mathrm{PSL}(2, \mathbb{R})$. Further let $\varphi : \Gamma \rightarrow \Gamma'$ be a surjective homomorphism between them. The group $\Gamma_\varphi := \{(g, \varphi(g)) \mid g \in \Gamma\}$ is Zariski dense over \mathbb{R} in $\mathrm{PSL}(2, \mathbb{C}) \times \mathrm{PSL}(2, \mathbb{R})$.

A proof of the following theorem is given by Schreier and Van der Waerden in [22].

Theorem 5.4 ([22]). *(i) All continuous automorphisms of $\mathrm{PSL}(2, \mathbb{R})$ are given by a conjugation with an element of $\mathrm{GL}(2, \mathbb{R})$.*

(ii) All continuous automorphisms of $\mathrm{PSL}(2, \mathbb{C})$ are given by a conjugation with an element of $\mathrm{GL}(2, \mathbb{C})$ or by a complex conjugation followed by a conjugation with an element of $\mathrm{GL}(2, \mathbb{C})$.

5.3.1 The general case

In the first four lemmas we will prove Theorem 5.9 which is the essential step of the proof of the main results for nonelementary subgroups of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$. Then we consider separately the three different cases: $q = 0$, $r = 0$ and $qr \neq 0$.

Unless specified otherwise, $\Gamma(A, \mathcal{O})$ will denote a subgroup of $\mathrm{PSL}(2, \mathbb{R})$ or $\mathrm{PSL}(2, \mathbb{C})$ derived from a quaternion algebra such that

$$\Gamma(A, \mathcal{O})^* \subseteq \mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r \text{ with } q + r \geq 2.$$

Here we fix for simplicity of notation the order of the complex and real factors.

Let S be a subgroup of $\Gamma(A, \mathcal{O})$ such that S^* is nonelementary. Then by Lemma 3.3 the regular limit set $\mathcal{L}_{S^*}^{reg}$ is not empty and in particular we can define the Furstenberg limit set F_{S^*} and the projective limit set P_{S^*} .

Lemma 5.5. *If for at least one $i \in \{1, \dots, q+r\}$, the mapping $\phi_i : \mathrm{Tr}(S^{(2)}) \rightarrow \phi_i(\mathrm{Tr}(S^{(2)}))$ is neither the identity nor the complex conjugation, then P_{S^*} contains more than one point.*

Proof. We have four cases for $\mathrm{Tr}(S)$ and $\phi_i(\mathrm{Tr}(S))$.

The first one is when $\mathrm{Tr}(S)$ and $\phi_i(\mathrm{Tr}(S))$ are both subsets of \mathbb{R} . Then by Corollary 1.5, the Zariski closures over \mathbb{R} of S and $\phi_i(S)$ are conjugates of $\mathrm{PSL}(2, \mathbb{R})$. Hence, by Theorem 5.3(i) (the criterion of Dal'Bo and Kim), $S_{\phi_i} := \{(s, \phi_i(s)) \mid s \in S\}$ is Zariski dense over \mathbb{R} in a conjugate of $\mathrm{PSL}(2, \mathbb{R}) \times \mathrm{PSL}(2, \mathbb{R})$.

The second case is when $\mathrm{Tr}(S)$ is not a subset of \mathbb{R} and $\phi_i(\mathrm{Tr}(S))$ is a subset of \mathbb{R} . Then by Corollary 1.5, the Zariski closure over \mathbb{R} of S is $\mathrm{PSL}(2, \mathbb{C})$ and the Zariski closure over \mathbb{R} of $\phi_i(S)$ is a conjugate of $\mathrm{PSL}(2, \mathbb{R})$. By Theorem 5.3(iii) S_{ϕ_i} is then Zariski dense over \mathbb{R} in a conjugate of $\mathrm{PSL}(2, \mathbb{C}) \times \mathrm{PSL}(2, \mathbb{R})$.

The third case is when $\mathrm{Tr}(S)$ is a subset of \mathbb{R} and $\phi_i(\mathrm{Tr}(S))$ not is a subset of \mathbb{R} . It is analogous to the second case.

The last case is when both $\mathrm{Tr}(S)$ and $\phi_i(\mathrm{Tr}(S))$ are not subsets of \mathbb{R} . Then by Corollary 1.5, the Zariski closures over \mathbb{R} of S and $\phi_i(S)$ are $\mathrm{PSL}(2, \mathbb{C})$. Hence, by Theorem 5.3(ii) (the criterion of Dal'Bo and Kim), S_{ϕ_i} is Zariski dense over \mathbb{R} in $\mathrm{PSL}(2, \mathbb{C}) \times \mathrm{PSL}(2, \mathbb{C})$.

In all of the cases, by Theorem 3.9 follows that $\overline{P_{S_{\phi_i}}}$ has a nonempty interior in \mathbb{RP}^1 , i.e. $P_{S_{\phi_i}}$ contains more than one point.

Let h be a loxodromic transformation in S all of whose ϕ -conjugates are loxodromic and whose existence is guaranteed by Lemma 3.3. Since $P_{S_{\phi_i}}$ contains more than one point, we can take $g \in S$ such that the translation directions $(\ell(h) : \ell(\phi_i(h)))$ and $(\ell(g) : \ell(\phi_i(g)))$ are different.

Case 1: If all ϕ -conjugates of g are loxodromic isometries, then the translation directions $L(h)$ and $L(g)$ of h and g determine different points in \mathbb{RP}_+^{q+r-1} and hence P_{S^*} consists of more than one point.

Case 2: There is a ϕ -conjugate of g that is an elliptic isometry of infinite order. By Theorem 3.8, $\overline{P_{S^*}}$ is convex and in particular path connected. Hence there is a path in P_{S^*} between $L(h)$ and $L(g)$. Since \mathbb{RP}_+^{q+r-1} is open, there is an open subset of the path in \mathbb{RP}_+^{q+r-1} . Therefore there is another point in P_{S^*} except $L(h)$. \square

We will need the following lemma in the proof of Lemma 5.7.

Lemma 5.6. *Let Δ be an irreducible arithmetic subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$. Then for all $g = (g_1, \dots, g_{q+r}) \in \Delta$, the traces $\mathrm{tr}(g_1), \dots, \mathrm{tr}(g_{q+r})$ are algebraic integers.*

Proof. The group Δ is commensurable to a $\Gamma(A, \mathcal{O})^*$. Then for all $g \in \Delta$, there is a power $g^n \in \Gamma(A, \mathcal{O})^*$ for some $n \in \mathbb{N}$.

From Lemma 2.2.7 and Lemma 2.2.4 in [16] it follows that the traces of all elements in $\Gamma(A, \mathcal{O})$ are algebraic integers. Hence $\mathrm{tr}(g_i^n)$, $i = 1, \dots, q+r$, are algebraic integers. Since $\mathrm{tr}(g_i^n)$ is a monic polynomial with integer coefficients in $\mathrm{tr}(g_i)$, the trace $\mathrm{tr}(g_i)$ satisfies a monic polynomial with coefficients that are algebraic integers and hence is an algebraic integer. \square

Lemma 5.7. *Let S be finitely generated. Then the mapping $\phi_i : \mathrm{Tr}(S^{(2)}) \rightarrow \phi_i(\mathrm{Tr}(S^{(2)}))$ is neither the identity nor the complex conjugation for at least one ϕ_i , $i \in \{1, \dots, q+r\}$, if and only if S is not contained in an arithmetic Fuchsian or Kleinian group.*

Proof. In order to prove the first implication we assume that the mapping $\phi_i : \mathrm{Tr}(S^{(2)}) \rightarrow \phi_i(\mathrm{Tr}(S^{(2)}))$ is neither the identity nor the complex conjugation for at least one ϕ_i , $i \in \{1, \dots, q+r\}$. In this case S is not contained in an arithmetic Kleinian or Fuchsian group because there is the embedding ϕ_i of $\mathbb{Q}(\mathrm{Tr}(S^{(2)}))$ into \mathbb{C} which is neither the identity nor the complex conjugation such that $\phi_i(\mathrm{Tr}(S^{(2)}))$ is not bounded in \mathbb{C} and this contradicts the second condition in Theorem 4.4 and Theorem 4.7.

We prove the negation of the second implication. We assume that for all $i = 1, \dots, q+r$ we have $\phi_i|_{\text{Tr}(S^{(2)})} = id$, i.e. $\text{tr}(g) = \pm\phi_i(\text{tr}(g))$, or $\phi_i|_{\text{Tr}(S^{(2)})}$ is the complex conjugation, i.e. $\overline{\text{tr}(g)} = \pm\phi_i(\text{tr}(g))$ for all $g \in \Gamma$.

We consider the following set of matrices

$$AS^{(2)} = \left\{ \sum a_i g_i \mid a_i \in \mathbb{Q}(\text{Tr}(S^{(2)})), g_i \in S^{(2)} \right\}$$

where only finitely many of the a_i are nonzero. By Theorem 4.1, $AS^{(2)}$ is a quaternion algebra over $\mathbb{Q}(\text{Tr}(S^{(2)}))$ because S is finitely generated. By construction it is contained in A . So it is a quaternion algebra over the algebraic number field $\mathbb{Q}(\text{Tr}(S^{(2)}))$ which is unramified at id and ramified at all other infinite places. By Lemma 5.6 all traces in S are algebraic integers and hence by Theorem 4.2, an order of $AS^{(2)}$ is

$$\mathcal{O}S^{(2)} = \left\{ \sum a_i g_i \mid a_i \in \mathcal{O}_{\mathbb{Q}(\text{Tr}(S^{(2)}))}, g_i \in S^{(2)} \right\}$$

where only finitely many of the a_i are nonzero. The group $\mathcal{O}S^{(2)^1} := \{\alpha \in \mathcal{O}S \mid \text{Nrd}(\alpha) = 1\}$ is an arithmetic Kleinian or Fuchsian group depending on whether its trace field is a subset of \mathbb{R} or not. The group $S^{(2)}$ is contained in $\mathcal{O}S^{(2)^1}$.

It remains to construct an arithmetic Fuchsian group containing S . Since S is finitely generated, we can assume that it is generated by its elements h_1, \dots, h_m . Note that $h_i^2 \in \mathcal{O}S^{(2)^1}$ because $h_i^2 \in S^{(2)}$ for all $i = 1, \dots, m$. We consider the group \tilde{S} generated by $\mathcal{O}S^{(2)^1}$ and h_1, \dots, h_m . It is finitely generated and nonelementary. Hence $\tilde{S}^{(2)}$ is a finite index subgroup of \tilde{S} . On the other hand we have the group inclusions $\tilde{S}^{(2)} \leq \mathcal{O}S^{(2)^1} \leq \tilde{S}$. Therefore $\mathcal{O}S^{(2)^1}$ is a finite index subgroup of \tilde{S} and \tilde{S} is an arithmetic Kleinian or Fuchsian subgroup of $\Gamma(A, \mathcal{O})$. \square

Remark. We also proved the statement that S is contained in an arithmetic Fuchsian or Kleinian group if and only if S is contained in an arithmetic Fuchsian or Kleinian subgroup of $\Gamma(A, \mathcal{O})$.

The next lemma shows that there are groups with the smallest possible projective limit set.

Lemma 5.8. *If S is contained in an arithmetic Fuchsian or Kleinian group, then P_{S^*} consists only of the point $(1 : \dots : 1)$.*

Proof. We prove the negation of this implication. Assume P_{S^*} contains at least one point different from $(1 : \dots : 1)$. By Theorem 2.2, the translation directions of the loxodromic isometries in S^* are dense in P_{S^*} . Therefore P_{S^*} contains a loxodromic transformation h^* with $L(h^*) \neq (1 : \dots : 1)$. There is ϕ_i such that $\ell(h) \neq \ell(\phi_i(h))$, where $\ell(g)$ denotes the length of the closed geodesic corresponding to g .

For all $g, \tilde{g} \in \text{PSL}(2, \mathbb{C})$, if $\ell(g) \neq \ell(\tilde{g})$, then $\text{tr}(g) \neq \text{tr}(\tilde{g})$ and $\text{tr}(g) \neq \overline{\text{tr}(\tilde{g})}$. Therefore, for the above ϕ_i , we have $\text{tr}(h) \neq \pm \phi_i(\text{tr}(h))$ and $\text{tr}(h) \neq \pm \phi_i(\overline{\text{tr}(h)})$ and in particular the mapping $\phi_i : \text{Tr}(S^{(2)}) \rightarrow \phi_i(\text{Tr}(S^{(2)}))$ is neither the identity nor the complex conjugation. Hence by Lemma 5.7, the group S is not contained in an arithmetic Fuchsian or Kleinian group. \square

The following theorem follows directly from Lemma 5.5, Lemma 5.7 and Lemma 5.8.

Theorem 5.9. *Let $\Gamma(A, \mathcal{O})$ be a subgroup of $\text{PSL}(2, \mathbb{C})$ or $\text{PSL}(2, \mathbb{R})$ derived from a quaternion algebra such that $\Gamma(A, \mathcal{O})^* \subset \text{PSL}(2, \mathbb{C})^q \times \text{PSL}(2, \mathbb{R})^r$ with $r+q \geq 2$ and let S be a finitely generated subgroup of $\Gamma(A, \mathcal{O})$ such that S^* is nonelementary. Then $\mathcal{L}_{S^*}^{reg}$ is not empty and P_{S^*} consists of exactly one point if and only if S is contained in an arithmetic Fuchsian or Kleinian group.*

Remark. From Theorem 5.9 follows in particular that if S is not a Fuchsian group, i.e. S is not discrete, then P_{S^*} contains more than one point.

Theorem 5.10. *Let Δ be an irreducible arithmetic subgroup of $\text{PSL}(2, \mathbb{C})^q \times \text{PSL}(2, \mathbb{R})^r$ with $q+r \geq 2$ and Γ a finitely generated nonelementary subgroup of Δ . Then $\mathcal{L}_{\Gamma}^{reg}$ is not empty and P_{Γ} consists of exactly one point if and only if $p_j(\Gamma)$ is contained in an arithmetic Fuchsian or Kleinian group for some $j \in \{1, \dots, q+r\}$.*

Proof. By Lemma 5.1, the group $p_j(\Gamma)$ is contained in an arithmetic Fuchsian or Kleinian group if and only if the group $p_1(\Gamma)$ is contained in an arithmetic Fuchsian or Kleinian group. Thus we prove the statement with $p_1(\Gamma)$ instead of $p_j(\Gamma)$.

We recall that $\mathcal{L}_{\Gamma}^{reg}$ is not empty by Lemma 3.4.

Since Δ is arithmetic, it is commensurable with an arithmetic group derived from a quaternion algebra $\Gamma(A, \mathcal{O})^*$. Hence there is $k \in \mathbb{N}$ such that, for each $g = (g_1, \dots, g_{q+r})$ in Γ , g^k is in $\Gamma(A, \mathcal{O})^*$.

There is a subgroup S of $\Gamma(A, \mathcal{O})$ such that $S^* = \Gamma \cap \Delta \cap \Gamma(A, \mathcal{O})^*$. The group Γ is commensurable with the subgroup S^* . Then $p_1(\Gamma)$ and S are also

commensurable. The group S^* is finitely generated because it is a finite index subgroup of the finitely generated group Γ . (This follows from the Schreier Index Formula, see for example the book [23], 2.2.5.) The group S^* is also nonelementary because Γ is nonelementary: Let g and h be two loxodromic isometries that generate a Schottky group in Γ . The isometries g^k and h^k are in S^* . Then g^k and h^k generate a Schottky subgroup of S^* .

Thus S^* is a finitely generated nonelementary subgroup of $\Gamma(A, \mathcal{O})$. By Theorem 5.9, the group S is contained in an arithmetic Fuchsian or Kleinian group if and only if its projective limit set P_{S^*} contains exactly one point.

The final step is to go back to Γ .

If P_Γ contains at least two points, then it contains two points that are the translation directions of two loxodromic isometries g and h of Γ . The isometries g^k and h^k that are in S^* have the same translation directions as g and h . Hence $L(g^k)$ and $L(h^k)$ are different points in P_{S^*} and therefore S is not a subgroup of an arithmetic Fuchsian or Kleinian group. Thus $p_1(\Gamma)$ is not a subgroup of an arithmetic Fuchsian or Kleinian group too.

If P_Γ contains exactly one point, then P_{S^*} contains also exactly one point and S is contained in an arithmetic Fuchsian or Kleinian group. Hence the quaternion algebra $B := AS^{(2)} = Ap_1(\Gamma)^{(2)}$, which is an invariant of the commensurability class, is unramified only at one place. Since by Lemma 5.6 the trace set $\text{Tr}(p_1(\Gamma)^{(2)})$ consists of algebraic integers, $\mathcal{O}p_1(\Gamma)^{(2)}$ is an order in B and thus $p_1(\Gamma)^{(2)}$ is a subgroup of an arithmetic Fuchsian or Kleinian group. The proof that $p_1(\Gamma)$ is a subgroup of an arithmetic Fuchsian or Kleinian group is the same as the one for S in the end of Lemma 5.7. \square

5.3.2 Subgroups of $\text{PSL}(2, \mathbb{R})^r$

In the case when $q = 0$ we can specify the statement of Theorem 5.10. First, we have Lemma 3.4, so requiring that Γ is nonelementary is equivalent to requiring that one of its projections is nonelementary. And second, $\text{PSL}(2, \mathbb{R})$ does not have arithmetic Kleinian subgroups. Hence we have proved the following corollary.

Corollary 5.11. *Let Δ be an irreducible arithmetic subgroup of $\text{PSL}(2, \mathbb{R})^r$ with $r \geq 2$ and Γ a finitely generated nonelementary subgroup of Δ . Then \mathcal{L}_Γ^{reg} is not empty and P_Γ consists of exactly one point if and only if $p_j(\Gamma)$ is contained in an arithmetic Fuchsian group for some $j \in \{1, \dots, r\}$.*

Remark. This corollary is in particular true when $p_j(\Gamma)$ is a cofinite Fuchsian group.

5.3.3 Subgroups of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$

In the case when both q and r are at least 1, we can state Theorem 5.10 more precisely because by the remark after Lemma 5.1, $p_j(\Gamma)$ can not be a cofinite arithmetic Kleinian group for any group Γ .

Corollary 5.12. *Let Δ be an irreducible arithmetic subgroup of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q, r \geq 1$ and Γ a subgroup of Δ such that $p_j(\Gamma)$ is a finitely generated nonelementary subgroup for some $j \in \{1, \dots, q+r\}$. Then $\mathcal{L}_\Gamma^{\mathrm{reg}}$ is not empty and P_Γ consists of exactly one point if and only if $p_j(\Gamma)$ is contained in an arithmetic Fuchsian group.*

Remark. It is not possible to prove an analogous statement to Lemma 3.4 for subgroups of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ because if S is nonelementary subgroup of a $\Gamma(A, \mathcal{O})$, then S^* is not necessarily nonelementary.

Consider, for example, the quaternion algebra $\left(\frac{\sqrt{2}, -1}{\mathbb{Q}(\sqrt{2})}\right)$ with its embedding ϕ_1 in $M(2, \mathbb{Q}(\sqrt[4]{2}))$ given by the linear map sending the elements of the basis of A to the following matrices:

$$1 \mapsto \begin{bmatrix} 1 & 0 \\ 0 & 1 \end{bmatrix}, \quad i \mapsto \begin{bmatrix} \sqrt[4]{2} & 0 \\ 0 & -\sqrt[4]{2} \end{bmatrix}, \quad j \mapsto \begin{bmatrix} 0 & 1 \\ -1 & 0 \end{bmatrix}, \quad k \mapsto \begin{bmatrix} 0 & \sqrt[4]{2} \\ \sqrt[4]{2} & 0 \end{bmatrix}.$$

The finitely generated $\mathcal{O}_{\mathbb{Q}(\sqrt{2})}$ -module $\mathcal{O} = \{x = x_0 + x_1i + x_2j + x_3k \mid x_0, x_1, x_2, x_3 \in \mathcal{O}_{\mathbb{Q}(\sqrt{2})}\}$ is a ring containing 1 and hence an order because i^2 and j^2 are algebraic integers. The group $S = \phi_1(\mathcal{O}^\times)$ is an arithmetic Fuchsian group because its ϕ -conjugate is a subgroup of $\left(\frac{-\sqrt{2}, -1}{\mathbb{Q}(\sqrt{2})}\right)$, which is isomorphic to the Hamilton quaternion algebra \mathbf{H} .

The group S is a subgroup of the arithmetic group acting on $(\mathbb{H}^2)^2 \times \mathbb{H}^3$

$$\Delta = \{A \in M(2, \mathbb{Q}(\sqrt[4]{2})) \mid \det A = 1\}.$$

The group S^* is not nonelementary because $\phi_3(S)$, which is a subgroup of $\mathrm{PSL}(2, \mathbb{C})$, consists only of elliptic isometries.

We can construct some other examples by instead of taking $M(2, \mathbb{Q}(\sqrt[4]{2}))$ we take $M(2, K)$ where K is a finite extension of $\mathbb{Q}(\sqrt[4]{2})$.

5.3.4 Subgroups of $\mathrm{PSL}(2, \mathbb{C})^q$

In the case $r = 0$, Theorem 5.10 is stated in the most general way. This case is of independent interest because this is the only case when $p_j(\Gamma)$ can be a cofinite arithmetic Kleinian group.

5.4 Subgroups with parabolic elements

We can prove Theorem 5.11 using different methods in the case when the group S contains parabolic elements. This proof does not use the results of Benoist and Dal'Bo. Here we only give the proof of the main new step for the case where S^* is a subgroup of $\mathrm{PSL}(2, \mathbb{R})^r$.

Proposition 5.13. *Let $\Gamma(A, \mathcal{O})$ be a subgroup of $\mathrm{PSL}(2, \mathbb{R})$ derived from a quaternion algebra such that $\Gamma(A, \mathcal{O})^* \subset \mathrm{PSL}(2, \mathbb{R})^r$ with $r \geq 2$ and let S be a finitely generated nonelementary subgroup of $\Gamma(A, \mathcal{O})$. Then P_{S^*} contains the point $(1 : \dots : 1)$.*

Proof. First we will show that $\mathcal{L}_{S^*}^{reg}$ is not empty and P_{S^*} contains $(1 : \dots : 1)$.

Let T_u be a hyperbolic isometry in S . The connection between the translation length of T_u and its trace is given by $\mathrm{tr}(T_u) = 2 \cosh(\ell(T_u)/2)$. The translation length of T_u is equal to the length of the only simple closed geodesic in $\langle T_u \rangle \backslash \mathbb{H}^2$. For a Fuchsian group Γ there is a bijection between its hyperbolic elements and the closed geodesics in $\Gamma \backslash \mathbb{H}^2$. Hence for the length of every closed geodesic in $\Gamma \backslash \mathbb{H}^2$ there is at least one hyperbolic transformation in Γ with this translation length.

A *Y-piece* is a surface of constant curvature -1 and of signature $(0, 3)$, i.e. homeomorphic to a topological sphere with three points removed. By Geninska and Leuzinger [9], Corollary 2.3, which is true not only for Fuchsian groups but also for nonelementary (non-discrete) subgroups of $\mathrm{PSL}(2, \mathbb{R})$, an element $T_v \in S$ exists such that $\langle T_u, T_v \rangle \backslash \mathbb{H}^2$ contains a Y-piece with one cusp and two boundary geodesics of length $\ell(T_u)$ and $\ell(T_v)$. By Schmutz [20], Lemma 1, for all $n \in \mathbb{N}$, this Y-piece contains a closed geodesic such that the corresponding hyperbolic isometry T_n satisfies

$$\mathrm{tr}(T_n) = n(\mathrm{tr}(T_u) + \mathrm{tr}(T_v)) - \mathrm{tr}(T_u).$$

For n big enough, all ϕ -conjugates $\phi_i(T_n)$ of T_n are hyperbolic because

$$\mathrm{tr}(\phi_i(T_n)) = |\phi_i(\mathrm{tr}(T_n))| = |n(\phi_i(\mathrm{tr}(T_u)) + \phi_i(\mathrm{tr}(T_v))) - \phi_i(\mathrm{tr}(T_u))|$$

is unbounded when n is unbounded. (In this way we found a hyperbolic element in S^* , i.e. a hyperbolic element in S such that all its ϕ -conjugates are hyperbolic.)

We set $A := \text{tr}(T_u) + \text{tr}(T_v)$ and $B := \text{tr}(T_u)$. Then

$$\ell(T_n) = 2\text{arcosh}\frac{\text{tr}(T_n)}{2} = 2\text{arcosh}\frac{nA - B}{2} \stackrel{n \rightarrow \infty}{\approx} 2\ln(nA - B).$$

Hence for big n , the translation direction of T_n is asymptotic to

$$(2\ln(n) + 2\ln(A) : \dots : 2\ln(n) + 2\ln(|\phi_i(A)|)),$$

which converges towards $(1 : \dots : 1)$. Thus $(1 : \dots : 1)$ is in P_{S^*} . \square

Remark. In the general case we do not have Y-pieces but just groups generated by two elements and with their help we can create an analogous sequence of translation directions converging $(1 : \dots : 1)$.

Knowing that the projective limit set always contains the point $(1 : \dots : 1)$, we can finish the alternative proof of Lemma 5.5 by the two cases from its first proof.

5.5 Small limit cones

The restriction in Theorem 5.10 that Γ should be nonelementary is needed so that \mathcal{L}_Γ^{reg} is nonempty and hence P_Γ is well defined. This can be avoided by using the limit cone of Γ as defined in Section 3.4. This is proved in Theorem 5.16. In order to do so, we first need two lemmas.

Lemma 5.14. *Let Γ be a finitely generated subgroup of an irreducible arithmetic group Δ in $\text{PSL}(2, \mathbb{C})^q \times \text{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$. If $p_j(\Gamma)$ for some $j \in \{1, \dots, q + r\}$ is nonelementary and not a subgroup of an arithmetic Fuchsian or Kleinian group, then there is $i \in \{1, \dots, q + r\}$, $i \neq j$, such that $p_i(\Gamma)$ is nonelementary.*

Proof. Since Δ is arithmetic, it is commensurable with an arithmetic group derived from a quaternion algebra $\Gamma(A, \mathcal{O})^*$.

We assume that $p_i(\Gamma)$ is elementary for all i except j . Then for the subgroup S of $\Gamma(A, \mathcal{O})$ defined as $S^* = \Gamma \cap \Delta \cap \Gamma(A, \mathcal{O})^*$ only $\phi_j(S)$ is nonelementary. This means that for all embeddings σ of the field $F := \mathbb{Q}(\text{Tr}(\phi_j(S)^{(2)}))$ into \mathbb{C} that are not the identity or the complex conjugation,

the set $\sigma(\text{Tr}(\phi_j(S)^{(2)}))$ is bounded. By Lemma 5.6, the trace set $\text{Tr}(\phi_j(S)^{(2)})$ consists of algebraic integers. Since the properties nonelementary and finitely generated are invariant in the commensurability class (see the proof of Theorem 5.10), the group $S^{(2)}$ is also nonelementary and hence by Lemma 5.1.3 and Corollary 8.3.7 in [16] it is a subgroup of an arithmetic Kleinian or Fuchsian group. Then $p_j(\Gamma)$ is a subgroup of an arithmetic Fuchsian or Kleinian group, which is a contradiction. \square

The second lemma explains how to make nonelementary a subgroup Γ of Δ that is not nonelementary. In order to do so, we need to consider Γ as a subgroup of the product group $\text{PSL}(2, \mathbb{C})^{q'} \times \text{PSL}(2, \mathbb{R})^r$ with $q' < q$.

Here is the place to remark that since all mixed isometries in Γ have only components that are loxodromic and elliptic of infinite order, we can write Γ as $\Gamma = \{(\phi_1(g_1), \phi_2(g_1), \dots, \phi_{q+r}(g_1)) \mid g_1 \in p_1(\Gamma)\}$ where ϕ_i is a surjective homomorphism between $p_1(\Gamma)$ and $p_i(\Gamma)$. Here ϕ_i coincides with the ϕ_i coming from $\Gamma(A, \mathcal{O})^*$ for $\Gamma \cap \Gamma(A, \mathcal{O})^*$.

If for at least one $j \in \{1, \dots, q+r\}$, the projection $p_j(\Gamma)$ is nonelementary, define

$$\Gamma^{ne} := \{(\phi_{i_1}(g_1), \phi_{i_2}(g_1), \dots, \phi_{i_n}(g_1)) \mid i_1 < \dots < i_n \text{ and } p_{i_k}(\Gamma) \text{ nonelementary}\}.$$

Lemma 5.15. *The group Γ^{ne} is nonelementary, discrete and its limit set is identified canonically with the limit set of Γ .*

Proof. Γ^{ne} is nonelementary and discrete by definition.

By Proposition 3.6 if $p_i(\Gamma)$ is not nonelementary then $p_i(\Gamma)$ is not a subgroup of $\text{PSL}(2, \mathbb{R})$ and it consists only of elliptic isometries with a common fixed point. Let I be the set of all i such that $p_i(\Gamma)$ is not nonelementary. Then for each representative geodesic γ of each point in \mathcal{L}_Γ , the projection $\gamma_i := p_i(\gamma)$ is constant for $i \in I$. The following mapping gives the identification of \mathcal{L}_Γ and $\mathcal{L}_{\Gamma^{ne}}$:

$$\gamma = (\gamma_1, \dots, \gamma_{q+r}) \mapsto (\gamma_{i_1}, \dots, \gamma_{i_n}).$$

\square

Theorem 5.16. *Let Δ be an irreducible arithmetic subgroup of $\text{PSL}(2, \mathbb{C})^q \times \text{PSL}(2, \mathbb{R})^r$ with $q+r \geq 2$ and Γ a finitely generated subgroup of Δ . Then the limit cone of Γ consists of exactly one point if and only if $p_j(\Gamma)$ is contained in an arithmetic Fuchsian or Kleinian group for some $j \in \{1, \dots, q+r\}$.*

Proof. The idea is to apply Theorem 5.10 to Γ^{ne} . In order to do this we need that $n \geq 2$, because otherwise Γ^{ne} is just a subgroup of $\mathrm{PSL}(2, \mathbb{R})$ or $\mathrm{PSL}(2, \mathbb{C})$.

If $n = 1$, then the limit cone of Γ contains only the line

$$\left(\begin{bmatrix} 0 & 0 \\ 0 & 0 \end{bmatrix}, \dots, \begin{bmatrix} 0 & 0 \\ 0 & 0 \end{bmatrix}, \begin{bmatrix} tx_j & 0 \\ 0 & -tx_j \end{bmatrix}, \begin{bmatrix} 0 & 0 \\ 0 & 0 \end{bmatrix}, \dots, \begin{bmatrix} 0 & 0 \\ 0 & 0 \end{bmatrix} \right), \quad t \in \mathbb{R}.$$

But in this case, by Lemma 5.14, $p_j(\Gamma)$ is a subgroup of an arithmetic Fuchsian or Kleinian group.

If $n \geq 2$, the limit cone of Γ is identified with the limit cone of Γ^{ne} , which coincides with $\overline{P_{\Gamma^{ne}}}$. By Theorem 5.10, then $\mathcal{L}_{\Gamma^{ne}}^{reg}$ is not empty and $P_{\Gamma^{ne}}$ consists of exactly one point if and only if $p_j(\Gamma)$ is contained in an arithmetic Fuchsian or Kleinian group for some $j \in \{1, \dots, n\}$. \square

5.6 The structure of groups with an arithmetic projection and their limit set

In Theorem 5.10 we have seen that a finitely generated nonelementary subgroup Γ of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ has the smallest possible nonempty projective limit set only if $p_j(\Gamma)$ is a nonelementary subgroup of an arithmetic Fuchsian or Kleinian group for some $j \in 1, \dots, q + r$. In this section we determine the structure of Γ and its limit set. Corollary 5.18 finishes the proof of Theorem B.

Lemma 5.17. *If $\Gamma_j := p_j(\Gamma)$ is nonelementary and a subgroup of an arithmetic Fuchsian or Kleinian group, then \mathcal{L}_{Γ_j} is homeomorphic to \mathcal{L}_{Γ} .*

Proof. If $\Gamma_i := p_i(\Gamma)$ is nonelementary only if $i = j$, then clearly \mathcal{L}_{Γ_j} is homeomorphic to \mathcal{L}_{Γ} .

We assume that there is at least one more $i \neq j$ such that Γ_i is nonelementary. Then by Lemma 5.15, the group Γ^{ne} is a nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{C})^{q'} \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q' \leq q$ and $q + r \geq 2$ and its limit set is identified with the limit set of Γ . For simplicity of the notation, we will assume that $\Gamma = \Gamma^{ne}$ and also that $j = 1$. The group Γ_1 does not need necessarily to be a subgroup of $\mathrm{PSL}(2, \mathbb{C})$ even if $q \neq 0$.

By Theorem 5.10, the regular limit set $\mathcal{L}_{\Gamma}^{reg}$ is not empty and P_{Γ} consists of exactly one point. Since $\mathcal{L}_{\Gamma}^{reg}$ equals the product $F_{\Gamma} \times P_{\Gamma}$ (see 2.2), $\mathcal{L}_{\Gamma}^{reg}$ is

homeomorphic to F_Γ and so it is contained in the generalized torus $(\partial\mathbb{H}^3)^q \times (\partial\mathbb{H}^2)^r$.

Theorem 5.12 in [14] says that if \mathcal{L}_Γ^{reg} is not empty, then the attractive fixed points of the loxodromic isometries in Γ are dense in \mathcal{L}_Γ . Hence \mathcal{L}_Γ^{reg} is dense in \mathcal{L}_Γ and so $\mathcal{L}_\Gamma^{reg} = \mathcal{L}_\Gamma$ because \mathcal{L}_Γ^{reg} is contained in the compact (and hence closed) generalized torus $(\partial\mathbb{H}^3)^q \times (\partial\mathbb{H}^2)^r$.

We have $\Gamma = \{(g_1, \phi_2(g_1), \dots, \phi_{q+r}(g_1)) \mid g_1 \in p_1(\Gamma)\}$ where ϕ_i is a surjective homomorphism between $p_1(\Gamma)$ and $p_i(\Gamma)$. We define the group $\Gamma_{1i} := \{(g_1, \phi_i(g_1)) \mid g_1 \in p_1(\Gamma)\}$.

If $p_1(\Gamma)$ is a subgroup of an arithmetic Fuchsian group, then for all $i = 1, \dots, q+r$, the group $\Gamma_i := p_i(\Gamma)$ is also a subgroup of an arithmetic Fuchsian group and hence $\text{Tr}(\Gamma_i)$ is a subset of \mathbb{R} . Then by Corollary 1.5, the Zariski closures over \mathbb{R} of Γ_i is (a conjugate of) $\text{PSL}(2, \mathbb{R})$. Since P_Γ consists of exactly one point, $P_{\Gamma_{1i}}$ consists also of exactly one point for all $i = 1, \dots, q+r$. Hence by Benoist's Theorem 3.9, the group Γ_{1i} is not Zariski dense in (a conjugate of) $\text{PSL}(2, \mathbb{R}) \times \text{PSL}(2, \mathbb{R})$ and then by the criterion of Dal'Bo and Kim (Theorem 5.3), for all $i = 1, \dots, q+r$, the homomorphism ϕ_i can be extended to a continuous isomorphism A_i between conjugates of $\text{PSL}(2, \mathbb{R})$, which, according to Theorem 5.4, is given by a conjugation with an element $A_i = \begin{bmatrix} a_i & b_i \\ c_i & d_i \end{bmatrix} \in \text{GL}(2, \mathbb{R})$. Hence for all $g = (g_1, \dots, g_{q+r}) \in \Gamma$, $g_i = A_i g_1 A_i^{-1}$.

If Γ_1 is a subgroup of an arithmetic Kleinian group but not a subgroup of an arithmetic Fuchsian group (this is possible only in the case $r = 0$), then by Corollary 1.5, the Zariski closures over \mathbb{R} of Γ_i is $\text{PSL}(2, \mathbb{C})$. As above, for each $i = 1, \dots, q$, we can find $A_i = \begin{bmatrix} a_i & b_i \\ c_i & d_i \end{bmatrix} \in \text{GL}(2, \mathbb{C})$ such that for all $g = (g_1, \dots, g_q) \in \Gamma$, $g_i = A_i g_1 A_i^{-1}$, or for all $g = (g_1, \dots, g_q) \in \Gamma$, $g_i = A_i \overline{g_1} A_i^{-1}$, where $\overline{g_1}$ denotes the complex conjugation.

If ξ is an attractive fixed point of an element $g_1 = p_1(g)$ in Γ_1 with $g = (g_1, \dots, g_{q+r}) \in \Gamma$, then either $A_i(\xi) := \frac{a_i \xi + b_i}{c_i \xi + d_i}$ or $A_i(\xi) := \frac{a_i \overline{\xi} + b_i}{c_i \overline{\xi} + d_i}$ is the attractive fixed point of g_i and vice versa. The maps A_i are homeomorphisms of $\partial\mathbb{H}^3$ (and in the first case of $\partial\mathbb{H}^2$).

We consider the mapping $A : \mathcal{L}_{\Gamma_1} \rightarrow \mathcal{L}_\Gamma$, $z \mapsto (z, \widetilde{A}_2(z), \dots, \widetilde{A}_r(z)) \times (1 : \dots : 1)$ where $\widetilde{A}_i(z) := \frac{a_i z + b_i}{c_i z + d_i}$ if σ is the identity and $\widetilde{A}_i(z) := \frac{a_i \overline{z} + b_i}{c_i \overline{z} + d_i}$ if σ is the complex conjugation, $i = 1, \dots, q+r$. This mapping is a homeomorphism on its image, i.e. $A : \mathcal{L}_{\Gamma_1} \rightarrow A(\mathcal{L}_{\Gamma_1})$ is a homeomorphism. Since A is a

bijection between the attractive fixed points of the loxodromic isometries in Γ and the attractive fixed points of the loxodromic isometries in Γ_1 , and since the attractive fixed points of the loxodromic isometries are dense in the corresponding limit set, $\mathcal{L}_\Gamma = A(\mathcal{L}_{\Gamma_1})$. Therefore $A : \mathcal{L}_{\Gamma_1} \rightarrow \mathcal{L}_\Gamma$ is a homeomorphism. \square

The above proof is also the proof of the following corollary.

Corollary 5.18. *Let Γ be a finitely generated nonelementary subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$. If $S := p_j(\Gamma)$ is a nonelementary subgroup of an arithmetic Fuchsian or Kleinian group for some $j \in 1, \dots, q + r$, then Γ is a conjugate by an element in $\mathrm{GL}(2, \mathbb{C})^q \times \mathrm{GL}(2, \mathbb{R})^r$ of a group*

$$\mathrm{Diag}(S) := \{(\sigma_1(s), \dots, \sigma_{q+r}(s)) \mid s \in S\},$$

where, for $i = 1, \dots, q + r$, σ_i denotes either the identity or the complex conjugation.

This corollary and Theorem 5.10 prove Theorem B from the introduction.

5.7 Small limit sets

5.7.1 Subgroups of $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$

In this section we answer the question when the limit set of Γ is topologically a circle or a subspace of a circle where Γ is a finitely generated subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$.

We say that a set X is embedded homeomorphically in a circle if there exists a map $f : X \rightarrow S^1$ such that $f : X \rightarrow f(X)$ is a homeomorphism.

Theorem 5.19. *Let Γ be a finitely generated subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$ and $r \neq 0$ such that $p_j(\Gamma)$ is nonelementary for some $j \in \{1, \dots, q + r\}$. Then \mathcal{L}_Γ is embedded homeomorphically in a circle if and only if $p_j(\Gamma)$ is contained in an arithmetic Fuchsian group.*

Proof. If $\Gamma_j := p_j(\Gamma)$ is a subgroup of an arithmetic Fuchsian group, then \mathcal{L}_Γ and \mathcal{L}_{Γ_j} are homeomorphic (Lemma 5.17). Since \mathcal{L}_{Γ_j} is a topological subspace of S^1 , the limit set \mathcal{L}_Γ is embedded homeomorphically in a circle.

Now let $p_j(\Gamma)$ be such that it is not contained in an arithmetic Fuchsian group. Then according to Theorem 5.10, P_Γ contains at least two different points and by Lemma 3.7 there is a path in P_Γ between these points and thus P_Γ contains an interval. Let I be an open subinterval (contained in this interval.)

The next step is to show that F_Γ is infinite. Since \mathcal{L}_Γ is nonempty, there is at least one loxodromic element \tilde{h} in Γ . By Lemma 3.1, starting from \tilde{h} and \tilde{h} , we can find loxodromic isometries g and h in Γ such that the groups generated by the corresponding components of g and h are Schottky with only loxodromic elements. The projections of the attractive fixed points of $g^k h g^{-k}$, $k \in \mathbb{N}$, in the Furstenberg boundary give us infinitely many points in F_Γ .

Consequently, since F_Γ is closed and lies in the generalized torus $(\partial\mathbb{H}^3)^q \times (\partial\mathbb{H}^2)^r$, it contains a point ξ that is not isolated. This means that any neighborhood U of ξ in F_Γ contains a point ξ_U different from ξ .

Let us assume that there is a topological embedding $f : \mathcal{L}_\Gamma \rightarrow S^1$, i.e. f is a homeomorphism between \mathcal{L}_Γ and $f(\mathcal{L}_\Gamma)$ with the subset topology. Since $\{\xi\} \times I \subset \mathcal{L}_\Gamma$ is connected, the image $f(\{\xi\} \times I)$ is also connected. Hence $f(\{\xi\} \times I)$ is an arc in S^1 and thus open in S^1 and so in $f(\mathcal{L}_\Gamma)$. Since f is homeomorphism, the preimage of the open set $f(\{\xi\} \times I)$ is open in \mathcal{L}_Γ , i.e. $\{\xi\} \times I$ is open in \mathcal{L}_Γ .

The topology of $((\partial\mathbb{H}^3)^q \times (\partial\mathbb{H}^2)^r)_{reg}$ is the product topology and $\mathcal{L}_\Gamma^{reg} \subseteq ((\partial\mathbb{H}^3)^q \times (\partial\mathbb{H}^2)^r)_{reg}$ has the product subspace topology. In particular, each open set V containing $\{\xi\} \times I$ contains also $\{\xi_U\} \times I$ where U is a neighborhood of ξ contained in the projection of V in F_Γ . Hence, since any neighborhood U of ξ in F_Γ contains a point ξ_U different from ξ , $\{\xi\} \times I$ is not open in \mathcal{L}_Γ . This is a contradiction. \square

Theorem 5.19 allows us to decide whether $p_j(\Gamma)$ is a subgroup of an arithmetic Fuchsian group or not. The next corollary distinguishes when $p_j(\Gamma)$ is a (cofinite) arithmetic Fuchsian group and when it is not.

Corollary 5.20. *Let Γ be a finitely generated subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$ and $r \neq 0$ such that $p_j(\Gamma)$ is nonelementary for some $j \in \{1, \dots, q + r\}$. Then \mathcal{L}_Γ is homeomorphic to a circle if and only if $p_j(\Gamma)$ is a cofinite arithmetic Fuchsian group.*

Proof. If $\Gamma_j := p_j(\Gamma)$ is not a subgroup of an arithmetic Fuchsian group, then by the previous theorem, \mathcal{L}_Γ is not homeomorphic to a circle.

Now let Γ_j be a subgroup of an arithmetic Fuchsian group. Then by Lemma 5.17, \mathcal{L}_Γ is homeomorphic to \mathcal{L}_{Γ_j} .

If \mathcal{L}_Γ be homeomorphic to a circle, then \mathcal{L}_{Γ_j} is connected. Since Γ_j is nonelementary, \mathcal{L}_{Γ_j} contains more than two points and by Theorem 3.4.6 in [10], it is either the whole boundary $\partial\mathbb{H}^2$ of \mathbb{H}^2 or it is nowhere dense in $\partial\mathbb{H}^2$ and in particular not connected. Hence \mathcal{L}_{Γ_j} is $\partial\mathbb{H}^2$.

Combining Theorem 4.6.1 and Theorem 4.5.1 in [10] we get that a finitely generated Fuchsian group of the first kind, i.e. whose limit set is $\partial\mathbb{H}^2$, has a fundamental region of finite hyperbolic area. Therefore Γ_j is cofinite arithmetic Fuchsian group.

The converse is also true, namely, if Γ_j is cofinite arithmetic Fuchsian group, then \mathcal{L}_{Γ_j} and hence \mathcal{L}_Γ are homeomorphic to S^1 . \square

5.7.2 Subgroups of $\mathrm{PSL}(2, \mathbb{C})^q$

We consider a subgroup Γ of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q$. The question we answer is when \mathcal{L}_Γ is a sphere. The next theorem is analogous to Corollary 5.20 but it needs an additional structure on the geometric boundary $\partial(\mathbb{H}^3)^q$.

The geometric boundary $\partial(\mathbb{H}^3)^q$ is homeomorphic to the unit tangent sphere at a point in $(\mathbb{H}^3)^q$. This unit tangent sphere has a natural smooth structure induced by the Riemannian metric of $(\mathbb{H}^3)^q$ and this makes the unit tangent sphere diffeomorphic to the standard $(3q - 1)$ -sphere and defines a smooth structure on $\partial(\mathbb{H}^3)^q$.

Theorem 5.21. *Let Γ be a subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q$ with $q \geq 2$ such that $p_j(\Gamma)$ is a cofinite Kleinian group for some $j \in \{1, \dots, q\}$. Then \mathcal{L}_Γ is the image of a differentiable embedding of the 2-sphere S^2 in $\partial(\mathbb{H}^3)^q$ if and only if $p_j(\Gamma)$ is an arithmetic Kleinian group.*

Proof. For simplicity we will denote $p_i(\Gamma)$ by Γ_i for all $i = 1, \dots, q$. Without loss of generality, we can assume that $p_j(\Gamma)$ is a cofinite Kleinian group for $j = 1$.

In order to show the first implication let Γ_1 be an arithmetic Kleinian group. Then \mathcal{L}_Γ and \mathcal{L}_{Γ_1} are homeomorphic (Lemma 5.17). From the proof of Lemma 5.17 it follows that \mathcal{L}_Γ and \mathcal{L}_{Γ_1} are diffeomorphic because \widetilde{A}_i are diffeomorphisms of the Riemann sphere for $i = 1, \dots, q$.

Thus \mathcal{L}_Γ is the image of an embedding of the S^2 in $\partial(\mathbb{H}^3)^q$.

In order to show the second implication, we assume that Γ_1 is not arithmetic and the limit set of Γ is the image of an embedding of the sphere S^2 in $\partial(\mathbb{H}^3)^q$. By Lemma 5.15, \mathcal{L}_Γ and $\mathcal{L}_{\Gamma^{ne}}$ are diffeomorphic. Here $\partial(\mathbb{H}^3)^q$ is a submanifold of $\partial(\mathbb{H}^3)^q$.

The projective limit set $P_{\Gamma^{ne}}$ contains at least two different points (Theorem 5.10) and by Theorem 3.8, it contains also a path joining them.

Theorem 4.10 in [15] says that the set of attractive fixed points of loxodromic isometries in a nonelementary subgroup of $\mathrm{PSL}(2, \mathbb{C})^n$ is dense in its limit set. It follows that $\mathcal{L}_{\Gamma^{ne}}^{reg}$ is dense in $\mathcal{L}_{\Gamma^{ne}}$. Additionally, since $\partial(\mathbb{H}^3)_{reg}^n$ is open in $\partial(\mathbb{H}^3)^n$, $\mathcal{L}_{\Gamma^{ne}}^{reg}$ is open in $\mathcal{L}_{\Gamma^{ne}}$. Hence $\mathcal{L}_{\Gamma^{ne}}^{reg}$ is open and dense in $\mathcal{L}_{\Gamma^{ne}}$.

The limit set \mathcal{L}_{Γ_1} of Γ_1 is $\partial\mathbb{H}^3$, i.e. homeomorphic to S^2 . To each point in \mathcal{L}_{Γ_1} corresponds at least one point in $\mathcal{L}_{\Gamma^{ne}}$. We will show that each point in \mathcal{L}_{Γ_1} is the projection in the first factor of a point in $\mathcal{L}_{\Gamma^{ne}}^{reg}$.

For each point in $\mathcal{L}_{\Gamma^{ne}}^{sing}$ there is a sequence in $\mathcal{L}_{\Gamma^{ne}}^{reg}$ that converges to it. Let ξ be a point in $\mathcal{L}_{\Gamma^{ne}}^{sing}$ such that the projection of one of its representative geodesics in the first factor is not a constant. This means that the first factors of the regular elements converge to the first factor of ξ . The projections of the regular elements in the Furstenberg boundary $(\partial\mathbb{H}^3)^q$ converge to a point in $(\partial\mathbb{H}^3)^q$ (because $(\partial\mathbb{H}^3)^q$ is compact). Since $F_{\Gamma^{ne}}$ is closed, there is a point in $\mathcal{L}_{\Gamma^{ne}}^{reg}$ such that its projection in the first factor coincides with the first factor of ξ .

Hence the projection of $\mathcal{L}_{\Gamma^{ne}}^{reg}$ on the first factor of the regular boundary is \mathcal{L}_{Γ_1} , which is the 2-sphere. Since $\mathcal{L}_{\Gamma^{ne}}^{reg} = F_{\Gamma^{ne}} \times P_{\Gamma^{ne}}$ by Theorem 2.2, the projection of $\mathcal{L}_{\Gamma^{ne}}^{reg}$ on the first factor times $P_{\Gamma^{ne}}$ contains a set homeomorphic to \mathbb{R}^3 . On the other side $\mathcal{L}_{\Gamma^{ne}}^{reg}$ is a two dimensional smooth submanifold of $\partial(\mathbb{H}^3)_{reg}$ and therefore its projection on the first factor times $P_{\Gamma^{ne}}$ is two dimensional, which is impossible.

Thus if Γ_1 is not arithmetic, then the limit set of Γ^{ne} is not the image of an embedding of the S^2 in $\partial(\mathbb{H}^3)^q$. \square

Remark. The fact that the projection of $\mathcal{L}_{\Gamma^{ne}}^{reg}$ on the first factor times $P_{\Gamma^{ne}}$ contains a set homeomorphic to \mathbb{R}^3 while $\mathcal{L}_{\Gamma^{ne}}^{reg}$ is two dimensional is not a contradiction if $\mathcal{L}_{\Gamma^{ne}}^{reg}$ is just assumed to be homeomorphic to S^2 .

We can give a more precise answer to the question when the limit set is topologically a circle. An answer is given by the next theorem. In order to state it, we need the definition of a quasi-Fuchsian group. A *quasi-Fuchsian*

group is a subgroup of $\mathrm{PSL}(2, \mathbb{C})$ whose limit set is homeomorphic to a circle.

Theorem 5.22. *Let Γ be a finitely generated subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q$ with $q \geq 2$ such that $p_j(\Gamma)$ is nonelementary for some $j \in \{1, \dots, q\}$. Then \mathcal{L}_Γ is homeomorphic to a circle if and only if $p_j(\Gamma)$ is a cofinite arithmetic Fuchsian group or a quasi-Fuchsian subgroup of an arithmetic Kleinian group.*

Proof. Again for simplicity we will denote $p_i(\Gamma)$ by Γ_i for all $i = 1, \dots, q$. Without loss of generality, we can assume that $p_j(\Gamma)$ is nonelementary for $j = 1$.

We will consider two main cases: when Γ_1 is a subgroup of an arithmetic Fuchsian or Kleinian group and when it is not.

Let Γ_1 be an arithmetic Kleinian group, then \mathcal{L}_Γ and \mathcal{L}_{Γ_1} are homeomorphic (Lemma 5.17). In the next three paragraphs we consider the different possibilities for Γ_1 .

If Γ_1 is a cofinite arithmetic Fuchsian group or a quasi-Fuchsian subgroup of an arithmetic Kleinian group, then \mathcal{L}_{Γ_1} is topologically a circle.

If Γ_1 is a subgroup of an arithmetic Fuchsian group but is not cofinite, then by Theorem 4.6.1 and Theorem 4.5.1 in Katok's book [10], Γ_1 is not of the first kind and since it is nonelementary from Theorem 3.4.6 in [10] follows that \mathcal{L}_{Γ_1} is nowhere dense in the circle in $\partial\mathbb{H}^3$ that is left invariant by Γ_1 and in particular not connected. Thus in this case \mathcal{L}_Γ is not homeomorphic to a circle.

Let Γ_1 be a subgroup of an arithmetic Kleinian group. If Γ_1 is (conjugated to) a Fuchsian group, then it is contained in an arithmetic Fuchsian group and we are in the previous case. If Γ_1 contains purely loxodromic elements, then \mathcal{L}_{Γ_1} is homeomorphic to a circle if and only if Γ_1 is a quasi-Fuchsian group. Hence if Γ_1 contains purely loxodromic elements, then \mathcal{L}_Γ is homeomorphic to a circle if and only if Γ_1 is a quasi-Fuchsian group.

Now we come back to the second big case. Let Γ_1 be such that it is not contained in an arithmetic Fuchsian or Kleinian group. By Lemma 5.15, \mathcal{L}_Γ and $\mathcal{L}_{\Gamma^{ne}}$ are homeomorphic, Γ^{ne} is a subgroup of $\mathrm{PSL}(2, \mathbb{C})^n$ and by Lemma 5.14 $n \geq 2$.

Then according to Theorem 5.10, $P_{\Gamma^{ne}}$ contains at least two different points and by Lemma 3.3 there is a path in $P_{\Gamma^{ne}}$ between these points and thus $P_{\Gamma^{ne}}$ contains an interval. The rest of the proof in this case is analogous to the corresponding part in Theorem 5.19 that shows that \mathcal{L}_Γ is not

homeomorphically embedded in a circle. □

Remark. From the proof it follows in particular that if \mathcal{L}_Γ is not contained in a circle, then $p_j(\Gamma)$ is not a subgroup of an arithmetic Fuchsian or Kleinian group.

To the best of my knowledge it is not known how quasi-Fuchsian subgroups of arithmetic Kleinian groups look like. Is it possible that they are always arithmetic Fuchsian groups?

6 The limit set of modular embeddings of Fuchsian groups

We already saw that for an arithmetic Fuchsian group the projection of the regular limit set into the Furstenberg boundary is homeomorphic to a circle. In this section we provide examples of “small” groups with a “big” limit set, where the projection of the regular limit set into the Furstenberg boundary is the whole Furstenberg boundary.

Let Γ_1 be a semi-arithmetic subgroup of $\mathrm{PSL}(2, \mathbb{R})$ that is a subgroup of an arithmetic group derived from a quaternion algebra acting on $(\mathbb{H}^2)^r$. We set $\Gamma := \Gamma_1^*$ a subgroup of $\mathrm{PSL}(2, \mathbb{R})^r$. Then Γ_1 is said to have a *modular embedding* if for the natural embedding $f : \Gamma_1 \rightarrow \Gamma^* = \Gamma$ there exists a holomorphic embedding $F : \mathbb{H}^2 \rightarrow (\mathbb{H}^2)^r$ with

$$F(Tz) = f(T)F(z), \quad \text{for all } T \in \Gamma_1 \quad \text{and all } z \in \mathbb{H}^2.$$

Examples of strictly semi-arithmetic groups admitting modular embeddings are Fuchsian triangle groups (see Cohen and Wolfart [4]).

According to Theorem 3 by Schmutz and Wolfart in [21], if ϕ_i is not a conjugation then $\phi_i(\Gamma_1)$ is not a Fuchsian group. Since every nondiscrete subgroup of $\mathrm{PSL}(2, \mathbb{R})$ has elliptic elements of infinite order (see Theorem 8.4.1 in Beardon [1]), the nondiscrete group $\phi_i(\Gamma_1)$ contains elliptic elements of infinite order. (Here the ϕ_i are the same as the ones from the definition of Γ_1^* .) We will use this in the proof of Theorem 6.2.

In the further discussion, we will assume that none of the ϕ_i except ϕ_1 is a conjugation. In other words, we will assume that $\mathrm{PSL}(2, \mathbb{R})^r$ is the minimal product for which Γ_1 has a modular embedding in an irreducible arithmetic subgroup Γ of $\mathrm{PSL}(2, \mathbb{R})^r$. The number r is the degree of $\mathbb{Q}(\mathrm{Tr}(\Gamma_1))$ over \mathbb{Q} . An example of such a Γ is a group commensurable to $\Gamma(A\Gamma_1^{(2)}, \mathcal{O}\Gamma_1^{(2)})^*$ such that $p_1(\Gamma)$ contains Γ_1 .

Corollary 5 by Schmutz and Wolfart [21] states that for all $g = (g_1, \dots, g_r)$ in Γ such that g_1 is hyperbolic, we have the inequality $\mathrm{tr}(g_i) < \mathrm{tr}(g_1)$ for $i = 2, \dots, r$. Hence for every hyperbolic (or mixed) g in Γ the inequalities $\ell(g_i) < \ell(g_1)$ for $i = 2, \dots, r$ hold. Thus the translation direction $L(g)$ is in $\{(x_1 : \dots : x_r) \mid x_1 \geq x_i \text{ for all } i = 2, \dots, r\}$.

Since Γ is nonelementary, by Theorem 2.2 it follows that the translation directions of the hyperbolic isometries in Γ are dense in P_Γ and we have the following proposition.

Proposition 6.1. *Let $\Gamma < \mathrm{PSL}(2, \mathbb{R})^r$ be a modular embedding of a semi-arithmetic Fuchsian group Γ_1 . Then*

$$P_\Gamma \subseteq \{(x_1 : \dots : x_r) \mid x_1 \geq x_i \text{ for all } i = 2, \dots, r\}.$$

Remark. (i) In the above proposition, r is not necessarily the smallest one for which Γ has a modular embedding.

(ii) There are examples of semi-arithmetic groups that do not admit modular embeddings and for which the proposition is not true. E.g. the strictly semi-arithmetic examples from Theorem 1 in [21].

As this proposition already shows, P_Γ is not \mathbb{RP}_+^{r-1} and hence the limit set \mathcal{L}_Γ is not the whole geometric boundary of $(\mathbb{H}^2)^r$. Nevertheless, we can still ask the question whether P_Γ contains an open subset of \mathbb{RP}_+^{r-1} or not.

From the fact that $\mathrm{tr}(g_i) < \mathrm{tr}(g_1)$ for $i = 2, \dots, r$ it follows that for all hyperbolic $g_1 \in \Gamma_1$, the conjugates of their traces are different, i.e. $\mathrm{tr}(g_i) \neq \mathrm{tr}(g_j)$ if $i \neq j$. Hence no trace in $\mathrm{Tr}(\Gamma_1)$ of a hyperbolic element is contained in a proper subfield of the trace field $\mathbb{Q}(\mathrm{Tr}(\Gamma_1))$ of Γ_1 . In particular there are no hyperbolic elements in Γ_1 with integer traces.

The next theorem shows examples of groups admitting modular embeddings that are in some sense “big”.

Theorem 6.2. *Let Γ be a subgroup of an irreducible arithmetic subgroup of $\mathrm{PSL}(2, \mathbb{R})^r$ with $r = 2, 3$ such that $p_1(\Gamma)$ is a semi-arithmetic Fuchsian group admitting a modular embedding and r is the smallest power for which Γ_1 has a modular embedding in an irreducible arithmetic subgroup of $\mathrm{PSL}(2, \mathbb{R})^r$.*

Then F_Γ is the whole Furstenberg boundary $(\partial\mathbb{H}^2)^r$.

Proof. We first give arguments that are true for general r .

We denote $\Gamma_i := p_i(\Gamma)$, for $i = 1, \dots, r$.

First we remark that by Lemma 3.4 the regular limit set of Γ is not empty and hence there is $\xi = (\xi_1, \dots, \xi_r) \in F_\Gamma$. Without loss of generality, we can assume that ξ is the projection in the Furstenberg boundary of the attractive fixed point of a hyperbolic isometry in Γ . By Theorem 2.2, F_Γ is the minimal closed Γ -invariant subset of the Furstenberg boundary $(\partial\mathbb{H}^2)^r$. Then $F_\Gamma = \overline{\Gamma(\xi)}$. The idea is to show that $\overline{\Gamma(\xi)}$ is the whole Furstenberg boundary $(\partial\mathbb{H}^2)^r$ and hence $F_\Gamma = (\partial\mathbb{H}^2)^r$.

We will mainly use that except of Γ_1 all the other Γ_i are non discrete and in particular that then they contain elliptic elements of infinite order. An

elliptic element e of infinite order acts on $\partial\mathbb{H}^2$ as a "rotation" of irrational angle. That is why the orbit of a point in $\partial\mathbb{H}^2$ under the action of e is dense in $\partial\mathbb{H}^2$.

We will show that $(\partial\mathbb{H}^2)^r = \overline{\Gamma(\xi)}$ for the cases $r = 2, 3$.

Case $r = 2$: Let $g = (g_1, g_2) \in \Gamma$ be a transformation such that g_2 is an elliptic transformation of infinite order. Such g_2 exists because Γ_2 is not discrete. The isometry g_1 is hyperbolic because Γ_1 is discrete.

Let η_1 be the attractive fixed point of g_1 . First we note that $\{\eta_1\} \times \partial\mathbb{H}^2$ is in $\overline{\Gamma(\xi)}$. The reason is that for any point $\eta_2 \in \mathbb{H}^2$ there is a sequence $\{n_k\}$ of powers such that $g_2^{n_k}(\xi_2) \rightarrow \eta_2$ when $n_k \rightarrow \infty$ and additionally, because of the dynamics of the hyperbolic isometries, $g_1^{n_k}(\xi_1) \rightarrow \eta_1$ when $n_k \rightarrow \infty$. The only problem could be that ξ_1 is the repelling fixed point of g_1 . In this case we consider g^{-1} instead of g .

Now let $\zeta = (\zeta_1, \zeta_2)$ be a point in $\partial\mathbb{H}^2 \times \partial\mathbb{H}^2$. Since Γ_1 is a cofinite Fuchsian group, \mathcal{L}_{Γ_1} is the whole boundary of \mathbb{H}^2 . It is also the minimal closed Γ_1 -invariant subset of $\partial\mathbb{H}^2$ (see Theorem 5.3.7 in [1]). Therefore $\mathcal{L}_{\Gamma_1} = \overline{\Gamma_1(\eta_1)}$ and there is a sequence of elements $\{h_n\}$ in Γ such that $(h_n)_1(\eta_1) \xrightarrow{n \rightarrow \infty} \zeta_1$.

The points $(\eta_1, (h_n)_2^{-1}(\zeta_2))$ are points in $\overline{\Gamma(\xi)}$ because it contains $\{\eta_1\} \times \partial\mathbb{H}^2$. Therefore all the points $((h_n)_1(\eta_1), \zeta_2)$ are in $\overline{\Gamma(\xi)}$. Therefore their limit $\zeta = \lim_{n \rightarrow \infty} ((h_n)_1(\eta_1), \zeta_2)$ is also in $\overline{\Gamma(\xi)}$. Thus $\overline{\Gamma(\xi)} = (\partial\mathbb{H}^2)^2$.

Case $r = 3$: Let $g = (g_1, g_2, g_3) \in \Gamma$ be a transformation such that g_2 is an elliptic transformation of infinite order. The isometry g_1 is hyperbolic because Γ_1 is discrete. Let η_1 be its attractive fixed point. The isometry g_3 can be either hyperbolic or elliptic of infinite order.

- First assume that g_3 is hyperbolic with attractive fixed point η_3 . We can assume that ξ_1 and ξ_3 are none of the fixed points of g_1 and g_3 respectively. The reason is that ξ is the projection on the Furstenberg boundary of the attractive fixed point of an element \tilde{g} in Γ . By Lemma 3.1, we can find \tilde{g}' such that \tilde{g}'_i and g_i do not have any common fixed point for $i = 1, 2, 3$. Then instead of the attractive fixed point of \tilde{g} we can take the attractive fixed point of \tilde{g}' . Then as in the previous case we see that $\{\eta_1\} \times \partial\mathbb{H}^2 \times \{\eta_3\}$ is a subset of $\overline{\Gamma(\xi)}$.

The next step is to use an element $h = (h_1, h_2, h_3)$ such that h_3 is an elliptic isometry of infinite order. Such an element exists because Γ_3 is not discrete. For any point $(\zeta_1, \zeta_2, \zeta_3)$ in the Γ -orbit of $\{\eta_1\} \times \partial\mathbb{H}^2 \times \{\eta_3\}$,

the points in $\{\zeta_1\} \times \partial\mathbb{H}^2 \times \{\zeta_3\}$ are also in the orbit. Hence we can forget the second factor and proceed as in the case $r = 2$.

- Assume now that g_3 is elliptic of infinite order. We forget for a moment the first factor and look at the action of (g_2, g_3) on the 2-torus $(\partial\mathbb{H}^2)^2$. As already remarked the traces of g_2 and g_3 are different. Let $\text{tr}(g_2) = |2\cos(\alpha\pi)|$ and $\text{tr}(g_3) = |2\cos(\beta\pi)|$. Since g_2 and g_3 are elliptic of infinite order, they are rotations of angles $2\alpha\pi$ and $2\beta\pi$ respectively where α and β are different irrational numbers in the interval $[0, \pi)$ and $\cos(\alpha\pi)$ is a conjugate of $\cos(\beta\pi) =: \phi(\cos(\alpha\pi))$. The orbit of (ξ_2, ξ_2) under (g_2, g_3) can be represented as the orbit of a point in the flat torus $S^1 \times S^1$ under translations with translation vector $(2\alpha, 2\beta)$. By Theorem 442 in the book of Hardy and Wright [11], the orbit of a point is dense if 2α , 2β and 1 are linearly independent over \mathbb{Q} .

Let us assume that 2α , 2β and 1 are linearly dependent over \mathbb{Q} , i.e. $2m\alpha + 2n\beta = k$ for some integers k, m, n .

For a positive integer l , we have $\cos(lx) = P_l(\cos x)$ where P_l is a polynomial of degree l . Hence

$$\begin{aligned}\phi(\cos(l\alpha\pi)) &= \phi(P_l(\cos(\alpha\pi))) = P_l(\phi(\cos(\alpha\pi))) \\ &= P_l(\cos(\beta\pi)) = \cos(l\beta\pi).\end{aligned}$$

This means that a conjugate of $\cos(n\alpha\pi)$ is

$$\begin{aligned}\phi(\cos(n\alpha\pi)) &= \cos(n\beta\pi) = \cos((k - m\alpha)\pi) \\ &= \cos(k\pi)\cos(m\alpha\pi) + \sin(k\pi)\sin(m\alpha\pi).\end{aligned}$$

Up to multiplying by two, one can assume that k is even and hence $\sin(k\pi) = 0$ and $\cos(k\pi) = 1$. Thus $\phi(\cos(n\alpha\pi)) = \cos(m\alpha\pi)$.

If $m = n$, then $\phi(\cos(n\alpha\pi)) = \cos(n\alpha\pi)$, which is impossible because $\cos(n\alpha\pi)$ is a conjugate of the trace of a hyperbolic element in Γ_1 and it is not contained in a proper subfield of $\mathbb{Q}(\text{Tr}(\Gamma_1))$. Hence $m \neq n$.

We will show that $\phi(\cos(n\alpha\pi)) = \cos(m\alpha\pi)$ is impossible by finding c different conjugates of $\cos(n^c\alpha\pi)$ where c is an arbitrary integer.

$$\begin{aligned}\phi(\cos(n^c\alpha\pi)) &= \phi(P_{n^{c-1}}(\cos(n\alpha\pi))) = P_{n^{c-1}}(\phi(\cos(n\alpha\pi))) \\ &= P_{n^{c-1}}(\cos(m\alpha\pi)) = \cos(mn^{c-1}\alpha\pi).\end{aligned}$$

By induction we see that for every integer d with $0 < d \leq c$,

$$\phi^d(\cos(n^c \alpha \pi)) = \cos(m^d n^{c-d} \alpha \pi).$$

All $\phi^d(\cos(n^d \alpha \pi))$ are conjugate and different because $\cos(m^d n^{c-d} \alpha \pi)$ are different for different d . This contradicts the fact that $\mathbb{Q}(\text{Tr}(\Gamma))$ is a finite extension of \mathbb{Q} .

Thus 2α , 2β and 1 are linearly independent over \mathbb{Q} . Therefore the orbit of (ξ_2, ξ_2) under (g_2, g_3) is dense in $\partial\mathbb{H}^2 \times \partial\mathbb{H}^2$. Hence $\{\eta_1\} \times \partial\mathbb{H}^2 \times \partial\mathbb{H}^2$ is a subset of $\overline{\Gamma(\xi)}$. The rest of the proof is as in the case $r = 2$.

□

Remark. (i) Examples of groups with $r = 2$ are the triangle groups $(5, \infty, \infty)$ and $(2, 5, \infty)$. For them we have also that their limit cone C_Γ is a subset of $P := \{(x_1 : x_2) \mid x_1 \geq x_2\}$. Even more, $C_\Gamma = P$ because $(1 : 1) \in C_\Gamma$ (Proposition 5.13), $(1 : 0) \in C_\Gamma$ (the second projection of the modular embedding contains an elliptic isometry of infinite order) and the two points are connected (Theorem 3.8). Therefore their limit set is “half” of the geometric boundary of $(\mathbb{H}^2)^2$.

(ii) Generally, for a modular embedding Γ of Γ_1 we can prove that the limit set contains a subset homeomorphic to \mathbb{R}^2 . I think it is not difficult to show that there is a subset homeomorphic to \mathbb{R}^3 or even \mathbb{R}^4 . A question is which is the biggest n such that \mathcal{L}_Γ contains a subset homeomorphic to \mathbb{R}^n . Other interesting questions are if \mathcal{L}_Γ is connected or even more if F_Γ is the whole Furstenberg boundary.

7 Totally geodesic embeddings

In this section we show applications of Theorem 5.19 and Theorem 5.22.

The idea for these applications came from the question if the modular embedding of a semi-arithmetic group admitting a modular embedding is totally geodesic.

We remind that we can write Γ as

$$\Gamma = \{(\phi_1(g_1), \phi_2(g_1), \dots, \phi_{q+r}(g_1)) \mid g_1 \in p_1(\Gamma)\}$$

where ϕ_i is a surjective homomorphism between $p_1(\Gamma)$ and $p_i(\Gamma)$. Hence there is a natural embedding of $p_i(\Gamma)$ into Γ given by the following mapping:

$$f : \Gamma_i \rightarrow \Gamma, \quad g_i \mapsto (\phi_1\phi_i^{-1}(g_1), \phi_2\phi_i^{-1}(g_1), \dots, \phi_{q+r}\phi_i^{-1}(g_1)).$$

Theorem 7.1. *Let Γ be a finitely generated nonelementary subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{R})^r$ with $r \geq 2$. Then $\Gamma_j := p_j(\Gamma)$ is a subgroup of an arithmetic Fuchsian group for some $j \in \{1, \dots, r\}$ if and only if for the natural embedding $f : \Gamma_1 \rightarrow \Gamma$ there exists a totally geodesic embedding $F : \mathbb{H}^2 \rightarrow (\mathbb{H}^2)^r$ with*

$$F(g_j z) = f(g_j)F(z), \quad \text{for all } g_j \in \Gamma_1 \quad \text{and all } z \in \mathbb{H}^2.$$

Proof. Let $F : \mathbb{H}^2 \rightarrow (\mathbb{H}^2)^r$ be a totally geodesic embedding with

$$F(g_1 z) = f(g_1)F(z), \quad \text{for all } g_1 \in \Gamma_1 \quad \text{and all } z \in \mathbb{H}^2.$$

Then the limit set of Γ is contained in the geometric boundary of $F(\mathbb{H}^2)$, which is a circle in $\partial(\mathbb{H}^2)^r$. By Theorem 5.19 this is only possible if Γ_j is a subgroup of an arithmetic Fuchsian group.

Now assume that Γ_j is a subgroup of an arithmetic Fuchsian group. By Lemma 5.2, then Γ_1 is also a subgroup of an arithmetic Fuchsian group. We consider the matrices $A_i = \begin{bmatrix} a_i & b_i \\ c_i & d_i \end{bmatrix} \in \mathrm{GL}(2, \mathbb{R})$, $i = 2, \dots, r$ from the proof of Lemma 5.17 which are defined so that for all $g_1 \in \Gamma_1$, the corresponding element $f(g_1)$ in Γ is given by $(g_1, A_2 g_2 A_2^{-1}, \dots, A_r g_r A_r^{-1})$. Then a totally geodesic embedding $F : \mathbb{H}^2 \rightarrow (\mathbb{H}^2)^r$ is given by $z \mapsto (z, \widetilde{A}_2(z), \dots, \widetilde{A}_r(z))$ where $\widetilde{A}_i(z) := \frac{a_i z + b_i}{c_i z + d_i}$ if $\det(A_i) > 0$ and $\widetilde{A}_i(z) := \frac{a_i \bar{z} + b_i}{c_i \bar{z} + d_i}$ if $\det(A_i) < 0$, $i = 2, \dots, r$. \square

The next theorem describes the totally geodesic embeddings of \mathbb{H}^2 into $(\mathbb{H}^3)^q$ that are left invariant by the action of Γ .

Theorem 7.2. *Let Γ be a finitely generated subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q$ with $q \geq 2$ such that $p_j(\Gamma)$ is nonelementary for some $j \in \{1, \dots, q\}$. Then there is a totally geodesic embedding of \mathbb{H}^2 in $(\mathbb{H}^3)^q$ that is left invariant by the action of Γ if and only if $p_j(\Gamma)$ is a subgroup of an arithmetic Fuchsian group.*

Proof. Without loss of generality, we can assume that $j = 1$.

Let $F : \mathbb{H}^2 \rightarrow (\mathbb{H}^3)^q$ be a totally geodesic embedding that is left invariant by the action of Γ . Then the limit set of Γ is contained in the geometric boundary of $F(\mathbb{H}^2)$, which is a circle in $\partial(\mathbb{H}^3)^q$. By the remark after the proof of Theorem 5.22 this is only possible if $\Gamma_1 := p_1(\Gamma)$ is a subgroup of an arithmetic Fuchsian or Kleinian group.

Now assume that Γ_1 is a subgroup of an arithmetic Fuchsian group. As in the proof of Theorem 5.22, after projecting, if needed, on the factors that do not consist only of elliptic isometries, we can assume that Γ is nonelementary.

By Proposition 3.6, Γ_i is either nonelementary or consists only of elliptic isometries with a common fixed point.

For $i = 1, \dots, q$ such that Γ_i is nonelementary, we consider the matrices $A_i = \begin{bmatrix} a_i & b_i \\ c_i & d_i \end{bmatrix} \in \mathrm{GL}(2, \mathbb{C})$, $i = 1, \dots, q$, from the proof of Lemma 5.17. Then the mappings ϕ_i are given by $\phi_i(g_1) := A_i g_1^\sigma A_i^{-1}$ for all $g_1 \in \Gamma_1$, where σ is fixed and denotes either the identity or the complex conjugation of g_1 .

Without loss of generality we can assume that Γ_1 leaves the plane $y = 0$ invariant. Then we define the totally geodesic embedding $F : \mathbb{H}^2 \rightarrow (\mathbb{H}^3)^q$ by $(x, t) \mapsto (z' := (x, 0, t), \widetilde{A}_2(z'), \dots, \widetilde{A}_r(z'))$ where \widetilde{A}_i is the extension to \mathbb{H}^3 of $\frac{a_i z + b_i}{c_i z + d_i}$ if Γ_i is nonelementary and σ is the identity, the extension to \mathbb{H}^3 of $\frac{a_i \bar{z} + b_i}{c_i \bar{z} + d_i}$ if Γ_i is nonelementary σ is the complex conjugation and the constant mapping to the fixed point of Γ_i if Γ is not nonelementary, $i = 1, \dots, q$.

The last case is when Γ_1 is a subgroup of an arithmetic Kleinian group. If Γ_1 is (conjugated to) a Fuchsian group, then it is contained in an arithmetic Fuchsian group and we are in the previous case. If Γ_1 contains purely loxodromic elements, then Γ_1 does not fix any geodesic plane in \mathbb{H}^3 . On the other hand, if F is a totally geodesic embedding as above, then $F(\mathbb{H}^2)$ is a geodesic plane in $(\mathbb{H}^3)^q$ that is fixed by Γ . Hence its projection $p_1(F(\mathbb{H}^2))$ in the first factor is fixed by Γ_1 . Since Γ_1 is nonelementary, the projection

$p_1(F(\mathbb{H}^2))$ cannot be just a point or a geodesic. Hence it is not possible that Γ_1 contains purely loxodromic elements and there is a totally geodesic embedding compatible with Γ . \square

The proof of the next theorem is analogous to the proof of the corresponding result in the real case Theorem 7.1. The only difference is in the construction of the totally geodesic embedding for the complex factors when Γ_j is arithmetic. This is done as in the proof of Theorem 7.2.

Theorem 7.3. *Let Γ be a finitely generated subgroup of an irreducible arithmetic group in $\mathrm{PSL}(2, \mathbb{C})^q \times \mathrm{PSL}(2, \mathbb{R})^r$ with $q + r \geq 2$ and $qr \neq 0$ such that $p_j(\Gamma)$ is nonelementary for some $j \in \{1, \dots, q + r\}$. Then there is a totally geodesic embedding of \mathbb{H}^2 in $(\mathbb{H}^3)^q \times (\mathbb{H}^2)^r$ that is left invariant by the action of Γ if and only if $p_j(\Gamma)$ is a subgroup of an arithmetic Fuchsian group.*
