Dr. Smith brought the meeting to order at 11:55 a.m.

Dr. Sheehan noted the handout everyone received regarding internship opportunities at Coastal Carolina University. We currently have 266 internship sites approved by the Office of Career Services. We have another large number of internship sites that are approved by our Colleges and Departments. We are working hard to bring all internship site activity into common practice and procedure without restricting the unique opportunities offered by individual departments and colleges.

After months of discussion with Deans and Faculty Senate, the Administration would like to create a new college, "University College," which will be the collegiate home of the First Year Experience, Academic Centers, non-declared majors, Interdisciplinary Studies majors, Bridge Program, Director of the Core Curriculum, College of record for UNIV courses, Life Long Learning and our various continuing education and outreach efforts. It represents an effort to ensure that every student who enrolls at Coastal Carolina is embedded within the administrative oversight of a Dean, and the curricular and appeals processes that are found in any college. There are no plans for faculty to have a full-time or permanent appointment in University
