# Dynamics of Cohen-Grossberg Neural Networks with Mixed Delays and Impulses

Impulsive Cohen-Grossberg neural networks with bounded and unbounded delays (i.e., mixed delays) are investigated. By using the Leray-Schauder fixed point theorem, differential inequality techniques, and constructing suitable Lyapunov functional, several new sufficient conditions on the existence and global exponential stability of periodic solution for the system are obtained, which improves some of the known results. An example and its numerical simulations are employed to illustrate our feasible results.

## 1. Introduction

In the recent years, dynamics of the Cohen-Grossberg neural networks (CGNNs) [1] has been extensively studied because of their immense potentials of application perspective in different areas such as pattern recognition, parallel computing, associative memory, combinational optimization, and signal and image processing [2–6]. The authors of [7–11] have studied the stability of equilibrium point or periodic solution of CGNNs with time-varying delays due to the transmission delays during the communication between neurons which will affect the dynamical behavior of neural networks. Considering the distant past also has influence on the recent behavior of the state, the authors of [12] investigated the stability of equilibrium point for CGNNs with continuously distributed delays. Impulsive effects are also likely to exist in the neural networks, that is, the state of the networks is subject to instantaneous perturbations and experiences abrupt change at certain moments. Authors of [13–16] have studied the stability of equilibrium point for impulsive delay CGNNs. However, the activation functions of CGNNs in [12–16] are bounded, and the restrictions on impulses in [13, 17] are very strong, which limit CGNNs' applications [7].

In theory and applications, global stability of periodic solution of CGNNs is of great importance since the global stability of equilibrium points can be considered as a special case of periodic solution with random period. Moreover, CGNNs model is one of the most popular and typical neural network models. Some other models, such as Hopfield-type neural networks, cellular neural networks, and bidirectional associative memory neural networks, are special cases of the model [14]. To our best knowledge, few authors have considered the existence and global exponential stability of periodic solutions for CGNNs with mixed delays and impulses. Therefore, it is necessary to consider the existence and global exponential stability of periodic solution for impulsive CGNNs with mixed delays.

The main methods used in this paper are Leray-Schauder's fixed point theorem, differential inequality techniques, and Lyapunov functional. Several new sufficient conditions are obtained for the existence and global exponential stability of periodic solution for impulsive CGNNs with mixed delays. Moreover, we discharge some restrictive conditions on the activation functions of the neurons, such as boundedness, monotonicity, and differentiable, we offer the precise convergence index, and give the weak conditions on impulses.

The rest of this paper is organized as follows. In Section 2, we introduce some notations and definitions and state some preliminary results needed in later sections. We then study, in Section 3, the existence of periodic solutions of impulsive CGNNs with mixed delays by using Leray-Schauder's fixed point theorem. In Section 4, with the help of Lyapunov functional, we will derive sufficient conditions for the global exponential stability of the periodic solution. At last, an example and its numerical simulations are employed to illustrate the feasible results of this paper.

## 2. Preliminaries

Consider the following CGNNs with mixed delays and impulses:

$$\begin{aligned} u_i'(t) = & -a_i(u_i(t)) \left\{ b_i(u_i(t)) - \sum_{j=1}^n \left[ b_{ij}(t) f_j(u_j(t - \tau_{ij}(t))) \right. \right. \\ & \left. \left. + c_{ij}(t) \int_{-\infty}^t k_{ij}(t-s) g_j(u_j(s)) ds \right] + I_i(t) \right\}, \quad t \neq t_k, \\ \Delta u_i(t_k) = & u_i(t_k^+) - u_i(t_k^-) = \gamma_{ik} u_i(t_k), \quad i = 1, 2, \dots, n, \end{aligned} \quad (2.1)$$

where  $\Delta u_i(t_k)$  ( $i = 1, 2, \dots, n$ ) are the impulses at moments  $t_k$ ,  $u_i(t)$  is left continuous at time  $t_k$ , and the right limit exists at  $t_k$ , that is,  $u_i(t_k) = u_i(t_k^-)$  and  $u_i(t_k^+)$  exist and  $0 < t_1 < t_2 < \dots$  is a strictly increasing sequence such that  $\lim_{k \rightarrow +\infty} t_k = +\infty$ ;  $u_i(t)$  is the state of neuron;  $a_i(u_i(t))$  and  $b_i(u_i(t))$  represent an amplification function at time  $t$  and an appropriately behaved function at time  $t$ , respectively;  $B = (b_{ij}(t))_{n \times n}$  and  $C = (c_{ij}(t))_{n \times n}$  are connection matrices;  $I(t) = (I_1(t), I_2(t), \dots, I_n(t))^T$  is the input function; and  $g(u) = (g_1(u_1), g_2(u_2), \dots, g_n(u_n))^T$  are the activation functions of the neurons.

Throughout this paper, we assume that

- (H<sub>1</sub>)  $b_{ij}(t), c_{ij}(t), \tau_{ij}(t) \geq 0$ ,  $I_i(t)$  are continuous  $\omega$ -periodic functions,  $\omega > 0$  is a constant,  $i, j = 1, 2, \dots, n$ ;
- (H<sub>2</sub>)  $a_i(u)$  is continuous and there exist positive constants  $\underline{a}_i$  and  $\bar{a}_i$  such that  $0 < \underline{a}_i \leq a_i(u) \leq \bar{a}_i$ ,  $u \in R$ ,  $i = 1, 2, \dots, n$ ;

- (H<sub>3</sub>) there is a positive constant  $l_i$  such that  $b'_i(u) \geq l_i$ ,  $b'_i(u)$  denotes the derivative of  $b_i(u)$ ,  $u \in R$ , and  $b_i(0) = 0$ ,  $i = 1, 2, \dots, n$ ;
- (H<sub>4</sub>)  $\{\gamma_{ik}\}$  and  $\{t_k\}$  are  $\omega$ -periodic sequence, that is, there exists a positive constant  $p$  such that  $t_{(k+p)} = t_k + \omega$ ,  $\gamma_{i(k+p)} = \gamma_{ik}$ ,  $i = 1, 2, \dots, n$ ;
- (H<sub>5</sub>)  $f_j, g_j \in C(R, R)$ , there are positive constants  $L_j^f > 0$ ,  $L_j^g > 0$ , such that  $|g_j(x) - g_j(y)| \leq L_j^g |x - y|$ ,  $|f_j(x) - f_j(y)| \leq L_j^f |x - y| \forall x, y \in R$ ,  $j = 1, 2, \dots, n$ ;
- (H<sub>6</sub>) the delay kernels  $k_{ij} : [0, +\infty) \rightarrow R$  are continuous, integrable and there exist positive constants  $\beta_{ij}$  such that

$$\int_0^{+\infty} |k_{ij}(s)| ds \leq \beta_{ij}, \quad i, j = 1, 2, \dots, n; \quad (2.2)$$

(H<sub>7</sub>)

$$\max_{1 \leq i \leq n} \sup_{0 \leq t \leq \omega} \left\{ \frac{\sum_{j=1}^n \bar{a}_j [|b_{ij}(t)| L_j^f + |c_{ij}(t)| L_j^g \beta_{ij}]}{q_i} \right\} = \theta < 1, \quad (2.3)$$

$$\max_{1 \leq i \leq n} \left\{ \theta + \frac{\bar{a}_i}{\underline{a}_i (1 - e^{-q_i \omega})} \sum_{k=1}^p |b_{ik}| \right\} < 1,$$

where  $q_i = \underline{a}_i l_i$ ;

(H<sub>8</sub>) there exists a constant  $\alpha_0 > 0$  such that

$$\int_0^{+\infty} |k_{ij}(s)| e^{\alpha_0 s} ds < +\infty, \quad i, j = 1, 2, \dots, n. \quad (2.4)$$

From (H<sub>2</sub>), the antiderivative of  $1/a_i(u_i)$  exists. We choose an antiderivative  $h_i(u_i)$  of  $1/a_i(u_i)$  that satisfies  $h_i(0) = 0$ . Obviously,  $(d/du_i)h_i(u_i) = 1/a_i(u_i)$ . By  $a_i(u_i) > 0$ , we obtain that  $h_i(u_i)$  is strictly monotone increasing about  $u_i$ . In view of derivative theorem for inverse function, the inverse function  $h_i^{-1}(u_i)$  of  $h_i(u_i)$  is differential and  $(d/du_i)h_i^{-1}(u_i) = a_i(u_i)$ . By (H<sub>3</sub>), composition function  $b_i(h_i^{-1}(z))$  is differential. Denote  $x_i(t) = h_i(u_i(t))$ , it is easy to see that  $x'_i(t) = u'_i(t)/a_i(u_i(t))$  and  $u_i(t) = h_i^{-1}(x_i(t))$ . Substituting these equalities into system (2.1), we get

$$\begin{aligned} x'_i(t) &= -b_i(h_i^{-1}(x_i(t))) \\ &\quad + \sum_{j=1}^n \left[ b_{ij}(t) f_j(h_j^{-1}(x_j(t - \tau_{ij}(t)))) \right. \\ &\quad \left. + c_{ij}(t) \int_{-\infty}^t k_{ij}(t-s) g_j(h_j^{-1}(x_j(s))) ds \right] - I_i(t), \quad t \neq t_k, \\ \Delta x_i(t_k) &= h_i((1 + \gamma_{ik}) h_i^{-1}(x_i(t_k))) - x_i(t_k) \doteq r_i(x_i(t_k)), \quad i = 1, 2, \dots, n, \end{aligned} \quad (2.5)$$

which can be rewritten as

$$\begin{aligned} x'_i(t) = & -d_i(x_i(t))x_i(t) + \sum_{j=1}^n \left[ b_{ij}(t)f_j(h_j^{-1}(x_j(t - \tau_{ij}(t)))) \right. \\ & \left. + c_{ij}(t) \int_{-\infty}^t k_{ij}(t-s)g_j(h_j^{-1}(x_j(s)))ds \right] - I_i(t), \quad t \neq t_k, \quad (2.6) \\ \Delta x_i(t_k) = & r_i(x_i(t_k)), \quad i = 1, 2, \dots, n, \end{aligned}$$

where  $d_i(x_i(t)) \triangleq b_i(h_i^{-1}(z))'|_{z=\xi_i}$ ,  $b_i(h_i^{-1}(z))'|_{z=\xi_i}$  denote the derivative of  $b_i(h_i^{-1}(z))$  at point  $z = \xi_i$ ,  $z \in R$ ,  $\xi_i$  is between 0 and  $x_i(t)$ .

The existence and global exponential stability of periodic solution for system (2.1) are equivalent to the existence and global exponential stability of periodic solution for system (2.5) or (2.6). So, we investigate the the existence and global exponential stability of periodic solution for system (2.6).

From the definition of  $h_i^{-1}(u)$ , using Lagrange mean value theorem, one gets

$$|h_i^{-1}(x) - h_i^{-1}(y)| = |(h_i^{-1})'(\xi)|(x - y) \leq \bar{a}_i|x - y|, \quad \forall x, y \in R, \quad (2.7)$$

where  $\xi$  is between  $x$  and  $y$ . Moreover, we have

$$\begin{aligned} |r_i(x_i(t_k))| & \leq \frac{1}{\underline{a}_i} |(1 + \gamma_{ik})h_i^{-1}(x_i(t_k)) - u_i(t_k)| \\ & = \frac{|\gamma_{ik}|}{\underline{a}_i} |h_i^{-1}(x_i(t_k))| \leq \frac{\bar{a}_i}{\underline{a}_i} |\gamma_{ik}| |x_i(t_k)|. \end{aligned} \quad (2.8)$$

For convenience, we denote  $\tau = \max\{\tau_{ij}(t) : t \in [0, \omega], i, j = 1, 2, \dots, n\}$ ,  $x = (x_1, x_2, \dots, x_n)^T$  to be a column vector, in which the symbol  $(^T)$  denotes the transpose of a vector.

*Definition 2.1.* A function  $x \in (R, R^n)$  is said to be a solution of (2.6) if the following conditions are satisfied.

- (i)  $x(t)$  is absolutely continuous on each  $(t_k, t_{k+1})$ ,  $k \in N$ .
- (ii) For each  $k \in N$ ,  $x(t_k^+)$  and  $x(t_k^-)$  exist and  $x(t_k) = x(t_k^-)$ .
- (iii)  $x(t)$  satisfies (2.6) for almost everywhere and at impulsive points,  $t_k$  may have discontinuity of the first kind.

The initial condition  $\phi = (\phi_1, \dots, \phi_n)^T$  of (2.6) is of the form

$$x_i(s) = \phi_i(s), \quad s \in (-\infty, 0], \quad i = 1, \dots, n, \quad (2.9)$$

where  $\phi_i(s)$ ,  $i = 1, 2, \dots, n$  are continuous functions.

*Definition 2.2.* Let  $x^*(t)$  be an  $\omega$ -periodic solution of (2.6) with initial value  $\phi^* = (\phi_1^*, \dots, \phi_n^*)^T \in C((-\infty, 0]; R^n)$ . If there exist constants  $\alpha > 0$ ,  $M \geq 1$  such that for every solution  $x(t)$  of (2.6) with initial value  $\phi \in C((-\infty, 0]; R^n)$ ,

$$\|x_i(t) - x_i^*(t)\| \leq M \|\phi - \phi^*\| e^{-\alpha t}, \quad \forall t > 0, i = 1, 2, \dots, n, \quad (2.10)$$

where  $\|\phi - \phi^*\| = \sup_{s \leq 0} \max_{1 \leq i \leq n} |\phi_i(s) - \phi_i^*(s)|$ . Then,  $x^*(t)$  is said to be globally exponentially stable.

**Lemma 2.3** (Leray-Schauder). *Let  $E$  be a Banach space, and let the operator  $A : E \rightarrow E$  be completely continuous. If the set  $\{\|x\| \mid x \in E, x = \lambda Ax, 0 < \lambda < 1\}$  is bounded, then  $A$  has a fixed point in  $T$ , where*

$$T = \{x \mid x \in E, \|x\| \leq R\}, \quad R = \sup \{\|x\| \mid x = \lambda Ax, 0 < \lambda < 1\}. \quad (2.11)$$

### 3. Existence of periodic solutions

**Lemma 3.1.** *Suppose that  $(H_1)$ – $(H_5)$  hold and let  $x(t)$  be an  $\omega$ -periodic solution of system (2.6). Then,*

$$\begin{aligned} x_i(t) = & \int_0^\omega \omega_i^x(t, s) \left[ \sum_{j=1}^n \left[ b_{ij}(s) f_j(h_j^{-1}(x_j(s - \tau_{ij}(s)))) \right. \right. \\ & \left. \left. + c_{ij}(s) \int_{-\infty}^s k_{ij}(s - v) g_j(h_j^{-1}(x_j(v))) dv \right] - I_i(s) \right] ds \\ & + \sum_{k=1}^p \omega_i^x(t, t_k) r_i(x_i(t_k)), \quad t \in [0, \omega], i = 1, 2, \dots, n, \end{aligned} \quad (3.1)$$

where

$$\omega_i^x(t, s) = \frac{1}{1 - e^{-\int_0^\omega d_i(x_i(v)) dv}} \begin{cases} e^{-\int_s^t d_i(x_i(v)) dv}, & 0 \leq s \leq t \leq \omega, \\ e^{-\left(\int_0^\omega d_i(x_i(v)) dv - \int_t^s d_i(x_i(v)) dv\right)}, & 0 \leq t < s \leq \omega. \end{cases} \quad (3.2)$$

*Proof.* Let  $t_q \leq t < t_{q+1}$ ,  $q \leq p$ . From the first expression of (2.6), we have

$$\begin{aligned} \left( x_i(t) e^{\int_0^t d_i(x_i(s)) ds} \right)' = & \left\{ \sum_{j=1}^n \left[ b_{ij}(t) f_j(h_j^{-1}(x_j(t - \tau_{ij}(t)))) \right. \right. \\ & \left. \left. + c_{ij}(t) \int_{-\infty}^t k_{ij}(t - s) g_j(h_j^{-1}(x_j(s))) ds \right] - I_i(t) \right\} e^{\int_0^t d_i(x_i(s)) ds}. \end{aligned} \quad (3.3)$$

Integrating (3.3) on intervals  $(0, t_1^-), (t_1^+, t_2^-), \dots, (t_q^+, t)$  and adding all of them, by the second formula of (2.6), we have

$$\begin{aligned} x_i(t) = & e^{-\int_0^t d_i(x_i(s))ds} x_i(0) + \sum_{k=1}^q e^{-\int_{t_k}^t d_i(x_i(s))ds} r_i(x_i(t_k)) \\ & + \int_0^t \left\{ \sum_{j=1}^n \left[ b_{ij}(s) f_j(h_j^{-1}(x_j(s - \tau_{ij}(s)))) \right. \right. \\ & \left. \left. + c_{ij}(s) \int_{-\infty}^s k_{ij}(s-v) g_j(h_j^{-1}(x_j(v))) dv \right] - I_i(s) \right\} e^{-\int_s^t d_i(x_i(v))dv} ds. \end{aligned} \quad (3.4)$$

Since  $x_i(\omega) = x_i(0)$ , from (3.4), we obtain

$$\begin{aligned} x_i(0) = & \frac{1}{1 - e^{-\int_0^\omega d_i(x_i(v))dv}} \left\{ \sum_{k=1}^p e^{-\int_0^\omega d_i(x_i(s))ds} r_i(x_i(t_k)) \right. \\ & + \int_0^\omega \left\{ \sum_{j=1}^n \left[ b_{ij}(s) f_j(h_j^{-1}(x_j(s - \tau_{ij}(s)))) \right. \right. \\ & \left. \left. + c_{ij}(s) \int_{-\infty}^s k_{ij}(s-v) g_j(h_j^{-1}(x_j(v))) dv \right] - I_i(s) \right\} \\ & \left. \times e^{-\int_s^\omega d_i(x_i(v))dv} ds \right\}. \end{aligned} \quad (3.5)$$

Substituting (3.5) into (3.4), we obtain (3.1). This completes the proof.  $\square$

In order to use Lemma 2.3, we take  $PC(J, R^n) = \{x(t) \mid x : J = [0, \omega] \rightarrow R^n \text{ as piecewise continuous periodic solution at } t \neq t_k, \text{ and } x(t_k^+), x(t_k^-) = x(t_k) \text{ exist at } t = t_k, k = 1, 2, \dots, p\}$ . Then,  $PC(J, R^n)$  is a Banach space with the norm

$$\|x\| = \max_{1 \leq i \leq n} \{ |x_i|_0 \}, \quad |x_i|_0 = \sup_{0 \leq t \leq \omega} |x_i(t)|, \quad i = 1, 2, \dots, n. \quad (3.6)$$

Set a mapping  $\Phi : PC(J, R^n) \rightarrow PC(J, R^n)$  by setting

$$(\Phi x)(t) = x(t), \quad t \in J = [0, \omega], \quad (3.7)$$

where

$$\begin{aligned} (\Phi x)_i(t) = & \int_0^\omega w_i^x(t, s) \left[ \sum_{j=1}^n \left[ b_{ij}(s) f_j(h_j^{-1}(x_j(s - \tau_{ij}(s)))) \right. \right. \\ & \left. \left. + c_{ij}(s) \int_{-\infty}^s k_{ij}(s-v) g_j(h_j^{-1}(x_j(v))) dv \right] - I_i(s) \right] ds \\ & + \sum_{k=1}^p w_i^x(t, t_k) r_i(x_i(t_k)). \end{aligned} \quad (3.8)$$

It is easy to know the fact that the existence of  $\omega$ -periodic solution of (2.6) is equivalent to the existence of fixed point of the mapping  $\Phi$  in  $PC(J, R^n)$ .

**Lemma 3.2.** *Suppose that  $(H_1)$ – $(H_7)$  hold. Then,  $\Phi : PC(J, R^n) \rightarrow PC(J, R^n)$  is completely continuous.*

*Proof.* First, we show that  $\Phi : PC(J, R^n) \rightarrow PC(J, R^n)$  is continuous. For any  $\varepsilon > 0$ , we take  $0 < \delta < \varepsilon / \max_{1 \leq i \leq n} \{\theta + \sum_{k=1}^p \eta_{ik} / (1 - e^{-q_i \omega})\}$ , where  $\eta_{ik} = (\bar{a}_i / \underline{a}_i) |1 + \gamma_{ik}| + 1$ . Then, for all  $x, y \in PC(J, R^n)$  and  $\|x - y\| < \delta$ , we have

$$\begin{aligned}
\|\Phi x - \Phi y\| &= \max_{1 \leq i \leq n} \sup_{0 \leq t \leq \omega} \left\{ \left| \int_0^\omega w_i^x(t, s) \right. \right. \\
&\quad \times \sum_{j=1}^n \left[ b_{ij}(s) [f_j(h_j^{-1}(x_j(s - \tau_{ij}(s)))) - f_j(h_j^{-1}(y_j(s - \tau_{ij}(s))))] \right. \\
&\quad \left. \left. + c_{ij}(s) \int_{-\infty}^s k_{ij}(s - v) [g_j(h_j^{-1}(x_j(v))) - g_j(h_j^{-1}(y_j(v)))] dv \right] ds \right. \\
&\quad \left. + \sum_{k=1}^p w_i^x(t, t_k) [r_i(x_i(t_k)) - r_i(y_i(t_k))] \right\} \\
&\leq \max_{1 \leq i \leq n} \sup_{0 \leq t \leq \omega} \left\{ \int_0^\omega w_i^x(t, s) q_i \theta ds + \sum_{k=1}^p \frac{\eta_{ik}}{1 - e^{-q_i \omega}} \right\} \|x - y\| \\
&< \max_{1 \leq i \leq n} \left\{ \theta + \frac{\sum_{k=1}^p \eta_{ik}}{1 - e^{-q_i \omega}} \right\} \delta < \varepsilon.
\end{aligned} \tag{3.9}$$

Hence,  $\Phi$  is continuous.

Next, we show  $\Phi$  maps bounded set into bounded set. For any  $x \in PC(J, R^n)$  with  $\|x\| < D$ , where  $D$  is some positive constant, we have

$$\begin{aligned}
\|\Phi x\| &= \max_{1 \leq i \leq n} \sup_{0 \leq t \leq \omega} \left\{ \left| \int_0^\omega w_i^x(t, s) \right. \right. \\
&\quad \times \left[ \sum_{j=1}^n \left[ b_{ij}(s) f_j(h_j^{-1}(x_j(s - \tau_{ij}(s)))) \right. \right. \\
&\quad \left. \left. + c_{ij}(s) \int_{-\infty}^s k_{ij}(s - v) g_j(h_j^{-1}(x_j(v))) dv \right] - I_i(s) \right] ds \\
&\quad \left. + \sum_{k=1}^p w_i^x(t, t_k) r_i(x_i(t_k)) \right\} \\
&< \max_{1 \leq i \leq n} \left\{ \theta + \frac{\bar{a}_i}{\underline{a}_i (1 - e^{-q_i \omega})} \sum_{k=1}^p |\gamma_{ik}| \right\} D \\
&\quad + \max_{1 \leq i \leq n} \left\{ \frac{1}{q_i} \left[ \sum_{j=1}^n [\bar{b}_{ij} |f_j(0)| + \bar{c}_{ij} \beta_{ij} |g_j(0)|] + \bar{I}_i \right] \right\},
\end{aligned} \tag{3.10}$$

where  $\bar{b}_{ij} = \max_{t \in [0, \omega]} |b_{ij}(t)|$ ,  $\bar{c}_{ij} = \max_{t \in [0, \omega]} |c_{ij}(t)|$ ,  $\bar{I}_i = \max_{t \in [0, \omega]} |I_i(t)|$ . Equation (3.10) implies that  $\|\Phi x\|$  is uniformly bounded for any  $\|x\| < D$ . Hence,  $\{\Phi x \mid x \in PC(J, R^n)\}$  is a family of uniformly bounded and equicontinuous functions on  $R$ . By using the Arzela-Ascoli theorem,  $\Phi : PC(J, R^n) \rightarrow PC(J, R^n)$  is compact. Therefore,  $\Phi : PC(J, R^n) \rightarrow PC(J, R^n)$  is completely continuous. This completes the proof.  $\square$

**Theorem 3.3.** *Suppose that (H<sub>1</sub>)–(H<sub>7</sub>) hold. Then, system (2.6) has an  $\omega$ -periodic solution.*

*Proof.* Let  $x \in PC(J, R^n)$ ,  $t \in J$ . We consider the operator equation

$$x = \lambda \Phi x, \quad \lambda \in (0, 1). \quad (3.11)$$

If  $x$  is a solution of (3.11), for  $t \in J$ , we obtain

$$\begin{aligned} \|x\| \leq \|\Phi x\| \leq \max_{1 \leq i \leq n} \left\{ \theta + \frac{\bar{a}_i}{\underline{a}_i (1 - e^{-q_i \omega})} \sum_{k=1}^p |\gamma_{ik}| \right\} \|x\| \\ + \max_{1 \leq i \leq n} \left\{ \frac{1}{q_i} \left[ \sum_{j=1}^n [\bar{b}_{ij} |f_j(0)| + \bar{c}_{ij} \beta_{ij} |g_j(0)|] + \bar{I}_i \right] \right\}, \end{aligned} \quad (3.12)$$

where this and  $\max_{1 \leq i \leq n} \{ \theta + (\bar{a}_i / \underline{a}_i (1 - e^{-q_i \omega})) \sum_{k=1}^p |\gamma_{ik}| \} < 1$  imply that

$$\|x\| \leq \frac{\max_{1 \leq i \leq n} \{ (1/q_i) [\sum_{j=1}^n [\bar{b}_{ij} |f_j(0)| + \bar{c}_{ij} \beta_{ij} |g_j(0)|] + \bar{I}_i] \}}{1 - \max_{1 \leq i \leq n} \{ \theta + (\bar{a}_i / \underline{a}_i (1 - e^{-q_i \omega})) \sum_{k=1}^p |\gamma_{ik}| \}} \triangleq R. \quad (3.13)$$

This shows that  $\|x\|$  of (3.11) is bounded, which is independent of  $\lambda \in (0, 1)$ . In view of Lemma 2.3, we obtain that  $\Phi$  has a fixed point. Hence, system (2.6) has one  $\omega$ -periodic solution with  $\|x\| \leq R$ . This completes the proof.  $\square$

#### 4. Global exponential stability of periodic solution

In this section, we will construct some suitable Lyapunov functionals to derive sufficient conditions which ensure that (2.6) has a unique  $\omega$ -periodic solution, and all solutions of (2.6) exponentially converge to its unique  $\omega$ -periodic solution.

**Theorem 4.1.** *Assume that (H<sub>1</sub>)–(H<sub>8</sub>) hold and*

$$(H_9) \ln M_k / (t_k - t_{k-1}) \leq \eta < \alpha, \text{ where } M_k = \max_{1 \leq i \leq n} \{ (\bar{a}_i / \underline{a}_i) [1 + \gamma_{ik}], 1 \}, \eta \text{ is a positive constant, } \alpha \text{ is given in the proof of this theorem, } t_0 = t_p - \omega.$$

*Then, system (2.6) has exactly one  $\omega$ -periodic solution, which is globally exponentially stable with the convergence index  $\alpha - \eta$ .*

*Proof.* By Theorem 3.3, there exists an  $\omega$ -periodic solution  $x^*(t) = (x_1^*(t), x_2^*(t), \dots, x_n^*(t))^T$  of (2.6) with initial value  $\phi^* = (\phi_1^*, \dots, \phi_n^*)^T$ . Suppose that  $x(t)$  is an arbitrary solution of system



(2.6) with initial value  $\phi = (\phi_1, \dots, \phi_n)^T$ . Set  $z(t) = (z_1(t), z_2(t), \dots, z_n(t))^T = x(t) - x^*(t)$ , then, from system (2.5), we have

$$\begin{aligned} z'_i(t) &= -[b_i(h_i^{-1}(x_i(t))) - b_i(h_i^{-1}(x_i^*(t)))] \\ &\quad + \sum_{j=1}^n \left[ b_{ij}(t) [f_j(h_j^{-1}(x_j(t - \tau_{ij}(t)))) - f_j(h_j^{-1}(x_j^*(t - \tau_{ij}(t))))] \right. \\ &\quad \left. + c_{ij}(t) \int_{-\infty}^t k_{ij}(t-s) [g_j(h_j^{-1}(x_j(s))) - g_j(h_j^{-1}(x_j^*(s)))] ds \right], \quad t \neq t_k, \\ z_i(t_k^+) &= h_i((1 + b_{ik})h_i^{-1}(x_i(t_k))) - h_i((1 + b_{ik})h_i^{-1}(x_i^*(t_k))), \quad i = 1, 2, \dots, n. \end{aligned} \quad (4.1)$$

By  $\theta < 1$ , we have

$$-q_i + \sum_{j=1}^n \bar{a}_j [|b_{ij}(t)|L_j^f + |c_{ij}(t)|L_j^g \beta_{ij}] < 0, \quad i = 1, 2, \dots, n. \quad (4.2)$$

Set

$$h_i(\lambda) = \lambda - q_i + \sum_{j=1}^n \bar{a}_j \left[ |b_{ij}(t)|L_j^f e^{\lambda\tau} + |c_{ij}(t)|L_j^g \int_0^{+\infty} |k_{ij}(s)|e^{\lambda s} ds \right], \quad i = 1, 2, \dots, n. \quad (4.3)$$

Clearly,  $h_i(\lambda)$ ,  $i = 1, 2, \dots, n$  are continuous functions on  $\mathbb{R}$ . Since

$$\begin{aligned} h_i(0) &\leq -q_i + \sum_{j=1}^n \bar{a}_j [|b_{ij}(t)|L_j^f + |c_{ij}(t)|L_j^g \beta_{ij}] < 0, \\ \frac{dh_i(\lambda)}{d\lambda} &= 1 + \sum_{j=1}^n \bar{a}_j \left[ \tau |b_{ij}(t)|L_j^f e^{\lambda\tau} + |c_{ij}(t)|L_j^g \int_0^{+\infty} |k_{ij}(s)|s e^{\lambda s} ds \right] > 0, \end{aligned} \quad (4.4)$$

and  $h_i(+\infty) = +\infty$ , hence  $h_i(\lambda)$ ,  $i = 1, 2, \dots, n$  are strictly monotone increasing functions. Therefore, for any  $i \in \{1, 2, \dots, n\}$  and  $t \geq 0$ , there is a unique  $\lambda(t)$  such that

$$\lambda(t) - q_i + \sum_{j=1}^n \bar{a}_j \left[ |b_{ij}(t)|L_j^f e^{\lambda(t)\tau} + |c_{ij}(t)|L_j^g \int_0^{+\infty} |k_{ij}(s)|e^{\lambda(t)s} ds \right] = 0. \quad (4.5)$$

Let  $\lambda_i^* = \inf_{t \geq 0} \{\lambda(t) \mid \lambda(t) - q_i + \sum_{j=1}^n \bar{a}_j [|b_{ij}(t)|L_j^f e^{\lambda(t)\tau} + |c_{ij}(t)|L_j^g \int_0^{+\infty} |k_{ij}(s)|e^{\lambda(t)s} ds] = 0\}$ . Obviously,  $\lambda_i^* \geq 0$ ,  $i = 1, 2, \dots, n$ . Now, we will prove that  $\lambda_i^* > 0$ ,  $i = 1, 2, \dots, n$ . Suppose this is not true, from (4.2), there exists a positive constant  $\eta$  such that

$$\inf_{t \geq 0, 1 \leq i \leq n} \left\{ \frac{q_i - \sum_{j=1}^n \bar{a}_j [|b_{ij}(t)|L_j^f + |c_{ij}(t)|L_j^g \beta_{ij}]}{1 + \sum_{j=1}^n \bar{a}_j [1.5\tau |b_{ij}(t)|L_j^f + |c_{ij}(t)|L_j^g \beta_{ij}]} \right\} \geq \eta. \quad (4.6)$$

Pick small  $\varepsilon > 0$ , then there exists  $t^i \geq 0$  such that

$$0 < \lambda_i^*(t^i) < \varepsilon < \eta, \quad \int_0^{+\infty} |k_{ij}(s)| e^{\varepsilon s} ds < \beta_{ij} + \eta. \quad (4.7)$$

Let us recall the inequality  $e^x < 1 + 1.5x$  for sufficiently small  $x > 0$ , then, we obtain

$$\begin{aligned} 0 &= \lambda_i^*(t^i) - q_i + \sum_{j=1}^n \bar{a}_j \left[ |b_{ij}(t^i)| L_j^f e^{\lambda_i^*(t^i)\tau} + |c_{ij}(t^i)| L_j^g \int_0^{+\infty} |k_{ij}(s)| e^{\lambda_i^*(t^i)s} ds \right] \\ &< \eta - q_i + \sum_{j=1}^n \bar{a}_j \left[ |b_{ij}(t^i)| L_j^f (1 + 1.5\eta\tau) + |c_{ij}(t^i)| L_j^g (\beta_{ij} + \eta) \right] \\ &\leq -q_i + \sum_{j=1}^n \bar{a}_j \left[ |b_{ij}(t^i)| L_j^f + |c_{ij}(t^i)| L_j^g \beta_{ij} \right] \\ &\quad + \frac{q_i - \sum_{j=1}^n \bar{a}_j \left[ |b_{ij}(t^i)| L_j^f + |c_{ij}(t^i)| L_j^g \beta_{ij} \right]}{1 + \sum_{j=1}^n \bar{a}_j \left[ 1.5\tau |b_{ij}(t^i)| L_j^f + |c_{ij}(t^i)| L_j^g \beta_{ij} \right]} \\ &\quad \times \left\{ 1 + \sum_{j=1}^n \bar{a}_j \left[ 1.5\tau |b_{ij}(t^i)| L_j^f + |c_{ij}(t^i)| L_j^g \beta_{ij} \right] \right\} = 0, \end{aligned} \quad (4.8)$$

which is a contradiction, and hence,  $\lambda_i^* > 0$ ,  $i = 1, 2, \dots, n$ .

Let  $\alpha = \min\{\lambda_1^*, \lambda_2^*, \dots, \lambda_n^*\}$ . Obviously, for all  $t \geq 0$ , we have

$$h_i(\alpha) = \alpha - q_i + \sum_{j=1}^n \bar{a}_j \left[ |b_{ij}(t)| L_j^f e^{\alpha\tau} + |c_{ij}(t)| L_j^g \int_0^{+\infty} |k_{ij}(s)| e^{\alpha s} ds \right] \leq 0, \quad i = 1, 2, \dots, n. \quad (4.9)$$

It is obvious that

$$|z_i(t)| \leq \|\phi - \phi^*\| \leq \|\phi - \phi^*\| e^{-\alpha t}, \quad \text{for } t \in (-\infty, 0], \quad i = 1, 2, \dots, n, \quad (4.10)$$

where  $\|\phi - \phi^*\|$  is defined as that in Definition 2.2.

Define the Lyapunov functional  $V = (V_1, V_2, \dots, V_n)^T$  by  $V_i = e^{\alpha t} |z_i(t)|$ ,  $i = 1, 2, \dots, n$ . In view of (4.1), for  $t \neq t_k$ ,  $k = 1, 2, \dots$ , we obtain

$$\begin{aligned} \frac{d^+ V_i(t)}{dt} &\leq e^{\alpha t} \left\{ (\alpha - q_i) |z_i(t)| + \sum_{j=1}^n \left[ |b_{ij}(t)| L_j^f \bar{a}_j |z_j(t - \tau_{ij}(t))| \right. \right. \\ &\quad \left. \left. + |c_{ij}(t)| \int_{-\infty}^t |k_{ij}(t-s)| L_j^g \bar{a}_j |z_j(s)| ds \right] \right\} \\ &\leq (\alpha - q_i) V_i(t) + \sum_{j=1}^n \bar{a}_j \left[ |b_{ij}(t)| e^{\alpha\tau} L_j^f V_j(t - \tau_{ij}(t)) \right. \\ &\quad \left. + |c_{ij}(t)| L_j^g \int_{-\infty}^t |k_{ij}(t-s)| e^{\alpha(t-s)} V_j(s) ds \right]. \end{aligned} \quad (4.11)$$

We claim that

$$V_i(t) = |z_i(t)|e^{\alpha t} \leq \|\phi - \phi^*\|, \quad i = 1, 2, \dots, n, \quad \forall t \in [0, t_1]. \quad (4.12)$$

Contrarily, there must exist  $i_0 \in \{1, 2, \dots, n\}$  and  $0 < \tilde{t} < t_1$  such that

$$V_{i_0}(\tilde{t}) = \|\phi - \phi^*\|, \quad \frac{d^+ V_{i_0}(\tilde{t})}{dt} > 0, \quad V_i(t) \leq \|\phi - \phi^*\|, \quad \forall t \in (-\infty, \tilde{t}], \quad i = 1, 2, \dots, n. \quad (4.13)$$

Together with (4.11) and (4.13), we obtain

$$\begin{aligned} 0 &< \frac{d^+ V_{i_0}(\tilde{t})}{dt} \\ &\leq \|\phi - \phi^*\| \left\{ \alpha - q_{i_0} + \sum_{j=1}^n \bar{a}_j \left[ |b_{i_0 j}(\tilde{t})| e^{\alpha \tau} L_j^f + |c_{i_0 j}(\tilde{t})| L_j^g \int_0^{+\infty} |k_{i_0 j}(s)| e^{\alpha s} ds \right] \right\}. \end{aligned} \quad (4.14)$$

Hence,

$$0 < \alpha - q_{i_0} + \sum_{j=1}^n \bar{a}_j \left[ |b_{i_0 j}(\tilde{t})| e^{\alpha \tau} L_j^f + |c_{i_0 j}(\tilde{t})| L_j^g \int_0^{+\infty} |k_{i_0 j}(s)| e^{\alpha s} ds \right], \quad (4.15)$$

which contradicts (4.9). Hence, (4.12) holds. It follows that

$$|z_i(t)| \leq \|\phi - \phi^*\| e^{-\alpha t}, \quad \forall t \in [0, t_1], \quad i = 1, 2, \dots, n. \quad (4.16)$$

When  $t = t_1$ , from the second expression of (4.1), we have

$$\begin{aligned} |z_i(t_1^+)| &\leq \frac{\bar{a}_i}{\underline{a}_i} |1 + \gamma_{i1}| |z_i(t_1)| \leq M_1 \lim_{t \rightarrow t_1^-} |z_i(t)| \\ &\leq M_1 \|\phi - \phi^*\| e^{-\alpha t_1}, \quad i = 1, 2, \dots, n. \end{aligned} \quad (4.17)$$

Similar to the steps of (4.9)–(4.16), we can also prove that

$$|z_i(t)| \leq M_1 \|\phi - \phi^*\| e^{-\alpha t}, \quad t \in [t_1, t_2], \quad i = 1, 2, \dots, n. \quad (4.18)$$

When  $t = t_2$ , again, from the second expression of (4.1), we have

$$|z_i(t_2^+)| \leq \frac{\bar{a}_i}{\underline{a}_i} |1 + b_{i2}| |z_i(t_2)| \leq M_1 M_2 \|\phi - \phi^*\| e^{-\alpha t_2}, \quad i = 1, 2, \dots, n. \quad (4.19)$$

By repeating the same procedure, we can deduce the following general result:

$$|z_i(t)| \leq M_1 M_2 \cdots M_k \|\phi - \phi^*\| e^{-\alpha t}, \quad t \in [t_k, t_{k+1}), \quad i = 1, 2, \dots, n. \quad (4.20)$$

By (H<sub>9</sub>), we have  $M_k \leq e^{\eta(t_k - t_{k-1})}$ , which implies that

$$M_1 M_2 \cdots M_k \leq e^{\eta(t_1 - t_0)} e^{\eta(t_2 - t_1)}, \dots, e^{\eta(t_k - t_{k-1})} \leq e^{\eta(\omega - t_p)} e^{\eta t}, \quad t \in [t_k, t_{k+1}). \quad (4.21)$$

So, in light of (4.20) and (4.21), we have

$$|x_i(t) - x_i^*(t)| = |z_i(t)| \leq e^{\eta(\omega - t_p)} \|\phi - \phi^*\| e^{-(\alpha - \eta)t}, \quad \forall t > 0, \quad i = 1, 2, \dots, n. \quad (4.22)$$

In view of Definition 2.2, the  $\omega$ -periodic solution  $x^*(t)$  of system (2.6) is globally exponentially stable with the convergence index  $\alpha - \eta$ . This completes the proof.  $\square$

*Remark 4.2.* Note that we have dropped the restriction: the activation functions are bounded and  $|1 + \gamma_{ik}| \leq 1$ , which is indispensable in [13, 17].

*Remark 4.3.* To the best of our knowledge, most of the existing research papers only give the existence of the convergence index, while we offer the precise convergence index in Theorem 4.1.

## 5. Application

In this section, we give an example to illustrate that our results are feasible. Consider the following Cohen-Grossberg neural networks with mixed delays and impulses:

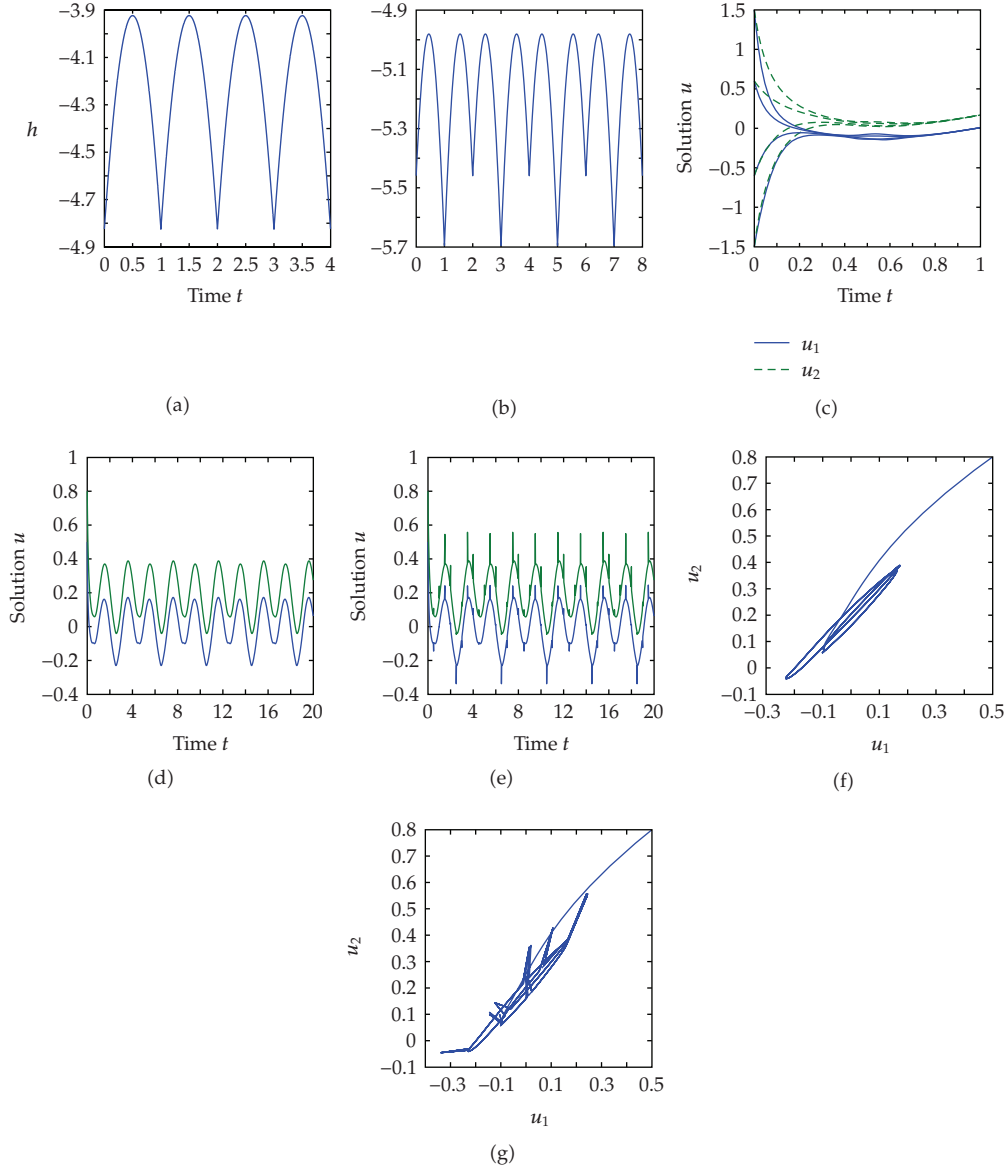
$$\begin{aligned} u_i'(t) = & -a_i(u_i(t)) \left\{ b_i(u_i(t)) - \sum_{j=1}^2 \left[ b_{ij}(t) f_j(u_j(t - \tau_{ij}(t))) \right. \right. \\ & \left. \left. + c_{ij}(t) \int_{-\infty}^t k_{ij}(t-s) g_j(u_j(s)) ds \right] + I_i(t) \right\}, \quad t \neq t_k, \\ \Delta u_i(t_k) = & u_i(t_k^+) - u_i(t_k^-) = 0.02 u_i(t_k), \quad i = 1, 2, \quad t_k = k - 0.5, \quad k = 1, 2, \dots, \end{aligned} \quad (5.1)$$

where  $f_1(u) = f_2(u) = g_1(u) = g_2(u) = |u + 1|$ ,  $a_1(u) = 3 + \sin u$ ,  $a_2(u) = 3 - \cos u$ ,  $b_1(u) = 5u + \sin u$ ,  $b_2(u) = 5u - \cos u$ ,  $I_i(t) = \sin \pi t$ ,  $\tau_{ij}(t) = (\cos \pi t)^2$ ,  $k_{ij} = \sin(t-s)e^{-2(t-s)}$ ,  $i, j = 1, 2$ :

$$\begin{pmatrix} b_{11} & b_{12} \\ b_{21} & b_{22} \end{pmatrix} = \begin{pmatrix} \frac{1}{6} \sin \frac{\pi t}{2} & \frac{1}{6} \cos \frac{\pi t}{2} \\ \frac{1}{10} \sin \frac{\pi t}{2} & \frac{1}{8} \cos \frac{\pi t}{2} \end{pmatrix}, \quad \begin{pmatrix} c_{11} & c_{12} \\ c_{21} & c_{22} \end{pmatrix} = \begin{pmatrix} \frac{1}{6} \cos \frac{\pi t}{2} & \frac{1}{6} \sin \frac{\pi t}{2} \\ \frac{1}{10} \sin \frac{\pi t}{2} & \frac{1}{12} \cos \frac{\pi t}{2} \end{pmatrix}. \quad (5.2)$$

We have  $\omega = 4$ ,  $L_1^f = L_2^f = L_1^g = L_2^g = 1$ ,  $\bar{a}_1 = \bar{a}_2 = 4$ ,  $\underline{a}_1 = \underline{a}_2 = 2$ ,  $l_1 = l_2 = 4$ ,  $\beta_{ij} = 1/2$ :

$$\theta \approx 0.1863 < 1, \quad \max_{1 \leq i \leq 2} \left\{ \theta + \frac{\bar{a}_i}{\underline{a}_i (1 - e^{-q_i \omega})} \sum_{k=1}^p |b_{ik}| \right\} \approx 0.3463 < 1, \quad (5.3)$$

In  $M_k / (t_k - t_{k-1}) = \ln 2.04 = 0.7129 < 1$ . Submitting  $\lambda = 1$  into (4.9), we have  $h_1(\lambda) < -3.9 < 0$ ,  $h_2(\lambda) < -4.9 < 0$ , (see Figures 1(a) and 1(b)). This implies that  $\ln 2.04 < 1 < \alpha$ . Hence, all the conditions needed in Theorem 4.1 are satisfied. Therefore, system (5.1) has a unique 4-periodic solution, which is globally exponentially stable (see Figures 1(c)–1(g)).

*Remark 5.1.* System (5.1) is a simple CGNNs with time-varying coefficients, mixed delays, and impulses. In system (5.1), the activation functions are all unbounded and

$|1 + b_{ik}| = 1.02 > 1$ ,  $i = 1, 2$ . Thus, none of the results in [13–17] can be applied to (5.1). This implies that the results of this paper are new and complement previously known results.
