

# What is a Meeting Preprint anyway?

- $\checkmark$  "Extended Abstract" is more accurate
- $\checkmark$  Not in the sense of a journal preprint (e.g. ArXiv)
- $\checkmark$  1-3 pages with graphics and some references
- $\checkmark$  Eventual submission as journal article often assumed

# **Preprints: Perceived Advantages**

- Members get "handy" copies of papers
- Increased attendance, membership
- More discussion; less lecturing in meetings
- Aids members in choosing meetings to attend
- Wider dissemination
- Better organization, higher quality papers
- Bistorical: publication outlet for divisions lacking journals
- Division revenue stream



# **Preprints: Perceived Disadvantages**

- Less editorial quality control; no peer review
- Author resistance
- Earlier submission deadlines
- Journal editorial policies on prior publication
- More work for division staff and volunteers
- Higher dues and/or minimal ROI
- Distribution challenges and costs (e.g. subscription fulfillment, third-party coordination)



### 2010 FUEL/PETR Member Survey

☑ Designed to gather opinion on delivery format(s)



**☑** 29% response rate (N=683)

#### $\boxdot$ 79% claimed they had read division preprints in last 5 years

- 47% preferred online + CD-ROM
- 42% preferred online-only



### 2010 FUEL/PETR Member Survey

Members were not asked whether preprints should be retained after ENFL merger.

**Pro/Con sentiments gleaned from 108 open-ended comments:** 

- $\square$  Keep the preprints: 3
- $\square$  Dump the preprints: 15

#### **Other recurring comments:**

- Image: "No paper no podium" policy a deterrent to membership/ submission
- ☑ Preprints have outlived their usefulness
- ☑ Many respondents unaware of online availability



### **Issues for Wider World**

- ? **Discovery**
- ? Access
- ? Low citation rates
- ? Bibliographic control (title/name changes, CASSI vs OCLC, etc.)
- ? Long term preservation
- ? Fulfillment problems after print ended
- ? **Few libraries subscribe(d)** (5 OCLC holders of ENFL CD)



## **Discovery: Then and Now**

✓ Original CA indexing policy: Preprint abstracted ONLY if journal article based on it did not appear within 18 months of meeting.

 $\checkmark$  Arguments not to index them at all due to ACS journal prepublication policies

- $\checkmark\,$  CAS now indexes all preprints routinely and promptly
- $\checkmark$  Web of Science does not index preprints.

### The Dreaded CD-ROM



- Reduced subscription base after print ceased; no (reliable) subscription options
- CDs don't work well on all platforms
- Embedded search software obsolete or non-functional
- Sile numbers  $\neq$  Paper numbers
- Not an archival format: loss, degradation, damage



## **Online Access Shortcomings**


**ACS Division Proceedings Online** 

- $\checkmark$  No institutional access to ENFL
- ✓ Reduced subscription base after print ceased
- $\checkmark$  No article-level linking from SciFinder via link resolvers
- ✓ No DOIs
- ✓ CASSI title differs from OCLC title(s)
- ✓ ACS Proceedings platform lacks vol/issue/pagination data
- $\checkmark$  Browse only by meeting/symposium, not paper numbers






#### **FUEL: Citing Rate**





ACS Divisional Proceedings ACS Publications is no longer offering subscriptions to ACS Divisional Proceedings >>>

Many of the ACS' technical divisions will be discontinuing the production of Divisional Proceedings. As a result, beginning January 01, 2014 ACS Publications will no longer offer institutional subscriptions to the ACS Divisional Proceedings. Institutional customers who retained a subscription to one or more of the ACS Divisional Proceedings throughout 2013 will continue to receive online electronic access at no charge to the all of proceedings to which they subscribed and had access in 2013. To minimize any inconvenience to our customers, this level of access will be maintained indefinitely while ACS Publications and Divisions explore options for managing this valuable content into the future.

### **Questions for the Future**


- What is the place of preprints in the literature now?
