# Look Who's Talking About Parental Incarceration

On November 14th, Extension Children, Youth & Family Consortium held its Lessons From the Field conference focused on parental incarceration. With nearly 375 participants from Minnesota and beyond, the participants represented a very diverse range of disciplines: health care workers, public health nurses, social workers, corrections professionals, child welfare professionals, educators, clergy, community professionals and volunteers. Many participants reported having never thought about this issue or knowing very little about the impact of parental incarceration on children and families prior to attending the event. A Duluth psychologist reported, "This was one of the most valuable, interesting, and relevant workshops I've ever attended. This is a topic our society needs to understand better in order to make positive changes that will benefit all of us." The feedback from participants underscored the need for more public attention directed to this topic.

As it turns out, the topic of parental incarceration and its impact on children is receiving increasing national attention. Here's a brief list of events within the past six months:

- June 2013 Sesame Workshop unveiled the new educational series <u>"Little Children, Big Challenges:</u> <u>Incarceration"</u>
- June 2013 Children, Youth, & Family Consortium (CYFC) published the eReview issue <u>"Children with</u> <u>Incarcerated Parents — Considering Children's Outcomes in the Context of Complex Family</u> <u>Experiences"</u>
- August 20, 2013 The White House hosted a conference jointly sponsored by the American Bar Association and the National Science Foundation, "Parental Incarceration in the United States: Bringing Together Research and Policy to Reduce Collateral Costs to Children"
- October 25, 2013 Racine, WI conference focused on children and families in Racine County impacted by having a parent in jail or prison; speaker Julie Poehlman, Professor and Chair of Human Development and Family Studies at UW-Madison shared the preliminary results from a 16-month study at the Racine County Jail funded by the National Institutes of Health
- November 14, 2013 CYFC hosted an all-day conference, "Unbarred: Strengthening Families Affected by Parental Incarceration"
- November 26, 2013 The New York Times published a story in the Science Times section by Natalie Angier, "Bonding From Behind Bars"

All of these initiatives highlight similar research findings; parental incarceration significantly impacts children and families and building and maintaining relationships during and after incarceration can mitigate negative consequences.

The Lessons From the Field evaluation summary yielded four major themes: expansion of knowledge, recognition of research, personal connections and empathy, and relevance to work. Participants said they learned new information. A Native American liaison from Olivia shared, "I guess I've always known that these things existed but never heard it laid out the way your group did. Excellent — this should be very helpful in my work." And a nurse from the Twin Cities said, "the entire conference was informative — offered new perspectives, new resources, and new opportunities to network."

Attendees reflected on ways the conference will impact their work with children and families in the future, allowing them to work more sensitively with their clients, colleagues and community members. Some plan to share resources with their clients. Others noted that they learned the value of talking honestly with children who have an incarcerated parent. Numerous clinicians wrote that the conference confirmed the value of maintaining parent/child relationships during incarceration. A child welfare worker explained that often children in the child protection system do not visit incarcerated parents, "this conference changed my outlook – courts often discourage visits but this should be considered by what is best for the child."

In the months since the conference, a number of exciting opportunities have surfaced, including the topic of parental incarceration as a primary focus of the "Research to Practice" series at the upcoming Minnesota Association for Children's Mental Health (MACMH) conference in Duluth, April 27-29, 2014.
