- Stuff (hurricanes, floods, etc.) happens
- Hardware breaks
- Software crashes
- Files get corrupted
- Publishers fold, merge, disappear
- Somebody hits the wrong button
- Somebody drops something
- Burning files to CDs and DVDs isn't enough
- It costs time/money/hassle to restore lost collections..."

"Nearly 500 journal titles have been cancelled in paper copy, where the digital equivalent exists in Portico. UCL will rely on publishers for e-delivery and will rely on Portico for digital archiving and providing long-term digital access when defined trigger events lead to loss of access ..." "With an increasing number of digital resources, comes a new approach to collection management and a need to ensure long term access. We needed to find a solution to reliably protect our investment in e-content." **University of Cincinnati**

"Keeping in mind that access to Portico requires a trigger event, we have decided that with the 2008 renewals, we will convert to electronic-only all those titles which are committed to Portico. As additional titles become part of Portico we will mark them for conversion to electronic with the next renewal cycle. We are applying this decision across-the-board: we are not agonizing over whether Professor X really prefers print or whether the illustrations in a given subject are better in print (and as one colleague pointed out, if you photocopy from an art journal, it's in black and white. If you print from the electronic, it's in color)..." Drew University

RUL is now a subscriber to the Portico "dark archive". We will pay a subscription that acts as a "failsafe" for disaster recovery in case of catastrophic event or other permanent failure of content provider. "Trigger events" allow participating libraries to access content. Publisher failure initiates trigger event; there have been four so far. LOCKSS serves a different purpose, and is for more temporary interruptions, but Portico is for catastrophic failure events.

"The CLI [Center for Library Initiatives] staff work under a set of goals for CIC collective licensing that seek to extend the breadth and depth of resources available at member universities while fostering high levels of collection coordination. The benefits of collaboration should also include measurable influence on the scholarly publishing market and the ability to secure broad rights for content related to teaching, research, scholarly sharing, and archiving... Vendors should address participation or plans to participate in statistics and access/archiving standards: COUNTER, Sushi, CLOCKSS, LOCKSS, Portico, ... Address backfile access, archiving processes, and post-cancellation access included in the agreement, and potential costs for these services..."

** "...Digital initiatives at the AUC Woodruff Library date back to 2005 beginning with a five year partnership with Cornell University, SOLINET (now LYRASIS), and nine historically black colleges and universities to expand access to the founding documents of HBCUs. As a result of this partnership, the AUC Woodruff Library gained expertise in digitization standards, metadata creation, and digitization methodologies. The AUC Woodruff Library serves as the technical administrator of the HBCU Library Alliance Digital Collection (http://hbcudigitallibrary.auctr.edu/), a collection that has grown from approximately 9,000 images to more than 16,000 images representing the founding materials of twenty-two HBCUs..."

** "...Since 2011, the HBCU Library Alliance has been preserving digital content in the MetaArchive Cooperative, a distributed LOCKSS (lots of copies keeps stuff safe) digital preservation network for the content held in the HBCU Library Alliance (HBCU LA) Digital Collection. On behalf of the 3 HBCU Library Alliance, The AUC Woodruff Library provides technical support and hosts the server as a preservation node on the network. In addition, the AUC Woodruff Library utilizes both CONTENTdm and Digital Commons, a hosted institutional repository for discovery and access to digital content. The WorldCat Local discovery tool provides access to content in both of these repositories through a "Google-like" search box on the Library's website. Discovery of content within these repositories is also possible using search engines such as Yahoo and Google..."

A Digital Collection Celebrating the Founding of the Historically Black College and University is a collection of primary resources from HBCU libraries and archives. It includes several thousand scanned pages and represents HBCU libraries first collaborative effort to make a historic collection digitially available. Collections are contributed from member libraries of the Historically Black College and University Library Alliance.

The collection includes photographs, university correspondence, manuscripts, images of campus buildings, alumni letters, memorabilia, and programs from campus events.

These images present HBCUs as cultural, social, and political institutions from the early 1800s until today.
