

Veterans Day

Every November 11 we observe Veterans Day as a way to honor those that have served in the United States Armed Forces. This national holiday was first observed in 1919 when President Woodrow Wilson proclaimed November 11 as <u>Armistice Day</u>. A year earlier on that date an armistice, or temporary cessation of hostilities, occurred between the Allied Forces and Germany to effectively end World War I. In 1954, President Eisenhower issued a <u>proclamation</u> to rename the holiday as Veterans Day and today Veterans Day is a legal public holiday (see <u>5 U.S.C. §6103</u>).



In honor of this national holiday, please take a moment next week to stop by the Law Library to give a "salute" to your RWU Law colleagues, students, faculty, friends, and family who are serving or have served by completing one of the forms at the Circulation Desk. Filled out forms will be hung at the Law Library entrance as a way to show our gratitude for their service. Stonewall Inn – Fifty+ Years in History

Christopher Park, located immediately across the street from the Stonewall Inn in Greenwich Village, was named a national historic monument in June 2016. <u>The Proclamation</u> establishing the monument stated in part that in "the early morning hours of June 28, 1969, a riot broke out in response to a police raid on the Stonewall Inn, at the time one of the City's best known LGBT bars. Over the course of the next several days, more demonstrations and riots occurred in the surrounding neighborhood including Christopher Park. During these days, because of its strategic location across from the bar, Christopher Park served as a gathering place, refuge, and platform for the community to voice its demand for LGBT civil rights. The Stonewall Uprising is considered by many to be the catalyst that launched the modern LGBT civil rights movement."



On Wednesday, November 15, Marek P. Bute '05, will be the Keynote Speaker at <u>RWU Law's Inaugural</u> <u>Stonewall Lecture</u>held on the Bristol Campus. RWU Law's annual Stonewall Lecture Series honors the numerous individuals who have fought for LGBTQ equality and justice, and the many contributions they have made to advance this modern day civil rights movement.

The events of 1969, known as the Stonewall uprising or riots have been recognized not only for their role in the LGBT rights movement, but also for playing an essential role in <u>feminist history</u> The searches "stonewall uprising" or "stonewall riots" on <u>HeinOnline</u> provide many opportunities to learn more about legal influence of those individuals who took a stand over fifty years ago.



Finding State Law Resources

Researchers looking for state law materials from states outside their own state are often faced with certain practical difficulties. The first is that no library can maintain print materials for every state. The second is that sometimes even in the highly digitized world of online research, you still need to see a resource the way it appears or appeared in print. The reasons are varied:

- Getting the page citations correct
- Viewing a photograph that appeared in an article



• Reading information from an accompanying graph or other graphic

Traditional online research services are not at a point where they fill these gaps consistently. They also do not always provide the depth of historical coverage that a researcher might need.

So where does a researcher go when these materials are not available in their library? One excellent resource is <u>HeinOnline</u>.

HeinOnline provides many types of state materials in a searchable image-based (pdf) format. Some materials are current. Other materials are for those times when you need historical research. Among the many types of primary state materials available are:

• <u>State Session Laws</u>, includes session laws of all 50 U.S. DC, Puerto Rico, and the Virgin Islands. All states are current within 60 days of the printed publication, and all states are available back to inception.

- <u>State Statutes: Historical Archive</u>, includes superseded state statutes for all fifty states, DC, and Puerto Rico.
- <u>State Reports: Historical Archive</u>, includes a listing of all the reporters for each state, DC, and Puerto Rico, with links to selected reporters. Availability of full-text varies by state.
- State Attorney General Reports and Opinions, includes all fifty states, Puerto Rico and the Virgin Islands.

Do you need help identifying the best primary resources on an issue? HeinOnline does not neglect state specific secondary sources for research.

- <u>Bar Journals</u>, more than 125 state and local bar journals are available to search by subject, citation, or browse by journal title/state.
- <u>National Survey of State Laws</u>, a database providing a comparison information on a state-by-state basis for many of the most prevalent and topical state legal issues. The information is presented in a chart format.
- <u>Subject Compilations of State Laws</u>, subject organized database compiling references to articles with extensive discussion comparing multiple state's laws.

Cookie Law

The holiday season is just around the corner and you know what that means: sweet treats galore!

Cookies (and cookie dough!) are a favorite for many, but these snacks aren't immune from being the subject of lawsuits. Some recent cases include consumers falling ill after eating at a <u>New York raw cookie dough</u> shop and a <u>class-action suit</u> about mislabeled protein amounts.



To stay in the know on these cookie cases, or any other topic you might want to research, check out the various <u>Alert Services</u> offered by Bloomberg, Lexis, and Westlaw. Alert Services provide you with an efficient method to continue to monitor developments on a specific question or topic that you are researching. Once you have developed a good search, you can use the Alert Services to automatically run that search and provide any new resources of the type selected.
