My dear Mrs. Dillon:

His Excellency the Archbishop has directed me to acknowledge your letter of March fourth.

I know of the fine leadership that your late husband, Doctor Dillon, gave to the important work of the Federation of Catholic Physicians' Guilds, and congratulate you on the sterling spirit which led you to take up the burden when he, at the call of God, laid it down.
