The subject matter may be predominantly philosophical, religious, or medico-moral in nature. Material should be typewritten, double-spaced, with good margins and on one side of the paper only. Manuscripts (original and one copy) should be submitted to the Editorial Office of Tiee Linacre Quarterly, 1438 South Grand Blvd., St. Louis, Missouri, 63104. One additional copy should be retained by the author. Full editorial privileges are reserved. References if used should appear at the end of the article and should conform to the usage of the Index Medicus. (This format is that employed in the Abstract Section of The Linacre Quarterly.) A brief but pertinent curriculum vitae of the author(s) should accompany the manuscript. The Thomas Linacre Award is made annually to the author(s) of the original article adjudged to be the best to appear in The Linacre Quarterly during each calendar year.
