The National IWY Plan of Action (to be presented at the Houston Conference for a vote of the delegates) will be approved by the IWY National Commission at the October 20-21 National Commission Meeting. This National Women's Conference will be a major media event. All networks (TV & radio), major papers, and wire services, will be treating it as front page news. The strategy of the opposition, since they do not have the delegate votes, is to make it appear that they are the grassroots majority. They will say the delegates represent NOW and feminists only, because the grassroots were closed out. We know this is not true, but they will try to have thousands of observers. Picture thousands of Mormons and other anti-women's rights groups booing passage of a pro-woman plan and picketing and demonstrating outside. Therefore, it is important that we get as many pro-women supporters as possible there. The reason that an overwhelming majority of the delegates support a pro-women's rights plan is because a majority of the people of the country do. We are the majority. Let us be sure to show that we are, by encouraging people to come to the Conference as observers. Do not fear the disruptions. There has never been a national women's rights conference that some have not sought to ridicule and divide. It is not women fighting women; it is a matter of divided political viewpoints. On one hand, the pro-woman movement is supported by most of the women and men in this country and is led by all major national women's groups and the largest and strongest feminist group (NOW). On the other hand, the anti-women reactionary social policies position is led by the all male-dominated Mormon hierarchy, the John Birch Society, the Klu Klux Klan, the American Nazi Party, the Conservative Caucus, the American Independent Party, the conservative wing of the Catholic hierarchy, pro-life groups (primarily funded by the Catholic hierarchy), women's auxiliaries of these groups, Birch Society inspired groups, e.g. "Women Who Want to be Women," "Hot Dog," and "HOW." Stop ERA, which appears to be woman led, draws many of its leaders from the conservative political movements -- the right wing of the Republican Party, the American Party, the Conservative Caucus, or the Birch Society bnadara ban , sagbad , anothed notice it will only be worn by NOW members.

Our job at Houston is to help the majority register its will, to help assure that minority rights are observed, that the process is fair, and that the majority viewpoint be presented to the TV and radio audience positively.

To help coordinate our effort, we are asking all observers (not delegates) to list their choice of hotels in the following order: (1) Lamar, (2) Whitehall, and (3) Ramada. We are asking all NOW delegates to stay at the Hyatt-Regency, the main delegate hotel, where many activities will be, and where the NOW headquarters will be. Although it is not a union hotel, most of the Sheraton is not unionized either. Houston simply is not a union city, and Texas is a right-to-work state. (As a Commissioner, I voted that the Conference should not be in Houston for these and other reasons. But it is, so we must be where the activity is.) This committee must be appointed
