**Charles Odell Clark, Sr.** '46, June 3, Easley, S.C. He served in the U.S. Army Medical Corps during World War II and was a retired Baptist minister.

John W. McCrary '48, August 6, Fletcher, N.C.

George Moulton Barksdale '49, March 28, Aquadulce, Calif. He served in both the Merchant Marines and the U.S. Air Force before becoming a special needs instructor for the physically challenged and an advocate for the disabled. A veteran character actor, he had roles in more than 30 films and television shows and did voice tracks. He was a member of the National Maritime Union and the Seamen's International Union, served as a docent of the Maritime Museum in Long Beach, Calif., and was a member of the Screen Actors Guild and the American Film Institute Conservancy.

**Charles H. Thomas** '49, July 19, North Myrtle Beach, S.C. He was a retired principal, having worked 39 years in education. He taught his last 14 years at Loris (S.C.) High School and retired in 1990. He served in the U.S. Navy during World War II and was a member of the North Strand Civitan Club.

**Ernest Bryant Hinnant, Sr.** '50, July 7, Florence, S.C. After serving in the 101st Airborne Corps Headquarters during the Korean War, he earned his law degree. He went on to practice law in Florence and was the Florence County Public Defender for 28 years. He was a member of the American, South Carolina and Florence County bar associations and the Public Defender's Corps.

## **Guest named to Romanian post**

Un August 1, the United States Senate approved the appointment of Michael Guest '79, a career Foreign Service officer, to be ambassador to Romania. President Bush nominated Guest to the position in June, and Secretary of State Colin Powell conducted the swearing-in ceremony September 18.

Guest is a summa cum laude graduate of Furman and recipient of the university's Bradshaw-Feaster Medal, which is awarded to the outstanding male graduate. He most recently was the principal deputy assistant secretary for the Bureau of Legislative Affairs in the State Department.

He has held several posts in Washington, serving as deputy executive secretary of the Department of State and as politicalmilitary officer in the Office of European Security and Political Affairs. From 1996-99 he was deputy chief of mission in Prague, and he has completed overseas assignments in Paris, Moscow and Hong Kong.

Guest earned a master's degree in foreign affairs from the University of Virginia. The San Francisco Chronicle reported that during his interview before the Senate Foreign Relations Committee, Guest said his goals would include preparing Romania for membership in NATO, working for economic reform and attempting to cut back on corruption, particularly with respect to human trafficking.

He had been organist and choirmaster at St. Paul's Episcopal Church in New Orleans for 12 years, and was also assistant organist for St. Dominic Catholic Church. He previously served as an organist in Tennessee, South Carolina, North Carolina, Illinois and Washington, D.C. He was a member of the American Choral Directors Association and the New Orleans chapter of the American Guild of Organists, where he served on the board. He had recorded and released several music programs and published choral work and musical scores.
