Scope and Content Note: Harvey Newton Heckle (1902-1979) was a clubman and worked with the South Carolina Highway Department as the state's District 4 engineer. The Harvey Newton Heckle Papers consist of correspondence, memoranda, reports, newspaper clippings, and handwritten notes pertaining to Heckle's activities with the South Carolina Highway Department as the state's District 4 engineer. Mr. Heckle's work with the First Baptist Church of Chester, the Lion's Club, the Exchange Club, and the Chester County Historical Society is also well documented. The collection also includes records pertaining to A.M. Heckle's, Harvey's uncle, work with the Southern Railway in Macon, Georgia and Amelia Heckle, Harvey's daughter, which includes certificates, educational brochures, and correspondence.
